BARACA AND PHILATHEA

Just What These Two Names of Bible Study Organizations Signify.

There are a great many people who do not know the unique origin and the meaning of the word "Baraca." Indeed, there are some Sunday school workers to whom this will be a bit of new information. Since the word "Baraca" is now a most usual one in the vocabulary of Sunday school workers throughout the entire world, it will be well to know how we came to have it.

In the 20th chapter of II Chronicles will be found the story from which "Baraca" is secured. Briefly it is this: The Kingdom of Judah was threatened by an army of its enemies, Good King Jehoshaphat prayed unto Jehovah for deliverance, and the Lord answered this prayer by vexing the hosts of the enemy, so that they fell upon and slew each other. Thus when King Jehoshaphat and his people went from Jerusalem out to the scene of the camp of the enemy, they found most of them slain and the remnant fled. They also found so many jewels and riches that they were three days gathering up the spoil.

Then comes the 26th verse, as follows: "And on the fourth day they assembled in the valley of Beracah; for there they blessed Jehovah, therefore the name of that place was called the Valley of Beracah unto this day." The margin translates this Beracah as "blessing."

When Mr. Marshall A. Hudson organized his first class for young men, he wanted a name for it. In carefully reading his Bible, he came upon this word meaning "blessing," and seized it for his class. The spelling of the word was changed slightly, so as to permit making of the monogram design which is so familiar in well organized Sunday schools today.

Baraca has indeed been a real "blessing" to thousands, and literally hundreds of thousands of young men all over North America and the world. It could not but bless them, when it has brought them into the Sunday school and to the Bible and to God.

In like manner, the young ladies have a most appropriate name for their organized classes. The word "Philathea" is made up from two Greek words, and means "Lovers of Truth."

The history of the derivation of these two great words in our modern Sunday school and religious life will make an interesting item for the scrap book of the reader of this article.—C. E. Crossland, in Presbyterian Standard.

UNIVERSITY NOTES.

Chapel Hill, N. C. April 11.—On Thursday night two victories were added to the debating record of the University of North Carolina, Messrs. C. E. McIntosh and F. N. Cox won a unanimous decision over a team representing the University of Georgia after a most spirited contest held in Gerrard hall. At the same time Messrs. H. E. Stacy and W. R. Edmonds measured arms with representatives of Washington and Lee University before an audience which taxed the capacity of the grand opera house in Greensboro. The decision in this debate was also unanimous in favor of Carolina. In both debates Carolina championed the negative of the question, Resolved, That all corporations doing inter-State commerce business should be required to take out Federal charters under such conditions as congress may by law provide. Constitutionality granted.

Carolina in thirteen debates with the University of Georgia has won all but four. Out of two debate with Washington and Lee she has lost one and won one. Out of the three inter-collegiate debates in which she has engaged this year, the third being with the University of Pennsylvania, she has won three. Carolina holds the distinction of having won twenty-one out of twenty-eight contests during her debating career, and of having never lost a series. Among her rivals have been John Hopkins, George Washington University, Tulane, Vanderbilt, Washington and Lee, and the Universities of Georgia, Pennsylvania and Virginia.

OHIO VALLEY EXPOSITION.

During the next few months there will be held in various cities of the Ohio Valley, art exhibitions for the purpose of determining the best works of each particular section. When competent judges shall have passed on these paintings and selected those which they consider entirely representative, steps will be taken to assemble all the works so selected and embracing them in a collection which shall be representative of the Ohio Valley for exhibition at the Ohio Valley Exposition, to be held in Cincinnati August 29 to September 24. Not only will the latest works of the leading artists of this section be shown, but efforts also will be made to secure masterpieces that were produced in the past and which have passed out of the hands of their creators and are now owned by art connoisseurs in various portions of the country. The Ohio valley, from Pittsburg to Cairo, boasts of a number of famous artists, and there is no doubt that all of them will be represented by their best works at the exposition, forming an exhibit that will prove unusually attractive and interesting. There is a prospect of southern artists following a similar plan for the display of their works, although the matter has not yet assumed definite form.

NEW HOLIDAY TODAY.

Commemorates Meeting of Provincial Congress at Halifax in 1776

A new holiday was added to the list of those to be observed in this state by the last legislature and it falls on April 12, today. The day commemorates the meeting of the provincial congress at Halifax in the year 1776, which provided for the military organization of the colony in anticipation of hostilities then expected with the mother country and also named delegates to a general congress of the colonies and passed resolutions which were the fore runner of the declaration of independence adopted more than two months later at Philadelphia. The day is made a legal holiday by the act of 1909, chapter 888, and as such will be observed by banks and other public institutions.—Asheville Citizen.

Use of Harrows and Weeders.

At this season of the year and a little later, harrow and weeders should play a very important part in farm economy. As fast as land is broken each half day's breaking should be harrowed, to pulverize any clods that may be present before they dry out and become hard. Pulverizing is easily done at the proper time, but if clods are left to become hard they may be in the way in planting and cultivating for a considerable time. The harrowing also helps to keep the moisture in the soil, and makes it mellow. The thoughtful and observant farmer in this section of the country knows that we almost invariably have a drought during the summer, so they begin thus early to keep the moisture in the soil for future use. Since plants take their food only when dissolved in water, we know that if there is no moisture in the soil there is no food there that can be used by the plants. Of course, the yield of the crop is cut off under such conditions.

In many cases, and especially on light soils, the weeder may be used as effectively as the harrow after breaking. The better time for the use of the weeder, is after the seed are planted. Even before the young plants are out of the ground, weed and seed grass are getting ready to come up with them. The weeder dislodges these seed, destroys them, and at the same time helps the corn or cotton seed to get through. Thus we have the young crop ahead of its enemies. By repeated use of the weeder every time a rain starts noxious seed to germinate, we may never see the much dreaded coat of young, vigorous grass. The work of the weeder is economical. A man and a horse can easily cultivate ten acres or more per day. Furthermore, the teeth, or fingers, of the weeder work among the young plants and destroy weeds that would later have to be gotten out by expensive hand hoeing, if a side plow had been used instead of the weeder. On stiff, heavy soils, a spike toothed harrow sometimes does better work than the weeder.

Probably the greatest caution to observe in the use of these implements is to run them at the proper time. After the grass forms a green carpet over the field, it is then too late for the weeder. The implement will destroy some of the grass, but will cultivate the remainder so that it will grow all the faster. Just as soon after a rain as the

Newsy Items of Interest Condensed for Busy Readers.

Some time during the early morning hours, supposedly between 1:20 and 2:00 o'clock, Mr. Victor Watson York, night watchman at the Milrose Mills, sent a bullet through his own heart, death resulting instantly. Fayetteville, April 11.—The body of a negro man later identified as Tom Johnson, who came to Cumberland from Chatham county in search of his grandchildren, and disappeared about five weeks ago, was found near the Atlantic Coast Line railroad, four miles north of Fayetteville, Friday evening, by section hands. The coroner's jury declared that his death was due to exposure and starvation.

Wilson, April 11.—This morning a dog foaming at the mouth and snapping at everything run amuck in the southern portion of the city. A white lad, two negroes and three dogs were bitten. All of the dogs were killed, and the head of the mad dog was sent to Raleigh. A telegram was received from Raleigh saying the dog was undoubtedly mad.

New Bern, April 11.—Fire at 11 o'clock last night at Meadows Marine railway burned several lumber sheds and store houses, valued at \$1,000. The loss is covered by insurance. The new blacksmith shop of F. W. Shriner adjoining was also burned with a loss of \$200.

Squire John M. Stout, of Alamance county, on Tuesday, April 5th, rounded out the one hundredth year of his life, and leaving the old century with its triumphs, its joys and its sorrows behind him, he starts upon the new century with a body as straight as that of a man of 25 and with his mind little impaired by the ravages of time.—Greensboro Record.

Mr. Andrew Joyner received a telegram yesterday afternoon notifying him of the death of Mrs. Mary Winfield Joyner, wife of his brother, Rev. Edmund Joyner, at the home of her son in Columbia, S. C., yesterday morning at 11 o'clock from an attack of pneumonia. The deceased resided at Tryon, N. C. She was in Columbia on a visit to her son, when she was stricken.—Greensboro Record.

soil is dry enough to admit the weight of the horse without packing, the weeder should be run over every acre that needs it. We may thus do two or three days' work before the soil is dry enough to admit the cultivator or deeper running implements.

Harrows and weeders are not intended for breaking land, but for the cultivating the surface of plowed soil. When a weight has to be placed on the harrow to force it into the soil, then we know the land has not been properly broken, or that it has become too hard for the use of the harrow.

What is a Bucket Shop?

Most of the people of the United States, in spite of the lively activity of the gambling spirit do not know what a "bucket shop" is. The simultaneous institution of legal proceedings by the Federal Department of Justice against a number of rich concerns operating bucket shops in various cities of the country makes the majority of newspaper readers wish to know the nature of such a shop.

A bucket shop is an office where bets are made on the movements of the stocks on the stock exchange, without the actual purchases or sales of these stocks. Bucket shop people manage, by various devices, to acquaint themselves of stock exchange fluctuations as soon as these figures are known on the stock exchange itself. The ability of the bucket shop operators to secure such information over telegraphic wires has for a long time constituted a scandal, and it is reported that the government contemplates making a telegraph company a party to the proceedings just indicated.

Your real broker buys and sells stocks for his customers on a margin, if they wish, but nevertheless on a basis of possessing and being able to deliver the property. Such a dealer has regular connections with the reputable stock exchanges and has the goods at his command. There may be too much leeway for the spirit of speculation in this, and there are abuses in the stock exchange methods; but the bucket shop is an affair of fraud and false pretense. It
