ALBERMARLE PRESBYTERY.

Holding an Interesting Session in Washington.

Washington, N. C., April 13.—Albermarle Presbytery convened in the Presbyterian church at nine thirty this morning for its first business session. The first subject on the program was a discussion of the present status of Peace Institute at Raleigh, and resolutions were introduced by Dr. Mc. C. White that the Presbytery assume a closer relation to the school, and appoint two directors on the school board. These resolutions were accepted, and the nomination of directors for school were placed in hands of nominating committee.

At his request Rev. C. G. Christian was dismissed from Albermarle Presbytery to enter Savannah Presbytery.

The narratives of the different churches were then read and the different reports placed in the hands of appropriate committees.

The Raleigh First Church called Rev. S. D. Watkins, of Bristol, N. C., as associate pastor. A call from Greenville church to Rev. R. C. Deal for one half his time was placed in his hands and accepted, also a call from Wilson church to Rev. G. C. Shive was read, but in his absence this was tabled until a later meeting.

Then there was a free discussion of the state of religion in various fields, making a very good showing. Deacons Muth, of Edenton and Moss, of Falkland, made reports of their respective churches. Mr. W. L. Hill made a very satisfactory report on Barium Springs Orphanage.

A call from Cann Memorial church, Elizabeth City, was placed in the hands of Rev. F. M. Hawley and accepted. Dr. White, of Raleigh, as principal and Rev. R. C. Deal, of Kinston, as alternate, Elder C. A. Lewis, principle and Elder C. R. Daniel as alternate were appointed commissioners to the General Assembly at Louisville, W. Va., in May. During the day Rev. M. T. Plyler, minister and Rev. A. McCullen, presiding elder of the Methodist church, and Rev. R. V. Hope, of the Christian church, were introduced to the Presbytery and invited to sit as visiting brethren.

At the night session ex-Gov. R. B. Glenn addressed a large audience on home missions making a strong talk and creating a profound impression on his hearers.

WOMAN'S UNION.

Washington, N. C., April 13.—The Woman's Missionary Union of Albermarle Presbytery also convened in the Methodist church at ten this morning for a two days' business session. Mrs. Samuel Watkins, the vice president, presided. Quite a large number of delegates were in attendance, a number of papers and reports of the different societies represented were read, giving glowing reports of the work done in both home and foreign mission fields. It was decided to separate from the Presbytery and work as an independent body of their own.

Upset a Lamp.

Wednesday night in the joint office of Messrs. N. W. Outlaw and J. L. Wooten on Third street, Mr. Wooten accidentally turned over a lamp that came near causing a blaze. The burning oil flowed out on the table and floor, but was put out before any damage was done to the building.

STATE NEWS.

Newsp Items of Interest Condensed for Busy Readers.

Durham, April 13.—In the Watts hospital Mrs. Lucy Holt lies at death's threshold, her brother, Isaac Terry, is desperately ill, her little daughter was yesterday taken away dead, and she is a widow of two weeks only.

His friends throughout the State will regret to learn that Col. Paul B. Means, of Concord, is critically ill. He has been sick for some time and is now in a Charlotte hospital. Hope for his recovery, says the Charlotte Chronicle, is abandoned.

Wilson, N. C. April 13.—The many friends of Hon. F. A. Woodard will be glad to know that he is improving from an attack of nervous prostration. His physician says he barely escaped a stroke of paralysis, but with a much needed rest he hopes for his recovery. In a few days Mr. Woodard will take a trip to recuperate his failing health.

Raleigh, April 13.—The state board of health is getting out a 45-page bulletin that is designated as "The Preacher's Bulletin for Sanitary Sunday, April 24, 1910." Dr. Rankin secretary of the board, estimates that there will be something like 3,000 special sermons of health and sanitation delivered from the North Carolina pulpits in every section of the state April 24. The bulletin suggests as a special text for the day is John x. 10—"I am come that they might have life, and that they might have it more abundantly."

Bankrupt Played Joke.

Raleigh, April 12.—The bankruptcy case of C. J. Rhodes, merchant of Wendell, this county, was up for the first meeting of the creditors today when J. B. Cheshire, Jr., was selected as trustee, errin Busbee being the referee. The assets amount to \$1,200 in cash. It is in this case that a laughable joke is told on Deputy United States Marshal R. W. Ward. He went to Wendell to serve the bankruptcy papers on Rhodes. He stopped a stranger to ask where Rhodes lived. The somewhat indifferent reply was that the house just through the grove was the Rhodes dwelling; that Mr. Rhodes was not at home, but that he could see Mrs. Rhodes. Marshal Ward then asked the stranger if he would be kind enough to hold his horse while he walked up to the house, as it would be impossible to drive the buggy. The stranger did this and received the thanks of Mr. Ward. A little later at a corner store the Deputy Marshal asked of a group of men where Rhodes had gone. They replied that he had not gone anywhere and that they noticed him only a little while before holding the deputy's horse.—Greensboro News.

CENSUS BEGINS FRIDAY

Host of 70 000 Interrogators Will be Turned Loose.

With the break of day on Friday, the 15th instant, a host of 70,000 interrogators—men and women, white and colored—will be turned loose in pursuit of the people of the United States. On that day Uncle Sam will begin the numbering of his children in preparation for the thirteenth census. He estimates that he has a family of about 90,000,000 men, women and children, and he has already employed and will then put to work a body of enumerators considerably greater than the standing army.

The law provides that the enumerators shall begin on the 15th, but it is not so peremptory about the commencing time as about the closing time, and already intimations have been received that in some instances the work may be postponed until Saturday. This is due to the fact that the 15th falls on Friday, and among the 70,000 name takers there are some who are superstitious as to this day of the week.

The enumeration will cover all of the 45 States and two Territories of the union proper and also Hawaii and Porto Rico, Alaska, the Philippine Islands and Guam will not be included, as special arrangements are made for numbering the people of those dependencies.

Trade Report.

Richmond, Va., April 13.—Bradstreet's Saturday will say for Richmond and vicinity:

Trade in general continues about as reflected in recent reports. Seasonable weather has favored spring trade and sales in seasonable lines have been satisfactory. Wholesalers of dry goods report fair ordering. Manufacturers of and dealers in shoes report active sales. Reports from Danville, one of the largest leaf tobacco markets, indicates general activity in all branches of the tobacco business; that market reports sales in excess of any previous year. Produce is in fair demand. Wholesale grocers report a good business. Manufacturers of and dealers in agricultural implements and fertilizer report satisfactory sales, indicating activity in early farming operations. Early spring and winter crops are reported in good condition. Building is active. Naval stores are firm at recent prevailing prices. Retail trade shows improvement. Collections are fair.

Gov. Patterson Pardons Cooper.

Nashville, Tenn., April 13.—While the Supreme court of Tennessee today was confirming the conviction of Col. Duncan B. Cooper for the slaying on November 9, 1908, in a Nashville street of former U. S. Senator E. W. Carmack, Governor Patterson wrote a full pardon for the defendant declaring that in his belief Colonel Cooper was not guilty. The Supreme court remanded for re-trial the case of Robin Cooper, convicted of the same crime as his father.

The situation is tense tonight, because of allegations by friends of Carmack that politics entered into the case. It is probable that Robin Cooper will never be retried, it is said. Both Coopers had been sentenced to 20 years' imprisonment.

Clean Up Week.

At the request of the Civic League of the town of Greenville the Board of Aldermen have designated the week beginning April 18th, as clean up week, during which time all the town horses and forces will be used for removing the rubbish and trash from all portions of the town. In order to the more thoroughly accomplish this result the town wagons will remove rubbish and trash from the following portions of the town on the following named days:

First Ward, That is that portion of the town lying north of Third street, on Monday, April 18th.

Second Ward, That is all that portion of the town lying between Third street on the north and Fifth street on the south, on Tuesday, April 19th.

Third Ward, That is all that portion of the town lying in the angle formed by the intersection of Fifth street and Dickinson avenue, on Wednesday, April 20th.

Fourth Ward, That is all that portion of the town lying in the angle formed by the intersection of Dickinson avenue and Evans street on Thursday, April 21st.

Fifth Ward, That is all that portion of the town lying between Evans street and Fifth street on Friday, April 22nd.

All persons having trash to remove in their various wards will place the same upon the streets on these days and it will be removed by the town wagons.

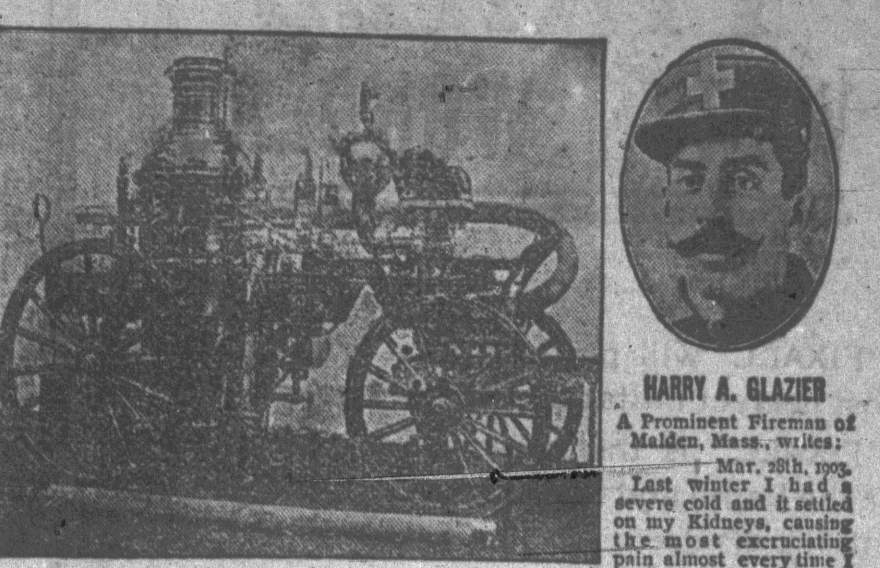
