## CONFEDERATE MEMORIAL DAY.

The Veterans Have Annual Reunion and Enjoy the Day.

Once more Memorial day has come, and with it the annual reunion of the survivors of the Confederacy. There are not many of the gallant old wearers of the gray still with us, and it is indeed a pleasure to see them come together on these reunion days. Not only is it a joy to them to meet their comrades in arms once more and talk over again the thrilling and trying scenes through which they passed back in the sixties, but it is also a joy to those who are younger—those who know not of those days of warfare except as it was told them by their ancestors or learned through history—to mingle with the gallant heroes. It is a pleasure to greet them. It is an honor to honor them. Theirs was a noble cause, and they defended it bravely. The sacrifices they made, the hardships they endured, makes them indeed heroes worthy of all honor and praise.

The committee in charge of the program of arrangements for the day, deemed it best because of the feeble condition of many of the old soldiers, to omit the march to the cemetery to witness the decorating with flowers of the graves of their comrades who had "passed over the river," and this part of the exercises of the day was left with the Daughters of the Confederacy. These met together and proceeded to the home of the dead to place their tribute of love and honor upon the graves of the departed heroes.

The old soldiers assembled on the court house square at 10:30, and all moved in column down Evans street and out Dickinson avenue to the Star warehouse, where a large crowd awaited them.

The assemblage was called to order by Maj. H. Harding, commander of Bryan Grimes Camp, who turned the exercises over to R. W. King, master of ceremonies, who announced the following program:

Invocation by Rev. B. F. Huske.

Song, "America," by a class of the 6th and 7th grades of the graded school.

Words of Welcome, by F. C. Harding; representing the mayor of the town who was prevented being in attendance.

Song, "The Old North State," by graded school class.

Introduction of orator, by D. C. Moore.

Memorial Address, Plato Collins, of Kinston.

Song, "Tenting on the Old Camp Ground," by quartette.

Benediction, by Rev. D. W. Arnold.

Song, "God be with you 'till we meet again" by quartette.

Mr. Collins took for the subject of his address "The Women of the Confederacy." To the women he paid a most beautiful tribute, picturing the privations, the hardships, the suffering they endured while fathers, sons, brothers and lovers were at the battle's front. He gave a number of illustrations of the noble deeds of heroism of women during the great struggle.

Just before the last song and benediction the veterans, led by Maj. Harding, gave the Rebel yell with enthusiasm and were loudly applauded.

At the conclusion of the exercises the veterans marched to the Gum warehouse where a bounteous dinner was served. As they were dispersing they several times raised "three cheers for Greenville."

## GRIFTON GRADED SCHOOL.

Closes With Brilliant Exercises and Bounteous Dinner.

Hanrahan, N. C., May 10.—We had the pleasure, and it was indeed a pleasure, of attending the commencement at Grifton. By 10:30 the academy was well filled, and before eleven it was filled to overflowing by those anxious to hear the address by Prof. Carlile. The exercises began with a song and chorus by the school, followed by an invocation and thanks to the Most High for guidance and blessings, at the close of which Prof. Brothers stepped to the front of the rostrum and in a few well chosen words expressed his regrets that Prof. Carlile could not come, but said that he had made provision for the occasion by sending in his stead J. E. Hoyle, a senior student of Wake Forest. Then a beardless boy of perhaps 13 summers stepped to the front. From start to finish he held that entire audience spell bound. His rhetoric was perfect, his diction fine, his oratory sublime, with one well rounded sentence following another, with that beauty that only another who has had training under such men as Carlile can display. Wake Forest has the reputation of sending out orators from her walls, and Hoyle on this occasion did not in the least lower her standard.

His theme was "Patriotism" as it once existed and as it should exist today and will exist if home and school combine to do their duty in teaching true patriotism. We will not do him the injustice of attempting to give an outline of his speech, but will say that Wake Forest need not hesitate to send him out to fill any of their places on an occasion like that.

After the speaking came the dinner spread on the campus, and all will bear me out in saying that none went empty away, but after all had partaken of all they would there was left to be gathered up many things. From the way that table was loaded with meat, chicken and other things one would have thought that the trust on eatables was busted. We are called upon to say just here, that the crowd could not have been more orderly even though the dinner had been served at a private home.

Next at 4 p. m. came the ball game of which you had a report.

By 7:30 p. m. the academy building was again filled until there was barely standing room to witness the program for that evening. The exercises were opened with a duet by Miss Hines, the teacher, and one of her pupils who had taken music but one school year. Newsy Items of Interest Condensed for Busy Readers.

Two young men were killed by a train in Rocky Mount Saturday night. They were Wilbur DeVault and Roy Gainey, both of Clinton, who worked at the cotton mill in Rocky Mount.

A bold attempt was made by William Skipper, John McFarland and C. L. Norris, prisoners confined in the county jail, to gain their liberty early yesterday morning. It will be remembered these same prisoners made their escape by picking the wall of the jail about ten days ago. As all 3 had been arrested again, Skipper in Norfolk, Norris in Greenville, and McFarland in this city, the city did not dream that another attempt for liberty would be made, but on yesterday the attempt was made and came near succeeding.—Washington News.

A most serious runaway took place yesterday, in consequence Editor James L. Mayo of the Daily News and Mrs. Mayo are hurt painfully if not seriously. Why their two children, Lacy, three-and-a-half years of age, and Elizabeth, just a little over one year old, were not hurt is a miracle. **The One-Horse Farmer.**

"Being convinced that one horse can not break land satisfactorily or economically, and that two horses will enable the farmer to prepare the land better and more economically, we want to inquire if a system of co-operation can not be put into practice by the one-horse farmers of any neighborhood which will virtually make them two- and three-horse farmers in the breaking and preparing of the land. Surely one good two-horse plow will cost no more than two one-horse plows. Two horses and one two horse plow will break as much land, and do it better, than two horses and two one horse plows. One reversible disk harrow and three horses will bed more land, pulverize more and do more towards preparing the land for planting, than three horses and three one-horse plows. In these comparisons any difference in the quantity or quality of work is on the side of the two-horse implements. The saving of man

labor will more than pay any difference in the cost of the implements.  
Any two one-horse farmers can, therefore, become two-horse farmers by the purchase of one two-horse plow and a reversible disk and a smoothing harrow and do at least one half more work than they are now doing, and do it better. They may be two-horse farmers in so far as the breaking of the land and preparing it for the crop is concerned. Furthermore, by the use of the smoothing harrow they can be two-horse farmers in the early cultivation of their crops. By the use of the weeder they can still further continue methods of cultivation resembling the approved practice of the two-horse farmer.  
After this by the use of light one-horse cultivators, they can do about as satisfactory work as the two-horse farmer, although at a higher cost. This is an age of combination and co-operation. Will the one horse farmers who really wish to do better farming consider this plan? Will they co-operate to the extent of buying the implements in combination and preparing the lands by joining their team force? Such a plan is not equal to individual ownership of two horses and the needed implements, but it is infinitely better than the one-horse methods now in use. It may be made the means of any two neighboring one-horse farmers doing better farming than they can possibly do working separately with one horse.—Raleigh (N. O.) Progressive Farmer and Gazette.

The night letter telegrams have proven a boon to many, but there are patrons that find them somewhat baffling.  
"Look at that man biting the end of his pen over there," the manager of a Broadway office said. "He is trying to think what in the world to say to use up the 50 words he is entitled to. I like to watch 'em in here at night. Most of them have more trouble trying to think up 50 words than they ever did in keeping their messages down to ten. AS CRAZY AS A LOON.

Old Phrase Seemingly Not a Libel on That Eccentric Bird.

"One often hears the expression 'As crazy as a loon,' and yet I wonder," says a writer in St. Nicholas, "how many realize how peculiarly fitting it sometimes is. Of all the birds and animals that have come under my observation I know of none that in any degree approaches the loon for sheer craziness or weirdness.

"Evening seems to be the loons' favorite time for their peculiar behavior. They collect in the middle of a lake, and when they have summoned all of their kind within hearing of the ball commences. They raise their bodies half out of water by furiously flapping their wings, at the same time making a most terrific splashing.

"They then propel themselves backward and forward, half swimming, half flying, all the while screaming at the top of their voices. They keep this up from ten to fifteen minutes and seem to get a great deal of satisfaction out of it. In the calm of a summer evening and aided a bit by the echoes a half dozen loons can make the fellows in a college cheering section hang their heads for shame.

"The loon is not only crazy acting, but at times is very aggravating. Perhaps—for instance, after a hard day—you are sitting by the campfire, quietly smoking and at peace with the whole world. Suddenly there breaks upon your ears the most bloodcurdling scream, followed by heartrending cries. Your first thought is that there is a child being murdered or a woman in distress, and you start to your feet. Then you realize it is only a loon.

"Or perhaps, having turned in, you are sleeping the sleep that comes only in the pine scented north. Again you start and wake as you hear a long, mournful cry echoing through the forest and involuntarily exclaim, 'Wolves!' There is a grunt, and the sleepy voice of your guide comes from the depth of his blankets, 'Non, m'sieu'; loon.'

"In the morning a hunter arises bent on vengeance for his broken repose and resolves to destroy the fiend as he sits mirrored in the lake. Although the modern cartridge rifle gives no warning of the shot, as did the old fashioned flintlock with its 'flash in the pan,' nevertheless the loon nearly every time seems to know when the bullet is coming and dives just in time to escape. Immediately after the discharge of the rifle the loon is serenely up again, his mocking laughter being but an added irritation. On the whole he seems rather to enjoy the performance.

"As a diver the loon excels, and naturally, for it is his sole means of livelihood. Not only is he marvelously quick, but he can remain under water for a seemingly endless time. In swimming under water he uses both wings and feet and can go for several hundred yards in this fashion. The loon, like many other water fowls, sleeps on the water with his head tucked under his wing.

"Several summers ago a friend of mine while camped on Lake Kiamika was out for an early morning paddle. It was just after dawn and very still. Out on the lake he espied a sleeping loon, and by dint of careful paddling he actually succeeded in approaching and capturing him. Proud of his capture, he took the loon ashore and tethered him to a stake. The loon struggled at first, but after awhile seemed to become reconciled. All went well until nightfall. Then the loon set up such a hideous outcry and kept it up so persistently that before morning he had earned his freedom."

How to Light a Solid Body.

Cadogan Morgan was the first electrician to experiment with electric light in solid bodies. This was in 1785. He first inserted two wires into a stick of wood and caused the spark to pass between them. This had the effect of illuminating the stick a beautiful blood red. An ivory ball, an orange or an apple may be lighted in the same manner. Some experimenters prefer the lemon for this purpose, it being very susceptible to the electric discharge, flashing forth at every spark as a spheroid of brilliant golden light. The wires used for this purpose should be brought within about half an inch of each other inside the lemon.

On Feb. 22, 1819, east and west Florida were ceded to the United States by treaty and purchase, Spain receiving \$5,000,000.

CRUDE ASTRONOMY.

Russian Peasants Have Queer Ideas of Sun, Moon and Stars.

Dr. Raymond Crawford, the author of this odd historical sketch, believes that the king's trouble was not apoplexy, but Bright's disease.
