## STATE NEWS.

### News Items of Interest Condensed for Busy Readers.

Washington, May 12.—The president today nominated Jesse A. Giles to be postmaster at Durham, N. C.

There was a jail delivery at Snow Hill, Wednesday night. A negro man in jail for larceny secured an iron bar, presumably from someone on the outside, and with it worked a hole through the brick wall and made his escape through the aperture. Another prisoner refused to leave, when offered his liberty, and was found in jail by the sheriff this morning.

Davidson, N. C., May 12.—Samuel O. Fleming, a member of the senior class of Davidson college, died very suddenly this afternoon shortly after dinner. He went to his room to rest, being very tired from having stood an examination today. He did not go to supper and his room mate on going back to the room, found him lying on his back dead, the muscles of his body being very tense. The cause of his death is unknown, but it is presumed to have been an attack of heart trouble.

Charlotte, May 12.—Former Congressman William Horton Bower, for years a leader in Western North Carolina politics, passed away this afternoon at his home in Caldwell county, aged 60 years.

Asheville, May 12.—The general conference today adopted a resolution to go into the election of bishops and all connectional officers at 10 o'clock next Monday morning. The committee on episcopacy will hold another meeting tonight, and it is likely will report to the conference tomorrow morning, making their recommendation as to the number to be elected.

Shipments of 703 barrels of whiskey, consigned to eleven white men and three negroes, since January 1st were revealed by the records produced by the Seaboard Air Line Railway today before Mayor MacRae. ### Little Harry Whedbee Dead.

Little Harry, aged about one year and eight months, son of Mayor and Mrs. H. W. Whedbee, died at 11 o'clock Thursday night at their home in West Greenville. The child had been sick for three weeks, much of the time being in a critical condition. Several times during the sickness its life was despaired of yet successive rallies caused hopes for its recovery to spring anew in the hearts of the watchers by the bedside. But other complications in the last day or two were more than the little sufferer could stand, and the end came peacefully Thursday night. The heart broken parents have the sympathy of every one in their great sorrow.

The funeral will take place Saturday morning, interment in Cherry Hill cemetery.

### How Stock Raising Will Help.

The increase of stock raising in the South means the coming of so many advantages that it is hard to enumerate them all at once.

It means that we are to get two profits from our crops instead of one—one profit from growing them and another from feeding them.

It means that we are to begin building up our lands instead of running them down.

It means that we are to use fertilizers more economically and get better results from their application.

It means that we are to become more business-like farmers, keeping in closer touch with markets and the business world.

And still another advantage which has been little thought of, is that it will make for a greater stability and efficiency in farm labor. Stock raising will demand the services of laborers all the year round, and by affording constant employment, and at better wages than are now paid, we shall get a more intelligent and more profitable class of farm labor.

It is to be hoped, moreover, that this result will give yet another blow to the old false idea that cheap, unintelligent labor is a help to any community. A laborer who is worth \$2 a day will make you a bigger profit than a laborer who is worth only 50 cents a day, just as surely as a \$2 investment will bring more interest than a 50-cent investment.—Raleigh (N. C.) Progressive Farmer and Gazette.

### Kill the Grass as it Starts.

It is an easy job to go rapidly over a field with smoothing harrow before the crop comes up and then with the weeder keep down every sign of crust. It takes a mere scratch to destroy grass that is just germinating from the seed, and if you keep up the shallow cultivation through the season, you kill all the grass seed that are within the limit where they can germinate. But the man who waits for the grass to get the start has to turn a lot of earth to cover it, and he brings up more seed near the surface to sprout, and has the slow work to do over again, all because he did not have an implement that he could run rapidly over several rows before the grass got a start.—Raleigh (N. **PERPETUATE COUNTY HIS ORY**

The recent reunion of Confederate veterans on Memorial day, reminds us that at the reunion a year ago a monument was started to raise a popular subscription to erect a Confederate monument here. Several subscriptions were made and published in The Reflector shortly after the reunion, but interest in the contemplated movement soon lagged. Nothing was said about the matter at the recent reunion that we have heard of, so it is taken for granted that the movement stands about where it did a year ago.

In Pitt county the matter of perpetuating the heroes of the Confederacy and the part the county took in the civil war, as well as other historic events, has been too long neglected. The county has made a record of which she may well feel proud, and before it is too late some means should be adopted to perpetuate this record for coming generations. In this connection The Reflector is going to offer a suggestion that it believes is better than erecting a monument.

Pitt county is about to begin the erection of a new court house. It is the purpose of the board of county commissioners and building committee to make it a handsome building, one that will be the pride of the county and ample for years to come. It is the wish of all people of the county that this be done, for the county is amply able to do so. There is no better place for permanently recording the historical events and valor of the county than on the walls of this court house, and the time to plan and arrange for this is before work on the building begins.

In constructing the courtroom or halls, or both, slight depressions could be made in the walls for the placing of historical and memorial tablets, and on such tablets the history of the county could be given. This would add both to the appearance and interest of the court house, and to prepare the walls for the tablets would add nothing to the cost of the building. As to the tablets themselves these could be placed from time to time as they might be provided for by popular subscription or otherwise. A county historical society or committee could be appointed to collect the data for the tablets and see that they were properly arranged, so that the history of the county may be preserved and easily accessible.

We would like to see this suggestion adopted and invite expressions of opinion from any one who may feel interested in it.
