## DEATH OF CAPT JOHN KING

One of County's Most Prominent Citizens Passes Away.

Capt. John King died about 6:30 o'clock, Saturday afternoon, at his home near Falkland, of pneumonia. The funeral took place Sunday afternoon, conducted by Rev. Mr. Morton, of Farmville, and was largely attended. He was 80 years old last February.

In the death of Capt. King, Pitt county loses one of its best and most influential citizens. He was a native of the county, and for more than half a century after reaching man's estate lived on his farm near Falkland, with the exception of four years just after the war that he engaged in merchandising in Tarboro. He was an even tempered man, all ways firm in his decisions, yet without harshness, ever having the highest consideration for others. For twenty-five years he was a magistrate of his township, and was looked up to as a leader. He was a staunch Democrat, and always took active interest in the conventions and affairs of his party. He represented his county in the State senate, and was one of the first judges of the county inferior court when that court was established. He was a member of the Christian church and lived a faithful follower of Christ.

Capt. King was thrice married, his first wife being Miss Martha Joyner, second Miss Bettie Cobb and third Miss Fannie Bynum. His last wife died about eight years ago. By his first marriage there survived one daughter, Mrs. B. R. King, of Goldsboro; the surviving children of his second marriage are Mr. G. B. King, of Washington City, Mr. E. C. King, of Falkland, and Mrs. J. L. Fountain, of Asheville; by his third marriage Mr. A. B. King, of Goldsboro, Mr. S. V. King, of Charleston, Va., and Mr. John King, of Falkland. All of his children were with him during the last few days of his illness and when the end came. He is also survived by one brother, Col. W. M. King, of Greenville, and two sisters, Mrs. C. V. Newton, of Fountain, and Mrs. Nannie Moore, of Farmville.

## HORSE BREAKS BUGGY IN TWO

Not Frightened, but Getting Out of the Way of Danger.

About midday Sunday Mr. W. H. Dail, Jr., left his horse and buggy standing in front of the residence of Mr. R. L. Smith while he went in to the porch for a few minutes chat. Mr. Evans Sledge came by in an automobile, and running the car rather close to the horse and buggy, the animal deliberately mounted the sidewalk and tried to pull the buggy up after him. The front wheels of the buggy went up all right, but the curbing was so high that the rear wheels hung, and the hard pull snapped the wood work in two, leaving the body and rear wheels of the buggy in the edge of the street while the horse walked up in the yard with the shafts and front wheels. The horse did not appear to be at all frightened, but seemed to display animal instinct of getting out of the way of supposed danger.

## NOMINEES IN WAKE PRIMARY.

Unofficial Returns Show Mass Meeting Ticket Loses but One Candidate.

The unofficial figures of the Democratic primary in Wake county make the nominations as follows:

For the Senate, E. W. Sikes. For the House, Richard H. Battle, E. R. Pace, John T. Judd. For Clerk of Court, Millard Mial.

For Sheriff, J. H. Sears. For Register of Deeds, C. H. Anderson.

For County Treasurer, George T. Norwood. For County Commissioners, G. M. Bell, B. S. Franklin, I. H. Lynn.

It was not until last night that the final returns came in, these from Rolesville, and with these the result of the election, based on unofficial figures was made known.

Sheriff J. H. Sears, of Apex, from these figures, has defeated Mr. Hal D. Rand, of Garner, by a majority of 83 votes. Mr. Millard Mial, by the same figures, defeats Clerk of the Court Russ by a majority of 59 votes.

The majority of Dr. E. W. Sikes, of Wake Forest, over Mr. W. B. Jones, of Raleigh, for the State Senate is 375.

The complete returns for county and legislative officers is set out in a tabulation of the vote given in this issue, which shows the number of votes each candidate received. The entire Mass Meeting ticket, with the exception of Mr. Hal D. Rand, for sheriff, was nominated.

The county convention will be held in Raleigh next Saturday at noon. The anti-ring forces have 22 out of the 36 members of the county executive committee, and over 100 out of the 160 delegates to the Democratic county convention.—Raleigh News and Observer.

Mrs. Cherry's reading of selections in the negro dialect from such writers as Mary Fairfax Childs and Thomas Nelson Page showed her to be not only an entertainer, but an artistic one.—Rochester, N. Only a few build air ships, but any of us can build air castles.

If it does not look like Harry W. Whedbee is going to be the next Superior court judge of this district, we do not read the indications correctly.

In celebrating the one hundred and second anniversary of Dayton, Ohio, The Daily News of that city issued an edition of over 200 pages. It is one of the largest, finest and best illustrated papers ever published in the United States.

United States Senator Gore, the blind senator of Oklahoma, startled the senate Friday with the announcement that an effort had been made to bribe him in connection with the fees of certain Indian agencies. The senate has ordered an investigation of the matter.

The result of the primaries in Wake county Saturday show that the mass meeting or "insurgent" ticket was nominated. Be the result as it may, it is the duty of the Democrats of that county to get together and support the nominees of the primary.

There are many who do not like him nor his policies, but there is no shaking off the impression that just now Theodore Roosevelt stands in the forefront as the biggest man in the country, and possibly in the world. If he decides to express himself, the next Republican national convention is going to do exactly what he says. He can be absolute dictator of the party if he wants to be.

We hear that there is a movement on foot to try to get the incoming board of aldermen to give Greenville an "open Sunday," that is to let cold drink and cigar vending places stay open and sell goods on that day. It is to be hoped the aldermen will not yield to any such entreaty, for to do so would not be creditable to the town. There is no need of such places to be open and such things to be sold on Sundays.

Editor W. C. Dowd, of the Charlotte News, has been re-nominated in Mecklenburg county for the legislature, and will again be a candidate for speaker

of the house. Mr. Dowd has twice before been a candidate for speaker, and missed it by only a small majority. He is in every way qualified for this honor and should have it, and the house would honor itself by electing him speaker.

The municipal authorities of Gastonia have prohibited the druggists selling cigars and soft drinks on Sunday and the druggists have decided to close for the entire day. Persons who want medicine in Gastonia on Sunday will have to look up the druggists. As a matter of fact, the keeping of drug stores open on Sunday, to sell medicines, even, isn't so much of a necessity as it appears. The real necessary business in medicines on Sunday is very limited except on rare occasions, and the druggists could observe very short hours on that day without seriously inconveniencing anybody. Keeping open drug stores on Sunday furnishes a resort for loafers, and the sales of cigars and soft drinks, where such sales are allowed, is the chief business. Where this is permitted for any length of time it is soon demanded as a matter of necessity. If the sale of cigars and soft drinks is a necessity on Sunday, the sale of ice cream, fruits, etc., is just as necessary. Carrying it a little further, the sale of fresh meats on Sunday can be construed necessary, and by and by some excuse could be offered for doing almost any sort of business on Sunday.—Statesville Landmark.

is worn at the death of a relative and  
is intended to express the belief that  
the deceased has gone to heaven. In  
Egypt and Burma yellow is worn, to  
symbolize the sere and yellow leaf.  
—London Answers.

## Really Antique.

An excellent plaster of paris cast  
may be seen in one of the Egyptian  
galleries of the British museum of the  
famous sycamore statuette known as  
the "Shelb-el-Beled," or "Village  
Sheikh." The original dates from 3900  
B. C. and is still in perfect condition,  
although it is the oldest known speci-  
men of woodcarving. It represents an  
overseer of the workmen engaged in  
building the pyramids, close to Sakka-  
rao, where it was discovered.—London  
News.

## ACCUSED AS A WITCH.

Tried For "Conversing With the Devil  
in the Form of a Cat."

Jane Wenham was indicted at the  
Hertfordshire assizes on March 4, 1712,  
for "conversing with the devil in the  
form of a cat," under the provisions of  
the act of 1604, repealed in 1736. Her  
prosecutors wished to have her also  
indicted for practicing witchcraft to  
the harm of Ann Thorn, a servant girl  
sixteen years old, but this was not  
allowed, although evidence was pro-  
duced at the trial to show what injury  
had been done the victim by means of  
crooked pins and by placing eases and  
cats' hairs in Ann Thorn's pillow and  
how the prisoner had caused the death  
of some cattle simply by walking  
through a turnip field.

The jury brought her in "guilty,"  
and Mr. Justice Powell passed sen-  
tence of death, but took steps to quash  
the verdict. Wenham's prosecutors  
published an account of the case, but  
their arguments were pulverized by  
scientific men. Jane Wenham herself  
was liberated and taken under the  
protection of Colonel Plummer, who  
gave her a cottage, and we are told  
by Dr. Hutchinson that in 1720 the  
whole country was fully convinced of  
her innocence.—London Spectator.

## Do You Know This Flower?

Among the guests at a summer hotel  
in Vermont was a scientist from  
Boston, noted for his botanical re-  
searches, and a woman desirous of im-  
pressing him with her stores of gen-  
eral knowledge; also she affected a  
deep interest in all matters pertaining

## Watch Your Shoulders.

When standing before a looking glass  
notice if your shoulders are the same  
height. Generally the right is higher  
than the left. The reason for this un-  
evenness lies in the way one sits. You  
get into a comfortable chair at your  
desk, and at once you rest your right  
elbow on the arm of your chair or  
your desk, thus throwing one shoulder  
higher than the other. This is especi-  
ally the case where one writes a great  
deal. When you notice that one shoul-  
der is higher than the other the thing  
to do is to change your way of sitting  
at your desk. Two simple exercises  
will be beneficial. The arm of the low-  
er shoulder should be extended up-  
ward, the hand grasping a dumbbell.  
That of the higher shoulder should be  
lowered and made to support a heavy  
weight.

## The Sleep of Seeds.

Oats, corn, fennel and some flower  
seeds were exposed during 118 days  
to a temperature of 40 degrees F. be-  
low zero. Afterward when placed in  
suitable surroundings nearly all of the  
fennel, oat and corn seeds and many  
of the others germinated. It is con-  
cluded that the protoplasm, or the  
principle of life, in a resting seed is  
in a state of inaction not comparable  
to that of a smoldering fire, but rather  
like that of a chemical mixture which  
is capable of forming a combination  
whenever the required conditions of  
temperature and illumination are pres-  
ent.

it would be fine fun to play the critic  
of his own work, so chimed in ironi-  
cally:

"A masterpiece? I don't in the least  
agree with you, sir. I'm a musician  
myself, so know what I'm talking  
about. The fact is this opera is a  
worthless production and brimful of  
imitations and plagiarisms. For in-  
stance, that cavatina is fished bodily  
from Berlioz, the duet in the first act  
is all Gounod, while the finale is a  
sorry copy of one you will find in  
Verdi."

Next day Leoncavallo drove to the  
railway station and bought the leading  
local journal. On comfortably seating  
himself in the train he opened it and  
was aghast with astonishment at en-  
countering the following lines:  
"Signor Leoncavallo's opinion on  
'Pagliacci.' Declaration of plagiarism.  
Confession of a composer bereft of all  
originality."

The great Italian master added, "Evi-  
dently my neighbor was a journalist  
who had dogged me, but to this day  
I have cold sweats every time I recall  
the incident."

## STEALING A DOG.

Sir Edwin Landseer's Experience With  
a London Fancier.

Sir Edwin Landseer, the animal  
painter, one time was about to put the  
finishing touches to the portrait of a  
dog belonging to a nobleman and was  
expecting a visit from his model when  
the owner arrived in a state of great  
perturbation without the dog. The ani-  
mal had been stolen. After talking  
over the loss with Sir Edwin the owner  
decided to leave the matter in the  
painter's hands, together with a ten  
pound note as a reward for the recov-  
ery of the dog.

Sir Edwin's acquaintance with the  
dog fanciers was large, and he sum-  
moned to his aid one Jem Smith, who  
he thought might put him on the right  
track. He showed the man the picture  
and the banknote and promised that  
if the dog was restored no questions  
should be asked. Six weeks later  
Smith arrived at the studio leading the  
missing dog by a piece of string.

"Here is your £10," said the artist, "and  
I suppose I must ask no questions.  
But now that the affair is done with  
you may just as well tell me about it."  
After a moment of hesitation the  
man confessed that he himself was the  
thief. "You, you thundering rascal!"  
exclaimed Sir Edwin. "Then why on  
earth have you kept us in suspense all  
this time?" "Well, you see, gov'ner,"  
was the answer, "I stole the dog, but  
the gentleman I sold him to kept 'im so  
jolly close that I hadn't a chance of  
nicking him again till yesterday, and  
that's the truth, s'elp me."

## Birds as Oracles.

A most remarkable superstition of the  
Kenyahs of Borneo is the consulta-  
tion of birds. If, for example, a Ken-  
yah has to undertake a long journey  
he will not risk it without having first  
consulted the "fakki," a kind of hawk.  
If the hawk flies with its wings spread  
out to the right side it is a good sign,  
but if it goes to the left or flaps its  
wings then the journey is not begun in  
any circumstances. The next day the  
Kenyah tries once more until the hawk  
gives the sign which he wants. Thus  
the continuation of the journey  
depends on the flight of the birds. Some  
birds are of greater importance than  
others, and also to the singing of the  
birds attention is given. Other  
animals are also consulted, and the sea  
Dyaks call every animal a "bird" when  
they consult it.

## Prodigality of Life in Ancient Egypt.

The reckless prodigality with which  
in ancient Egypt the upper classes  
squandered away the labor and lives  
of the people is perfectly startling. In  
this respect, as the monuments yet re-  
maining abundantly prove, they stand  
alone and without a rival. We may  
form some idea of the almost incred-  
ible waste when we hear that 2,000  
men were occupied for three years in  
carrying a single stone from Elephan-  
te to Sais, that the canal of the  
Red sea alone cost the lives of 120,000  
Egyptians and that to build one of the  
pyramids required the labor of 300,000  
men for twenty years.

## CANNING TOMATOES WHOLE.

We have received several requests  
for a receipt for canning tomatoes  
whole for salad, which was printed  
two years ago, reprinted last year. It  
proved so satisfactory that all who  
tried it are loud in its praise, declar-  
ing that the tomatoes are just like  
those freshly gathered, when used in a  
salad. Select perfect tomatoes of even  
size, fully ripe, but not soft skin.  
Skin them by scalding, then pack in  
wide-mouthed jars. Put them in care-  
fully without spueezing, and do not  
fill the jars so full that the topmost  
fruit press against the lid. Put in a  
little salt, then wrap a wet cloth  
around the jar, and fill it with boiling  
water. Put on the lid and seal it  
tight; then put the jar in a kettle of  
hot water, deep enough to come right  
over the top; leave it there, without  
any further cooking, until the water  
becomes cold, then wipe the jar and  
keep in a cool dark place.—Exchange.

## Hog Raising in North Carolina.

The North Carolina experiment sta-  
tion has just issued a bulletin on hog  
raising in North Carolina, which is  
available to all farmers in the State  
who are interested in this subject and  
who apply for a copy of same.

The importance of the swine indus-  
try in North Carolina has not been  
fully appreciated by our farmers and  
it is evident, says Director Williams,  
from the inquiries coming to the sta-  
tion that Northern and Western hog  
growers are coming to realize some-  
thing as to the opportunities afford-  
ed by this and other Southern States  
for this industry. Every farmer who  
grows hogs should have a copy of this  
publication and with its aid help to  
place the swine industry of the State  
on a broader and more economical  
basis.

There is possibly not another State  
in the Union where hogs can be grown  
as economically as in North Carolina,  
and it should be the aim of every far-  
mer to do his part in growing a sub-  
stantial number of hogs each year.  
Thousands of hundreds of thousands  
of dollars are sent out of the State an-  
nually for pork and bacon, which  
could be produced here in North Car-  
olina by our farmers as cheaply as  
is done in the West.

The bulletin devotes some attention  
to the selection of breeding stock, the  
feeding, care and management of the  
herd, prevention of disease and other  
important subjects, bearing directly  
on the practical side of the business.  
The aim it would seem in preparing  
this publication is to bring the farm-  
ers in closer touch with a much neg-  
lected and undeveloped industry  
which offers possibly greater induc-  
ements than any other lines of live  
stock raising where only small capi-  
tal is to be invested.

this bulletin from Director C. B. Wil-  
liams, West Raleigh.
