CLARK, WALKER AND ALLEN SUPREME COURT JUDGES.

BROWN AND LEE NAMED FOR CORPORATION COMMISSIONERS

Splendid Work of Democratic State Convention—Ticket Meets Approval of the People.

Charlotte, N. C., July 15.—The great gathering of Democratic forces of the State in convention here yesterday nominated the following ticket:

For Chief Justice—Walter Clark, of Wake.

For associate Justice of the Supreme Court—Platt D. Walker, of Mecklenburg; William R. Allen, of Wayne.

For Corporation Commissioners—To fill the unexpired term of the late B. F. Aycock, Henry C. Brown, of Wake. For the full term, to succeed Samuel L. Rogers, W. T. Lee, of Haywood.

At the close of the afternoon session the various nominations for judges made in the several districts were endorsed by a unanimous vote.

Some of the Districts.

Mr. J. A. Lockart, of Anson, eloquently presented the name of Chief Justice Walter Clark, of Wake, for nomination for Chief Justice, there being no opposition.

Ex-Judge R. W. Winston, of Raleigh, next spoke seconding the nomination, his splendid address being handsomely received. At the conclusion of his address, on motion of Mr. Ernest Green, of New Bern, the nomination was made by a unanimous vote.

The name of Associate Justice Platt D. Walker was presented by Hon. C. W. Tillett, of Charlotte, there being no opposition to him. Mr. Tillett made a happy reference to Judge Walker's recent marriage.

Hon. Theo. Klutz, of Rowan, most eloquently seconded the nomination and paid high tribute to Judge Walker as a man, a lawyer and a jurist, saying the State had a right to be proud of his record. On motion of Hon. R. N. Hackett, of Wilkes, the nomination was made by acclamation.

Then came the first contest of the convention. As Chairman Moore mentioned the names of Judges Manning, of Durham, and Allen, of Wayne, in the contest for Supreme Court Justice, the forces applauded.

Mr. Victor S. Bryant, of Durham, appeared to speak in behalf of Judge Manning, and his address was a feature of the convention. He was in splendid voice and his remarks were in the nature of a vote winner if votes could have been won.

There were many cheers for Judge Manning at the close of Mr. Bryant's speech.

As ex-Governor Chas. B. Aycock appeared to speak for Judge W. R. Allen, the applause came from the opposing forces. The delegates for the first time rose in their seats and waved their hats, seconding it.

It was a tribute to Aycock as well as to Allen.

Succeeding the nomination for Judge Manning, was Mr. Cameron Morrison, of Charlotte, whose speech was a gem.

Hon. Walter E. Daniel, of Halifax, next spoke for Judge Allen, his address being a gem in eloquence. His speech a splendid tribute to Judge Allen and it was given great applause.

Mr. James H. Dillard, of Murphy, next attempted to speak for Judge Allen, but the confusion was so great, and there were so many cries of "vote, vote," from the impatient delegates that he was forced to desist.

Then came the ballot, and Allen's victory, his vote being 526,978 to 437,972 for Manning, with five one-hundredths of a vote for J. H. Merriam, of Asheville, Clay and Tyrrell not represented, Allen's majority being 92,006.

Before the final result was announced Mr. H. A. Foushee, of Durham Judge Manning's manager, moved to make the nomination of Judge Allen unanimous and this was done by a rising vote.

For Corporation Commissioner

Mr. H. C. Brown, present commissioner was nominated by acclamation to succeed himself.

For the other commissioner, the names of Judge A. W. Graham, of Granville; Hon. W. T. Lee, of Haywood and Mr. J. H. Pearson, of Burke, were presented.

The vote was: Lee, 567,663; Graham, 313,918, and Pearson, 126,348, this giving Lee a majority of 127,397 over Graham and Pearson.

HOW GREENVILLE GROWS.

Post Office Receipts Tells The Story
\$10,475 Last Year.

It has been said many times before, that the post office, of a town is one of the best indications of the growth of the business of that town. Postmaster R. C. Flanagan, has given us some figures that show what Greenville is doing in this particular, and they are interesting by the way of comparison as well.

For the month of June 1909, the post office receipts were \$574.67, and for the same month of 1910, they were \$748.97, a gain of \$174.30. For the quarter ending June 30th, 1909, the receipts were \$2,105.85, and for the corresponding quarter this year \$4,376.90, a gain of \$2,271.05.

For the fiscal year ending June 30, 1910, the receipts were \$10,475, enough to put Greenville well over the limit that entitles her to free mail delivery in the city. We hope "Uncle Sam" will make note of this and hurry up the free delivery.

LIEUTENANT BRUCE COTTEN RESIGNS FROM ARMY.

CAUSED ASSIGNED IS PROPOSED
MATRIMONY.

Gossips Link the Names of the Two
Together, but Their Engagement is
Later Denied.

Baltimore, Md., July 13.—After more than ten years spent in the United States Army, during which time he has risen from the grade of corporal to first lieutenant, Bruce Cotten, a native of Wilson, N. C., has notified the War Department of his intention to resign his commission.

Lieut. Cotten has been paying attention to Mrs. Jesse Tyson, a young widow, and a society leader of Baltimore, for some time past and it is believed his reason for leaving the Army is to wed Mrs. Tyson.

Lieut. Cotten will enter upon a two months leave of absence on Friday, and at the expiration of this leave, will sever all connection with the military service.

Mrs. Tyson sailed for Europe last Saturday and it is the intention of Lieut. Cotten to follow her to the other side in about a month. Lieut. Cotten is the son of Mr. Robert Randolph Cotten, a well known business man of Wilson, N. C.—Press Dispatch.

The error in the above is the statement that the prospective bridegroom is a native of Wilson and that his father is a well known business man of that town. The young man was born right here in Pitt county, and his father is proud of his being a citizen and business man of this county.

The Engagement Denied.

Following the statement made in the above press dispatch, the Baltimore Sun says:

In view of the fact that Lieut. Bruce Cotten, of the Coast Artillery Corps, stationed at Fort McHenry, has sent in his resignation from the army and has asked for leave of absence to go beyond the seas, much credence has been given the rumors of his engagement to Mrs. Jesse Tyson, of Baltimore.

Lieutenant Cotten will leave Fort McHenry in a few days to join his mother, Mrs. Randolph Cotten, at Virginia Beach. After a short visit there, he expects to return to Baltimore. He says he may go abroad next month. The Lieutenant's resignation will take effect early in September.

While their friends here know nothing definite in regard to an engagement between Mrs. Tyson and Lieutenant Cotten, it is well known that they are devoted friends and such an announcement would not come as a surprise to anyone. This, in spite of the fact that even on Saturday, when Mrs. Tyson sailed for Europe with a party of friends, both she and Lieutenant Cotten denied being engaged, and even when seen at Fort McHenry yesterday, the Lieutenant reiterated the denial.

Mrs. Tyson is one of Baltimore's most beautiful women and is noted as a charming and popular hostess. She is a musician of ability and a patron of art.

Lieutenant Cotten has been in the army since 1898, when he enlisted as a corporal in Battalion A, Washington Infantry. He served through the Spanish-American war, and upon his return entered the regular army. He belongs to one of the oldest and most distinguished families of North Carolina, a number of members are in the army and navy. He is a son of Col. R. R. Cotten of Cottdale, Pitt County, N. C.

All last winter, gossip frequently linked the names of the army officer and Mrs. Tyson, and speculation was rife as to whether they were engaged or not. Both being popular and prominent, the sudden announcement of the officer's leave of absence, followed immediately by the announcement that he had sent in his resignation from the service, has revived the rumors and society is once more agog.

Announcement that President Taft had accepted the voluntary resignation of Lieutenant Cotten was made yesterday in orders issued by Acting Secretary of War Oliver. The reasons given by the officer in his application which was received several days ago, included nothing to indicate that he contemplated matrimony. Marriage is not denied to any officer of whatever grade in either army or navy. Cadets at West Point and midshipmen at Annapolis and at sea are not allowed to marry.

HAVE NARROW ESCAPE.

Overtaken by Severe Storm on Road
and Horses Run Away.

Mr. C. D. Rountree, who has just returned from Seven Springs, tells us of the narrow escape from a serious accident to his party. They left the springs Thursday afternoon to drive to the railroad station at LaGrange, nine miles distant. Mr. Rountree and a gentleman from Wilson were in one carriage in front, and Misses Lizzinia and Susie Moore and a gentleman from Goldsboro were in a carriage a short distance behind.

When about half way to LaGrange the party was caught in a storm, with a torrent of rain and terrific lightning. A flash of lightning struck near the carriage occupied by the ladies, causing the horses to run away. Fortunately for the occupants, the horses had not gone far at their break-neck speed before they broke the single tree of the carriage and became unhitched from the vehicle, leaving it standing in the road. The horses ran on for some distance when they plunged into a tree, killing one of them instantly and so badly injuring the other that it will die.

THREATENED WITH STRIKE.

Federal Intervention Sought—40,000
Men Involved.

Philadelphia, July 15.—Federal intervention will be sought to prevent a strike that is threatened among the employees of the Pennsylvania railroad. Leaders of the trainmen say they will see no enforced arbitration of their demands, but General Manager Myers, of the road, has decided to seek relief through the Erdman act.

The strike leaders declared today that the situation was a deadlock, with only the calling of the strike as the next possible move. Hopes were expressed of a settlement being reached, but there is no definite program the situation looks bad. About 400,000 men are out with the company.

ter or reputation so swiftly and surely that it is soon almost an impossibility to turn it loose. The beginning of an evil habit is small. It grows by day. The divine injunction "Train up a child in the way he should go, and when he is old he will not depart from it" is true to a letter. Be sure not to neglect the habits.

To Keep Free of Flies.

"Kill the first fly." Considering that one female fly can bring into being several millions of the pests in one summer, it would seem a good job to kill that first one.

If the first and its immediate followers are let live and the house becomes overrun, there are several suggestions for ridding the rooms of them. One course, taken from the south where mosquitoes are a public menace, is to burn pyrethrum powder in a room. This benumbs the flies and they fall to the floor and can be swept out. The trouble with this is that pyrethrum powder is not sold at many drug stores in the north.

From the American Civic Association at Washington comes this hint: Drop twenty drops of carbolic acid on a hot iron; the vapor kills the flies. Sticky fly paper has both good and bad qualities. It does trap some flies. But those that get their feet coated with the adhesive matter are likely to return to their flth heaps prepared to carry back to the house added quantities of disease-bearing matter sticking to their feet. Fly traps do their part, but Dr. C. St. Clair Drake of the Chicago health department says the insects are cautious.

"The flies soon learn to be wary of traps," Dr. Drake says. "Those that have had any experience with them cannot be caught, and shortly a tribe of flies too shrewd to be trapped might be evolved. The insects also avoid the sticky fly paper after one experience. They are crafty little fellows and the instinct of life is as strong as in many superior beings."

Various poisons are suggested, the best of which the doctors say, is formalin in water. Put a spoonful of the chemical into half a cup of water and leave it exposed in theroom and the flies will do the rest.

In passing it is worthy to note that this insect, with its love for odors that offend the nostrils of man, has a strong aversion for scents which the human likes. This has given a hint for still another prevention, of minor worth. Aromatic plants in rooms and at windows act as repulsives. Such plants, then have a double value in sick rooms; they are pleasing to the sufferer and discourages the fly that, with evil purpose, looks through the open window.—From "Campaigning Against the Fly," in August Technical World Magazine.

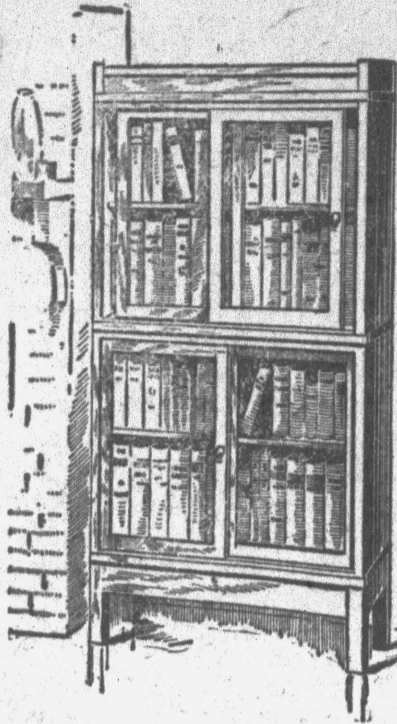

BROOKLYN TABERNACLE BIBLE STUDIES

CONFESSING THE SON OF GOD.

Matthew 16:13-28—July 17.

"Thou art the Christ, the Son of the living God."

OUR Master, wisely and with becoming modesty, hesitated to declare his own greatness. He allowed his actions to speak and to tell to his disciples that he proceeded and came forth from God, and that in the performing of miracles, and particularly in his teachings, he was the finger of God and his mouth-piece. John the Baptist was sent to be his special fore-runner. It was he that declared that Jesus was "the Lamb of God which taketh away the sin of the world." It was he, that declareth that the Master was so much greater than himself that he was not worthy to stoop down and loose the Master's sandals.

But after John had borne him witness, testifying, "This is he," and had declared that he saw the holy Spirit descending upon Jesus like a dove, and that this was a sign given him whereby he might know his Messiahship, then came the time for the Master to bring the matter pointedly to the attention of his followers. John had been cast into prison and later had been beheaded. John's prophetic testimony was fulfilled, when he said of Jesus, "He must increase, but I must decrease." The mission of Jesus and his Apostles became more prominent every day, and those who had formerly talked about John were now asking respecting Jesus, whether he was a prophet sent of God, or whether he was the Messiah. Do the rulers indeed know whether this is the Messiah or not? Surely "no man could do the miracles which he doeth unless God be with him" in some special manner.

Our Lord first inquired respecting the general opinion of the people concerning himself. He did this, not because of his own ignorance, but that he might draw out the thoughts of his disciples. They replied that some thought he was John the Baptist; others supposed he was one of the prophets. The ideas of the heathen were gradually making inroads upon the Jews. The doctrine of reincarnation, wholly unscriptural, is suggested in these answers. All the answers, of course, were wrong, for the prophets were all dead and could not reappear until the resurrection. Then our Lord pointedly put the question to his chosen followers: "Who do ye say that I am?" The courageous St. Peter promptly answered as spokesman for the whole company, "Thou art the Christ [Messiah], the Son of the living God." This was the very answer designed to be brought forth. It was the truth, but our Lord hesitated to present it, because it would better come from the disciples themselves and then have his endorsement. His answer to St. Peter was, "Blessed art thou, Simon Bar-jona, for flesh and blood hath not revealed it unto thee, but my Father which is in heaven."

It was not that St. Peter had experienced a special vision or revelation, but such a great spiritual fact as was then under consideration, at that time could be appreciated only by those who were specially favored of the Father. Indeed, it is evident that the same principle still operates, for we read, "No man can come unto me, except the Father which sent me draw him." Our primary drawing and calling is of the Father up to the time when we accept his grace in Christ and make our consecration to do his will and receive the spirit of adoption into his family as God's children; we are then put into the school of Christ to learn of him. Let us learn the lesson that the special blessings always come, not only from believing in Christ, but also from confessing to and before others.

According to the Greek, our Lord replied to Peter, "Thou art a stone, and upon this rock will I build my Church." The rock upon which the Church is built is this confession which St. Peter made. St. Peter himself was not the rock, but he was one of the living stones built by faith upon the rock of truth. It was this same Apostle who so beautifully explained the whole matter, assuring us that all consecrated believers are "living stones" in the temple of God, whose foundation and cap stone is Christ, in whom we are builded together through the operation of the holy Spirit.—I Peter 2:4-7.

The expression, "Upon this rock I will build my Church and the gates of hell [hades] shall not prevail against it," is one that is much misunderstood. The gates of hell are not gates to some place of torture, nor gates to purgatory. They are, in the Greek, "gates of *hades*," and *hades* signifies a state or condition of death. The passage might well be translated, "The gates of the grave shall not prevail against it." That is to say, Christ Jesus invites the Church to die with him, to share in his sacrifice, in his death, and while, apparently, the gates of *hades* have prevailed against the Church, against God's people, for more than eighteen centuries, nevertheless, we have the assurance that they shall not forever prevail. The Master's assurance is that by his death he has become Lord of all and has the keys of death and *hades*. He has the right to open *hades*, the tomb, and to call forth all who have gone down into it. He assures us that he will do this, as he says, "All that are in their graves shall hear the voice of the Son of man and shall come forth."

Nevertheless, for all these centuries it has required faith to believe that, by dying with Christ, his followers shall yet live with him—that sharing with him in his death they shall yet share with him in his resurrection to the glory, honor and immortality of the Divine nature. So, then, our Lord's words mean that there will be a resurrection from the grave, and since the Church is to be "a kind of firstfruits unto God of his creatures" (James 1:18; Revelation 14:4), her resurrection means, indirectly, this result, the uplifting of mankind, the opening of the grave to every member of the human family.

The giving of the "keys" of the Kingdom to St. Peter has no reference to locks and bars of heaven, over which St. Peter is the custodian. The Church in the present time is the Kingdom of Heaven in its preparatory or embryotic state, and St. Peter was privileged to do the opening work to the Gospel Church. He opened the door to the Jews at Pentecost, when, as the mouth-piece of the Lord, he proclaimed the meaning of the Pentecostal blessing and the hopes then open to every Jew coming, individually into membership in Christ. He used the second "key" to open the same kingdom privileges to the Gentiles, in that when the due time came for Cornelius, the first Gentile convert, to be received, St. Peter did the work. By preaching to Cornelius the Gospel and by baptizing him into Christ he threw open the door to the Gentiles, as our Lord foretold in the words of this lesson.

St. Peter's commission that whatever things he should bind on earth should be bound in heaven and what things he should loose on earth should be loosed in heaven, is the same that was given to the other Apostles. (See Matthew 18:18.) It does not mean, of course, that the Lord has turned matters over to St. Peter and made him Lord of heaven and earth, nor that any or all of the Apostles were so honored. It simply means this: God purposes to use his Apostles and to so hold up their hands, in all their affairs, that the whole Church may have confidence in them, and may recognize their teachings as of God. If they declared that certain of the commandments under the Jewish law were not binding upon Christians, we must know that their statements were true, and that, similarly, in heaven, the release or change is recognized. And if they bound certain doctrines and teachings, we must know that those are bound and firmly established in heaven. In other words, we must recognize the Apostles as God's inherent mouthpieces.

The time for proclaiming Jesus as the Messiah did not come until after his death and resurrection. Indeed his Messiahship properly dates from his resurrection. He desired his disciples to recognize him properly, and he explained to them about his approaching death and resurrection, but he did not wish them to proclaim this to the world until the due time. St. Peter, perhaps elated with the Lord's commendation of his previous speech, undertook now the role of teacher to the one whom he had just acknowledged as the Messiah. In this he erred. It was in sympathy that he urged that the Master should not think of any steps which led to suffering and death, but should rather of prosperity and earthly favor, yet our Lord's reproof was pointed. He said: You are my adversary, Peter, when you thus speak to me. You will thus endeavor to dissuade me from doing my Father's will, to hinder me from drinking the cup which my Father has poured for me; your counsel is that common to the world and not of God.

Similarly, the followers of Jesus sometimes need to resist their friends, who thus offer counsel contrary to Divine will and word and providence. These should not be encouraged nor their advice followed. They need correction from their fellow disciples, as did St. Peter.

The words of Peter furnished the Master an opportunity for calling the attention of his followers to the terms of discipleship. Not only must the Master himself suffer, but all of his followers likewise. This course was provided for every one, and whoever would flee from it would lose the eternal life hoped for. Whoever would take up his cross and follow the Master to death would thereby make sure of his share in eternal life on the heavenly plane. His disciples had already pledged their earthly lives, and for them to withhold them for worldly advantage, would mean that they would lose their souls, their lives. This is not true of the world in general, but merely of the Church, called to be of the elect, Royal Priesthood.

He then assured them of his second coming, when he would come in the glory of the Father and with his angels (messengers)—not again as a man—as a sacrifice. At the time of his second coming he would reward every one of his followers according to the faithfulness of each. He concluded this reference to the coming Kingdom by the assurance that some of them would have an ocular demonstration of his coming power and glory before they would die. This we will consider in our next study.

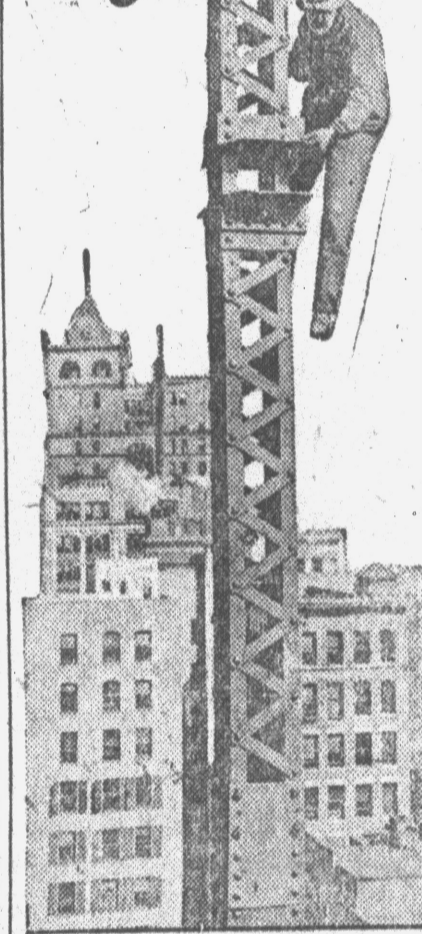

New York July 15.—The stock market conditions today were much the same as at the closing of yesterday. Many issues were in brisk demand with some traders doing their heaviest buying, most of them resuming efforts to cover shorts at advancing prices. Amalgumated capped at a gain of 3/4 was the most prominent feature. Reading gained 1/2 and St. Paul 1/2. The tone held strong.

New York, July 15.—There was a renewal of covering in July contracts at the opening today, that option selling up to 16, 10, or 17 points above the closing price yesterday. The general list started 6 to 16 points higher on near months, and was unchanged to 2 points lower on far months. The Market was very feverish after the call. Opening: July, 15.95; August, 14.95; September, 13.46; October, 12.77.

Chicago, July 15.—Wheat was 15 1/2 points higher on all markets today, on account of dry weather in Northwest. Corn and oats were also up and provisions firmer. Opening: Wheat September, 1.06 1/2; corn 60 1/2; oats 39 1/2; pork 21.85.

Trade Report.

Richmond, Va., July 14.—Bradstreet's Saturday will say for Richmond and vicinity: Trade in general is irregular, some lines showing activity, while others are quiet. Satisfactory orders are being received for practically all lines of goods sold on long terms or for future shipments, while filling in orders, or orders for immediate shipment are not up to the average. Hats, caps, trunks shoes and kindred lines are fairly active. Drugs and flavoring extracts are in good demand. Naval stores continue fair at recent prevailing prices. Produce is quiet. Manufacturers of ales, beers and also soda contain peripherals report good sales. Warm, damp weather has favorable crop growing and reports show improvements in most crops, however, they are generally backward, on account of an unfavorable spring. Cotton is reported much improved and a fair crop is expected. Fruit is generally plentiful. Collections are irregular with a general tendency toward slowness. Banks continue to find ready demand for available funds.
