FISHERIES DISPUTE SETTLED.

Great Britain has Sovereign Right to Make Regulations.

The Hague, Sept. 7.—The award in the fisheries dispute between England and Canada against the United States, was signed this morning. This was a triumph for arbitration. It holds that the British have absolute sovereign rights to form regulations in Newfoundland waters, but recommends that two months' notice be given on the whole. The award is regarded in the diplomatic world as satisfactory. The decision is unanimous on all questions but one, this being the question of defining bays, which the commission refused to do. By the award the dispute that has lasted almost a hundred years, and has twice nearly brought England and the United States to war, is definitely settled. An industry of a million dollars a year is beyond dispute and complicated questions, which have been wrangled over since 1818, are solved. The agreement of British and American judges is complete, the only objection being made by Senor Drago, the Argentine representative. The agreement, it is believed, will prove generally satisfactory to all three countries involved.

GIRL ATTEMPTS SUICIDE.

Takes a Drink of Carbolic Acid and is Hurried to Hospital.

Raleigh, Sept. 7.—Gillie Batten, a white girl working at the Martin Hosier mill, attempted suicide this morning by drinking carbolic acid. She swallowed the deadly drug about 6 o'clock and was hurried to Rex hospital. At 11 o'clock she was still living, and the nurse at the hospital thinks she will recover. But little is known of the girl here, she had been working in the mill about a month and is thought to have come from Selma.

A LEMON IN MILWAUKEE.

Mayor Refuses to Take Part in Roosevelt Reception.

He sent word to the Roosevelt party several days ago that in view of political ideas expressed by Roosevelt he could not consistently take part in the reception.

ALMOST A FIRE.

McLemore's Pressing Room Gives a Scare.

There was some excitement on the street a little before 10 o'clock this morning, when smoke was seen pouring out of Mr. B. F. McLemore's clothes pressing establishment. His place is located in one of the rooms in the row of frame buildings on the Dancy property, a very inviting section for a fire.

Large numbers of citizens and the fire department were quickly on the scene and the fire was put out before there was any damage of consequence, except to the contents of Mr. McLemore's establishment. The clothing of several of his customers on hand to be pressed were ruined, and all of his fixtures were more or less damaged.

The fire occurred in the back room of the establishment where the cleaning and pressing are done, and in some way caught from one of the small gasoline stoves. The entire room was in a blaze in a moment.

Messrs. W. B. Wilson & Son and Mr. F. H. Beaton, who have offices on each side of where the fire was, moved out their fixtures in a hurry.

NORTH CAROLINA NEWS.

Gathered From Our Exchanges Today of Events Just Happened.

Richmond, Va., Sept. 5.—J. G. Hollingsworth, a prominent merchant of Fayetteville, N. C., who suffered a fractured skull in the fatal smash which terminated in a joy ride taken by a party of friends on Friday morning shortly before one o'clock, passed away at the Johnston-Willis Hospital here tonight at 7.40, never fully regaining consciousness.

Danville, Va., Sept. 6.—Mrs. Sallie Underwood, wife of John Underwood, of Reidsville, died at the General hospital here tonight as the result of being run over by a Southern railway freight train. Mrs. Underwood was crossing the tracks in the railway yards at Reidsville this afternoon and while dodging a passenger train, was struck by a freight train coming in the opposite direction. Both of her arms were cut off. She was brought here but never recovered from the shock. Mrs. Underwood was about 25 years of age, and formerly lived here.

The double tracks are getting the railroads into almost as much trouble as the single ones.

A man called Mr. Roosevelt a liar, and got over a column write-up in the papers.

Here's hoping the old soldiers are having a big time in Norfolk, and we are sure they are.

They are now measuring the eggs New Yorkers eat by the mile, and the report says the city got away with thirty three thousand miles of them in a year's time.

Charles W. Morse, who is serving a term in the Federal prison in Atlanta, was placed in a dungeon two days on bread and water for insolence to an officer. Guess that will check the efforts to get him pardoned, at least for a time.

The dispatches are now saying that one, Colonel Roosevelt, has turned his face homeward on his journey. We hope he will soon get there and quit occupying so much space in the papers.

Sometime ago, if our memory serves us correctly, the name of a brother of the mayor of Kinston at that time appeared in a list of indictments for selling liquor. Now we see it going the rounds that a son of an ex-mayor of Raleigh has been arrested for a similar offense.

The Boll Weevil Among Us.

Has the boll weevil reached North Carolina? This is the question asked in Richmond county just now, and although no definite answer has yet been given, there is a bare possibility that such is the case. The farm under suspicion lies near the Anson line and its cotton promised particularly well this year. A visitor looking the crop over noticed that some of the bolls appeared to be spotted. "One of these was pulled off," notes The Salisbury Post, "and upon examination the decayed part was found to be full of small worms, wiggling and working exactly as may be seen in decaying animal matter. Some of the bolls were affected very slightly while as much as half of others was decayed. The part affected turned black at first and had much the appearance of a bruise. An investigation of the field showed that fully five per cent. of the bolls were effected in this manner."

It is greatly to be hoped that the trouble will not prove to be due to the boll weevil. The pest has travel-

ed rapidly from its original habitat in Texas, but as far as has yet been reported it had not been found thus far north. The scientists of the United States department of Agriculture are at work endeavoring to discover the insect which will do for the weevil what one imported from Australia did, for the San Jose scale in California, namely, exterminate it. So far their efforts have not been crowned with success, and the infection of the North Carolina cotton area with the weevil would prove a very serious matter. The Richmond county situation calls for investigation by the State authorities at the earliest possible moment, since, if the weevil is there, its presence ought to be certified, while if it is not much useless apprehension may be allayed.—Charlotte Observer.

Carolinnian Lands Good Job.

Mr. Thomas J. Pence writes from Washington to his paper, the Raleigh News and Observer, as follows: "Announcement came from Beverly last night that the President had appointed Dr. J. A. Holmes, formerly State Geologist of North Carolina, to the new position of Director of the Bureau of mines, which pays \$6,000 a year. Dr. Holmes has been connected with the United States Geological Survey since he left North Carolina, a few years ago.

"There is a big political significance to the appointment of Dr. Holmes to the head of the bureau of mining. Mr. Taft had practically turned down the North Carolinnian and Prof. Parker, of the Geological Survey, was in charge of the work. Dr. Holmes was ignored largely through the instrumentality of Secretary of the Interior Ballinger, who charged that he was too friendly to Gullford Pinchot, the deposed forester. While on the witness stand before the Ballinger-Pinchot investigation committee Secretary Ballinger said there was a lot of snakes in this department, and that he intended to drive them out. It was the understanding at the time that Dr. Holmes was one of those he had in mind. But the Taft mind has undergone a change and Ballinger does not stand so high at the White House. Recent events in the West, in connection with the reception of Theodore Roosevelt, has also caused the President to sit up and take notice and that is why Dr. Holmes has been made head of the Bureau of Mines and Mining after having been turned down for appointment. The nomination of Dr. Holmes is a sop to the Roosevelt-Pinchot following and the insurgents of the West.

"That is the story in a nutshell. In the meanwhile those who believe in the recognition of merit in the government service have achieved another victory."—Ex.

Have The Schoolrooms Ready.

Was there ever a community that had all of the schoolrooms ready for the reception of the pupils on the day school opened? This is a point in school organization of very much greater importance than any one except the teachers can appreciate.

The first few days when the pupils and teachers are getting acquainted, have a very great influence on the work of the entire year. It is highly important that the first impressions should be as favorable as it is possible to make them. Many a teacher has lost ground with a class from no other cause than the distractions, of the belated workman, fixing a lock, or the rounds of hammering, of the removal of ladders and paintpots at the time when control of the attention of the classes means losing or getting a grip on the situation.

The routine and crowded work of organization during the first days is bad enough and distracting enough at its best. No added features of disturbance should be permitted. A very great deal can be prevented. Of course, no one is to blame for it. The trouble seems to be that there is too much time during the summer vacation in which to do it and it is put off too long. The perfection of school work is made up of trifles. The discipline of a year may hang upon such little things as these at the opening. The executive school officials may not realize the full importance of the need, but every one of the teaching organization knows it. Since the success of the schools depend more upon the efficiency and good work of the teachers than upon any other branch of the service, the others will help a great deal by making all possible speed in getting the rooms ready before school opens.—Washington Post.

GREAT SALT LAKE.

An Immense Fresh Water Sea Some Thousands of Years Ago.

In glacial times Great Salt lake was a magnificent fresh water lake the size of Lake Huron—that is, about 18,000 square miles—and had its outlet into the Port Neuf, the Snake and the Columbia rivers. This was at least 10,000 years ago, but since that time the climate has become arid, and not enough water has fallen over the Great basin to supply that lost by evaporation. Consequently the lake has ceased to flow from its outlet and gradually dried up from over a thousand feet deep to fifteen feet and from 18,000 square miles in area to less than 1,700.

It is now seventy miles long and about thirty wide, but is beautiful still and is the home of myriads of sea birds and other waterfowl. It is the great resort of the people of Utah, for from 3,000 to 5,000 visit its shores daily in the summer, and many bathe in its waters. The lake contains about 7,000,000,000 tons of salt.

When the lake is high the salt is so diluted that it has gone down to 11 per cent. When it is low, as it was not many years ago, it reached saturation which for the mixed ingredients of the water is 30 per cent.

There is nothing mysterious about it any more than there would be about a teacup with a teaspoonful of salt in the bottom. If a tablespoonful of water were put in the cup on the salt it would taste very salty, but if the cup were filled to the brim with water it would not.

The salt has come from the water of the rivers flowing into it since it ceased to flow from its outlet. All river water contains salt, and the annual evaporation of from two to five cubic miles of this water leaves large quantities of salt behind, and so it has accumulated for thousands of years.

A DREAM JOURNEY.

It Was a Very Long One, but It Took Only a Few Minutes.

"Dreams are curious things," remarked the amateur psychologist. "Time does not seem to enter into their composition at all. For instance, the other day I was sitting on the porch of a hotel with a friend of mine smoking after lunch. It was a drowsy day, and conversation lagged. Presently I saw my friend nodding in his chair. He had dozed off, holding his lighted cigar in his left hand, which was folded over his right. His left hand relaxed, and the end of the cigar came in gentle contact with the right hand, inflicting a slight burn.

"The devil it won't!" exclaimed my friend, waking with a start. "The sentence sounded so incongruous that I burst out laughing. 'Won't what?' I asked. "How long have I been asleep?" he asked.

"Not more than a couple of minutes," I replied. "It doesn't seem possible," he said. "During that time I had a dream that pretty nearly took me around the world. I sailed for Southampton, did England, France, Switzerland and a part of Italy, then through the orient to India. It was in India that I became much interested in one of the native snake charmers. He had the snakes crawling all over him and offered me one to fondle. I told him I was afraid it would bite me. He assured me that it wouldn't, and I took the reptile in my hand. It promptly fastened its fangs in me. I said, 'The devil it won't!' and dropped it, and then I woke up."

"I explained the episode of the lighted cigar," concluded the amateur psychologist, "and we both laughed."—New York Sun.

Southey probably deserves to rank as the most industrious of authors. In the greater part of his life he spent fourteen hours a day in composition. He had six tables in his library. He wrote poetry at one, history at another, criticism at a third, and so on with the other subjects upon which he was engaged. He once described to Mme. de Stael the division of his time—two hours before breakfast for history, two hours for reading after, two hours for the composition of poetry, two hours for criticism, and so on through all his working day. IRONGLAD CASTE.

Its Rule Among the Hindus Absolute and Unchangeable.

THE POWER OF THE BRAHMAN

All the Wealth of the World Would Not Enable a Lower Caste Hindu to Wed Into His Family or Touch His Hand—Tyrannical Social Divisions.

Caste distinction in India is a thing difficult for a foreigner to comprehend. All the racial or religious distinctions which separate European nations from each other and divide them within themselves do not equal the number of classes into which the Hindus are divided by what is known as "caste."

The 200,000,000 Hindus are made up of diverse racial elements and speak about nineteen developed languages and over 100 dialects. They are again divided into over 3,000 castes, most of them with subcastes. One of these castes, the Brahmans, is split up into more than 800 subcastes, of which none will intermarry and few will eat together.

The term "caste" includes so many things that it is difficult to define it. There are, however, two properties essential to a true caste—first, there is no entry except by birth; second, marriage outside the caste is absolutely forbidden. To preserve the purity and maintain the exclusiveness of the society many minute rules of conduct, many restrictions on food and many ceremonial observances are imposed on the members and enforced by penalties which cannot be evaded, against which there is no appeal and which in extreme cases follow the offender beyond the grave.

But that is not all. The relations of castes to each other are as much a matter of religious observance as the rules for their internal regulation. The Brahmans are the highest admittedly and undoubtedly superior to all the rest. After them come those who are acknowledged to be twice born. The less honored follow in a graduated descent until the untouchable and unspeakable are reached at the lowest depth.

It may be urged that the separation between the Brahman and, let us say, the Kurmi market gardener is no wider than that between the peer of the United Kingdom and the coal miner. There is this essential difference—that it is impossible for an Indian to change his caste. The coal miner may be elected to parliament, may become a cabinet minister and if he can make money enough may marry his son to a duke's daughter.

The Kurmi must remain a Kurmi. All the wealth of Croesus will not enable him to make an alliance with a Brahman family or to touch a Brahman's hand. The members of a caste may and in some cases do raise themselves in the sight of other castes by adopting more elaborate ceremonies and more scrupulous observances.

A half civilized Gond, for example, may find himself brought into contact with Hindus as the plow encroaches on the forest. He tries to raise his position and add to his self respect by adopting the exclusiveness of his Hindu neighbors. He will even outdo them if he can, and if the Hindu is scrupulous about his food the convert will wash the very wood with which his dinner is cooked.

No endeavors of this kind, however, will avail to lessen by a hair's breadth the distance between him and the caste Hindu or even to induce the Hindu barber to look upon him as a client whose chin he may shave and whose toe nails he may pare without degradation.

Another point connected with caste which has a very practical bearing and must be taken into account is the power of coercion which it gives to the brotherhood. If a man is excommunicated by his caste fellows nobody in the caste will marry him or will accept water from his hands or will eat with him.

If he is married his wife will not touch him or speak to him. He is dead to his family. The priest will not perform ceremonies for him. The village barber will not shave him, and the washerwoman will not wash his clothes. These are the methods of bringing pressure on the man. The strictest boycott which Irishmen have invented is mild compared to the final sentence of a caste punishment.

A system like this is a stern fact which has to be faced. There is not a police case or a civil case or a trial at the sessions, there is hardly an appointment to an office in India of whatever degree, in which the matter of caste has not to be considered. It forces itself into every assessment of land revenue, into every adjudication of rent. It affects the administration of justice, the proceedings of municipal and district councils.

The influence and power of the Brahman and the idea that he is above the law and is not to be punished as other people are still alive, although a century of British justice has done something toward eradicating them. On the other hand, the suggestion that a man of a lower caste might rise to an equality or nearer to an equality with members of a caste above him is unthinkable. Where the low caste men are, there they must remain. If they believe themselves it will be made up to them in a future existence.—London Spectator.

Italy's Marriage Brokers.
Marriage brokers are a regular institution in Italy. In Genoa there are several marriage brokers who have pocketbooks filled with the names of the marriageable girls of the different classes, with notes of their figures, personal attractions, fortune and other circumstances. These brokers go about endeavoring to arrange matrimonial alliances in the same offhand mercantile manner which they would bring to bear upon a purely business transaction, and when they succeed they get a commission of 2 or 3 per cent upon the dowry, with such extras of bonuses as may be voluntarily bestowed by the party.—London Standard.

How Russian Peasants Live.
Most of the Russian peasants pass a great deal of their lives in workshops, where they work, eat and sleep, the same room sheltering a number and probably a pig in the bargain. There are few beds. Instead, all around the four walls of the room is fixed what may be literally described as a bench. It is made of wood, and at this works the peasant by day and on it he sleeps by night, each man at his own spot. The conditions of the Russian workshop or factory and the Russian prison and military barracks, so far as interior arrangements are concerned, are akin. Chairs there will also be, and a table, rudely fashioned, as a rule, by the men themselves.

WEST POINT UNIFORMS.

Cadets Must Sacrifice Comfort For the Sake of Looks.

"It is true," said a retired army officer in a discussion of West Pointers with the Washington Herald, "that many West Pointers acquire a figure of perfection of symmetry and a carriage the acme of manly grace, but these are due not to any ingenious appliances, but to the systematic drills and exercises that make the cadet, to a certain extent, an athlete. At the outset these young fellows are put through what are called the 'setting up' exercises, their object being to straighten the body and develop the chest. One might suppose that it would require a great amount of such exercise to make any marked showing, but three long hours of such exercise daily will soon produce beneficial results in the most stooped forms.

"The cadet uniform is also a great help in this direction. The dress coat is tight, very tight. The shoulders are heavily padded in order to give them a square effect. The chest is made thick, so that there will be no danger of wrinkling. And in size a new dress coat seems always to be designed for a boy several times smaller than the one who is to wear it. A new dress coat, in fact, is always a source of suffering to its owner. When he first puts it on it buttons readily about the neck, but seems to lack about six inches at the waist. The owner may squirm and wriggle and attempt to reduce his waist to a minimum circumference, but his maiden efforts are never sufficient to button the new dress coat. Experience is a great teacher, though, and the young fellow laughingly requests one or two of his friends to lend their assistance, and he finally succeeds in buttoning the coat. 'All this for the sake of looks. Comfort has no place in the makeup of a West Pointer; it's discipline and looks.'

WATCHED OVER BY SATAN.

Superstitions That Twine About the Mandrake Plant.

The little plant the mandrake has a wealth of tradition centering round it such as is seldom found in floral lore. Quite an insignificant little plant with a spindle shaped root often divided into two or three forks and rudely resembling the human form, it is doubtless from this latter fact that it has derived its name. Langhorne in the latter part of the eighteenth century tells us to

Mark how the rooted mandrake wears His human feet, his human hands, while it was once believed that a person pulling up a mandrake would instantly fall dead. This was said to be because the mandrake had a human heart at its root and when pulled it would scream in such a fearsome manner as to terrify the hearer to death or else induce madness. Shakespeare alludes to this where he says: And shrieks like mandrakes torn out of the earth, That living mortals, hearing them, run mad.

And again in "King Henry VII," where Suffolk, asked by Queen Margaret whether he has not spirit to curse his enemies, replies: Would curses kill, as doth the mandrake's groan, I would invent as bitter, searching terms As curst, as harsh, as horrible to hear.

From time immemorial the mandrake has been associated with enchantments and has ever been believed to be one of the most powerful charms of witches. Mr. Conway in a paper on "Mystic Trees and Flowers" states that "by popular superstitions in some places it is said to be perpetually watched over by Satan, and if it be pulled up at certain holy times and with certain invocations the evil spirit will appear to do the bidding of the practitioner."—Westminster Review.

The Holland Primrose.
There is a plant in Holland known as the evening primrose, which grows to a height of five or six feet and bears a profusion of large yellow flowers so brilliant that they attract immediate attention, even at a great distance, but the chief peculiarity about the plant is the fact that the flowers, which open just before sunset, burst into bloom so suddenly that they give one the impression of some magical agency. A man who has seen this sudden blooming says it is just as if some one had touched the land with a wand and thus covered it all at once with a golden sheet.
