WALTER WELLMAN'S BALLOON WRECKED.

VARIOUS TELEGRAMS TODAY ABOUT HIS TRIP.

The Last Is that America Falls in Sea and the Crew is Picked Up by a Passing Steamer—All Saved.

New York, Oct. 12.—Wellman's balloon, America, was wrecked at sea and abandoned. Wellman and the entire crew were rescued by the steamship Trent of the Royal Mail Steam Packet Co. Line bound for New York. This information was conveyed in an official report from Captain Down of the Trent to his office in New York. In the following dispatch: "At 5 a. m. sighted Wellman's airship, America, in distress, signaling by Morse code that she required assistance and help. After three hours maneuvering with fresh winds blowing rescued Wellman with his entire crew and cat. They were hauled safely aboard. All are well. The America was abandoned at latitude 35 degrees, 43 mins. north, longitude 68 degrees, 18 mins. west."

Wellman Heard From.

Halifax, N. S., Oct. 12.—A wireless message from Sable Island says Mr. Wellman's balloon was still afloat at 9 o'clock this morning. The wireless operator overheard Wellman in communication with a passing ocean liner. The America has covered between 750 and 1,000 miles.

Steamer Sails in Search of the Balloon, "America."

New York, Oct. 12.—The steamship Kronprinzessin Cecilie sailed from New York this morning under full steam after Wellman's balloon, America. The steamer hopes to get in touch with the balloon by wireless if it is still above the ocean. The Kronprinzessin Cecilie has the most powerful wireless plant on the Atlantic.

CRIPPEN TRIAL STARTED.

British Crown Prosecutor Gives Him a Scathing Denunciation

London, Oct. 12.—Dr. H. H. Crippen the American physician who is charged with the murder of his wife, was put on trial in Old Bailey court today. Crowds thronged the court room and streets. Crown Prosecutor Muir caused a sensation when he opened the case, saying: "We charge that this man willfully murdered his wife in order to get her money and remove her, the obstacle which prevented his marriage to Ethel Le Neve, his typist. Crippen plead not guilty. Bets are made favoring acquittal on the ground of lack of evidence. It is believed the defense has a surprise to spring. The crown prosecutor spoke two hours, his address being the most scathing denunciation of the prisoner ever heard in a British court."

STORM STRIKES FLORIDA COAST

Key West, St. Augustine and Other Cities Suffer Disastrously.

Jacksonville, Oct. 12.—The entire southern section of Florida is a vortex of the terrific hurricane today. Grave fears are felt for the safety of Key West and all other cities in the extreme southern part of Florida. At Key West is the worst storm ever experienced along that section. The storm raged all night at St. Augustine. Wind dashed waves of tidal immensity over the sea wall. Ships were broken from their moorings. The less goes into millions of dollars. Refugees report fearful damage and loss of life.

THE HURRICANE IN CUBA

Hundreds of Lives Lost and Great Destruction of Property

Havana, Oct. 12.—Exact loss of life in the recent fatal hurricane will never be known. Rescue squads report bodies swept to sea by tidal waves and hundreds of lives are lost, it is believed. Nine blocks in this city were under water. Large buildings crumbled over like paper. Dozens of towns were wiped out and crops ruined.

New Orleans, Oct. 12.—The hurricane has passed out of Cuba and is now traveling westward at a frightful velocity.

UNIVERSITY DAY

Celebration of Hundred Seventeenth Anniversary at Chapel Hill.

Chapel Hill, Oct. 12.—The 117th anniversary of the founding of the University of North Carolina was celebrated in chapel and throughout the state last Wednesday with the exercises of university day. In Chapel Hill the day was a holiday for the students. The alumni associations all over North Carolina and in many of the largest cities of the country celebrated the day fittingly. Telegrams were received from the associations in New York, Birmingham and various other places.

The principal address of the day in Chapel Hill was delivered by President Venable. He declared that the university faces a crisis, just as real and just as pressing as that brought on by the civil war, which resulted in the closing of the institution. The college is overcrowded in every way. Retrospection is bound to set in unless from some source, expected and naturally from the State, a more ample provision is made for the support of the college. He quoted figures to show that North Carolina, although possessing an amount of taxable property considerably greater than Virginia, was appropriating for the support of its state university a sum that hardly exceeds half of the yearly Virginia appropriation.

In his remarks at the chapel exercises Thursday following the fine celebration of university day, Dean Graham, of the academic department, after expressing the appreciation of the university at the wonderfully inspiring support that the alumni celebrations all over the country brought, called the attention of the students to what he considered the most significant fact of the celebration just passed. This was the civic strength of the young alumni who chiefly made up the local program. The greatest glory of the university is the educational renaissance in North Carolina so wide reaching in splendid results, was led by a group of educational statesmen trained in the university. McIver, Alderman, Aycock, Joyner and their helpers were men who belonged to practically the same college generation. The first fruits that the re-opened university offered to the State. The group that sat on the stage university day is from the point of view of educational leadership a part of the second great crop. Dean W. C. Smith, representing the State Normal college (President Foust was also an alumnus) President R. H. Wright, of the East Carolina Teachers' Training School; President Howard Rondthaler, of the Siena Female college, and President Walter Thompson, of the Jackson Manual Training School, were the speakers.

All of these men are practically of one college generation; all of them are leaders in the application of ideas that promise great things for the State; all of them are men of every sort of strength, including the fine strength of youth; all of them are men of healthy constructive thought; and better still all of them are consecrated to the service of North Carolina.

BECAUSE OF BLACKLIST

Woman Sues for \$10,000 but Recovers Only \$25

Wadesboro, Oct. 12.—In the Supreme court the case of Mrs. Emma Richardson against T. P. Rhyne was tried and the jury awarded a verdict of \$25 in favor of the plaintiff. This is one of the most interesting damage suits ever tried in Wadesboro. Mrs. Richardson is suing Mr. Rhyne, proprietor of Rhyne's meat market for \$10,000 damages for reporting her as a person who would not pay her debts to the Retail Merchants' Association, thereby causing her name to be placed on the "black list" of the association. Rhyne's claim against Richardson amounted to \$5.51 and his contention is that the bill was presented to her time after time and that she refused to pay.

Mrs. Richardson on the other hand, claims she does not owe Mr. Rhyne at all; that the bill, if due at all, was owing by the estate of her husband, the late Walter L. Richardson, and that Mr. Rhyne did not present the claim to her as his administratrix for collection. Mrs. Richardson also claims she was solvent at the time and that no effort was made to collect the bill by law.

Mrs. Richardson's name was reported to the Retail Merchants' Association as being unworthy of credit in the fall of 1903, at which time she was in New York visiting her sister. She returned to Wadesboro in December of the same year and found that credit was denied her by the merchants of the town because her name had been blacklisted by the Merchants' association.

DEPOT AGENT STABBED.

Two Negroes are Brought to Greenville and Locked Up.

Mr. Tildon, agent of the Norfolk Southern railroad at Grimesland, was seriously stabbed Sunday night by a negro. Mr. Tildon was in the depot awaiting the arrival of an excursion train from Wilson and a negro man had bought a ticket to go to Washington on that train. It seems that later the negro changed his mind about going on the train, and went into the depot again to get his money back. Another negro was with him at the time, and an argument arose over the ticket and money. The argument grew until it resulted in blows and one of the negroes drew a knife and seriously stabbed the agent.

Mr. Tildon is reported today as improving. The two negroes were caught and Monday evening were brought to Greenville and locked up.

In the Cotton Belt.

The New Orleans Picayune reports in its weekly review of the weather and the crops, that owing to the admitted lateness of the cotton crop all over the belt, the weather situation has become more than ever important for so late a period in the season. The unusually warm and summery weather during September undoubtedly did a great deal towards pushing ahead the latest portion of the crop and the cooler weather of the past week, unaccompanied by frost, will no doubt help rapid maturing. There was a fair amount of rain in the belt during the past seven days, and in some districts the rainfall was excessive. While picking and marketing have been delayed, the crop has been otherwise benefitted. The past week has developed practically the first cool spell of the season, but the temperature nowhere reached anywhere near the frost point, and, of course no harm was done. Owing to the lateness of the crop, the date of the first killing frost becomes of uncommon importance. A late frost would add materially to the yield, while an early frost would be disastrous to backward cotton. So far the season has been backward and temperatures higher than customary. While this gives no assurance of a late arrival of winter, it has created hope that the first killing frost may be delayed. If October is passed through without a killing frost it will mean much for the season's cotton yield.—Charlotte Chronicle.

Slightly Paralyzed.

KNIGHTS OF GIDEON.

Benevolent Order Pays a Death Claim in Greenville.

J. A. Joyner, president of the Knights of Gideon, and W. C. Redding, district deputy, both of Kinston, paid a death claim of \$125 to Lula Harris, widow of Luke Harris, deceased, at the First Baptist church, colored, here on last Sunday. Luke Harris was the man who was killed a few weeks ago by Frank Forbes and Joe Johnson. He had paid only \$1.50 to join the order and had been a member just twenty-eight days when his death occurred. The Knights of Gideon has become one of the largest negro societies in the State, having 215 lodges and 12,000 members. It has two lodges with 240 members in Greenville. After paying the Luke Harris death claim at the church last Sunday, the society formed a line of march to the cemetery to conduct the funeral of another member, Heber Whitehurst whose death claim will be paid promptly when it comes due. This society has paid out over \$82,000 in four years, and now has a net balance of \$10,000 on hand. It will collect this month over \$2,500.

How to Cure Peavine Hay.
Cut peavines just about the time the young peas begin to form. Cut later, the hay is not as digestible or so much relished by stock, and it is more difficult to save the leaves. If the leaves are allowed to become crisp in the sun they are almost sure to fall off. I allow the vines to lie as cut until pretty well wilted, then rake them into windrows. After remaining for a day in the windrow, they are put into small conical cocks about five feet high and from five to six feet in diameter at the base. They are allowed to stand for a day in the cocks then hauled to the barn. Every farmer who grows many acres of cowpeas for hay should own a tedder. By the use of the hay tedder I have put peavine hay in the barn in 36 hours after it was cut, in condition to keep perfectly. With such hays, peavine, alfalfa and red clover, there is nothing that will equal the tedder in curing the hay quickly, evenly and cheaply. On fairly fertile soil where the vines grow very rank it is nearly impossible to cure the vines evenly without the use of the tedder. The top side will over cure and the bottom will remain green. By using the tedder to turn the vines over after the top has wilted, the whole mass will be evenly cured and make better hay with less danger of mouldy spots.—E. R. Lloyd, in Raleigh Progressive Farmer and Gazette.

A WILY ORIENTAL

Guile of a Tricky Native Snake
Charmer in India.

GATHERED IN THE SERPENTS.

It Was No Trouble to Him to Lure the
Reptiles into His Basket, and the
Supply Was in No Danger of Giving
Out and Losing Him a Job.

Among the numerous objectionable
and dangerous creatures peculiar to
the orient none is more repulsive than
the snake. One shudders involuntarily
as one thinks of its wiggling body and
vicious characteristics. During my
residence in India I never felt safe
from its presence. I had my closets,
bed and even my bathtub searched ev-
ery day lest one should be found coiled
up in some corner, writes Eliza K.
Van Bergen in the Christian Intellig-
encer.

I was always on the watch for the
creatures and ever in mortal terror of
treading on one. It never occurred to
me to sleep without a light, and a
stick was always near at hand lest I
might find one unawares and be un-
prepared to meet it. I even looked
upon my thin mosquito curtain as a
slight protection, for it would at least
break its fall should a snake tumble
down suddenly from the ceiling.

The creatures have a decided prefer-
ence for cool, damp places and often
choose the bathroom and sometimes
the tub for their habitation, much to
the discomfort of its rightful habitue.
It is not unalloyed bliss to live in a
place infested with serpents. With
such formidable enemies, one never
forgets to be cautious, nor to guard
against their presence and sudden at-
tack. It makes one alert to be in the
midst of danger and adds spice to life.

Well, as I started out to say, my
garden was infested with snakes, and
I was persuaded to have a native
charmer summoned to lure them
away. His hideous occupation, weird
incantations and strange pets sur-
rounding the snake charmer with a pe-
culiar fascination. His magnetism
and skill are considered phenomenal
in the east.

the snakes without ever ceasing to
play his uncanny tune. His compan-

incident. It refers to the time when
the late king, then Prince of Wales,
made his famous visit to this country.
"I went to Boston," Miss Alcott re-
lates, "and I saw the Prince of Wales
troop over the common with his train at
review—a yellow haired laddie, very
like his mother. Fanny W. and I nod-
ded and waved as he passed and he
openly winked his boyish eye at us,
for Fanny with her yellow curls and
wild waving looked rather rowdy, and
the poor little prince wanted some fun.
We laughed and thought that we had
been more distinguished by the saucy
wink than by a stately bow. Boys are
always jolly—even princes."
By the way, this incident occurred
in 1860, when the Prince of Wales was
nineteen years old and consequently
quite a broth of a boy, and when Miss
Alcott—we blush to record it—was
twenty-eight.—New York Mail.

The Gold Dust Was There.

North America has counted as a gold
producing continent only since the late
forties. But it might well have done
so for about 200 years. According to
the London Chronicle, in the voyage
round the world which began in 1719
the privateer Captain Shelvocke found
in certain California valleys a rich
