## FROM MEXICO AGAIN.

Correspondent Returns From Long Trip and Resumes Work.

Ciudad de Valles, S. L. P., Mexico, October 17, 1910.

Editor Reflector:  
Quite a time has elapsed since I wrote. I left Texas, respectfully the United States, and am once more back in the Sierra Madre mountains, and at home in my mountain retreat.

When I came back, I found a great change. The whole country from Tampico to this place and to San Dignity, i. e., the whole Haustica Valley, 86 miles long and from 10 to 20 miles and more wide is in the hands of Americans, partly settlers and partly speculators. Here in this little city of about 3,000 inhabitants there are a dozen land offices of agents of different companies. Nearly every train brings people here from Texas, Oklahoma, Missouri, Kansas, Iowa, even Minnesota, with the intention of buying land. A great many have bought. When one walks through the streets of this antique little city he hears the English language spoken everywhere.

In one of my letters I mentioned that when people from the United States want to come here to buy lands, they ought to be on their lookout and beware of the land agents, and to buy from original owners (Mexicans or Spanish).

One can see here at present corn fields with ripe corn, corn in tassels (planted in July) and corn knee high, planted three or four weeks ago. Bananas, oranges, lemons, coconuts and, in fact, all tropical fruits, are grown here in abundance and to perfection. Also pears, apples, plums. The woods are full of huckleberry shrubs, six to eight feet high. One will find bananas and oranges growing wild; every day I get my bananas about a quarter of a mile from my house, out in the woods.

The rainy season is over—rainy season means that it rains in showers every day an hour or two, then the skies clear up, the sun shines clear and bright. Now we have the finest weather. We live under a deep blue Italian or Spanish sky. The heat is far less than in Texas; the nights are cool and pleasant; one needs a blanket to cover oneself.

I missed The Reflector ever so much. Since I left Delfina I did not get it any more.

I must close, for I am very busy now setting everything in order, planting and sowing garden seeds, in short turning the wilderness again into a little paradise. One has no idea of the luxurious growth of weeds and bushes when one was several months away. I wish success to The Reflector.

Hundred Thousand People Engaged in Search.

Ottawa, Canada, Oct. 24.—The most gigantic organized search in the history of North America is in full swing throughout northeastern Canada for Allen Hawley and Augustus Post, occupants of the missing balloon, America II. A hundred thousand persons are in the vast hunt for the balloon, which left St. Louis last Monday and has not definitely been heard from since. America II is the only balloon now missing, the Swiss balloon Czurea having been landed near Blacotasing, Ontario.

## AVIATION MEETS A FIASCO

Foreign Aviators Withdraw Because of Dangerous Course

International Aviation Field, Belmont Park, N. Y., Oct. 24.—The second aviation tournament for the world's supremacy of the air may end in a fiasco. The fight of foreign aviators against holding the race for the international and cup feature of the meet, developed today. Le Blance and Latham, Frenchmen, withdrew on the grounds that the course is a death trap and meet badly managed all round. Hamilton and Drexel, Americans may also withdraw on account of the dangerous condition of the course. There were no races yesterday on account of high winds, and doubt of any program today.

## TRAVELING MAN ROBBED.

Loses a Grip Containing \$10,000 Worth of Jewelry.

Chicago, Oct. 24.—D. C. Foster, traveling salesman from Columbus, O., was robbed of ten thousand dollars worth of jewelry in the lobby of Great Northern hotel here today. He declared he had the valuables in a suit case when he entered the hotel and set grip on the floor to register. When he turned to get grip it was gone. Detectives are working on the case.

## Smoking That Maddens.

Marihuana is a weed used by people of the lower class and sometimes by soldiers, but those who make larger use of it are prisoners sentenced to long terms. The use of the weed and its sale, especially in barracks and prisons, are very severely punished; yet it has many adepts, and Indian women cultivate it because they sell it at rather high prices. The dry leaves of marihuana alone or mixed with tobacco make the smoker wilder than a wild beast. It is said that immediately after the first three or four drafts of smoke smokers begin to feel a slight headache; then they see everything moving, and finally they lose all control of their mental faculties. Everything, the smokers say, takes the shape of a monster, and men look like devils. They begin to fight, and, of course, everything smashed is a monster "killed." ## The Curse of Cowdray.

Cowdray, once the estate of the earls of Egmont and now in the possession of Lord Cowdray, better known as Sir Weetman Pearson, is the subject of a very interesting superstition. Shortly after the dissolution of the monasteries Cowdray was conferred upon Sir Anthony Browne, the father of the first Lord Montague, who had already been given Battle Abbey as a reward for his services to Henry VIII. The story goes that Sir Anthony, who had destroyed the church and the cloisters in Battle Abbey, was visited in the great hall as he was holding his first feast by one of the dispossessed monks, who after solemnly cursing him, prophesied that his family should perish by fire and water. Two centuries and a half later the prophecy was tragically fulfilled. In 1783 the house was destroyed by fire and within a week of that disaster the last Lord Montague lost his life in Germany in an unsuccessful attempt to shoot the falls of the Rhine.—London News.

Republicans themselves give about some of the hardest knocks at their party and show its unfitness to again come in power in North Carolina.

The recent state fair, according to the Raleigh papers, is marked up as the greatest in the fifty years that the annual fairs have been held.

Newspaper headline says a man was hit by a telephone pole while going to a fire. The pole should be arrested on two charges, both for assault and battery, and for interfering with a fireman in the discharge of his duty.

The Democratic candidates of Pitt county are making a good record in their canvass, and the prospects for an increased majority for the entire ticket grows brighter every day. They have large gatherings at their speakings.

A Raleigh colored man was asked the question, when would the colored state fair be held? and replied that it usually came the rainy week right after the white folks held their fair. The colored state fair is being held this week, and it looks like they are going to have even better weather than the white folks had last week.

That Virginia mob, the other day, was somewhat different from the ordinary kind. Ordinarily they go after some fellow who has committed a crime and lynch him, but in the Virginia instance mentioned the mob broke open the prison and spirited away a man who had been convicted of murder and sentenced to death. The mob was after liberating, not lynching this man. And really this kind of mob was no more lawless than the other kind. But it shows what mob violence can lead to.

**An Error of Judgment**

Every now and then a school teacher is confronted with the delicate situation evolved from the fact that a pupil has knowledge of the misdeeds of a fellow-pupil of which the teacher himself is in ignorance. The information is desired in the interests of sound discipline but to compel the pupil to divulge it savors suspiciously of fostering the bearing of tales, a habit which no pupil can detest with more heartiness than the experienced teacher. Under such circumstances, it is usually expedient except in the gravest cases, to allow the matter to pass. Precisely an analogous situation confronted the board of police commissioners of Augusta, Ga., and their method of handling it differed widely from the one just suggested, possibly because this board is not so fortunate as to number any school men in its membership.

Thomas J. Hamilton, a reporter for The Daily Herald, says The Columbia State, summarizing the episode, "was assigned to a murder story. He applied for information to headquarters, of the police department,

getting nothing that was 'news' and finding the atmosphere thereabouts anything but encouraging. Hamilton went elsewhere for his story and got it. He did not call on his imagination but got details known only to the police. Some policeman had 'leaked'. His punishment was sought and Hamilton was summoned before a meeting of the police commission and asked to name the man who gave him the tip. Naturally he declined. Then the board adjudged him guilty of contempt, imposing a fine of \$30 or a jail term. Likewise, of course, Hamilton refused to pay the fine."

The Augusta authorities have taken hold of a rather live wire in invoking contempt proceedings. The knowing school boy referred to above is directly subordinate to the inquiring teacher and thus in some sort under pressure to obey his commands, but it is difficult to see the equity in a newspaper man's being punished simply for the purpose of maintaining discipline in the police department. The action will prove a boomerang, in that it gives very undesirable advertisement to difficulties existing in the administration of a department which is not the most manageable in any community. In the meantime, we do not suppose that The Daily Herald is losing any sleep over the free advertising it is receiving, or that it will allow the sufferings its reporter may have to undergo at the hands of the law to pass without suitable compensation.—Charlotte Observer.

**Buying a Farm With Hair**

What a singular lady Mrs. Helena Dysko, of New York, must be! She is trying to sell her hair to buy a farm. If she were trying to sell her farm to buy hair, there would be no occasion for wonder.

It is easy to see that Mrs. Dysko is not of American birth or rearing. She came over from Poland a few years ago with a glory of tawny hair that mantles her shoulders and, when free, almost entangles her footsteps. Wonderful hair, but not half so wonderful as her willingness to convert it into agriculture.

Tradition has it that the maidens and matrons of Thebes gave their tresses for the making of bowstrings in time of war. But that was long, long ago in a far off land. And fashions in hair must have been very different then from now. To be sure, if it came to the building of forts our modern heroines would offer their switches, and rats, their puffs, transformers and what-not for the national defense; and what then would we have to fear from the enemy?

**The Czar Bell.**

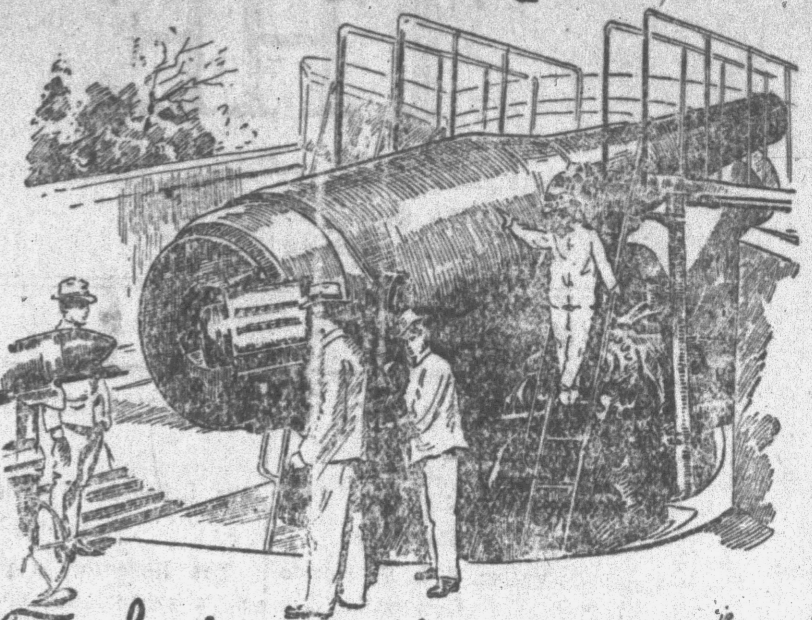

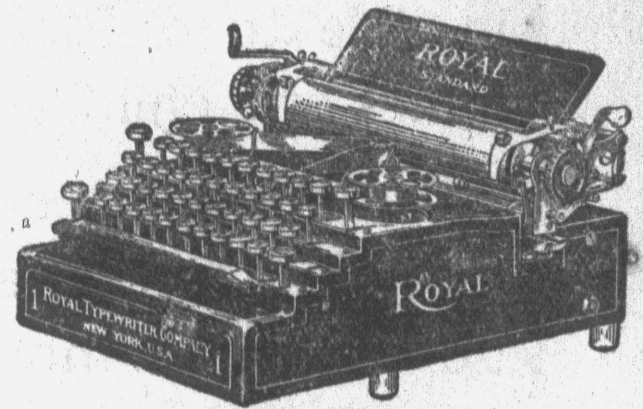

sale, and Cranch soon gave all his  
time to his new art. This was the be-  
ginning of what is now known as  
pyrography.

## ARIZONA ROAD RUNNER.

A Sociable Bird That is Said to Hate  
a Rattlesnake.

The road runner is one of Arizona's  
distinctive ornithological institutions.

ten inches high. It is not often seen  
in the farming districts, but is a fam-  
iliar sight on the desert.

It has gained the name of road run-  
ner from its habit of taking the road  
in front of travelers be they on horse-

quires, showing off its neighborly spir-  
it and running qualities. It is not un-  
common for it to keep in company of  
the traveler for several hundred yards.

the bird is the deadly enemy of that  
monster of the desert, the rattlesnake.

We don't know whether any of our  
readers ever saw a road runner kill a  
rattlesnake. If there is an authentic  
story of such a thing we would be  
glad to publish it. But the accepted  
tradition is that the road runner and  
the rattlesnake are deadly enemies  
and that the rattlesnake fears the  
road runner beyond anything else.

It is told that the bird drives the  
snake into a coil and then, darting  
around the serpent like lightning,  
pecks it to death. Whatever truth  
there may be in the stories of the  
road runner's accomplishments as a  
disciple of St. Patrick, it deserves the  
friendly protection it receives. Its  
quaint sociability is always a diver-  
sion for the lonesome desert traveler.  
—Arizona Republican.

**The Horseshoe Legend.**

horseshoe superstition: St. Dunstan

him, spread out his giant wings and  
vanished forever from my sight among  
the ledges below. The eaglet had left  
the nest and had flown."

**Babeons and Water.**  
In Captain Drayson's "Sporting  
Scenes Among the Kafirs" we find the  
following: "Well," said Kemp, "when  
I go into a country where there is not  
much water I always take my ba-  
boon." "You don't drink him, do you?"  
"No, but I make him show me water."  
"How do you do that?" "In this way:  
When water gets scarce I give the  
Bavian none. If he does not seem  
thirsty I rub a little salt on his tongue.  
I then take him out with a long string  
or chain. At first it was difficult to  
make him understand what was want-  
ed, for he always wished to go back  
to the wagons. Now, however, he is  
well trained. When I get him out  
some distance I let him go. He runs  
along a bit, scratches himself, shows  
his teeth at me, takes a smell up wind,  
looks all round, picks up a bit of grass,  
smells or eats it, stands up for another  
sniff, canters on, and so on. Wherever  
the nearest water is there he is sure to  
go."

**The Tyrant in the Field.**  
There have been few commanders so  
tyrannous as Lopez, the dictator of  
Paraguay, when, in the war of 1865-70,  
it fought single handed the neighbor-  
ing countries of Argentina, Brazil and  
Uruguay. Lopez, says Mr. W. H. Koebel  
in his "Argentina," was wont to  
carry the theory of victory or death to  
an uncomfortable point. "Officers  
were executed for mere remarks  
whose tone fell beneath the standard  
of confidence that Lopez had set up  
for himself. One, for instance, was  
shot for having announced in the  
course of his duty that the enemy was  
strongly entrenched! Another met his  
end on account of an unguarded  
speech to the effect that the Para-  
guayan army was accustomed to count  
the enemy's losses and forget its own."

**Old Time Railway Travel.**  
Third class passenger coaches in  
England used to be coupled on next to  
the engine. The travelers came in for  
terrible treatment when any accident  
occurred. At times the engine was  
driven tender first, in which case frozen  
hands could be warmed at the smoke-  
stack. The passengers were packed,  
seventy of them, into a truck eighteen  
feet in length by seven and a half in  
width. There was no roof and not, as  
a rule, proper protection at the sides.

**Our First Locomotives.**  
The first locomotives in the United  
States were brought over from Eng-  
land by Horatio Allen of New York  
in the fall of 1829 or the spring of  
1830, and one of them was set up on  
the Delaware and Hudson railroad at  
Carbondale, Pa., but, being found too  
heavy for the track, its use was aban-  
doned. The first locomotive construct-  
ed in this country was built by the  
West Point foundry at New York in  
1830 for the South Carolina railroad  
and named the Phoenix. A second en-  
gine was built the same year by the  
same establishment and for the same  
road and named the West Point. In  
the spring of 1831 a third engine was  
built by the same establishment for  
the Mohawk & Hudson railroad from  
Albany to Schenectady and called the  
De Witt Clinton. This was the first  
locomotive run in the state of New  
York. The first Stephenson locomotive  
ever imported into this country was  
the Robert Fulton. This engine was  
brought out in the summer of 1831 for  
the Mohawk & Hudson railroad. It  
was subsequently rebuilt and named  
the John Bull.

**Work Done While Asleep.**  
Cabanis tells us that Franklin on  
several occasions mentioned to him  
that he had been assisted by dreams  
in the conduct of affairs in which he  
was engaged.

Condillac states that while writing  
his "Course of Studies" he was fre-  
quently obliged to leave a chapter in-  
complete and retire to bed, and on  
awaking he found it on more than one  
occasion finished in his head.

**A Joke on the King.**  
Sir Ernest Cassel was persona grata  
with King Edward VII. As a matter  
of fact there was a curious and strik-  
ing resemblance between the back  
view of the late king and that of Sir  
Ernest. It was so pronounced that  
the great financier was known among his  
friends as "Windsor Castle."

There is a good story and a true one  
told in connection with this. It hap-  
pened at a garden party at Windsor  
castle. A well known peer of the realm  
was strolling about when, as he  
thought, he spotted Sir Ernest sitting  
in a chair. Going toward him on tip-  
toe, he gave him a resounding smack  
on the shoulder.

"Hello, old Windsor Castle!" he cried,  
"How are you?"  
The occupant of the chair, startled,  
turned around. It was King Edward,  
who, unaware of Sir Ernest's nick-  
name, was for a time exceedingly  
vexed at this undue liberty. However,  
when the circumstances were ex-  
plained to him he enjoyed the joke  
hugely.—London M. A. P.
