

## SENATOR SIMMONS' STIRRING SPEECH

COMPLETELY FLAYS MARION BUTLER, THE TRAITOR

CROWD CHEERS HIM HEARTILY

Danger That Would Come to the State if Republicans Could Get Control—Administration of the Two Parties Contrasted and Republican Extravagance and Corruption Exposed—Tariff and Other Issues.

Hon. F. M. Simmons, one of North Carolina's United States senators, arrived on the 11:25 A. C. L. train Friday afternoon and spoke in the city hall. The crowd was not large, owing to the disagreeable weather and lateness of the speaking, but it was representative and enthusiastic.

After an introduction by Col. F. G. James, who referred to Senator Simmons' leadership of the party in North Carolina for twenty years, the senator delivered a stirring speech.

He said it would be impossible for him, being in a white State like North Carolina, to be anything else but a Democrat. He first took up the special tax bonds about which so much has been recently said. He had no idea North Carolina would ever have to pay any of those bonds and would not have to do so if the State is properly represented in litigation over them. Republican ascendancy in our North Carolina would mean great danger to the State as that was the party issuing them. The people have for forty years protested the bonds as fraudulent, as the State had received no benefit from them. The speaker thoroughly showed Marion Butler's efforts to force the payment of these bonds. To turn over the State to the Republican party would be to put it under the absolute control of Marion Butler. He did not believe the people of North Carolina wanted to surrender the State to any such control. Butler is not a citizen of North Carolina, but lives in Washington City, and is in this State now as the representative of the special tax bonds.

Senator Simmons next took up the constitutional amendment and how the Republicans were trying to get control of the State so as to abolish this amendment.

If the Republican party should capture the legislature, every registrar in the State at the next election would be a Republican, and that would mean that every negro who had ever stuck his head inside a school house would be qualified to register. Thus the constitutional amendment which you adopted through sweat and blood would be made a dead letter.

He then took up the danger to the business interests of the State by incompetent Federal appointments in the State. Of all the sorry lists sent up to Washington for Federal appointments in the Southern States, North Carolina sends about the sorriest. It requires millions of dollars to carry on the enterprises and improvements in North Carolina. Not having the money, public improvements have been obtained through the issuing and sale of bonds, which could have been done only through the confidence and credit the Democratic party has given the State. Put the Republican party back into power and you destroy all this confidence and credit. North Carolina's greatest asset is her good government. No State has a better government than the Democratic party is giving North Carolina. When the Republican party had control of the State they came it as they could. The people grew tired of this and arose in their might and threw it out. Now the Republicans are saying they have since reformed and grown better and are begging the people to put them back in charge of the State. If you look it over and examine its leaders you will find it the same old con that we run out in 1898, with the exception of the black rings we pulled off the tail in 1900. It is enough to make one sick to talk about Republican rascality and misjudgment in North Carolina.

Then turning from the State, Senator Simmons talked at some length on national issues and the great extravagance in conducting the government.

Taft is spending twice as much money to run this government as Cleveland spent. Cleveland would

Court of Appeals Denies Crippen Another Trial.

London, Nov. 5.—Dr. Crippen's appeal from the verdict of guilty, rendered against him for the murder of his wife, Belle Elmore Crippen, was dismissed today and the death sentence was re-affirmed in the high court of criminal appeals. The American's last hope for freedom was doomed when the appeal judges refused to grant him another trial. Crippen will be hanged on Tuesday. The prisoner took the blow very hard. His face turned white and he trembled in his chair.

allow no extravagance nor stealing. He was Democrat, you know. He was so economical that before the end of his term there was a great surplus accumulated which he said should not have been collected from the people, but allowed to remain in their pockets. Senator Simmons then discussed the tariff, showing wherein it was a tariff neither for revenue nor protection, but for monopoly. Coming back to State matters he said Republican party in North Carolina is in a funny predicament. It does not know whether it is for Taft or against him. It does not know whether to endorse or repudiate him. The same is true as regards Butler. They do not know whether to be for Butler, or against him. They know he is denounced by the leaders of their party as a traitor and they realize that he is to be the dispenser of "pie" for North Carolina. Hence they are afraid to be against Butler when "pie" is involved, yet in their hearts they abhor him. They were as much puzzled over the meaning of the local self-government plank of their platform, none of them seeming to know what it means.

He had branded Butler as a traitor, and Butler had been going about the State abusing him for it, but he regarded such abuse as a badge of honor. If anybody doubted that all he had said about Butler was true, let him write to the most prominent Republicans in that State (several were named) and get their opinion of Butler as testimony to corroborate what he had charged.

Mr. Simmons closed with a stirring appeal to every Democrat to go to the polls on election day and help make the majority so large as to forever bury Butlerism.

His reference to Democratic victory in the nation in 1912, and to Harmon as the next president, brought shouts of applause.

It was the best speech heard in Pitt county during the entire campaign.

Why man, red-heads are an absolute safeguard against burglars as the followers of that profession cannot stand the light such heads reflect. Haven't you learned from experience?

As the campaign is now practically over, all but the voting, it is not out of place to speak of the high plain on which it has been conducted in Pitt county. In all the campaign there has been no bitterness, and so far as we have heard there has been no word of abuse by any candidate on either side against any one on the other. Chairman F. C. Harding, of the Democratic executive committee and Chairman R. C. Flanagan, of the Republican executive committee, are both to be commended for the high plain on which they have directed the campaign of their respective parties. It is the kind of campaign that leaves no wound to heal nor bad after effects. Of course the outcome of the election is going to be a Democratic victory as was expected, but the minority party will accept the result with the satisfaction of having done the best they could.

**Peanut Versus Weevil.**

The Louisiana cotton farmers have been very hard hit by the ravages of the boll weevil, but being of an ingenuitous turn of mind and not easy to discourage, they have buckled down to fight the pest in dead earnest, with what success may be gleaned from the remarkable increase in the value of their state's annual yield of corn. A press dispatch from New Orleans describes another weapon which has been recently brought into play in the same struggle—the humble but succulent peanut, prized delicacy of American boyhood and chief support of all circuses. "The production of peanuts" says the dispatch, "is the salvation of the cotton planter who suffers from the ravages of the weevil. The infested hilly lands will yield per acre from 20 to 65 bushels of peanuts valued at \$1 a bushel and the peanut hay is worth on a conservative estimate from \$12 to \$15 a ton. Not a few of the cotton oil mills in the weevil districts are rapidly being transformed into manufacturing plants of peanut oil which commands a better price in Europe than olive oil, while the cake which is a by-product makes an excellent stock-feed."

Pessimists may object that the change will result in an over-production of peanuts, to which it may

be answered that there is good reason to believe that a little attention would result in a material widening of the peanut market. Furthermore, it must be remembered that the growing of peanuts for three or four years on land invaded by the weevil will tend to exterminate the pest by the route thus opening the way for the return of such areas to cotton growing. At all events, the entrance of the small boy's joy into the Louisiana station bodes no good for the all-conquering boll weevil.—Charlotte Observer.

**For Stronger Sunday Laws.**

The North Carolina Lord's Day Alliance has gone on record as being strongly in favor of the enactment by the next legislature, of more stringent Sunday observance laws.

It is pointed out that at present only civil action can be brought against offenders of the Holy Sabbath and, while this method of breaking up lawlessness could be made effective it is not an adequate remedy.

Ministerial associations are requested to take a hand in the movement for more effective and comprehensive Sunday observance legislation.

Every minister of the state is asked to preach at least one sermon on the importance of proper observance of the Sabbath day.

The great majority of North Carolinians are strong believers in strict observance of Christian Sabbath, and the fact that Sunday has practically been set at naught in certain quarters is a matter generally deplored.

Here indeed is a work for religious bodies to take part in, and in theme for sermonizing.

In our rapid development let us not forget to respect that day set apart as holy.

It is probable that the next legislature will be urged to make Sabbath desecration a misdemeanor with heavy penalty attachment and when this is done officers of the law can make more headway in breaking up all sorts of abuses which have arisen.

The Alliance calls upon each community to express itself to the end that strong pressure be brought to bear upon legislators.

The Alliance has undertaken a great and a good and a much needed work.—Charlotte News.

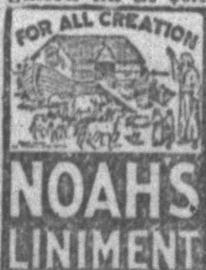
