## GIVE ONE DAY TO PATRIOTISM.

Chairman Eller Issues an Appeal to Patriots to Cease Vacations Tues.

Raleigh, N. C., Nov. 5, 1910. Democratic victory next Tuesday is as certain as any human even can be; the size of the majority is all that remains in doubt. It rests with us to make the victory decisive and final or to make it so indecisive as to render necessary a repetition two years hence of the campaign we are just concluding. If we merely hold the majority of two years ago the result of this campaign will be indecisive, and our efforts must be repeated in 1912; but if we increase our majority to 50,000 all effort to place North Carolina in the list of doubtful states will cease. It is not worth while to exert ourselves and for the next decade, at least, make North Carolina so certainly Democratic that no effort will be made by the National Republican party to carry it, and thus insure for our State a continuation of the peace and prosperity now enjoyed?

To end therefore that we may make our work final, and to the end that we may make unnecessary a benevolent repetition of the present campaign, I now call upon the Democrats to join in a movement to register a majority of 50,000 Tuesday. I suggest that all Democrats cease that day from their ordinary vocations and each one do what lies within his power to bring about this result. Those who employ others in their stores, factories, or on their farms, can well afford to suspend work one day that their employes may have full opportunity to exercise their influence around the polls. I suggest further, that as far as possible, every Democrat cast his vote early in the day so that absentees may quickly be discovered and encouraged to come before the polls close. Fellow Democrats, one good day's work next Tuesday means the end of Butler and the end of all effort to change North Carolina into a Republican State.

## DON'T UNDERSTATE THE FARM.

A Little Land Well Tilled is Better Than Many Acres Poorly Worked

The average American does not believe there is much money for him in the small farm, says Allan L. Benson in the *Delineator*. Ask him if he believes he could make a living on a ten-acre farm for a wife and three children, and he will throw up his hands. Suggest five acres to him and he will begin to suspect that you have designs upon his life.

Even if he be disposed to wrench his living from the soil—which, probably he will not do—he will tell you that he could do nothing on less than forty acres, and that eighty would barely give him decent comforts. More likely, he would reject the farming proposition altogether, and take a polite clerkship at twelve dollars a week, or a place in a factory at ten dollars.

Our national tendency is to get away from the land. In 1792, ninety-six per cent. of the population lived on farms. Now, seventy per cent. of the population are not engaged in farming. Americans are quitting the land as if they had measured its possibilities and found them insufficient.

The fact is that Americans never dreamed of the possibilities of land. Old as the earth is, Americans don't know what it can do. They regard Mother Earth as a lean mother. They believe much land must be used to get a little living. They believe all land is like a yeast cake—good only a little while: witness the abandoned farms to be found in New York and New England.

Americans are wrong. A little land is enough for a living. All land is good. Crops can be grown on sand if the grower knows how to grow them. No farms ever become useless. It is the farmer who becomes useless. Any land can be kept all that Ponce de Leon wanted to be himself—perpetually young. Broadly speaking, no land in America ever produced for a year a tenth of the wealth that it is capable of producing every year. If railroads were run as poorly as farms are tilled, a passenger would require a week, instead of eighteen hours, to go from Chicago to New York. Lack of understanding is the rule on the farm. There are just enough exceptions to prove the rule.

## The Spread of Infantile Paralysis.

Before 1907 epidemics of infantile paralysis were rare in this country. There was only one in New Orleans in 1841; and again, about thirty years ago, the disease was pronounced, but it was otherwise not especially noted until the beginning of the present century. There was a marked epidemic in Sweden in 1905; two in Australia in 1903 and 1908; and an extensive epidemic in Prussia in 1909. It is not likely that other European countries have wholly escaped. The disease has for several years past been prevalent in Scandinavia.

During the past four years infantile paralysis has prevailed throughout our country and probably but few States have been altogether exempt; Cuba has also been visited. In a single epidemic which visited New York City in 1907 2,500 cases were reported. The southern Hudson region, with the surrounding lowland sections, suffered also. There were in that year, moreover, cases in 136 of the 354 cities and towns of Massachusetts, the infection having been relatively much more prevalent in small towns than in the cities and large towns. The disease in its epidemic form is emphatically one of hot weather, prevailing most in July, August, September, and October. Cases have been noted to develop after a hot, dry "spell." Nevertheless it seems warm countries do not suffer as much as those more northerly. Epidemics are bound to subside with the first sharp frost.—From "Infantile Paralysis: A Menace," by John B. Huber, M. D., in the *American Review of Reviews*.

## MRS. J. T. SMITH DEAD.

Greenville Loses an Excellent Woman By Her Passing.

Mrs. Mary Smith, wife of Chief of Police J. T. Smith, died at 5.15 o'clock Sunday evening at their home in Washington street. She suffered a stroke of paralysis just two weeks ago, from which she never gained consciousness, the end coming gradually and peacefully.

Mrs. Smith was 62 years of age, and a daughter of the late Mr. Henry Sheppard. She was a member of the Methodist church, and truly a good woman, her life being filled with deeds of service for her Master, and with devotion to those about her. She was esteemed by a large circle of relatives and friends.

She was married to Capt. Smith in 1867, soon after the war in which he was a gallant soldier in the cause of the Confederacy. Besides the husband she is survived by five children. They are Mrs. C. L. Barrett, of Farmville; Mrs. J. H. Keck, Mrs. V. C. Fleming and Miss Mary Smith, of Greenville; and Mr. J. S. Smith, of Farmville. They have the sympathy of all our people in their sorrow.

Mrs. Smith is survived by two sisters, Mrs. Maggie Bynum, of Farmville and Mrs. J. A. Andrews, of Greenville; and two brothers, Mr. Henry Sheppard, of Greenville, and Mr. H. D. Sheppard, of Hanover, Pa. The funeral services were held in the Methodist church at 3 o'clock this afternoon, conducted by Rev. J. H. Shore, the interment following in Cherry Hill cemetery. The pall bearers were Messrs. E. H. Shelburn, C. T. Munford, Y. W. A. Bowen, J. C. Moe, J. L. Wooten, A. H. Taft and R. Williams.

## THE BLACK MEETING.

## A Difference in Morals.

How conditions have changed! In past years it was customary to associate western North Carolina with moonshining. Now the people of that section represent the strongest prohibition sentiment in the State. The west is dry while the east is wet—wet with whiskey, beer and home-made wine. In this week's issue on Charity and Children, Editor Archibald Johnson comments on this difference in morals. He cites Johnson county as an instance. "Johnson," he says "is a level country. For half a century it has had schools, railroads, and all the agencies of civilization. Until the recent past Madison was hemmed in from the outside world by a wall of mountains. Great progress has been made in the mountain county within the past decade and the people of Madison county have turned these opportunities to good account. They are moral, progressive and intelligent. They saw that liquor was a curse and drove it from their borders. Johnson is as wet as water. A majority of her people seem willing to sacrifice their political and religious principles for the sake of the glorious privilege of guzzling beer. A majority of the people of Wake are like those of Johnson. In fact there is tier of eastern counties where the liquor sentiment has its stronghold." This arraignment is a just one. It is a fact that the best place to find people who are prohibitionists from principle is in the mountain section of North Carolina. —Charlotte Chronicle.

## EXECUTION POSTPONED.

It is understood that postponement is to give Crippen's attorney time to prepare a plea to the home secretary for commutation of sentence.

## Oratorical Effects.

I once heard Everett, whose platform oratory was the acme of American art. His language was unimpeachable. But his every word, and not only his every word, but his every gesture, was unmistakably prepared. He seemed to gesticulate not only with his hands, but with his legs. He even planned scenic effects beforehand. Having to deliver a Fourth of July oration, he introduced a veteran of 1812, put him in a conspicuous place and told the old man to rise to him at his entrance into the hall. The old man did as he had been bidden. Everett apostrophized him with "Venerable old man, sit down! It is not for you to rise to us, but for us to rise to you." The veteran said afterward: "Mr. Everett is a strange man. He told me to rise when he came into the hall, and when I did rise he told me to sit down."—From Goldwin Smith's *Reminiscences in McClure's*.

## The Lightning Rod.

Though Franklin will continue to receive the honor that is his due as the inventor of the first practical lightning rod, the study of atmospheric electricity goes back at least to the time of Tullius Hostilius, who perished in an attempt to "draw fire from the sky." A learned priest of the name of Divisch is said to have erected the first lightning conductor in Europe. He set it up at Prendiz, Bohemia, in 1754, and it was 130 feet high. Though the Emperor Stephen and the Empress Maria Theresa publicly proclaimed their confidence in the inventor, a most disastrous drought that afflicted the country a year later was ascribed by the superstitious populace to the newfangled device, and Divisch was compelled to take it down. It is not probable that Franklin was acquainted with Divisch's experiment.

This is the last time we can urge Democrats to go to the polls tomorrow and do their duty.

The Raleigh News and Observer has made the best fight of its life against Marion Butler and has not failed to show up his infamy.

There is not a decent man in North Carolina but who feels a higher respect for every man who Marion Butler abused in his speech in Raleigh Friday.

You will not hear any drop in the ballot box tomorrow, as the fall of the votes will be silent, but when the counting is over, you will hear something drop.

The wife of Col. John Jacob Astor, who some months ago obtained a divorce from him, is to receive the sum of \$105,000 yearly as alimony. Must take a good pile for the lady to get along on.

We never did like to even feel, much less speak, a sentiment the slightest akin to anarchy, but after delivering such a speech as he did in Raleigh on Friday, Marion Butler should not have been allowed to keep his foot on North Carolina soil even for a day. It was an outrage to every sense of decency, the vituperations of a character steeped in villainy.

Col. Harry Skinner spoke in Durham Saturday, and The Herald of that city makes this reference to it:

The speech of Colonel Skinner was pre-eminently above the heads of his crowd. It was the most unresponsive audience of the years, though it was an attentive one. The quiet that was maintained throughout would have been one of the best tributes to it because it wasn't designed for a whoop-er-up. It was a thought producer, the utterance of a statesman, absolutely without incoherence, abuse or tommy rot, perfectly fair, without fallaciousness, though by no means a final utterance.

The Greenville Reflector said on Thursday: "Marion Butler is going to speak in Raleigh and try to explain it, but it won't explain." That was prophecy on Thursday. The speech was made and left Butler deeper in the hole. Today the Reflector prophecy is history.—Raleigh News and Observer.

**Liquor Advertisements.**

Have you noticed that very few newspapers in North Carolina carry advertisements for liquor houses? Every county editor in North Carolina would carry from one to five hundred dollars' worth of advertisements a year for liquor dealers outside that state, get good rates for the space and the cash in hand for every line of advertising, if they would accept such advertisements. The great majority of newspaper men do not want to and will not carry liquor advertisements, although the demand for space in newspapers by liquor dealers is great.

The man of the state who is selling liquor, knowing that no liquor can be legally sold in North Carolina, except that which is shipped in from other states, is glad enough to pay for liberal prices for newspaper space in which to tell about his goods.

There are exceptions, however, to this rule about carrying liquor advertisements and some newspaper men have no scruples about it, at least not enough to refuse the advertisements for liquor dealers. The Charlotte Observer of a recent Sunday carried 230 in. over ten full columns of liquor advertisements. The Lexington Dispatch and the Winston-Salem Union-Republican, while as far apart politically as the east is from the west, are of the same mind on the liquor publicity proposition, and each of these papers carries good big liquor advertisements.

Now, we are not throwing bouquets at those newspaper men who do not carry liquor advertisements, for some of them who refuse the advertisement for liquor houses just dare not carry such advertisements. Their patrons and subscribers would not stand for it. We do not mind telling you frankly that it would not be a paying proposition for the Enquirer to carry liquor advertisements. We fully believe that carrying even a small liquor advertisement in our paper every issue would mean to us a loss of fully five hundred dollars a year. We hope that belief is not our reason for not carrying whiskey advertisements. We hope that a motive a little higher than a few dollars made keeps us from accepting the money for space from the man who advertises that he has liquor for sale. But we do fully believe that if we were to carry from week to week advertisements for liquor houses that many of our very best subscribers would say to us point blank, "I cannot give you my money to send your paper into my home telling my boys about the fine quality of some distiller's liquor and telling them how to order it. And we just as fully believe that good advertisers, men who are carrying space in our paper year by year, would come right up and face to face tell us that they would not pay for space to tell about dry goods in a paper that continually advertise wet goods.

No, sir, the folks in these parts will not stand for liquor advertisements in a paper they pay for.
