THE TEACHERS' ASSOCIATION.

Hold an Interesting Meeting Saturday With Large Attendance.

The weather was ideal for the occasion, and Prof. W. H. Ragsdale was highly delighted at the record-breaking number of teachers and visitors present.

At 11.30 the association was called to order by President H. B. Smith, and the devotional exercises were conducted by the president.

The president called our attention to the value of the Education Bulletin in regard to the opening exercises of our schools as suggested by Mr. S. J. Barwick of the educational department. He then spoke of the policy that would be followed by the programme committee this year. He said efforts would be made to have programmes that would interest the teachers of all the grades, laying special emphasis on the fact that each teacher should be familiar to a certain extent with all the grades of work.

The association was highly entertained by some excellent reading from the second, third and fourth grades of the Greenville graded school under the direction of Misses Hampton, Knight and Gray, teachers of the above grades.

An excellent paper on "The Ideals of a Teacher" was ably read by Mrs. Kate R. Beckwith, of the Training School.

The association was glad to welcome Prof. H. E. Austin, who did so much to make the association a great success last year by his excellent series of lectures on the "Recreation." We are exceedingly fortunate again this year in securing his services for a lecture on "How to Study," at each of our meetings this year. He outlined his work for this year, urging that each teacher should purchase a book and study carefully each subject assigned.

After some brief announcements by Superintendent Ragsdale, the association adjourned.

THE BLACK MEETING.

Large Congregations and Deep Interest Being Shown.

A VALUABLE BULLETIN.

Bulletin 212 of the North Carolina Agricultural Experiment Station by Dr. F. L. Stevens, which has just appeared from the press gives full directions for preventing the various smuts of oats and wheat. These are due to little living parasitic plants which grow within the wheat and oat plants. They cause large loss, cutting down the yield of grain, often as much as 20 per cent. or over 30 per cent., while the stinking smut of wheat does a greater damage by injuring the milling quality of the grain. The formalin treatment which is thoroughly effective and costs almost nothing, is described and recommended for oat smut. The same treatment is even more effective than the ordinary blue-stone treatment for the stinking smut in wheat. The loose smut of wheat can be prevented by a modified hot water treatment coupled with separate growth of seed in a protected seed plat. Director C. B. Williams, West Raleigh, N. C., states that these diseases cause thousands upon thousands of dollars of loss every year to the oat and wheat crops of the State and that this bulletin was prepared especially to give farmers at this time the latest and most effective means of combating these diseases. He states that a copy of this bulletin may be secured by any resident of North Carolina free of cost upon application to him.

NOTES FROM THE UNIVERSITY

Football Defeats—Club and Society Organizations.

Chapel Hill, N. C., Nov. 15.—Now in the race of the defeat that have come in every game this season the Carolina varsity has reached the point where it must fall back upon its fighting nerve. The last remaining asset of the team, which by its record has almost justly lost the confidence of the student body, is the traditional Carolina spirit, the spirit which in the year 1906 followed a 35 to 6 defeat by V. P. I. and a 7 to 0 slaughter by the navy "came back" against their Thanksgiving foe for a 17 to 0 victory. Today the only thing remembered about the 1906 season is the victory over Virginia.

An important movement among the people of Chapel Hill culminated in the organization of the Community Club. The membership of the club is made up of the ladies of the town with men as honorary members. The purpose of the organization is the improvement of the town school, the sanitation of the streets and all other objects of a worthy public nature. Speeches were made by Dr. E. A. Abernethy and several members of the University faculty. Professor E. K. Graham presided at the meeting.

The Historical Society held its first meeting of the year in the alumni building Monday night. It was decided that the society should not have any officers this year and should be as informal as possible. The suggestion was favorably received that cigars should be provided and that meetings should be nothing more than roundtable discussions. The next meeting will take place the first Monday in December and the subject for discussion will be "Lessons to be Learned From the Present Elections."

At the regular Tuesday night meeting of the Y. M. C. A. Mr. R. T. Webb offered his resignation as treasurer of the association and the nominating committee presented the name of Mr. George Graham. The nomination will lie on the table for a week and then the election will be held. At this meeting Dr. W. DeB. McNider addressed the association on "The Functions of a Physician." He told of the duty to the individual as a healer, the duty to the community as an educator and preventer of disease and his duty as a scientist, who, the speaker said, finds his best laboratory in his every day practice.

LYNCHING NARROWLY AVERTED

Suspected Murderer Spritely Away to Escape Mob.

Ashbury Park, N. J., Nov. 15.—Frembling like a leaf, frightened to verge of collapse and momentarily expecting to be wrested from his protections and torn to pieces by infuriated people, Thomas Williams, suspected murderer of 9-year-old May Smith, was spirited from the lock-up here early today to the county jail at Freehold. Williams was taken away early this morning, after the mob had been driven back from the jail. After the mob disappeared the negro was taken out by officers and hurried away. Coroner Burday announced today he would not hold an inquest until the feeling had died down. It will probably be held next week.

NORTH CAROLINA ITEMS

Of News Happenings Far and Near Within Its Borders.

Asheville, Nov. 14.—News has reached here of a disastrous fire which broke out in Webster county seat of Jackson county, about 8.15 tonight, which has destroyed much of the town. The flames, originating in the kitchen of the Webster hotel, rapidly consumed the hotel of twenty rooms, spread to an adjoining drug store, destroyed the Bank of Tucker, the dwelling of a Mr. Allison and was still raging at 9.30 although it was believed at that time that the ravages had been checked.

Beaufort, Nov. 14.—Work on the inland waterway here has progressed to a point where the engineers tonight announced that practically the last stage will be reached Tuesday when the two dredges, working toward each other, meet. They are now only 150 feet apart. While the dredges will be operated after Tuesday by putting the finishing touches on the big ditch, there will be no hindrance to navigation and vessels drawing 10 feet will be able to use the new waterway, even at low water.

Marion, Nov. 14.—The returns from the thirty-fourth senatorial district, which is composed of Alexander, Burke Caldwell and McDowell counties, show that T. L. Sigmon, Democrat of Burke county, was elected by a majority of about 150 over Bell, Republican, of Alexander county. P. H. Mashburn, Republican, of McDowell county, who received the next highest vote, is now sheriff, not having resigned before the election and is, therefore, under Article 14, Section 27 and Article 2, Section 5, of the Constitution of North Carolina, ineligible to the office of senator. J. I. C. Bird, Democratic, of McDowell county, has the next highest vote and is therefore legally entitled to the seat. This news goes out with delight to the Democrats of the district, and will be received accordingly by the Democrats throughout the State, as this district two years ago sent two Republicans to the senate.

The North Carolina Library Association will hold its sixth annual meeting in Winston, December 7th and 8th, as the guest of the Winston Carnegie Library. The association was formed in May, 1904, to meet a growing demand among the State's library workers for mutual help and to aid the State's educational leaders in their endeavor to call forth and intensify a fine library spirit.

Sunday morning the home of Mr. Marion Pate at Snow Hill, was destroyed by fire of origin that was not learned. The building was situated near the Kinston-Snow Hill depot where about 400 bales of cotton were on the platform and menaced by the flames. None of it was destroyed, however. The loss to Mr. Pate is estimated at about \$600.—Kinston Free Press.

Mr. Daniel Yeargin, aged seventy-seven years, passed away at the Soldiers' Home early yesterday morning. He was a member of Co. 22d North Carolina regiment and came to this home from Randolph county February 23, 1906. The funeral will take place this morning at 10 o'clock.—Raleigh News and Observer.

Wilmington, Nov. 14.—Thomas P. Sykes, a well known citizen of Wilmington, was arrested this afternoon in arrest and bail proceedings in a suit for \$35,000 damages, instituted by W. M. Hurst, for alleged seduction of his daughter, Isabel Hurst. The complaint sets forth that the defendant is sixty-five years of age and the young woman sixteen.

Prizes at Munford's.

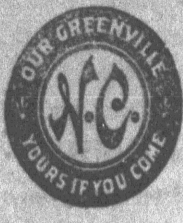

Sometime when you think you are in the light, you are in the dark.

Norman Mack's mistake was not as big as the one the colonel made when he said "We'll beat 'em to a frazzle."

The Greensboro News is certainly trying to laugh it off. That is the best view to take of it and lots better than crying.

Would you believe it, that on a public road within a half mile of Greenville, the county seat, the sand is so deep that two heavy vehicles meeting in the road could not turn out for each other? The thing has occurred and we have got the facts on it. An automobile was puffing along one way in the deep ruts of the wheel tracks and a heavily loaded ox cart was traveling in the opposite direction. When they met, neither the power of the automobile engine nor the strength of the yoke of oxen was sufficient to turn their respective vehicles out of the ruts. Wasn't that a fine public road picture in the shadow of a town of 5,000 population? That section of road is as bad as there is in the county, and it is little wonder that people had rather go twice the number of miles in some other direction than to plough through that deep sand to get to Greenville. It would pay to start at the east end of Fifth street and build a new road in a straight course until it crosses the mill run two miles below town and avoid that section of deep sand, to use put enough clay on the old road to make it hard.

Roosevelt Discredited.

A few months ago Colonel Theodore Roosevelt was the idol of a nation and the foremost citizen of the world. Today he is discredited, rejected, and looked upon by the great hosts of the American people as a common politician and adventurer and a man wholly lacking in truth of statement or honesty of purpose. He retired from the presidency at the height of his popularity. He had while president, championed popular measures, and while regarded as erratic, hot-headed, impulsive, unstable, he was thought to be honest at heart, and no president was ever more generally popular. His stay abroad had increased his popularity. Had he retired to private life when he came home and conducted himself decently he could have been the idol of the people as long as he lived. But inordinate ambition had gripped him. The lust for power was in his veins. Admiration turned his head. He thought he could dictate and the people would accept. He thought he was above, and beyond criticism and could do anything without being called to account. He failed to take into consideration the fact that the American people, as a whole, believe in fairness and honesty. He forgot his own often-urged sentiment of the "square deal." But the people of New York and the country believe in a "square deal."

and they repudiated Roosevelt because he denied the "square deal" to others, and because of the inconsistencies of his position. In New York he advocated the Payne-Aldrich tariff law; in Indiana he spoke against it, he made statements about Dix, the Democratic nominee, that were untrue, and when shown that they were untrue he did not apologize, but lied some more. He lied on Baldwin, the Democratic nominee in Connecticut, and when shown that he had lied, lied some more. Result: The people of Connecticut rose up en masse and called him a liar. And that is the plain judgment of the American people. A political adventurer the people are on to his ways. The idol is shattered and can never again be mended.—Raleigh Times.

They Will Come Again.

If there are those who think that the Republican party in this state will give up and quit, they would do well to undeceive themselves. There will be a new alignment and a recognition of the forces for the presidential year and the fight will be even more vigorous than it was in the recent campaign. It is not probable, either, that the party will have the handicap it labored under this year. The old scores have been evened up, bloody faces will be washed and the next campaign will see the Republicans united and out for business. The probabilities are, too, that the Democrats will be fortified by too much confidence. The "licking" of the Republicans in this state will only do them good and put them in a more troublesome mood for the next fight.—Charlotte Chronicle.

250 Per Cent. Profit in One Year.

The farmer who has every acre in harness, well fed and properly cared for, is the man who is making his farming profitable in these days. Tile drainage is a wonderful aid in bringing many types of soil into proper business relation with the farmer. These soils have, perhaps, been making only half a crop per year, and occasionally complete failure may have resulted during years when ordinary conditions were the least favorable. We had such a piece of land on Sunny Home Farm, naturally strong soil, but filled with wet-weather springs that no dependence could be put upon it. Being only a little piece about two acres, we had passed it by in our hurry to tile the larger fields. A little swamp grass and Japan clover—and these of little feed value because of being compelled to grow on water-sodded land—were produced on the field annually. Thirty dollars worth of tile was laid in this piece of land the past winter, the soil thoroughly prepared and planted in corn. A hundred and twenty bushels of corn, that is making at least \$125 worth of pork, is being harvested from the little piece, so we feel that the \$30 of tile and the \$20 worth of work expended in laying them is time and money well expended, considering that the improvement will last for a century, and a piece of land that was nothing but an eyesore has been made a little fat beauty-spot for all time.—L. French, in Raleigh Progressive Farmer and Gazette.

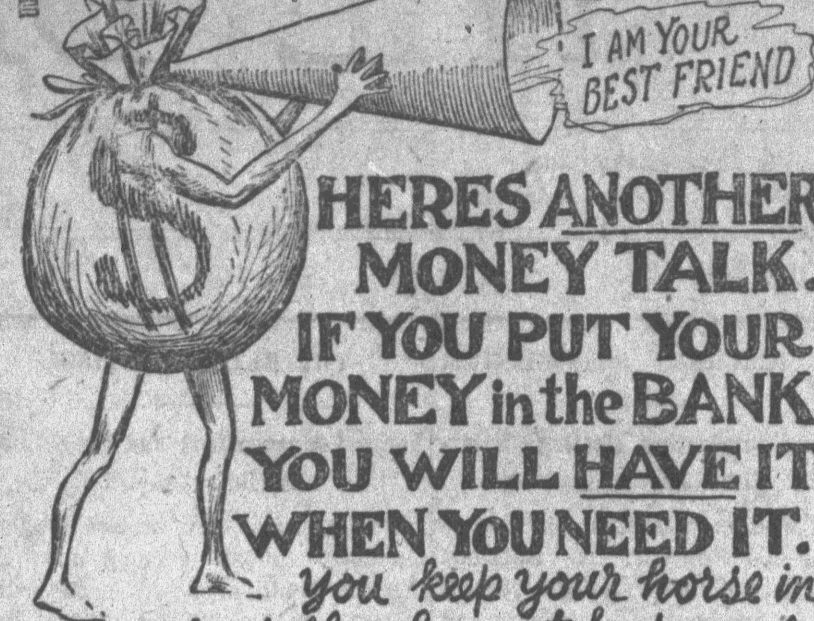

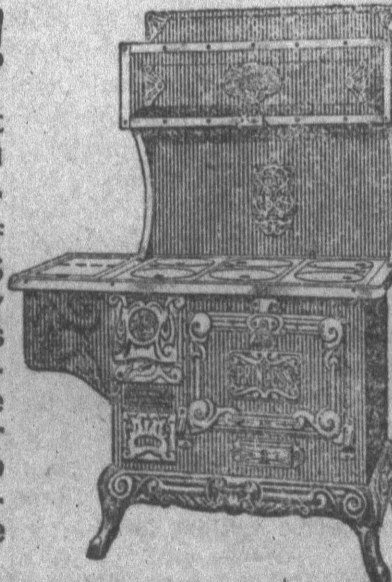

DEMON SHIPS.

Vessels That Seemed to Be Moved by the Spirit of Destruction.

There is an old Cornish legend of a phantom ship which is seen in or off Porthecurno harbor and which, unlike most ghosts, has a terrifying habit of pursuing any vessel which it sights. If it catches its victim there is a collision, but no roar of rushing water. At the moment of contact the ghost ship vanishes into thin air, and the puzzled crew of the other vessel rub their eyes in terrified amazement.

To any one who knows the legend the vessel that saw the phantom ship is, however, doomed. Before the next New Year's day she will be sunk in collision with another vessel or a rock. One wonders whether the original of this phantom at all resembled that notable and appropriately named yacht Satanita. The Satanita was a fine and very powerful cutter, which originally belonged to Mr. C. D. Clarke and afterward to Sir Maurice Fitzgerald.

The Satanita was a hard weather craft, but let the breeze be the least heavier than she liked and she would be seized, with what seemed more like demonical possession than anything else, and even with four men hanging on her helm she would sometimes take charge and rush right up into the wind.

But it is not only sailing ships that act at times in a strange and unaccountable fashion. Some years ago the British warships Pique, Mutine, Rosario and Britomart entered Klukiang harbor and dropped anchor in single file. Presently a steamer which had been discharging her cargo anchored and began to steam out.

She was just abreast of the warships when she suddenly made straight for the Pique. The warship's officers and men saw the man at the steamer's wheel doing all he knew to keep her off, but she flatly refused to answer her helm and went crashing into the Pique, smashing her boats and davits.

After clearing her she went for the Mutine, but luckily did not strike her full. However, she carried the Mutine's bowsprit clear away. Not yet satisfied, she made a rush at the Rosario, but by superhuman efforts on both ships the mad steamer was prevented from doing more than graze the third warship.

Something of the same kind was seen in the Thames a few years ago when the British steamship Poplar, turning to enter her dock, was struck and cut down to the water line by the French vessel Cordilleras. She at once began to fill, and the captain ordered full speed ahead for the purpose of beaching her.

Instead of making for the beach the Poplar made a sudden rush in a great circle out into the river, smashing into everything she came across. Then, as if filled with a spirit of revenge, she made for the vessel which had so terribly damaged her.

The Cordilleras tried in vain to get out of the way, but the Poplar smashed into her, damaging her so severely that she, too, had to be beached.—Pearson's Weekly.

BANKING IN ENGLAND.

Started by London Goldsmiths in the Seventeenth Century.

The business of banking was not introduced into England until the seventeenth century, when it began to be undertaken by goldsmiths in London, who appear to have borrowed it from Holland. It was attacked, as innovations commonly are, Mr. Gilbart in his "History and Principles of Banking" quotes from a pamphlet published in 1676, entitled "The Mystery of the New Fashioned Goldsmiths or Bankers Discovered," a passage that may be reproduced:

"Much about the same time—the time of the civil commotion—the goldsmiths (or new fashioned bankers) began to receive the rents of gentlemen's estates remitted to town and to allow them and others who put cash into their hands some interest for it if it remained but a single month in their hands or even a lesser time. There was a great allurements to put money into their hands, which would bear interest till the day they wanted it, and they could also draw it out by £100 or £50, etc., at a time as they wanted it with infinitely less trouble than if they had lent it out on either real or personal security. The consequence was that it quickly brought a great quantity of cash into their hands, so that the chief or greatest of them was now enabled to supply Cromwell with money in advance on the revenues as his occasion required upon great advantages to themselves."

FAMOUS STAR GROUP.

The Constellation Orion in Legend and
Literature.

The constellation Orion is mentioned
in the literature of all ages. In Egypt
it represented Horus, the young or ris-
ing sun, in a boat surmounted by stars,
closely followed by Sirius, which was
shown as a cow. It has also been
found sculptured on the walls of
Thebes 5,000 years ago. And on the
men of that early time it shone down
from the same position and with the
same brightness as it does on us today,
a striking example of the unchange-
ableness of the heavens.

From the days of the early Hindus
to the present the constellation has for
some reason borne always a stormy
character. Allusions to its direful in-
fluence are found everywhere among
the classic writers. Thus Milton wrote:

When with fierce winds Orion arrived
Hath vexed the Red sea coast.

The loss of the Roman squadron in
the first Punic war was ascribed to the
fleets having sailed just after the ris-
ing of Orion. The group has also been
employed as a calendar sign, its morn-
ing rising indicating the beginning of
summer, its midnight rising the season
of grape gathering and its early even-
ing rising the arrival of winter, with
its attendant storms. In recent times
the group has always represented a
great hunter or warrior. Its present
title came into Greek astronomy from
the Euphrates and originally signified
the light of heaven.

BABY TURTLES.

They Know Just What to Do and Do
It Without Guidance.

Just so soon as a baby turtle emerges
from the egg off he scuttles down to
the sea. He has no one to teach him,
no one to guide him. In his curious
little brain there is implanted a streak
of caution based upon the fact that
until a certain period in his life his
armor is soft and no defense against
hungry fish; and he at once seeks the
shelter in the tropical profusion of the
gulf weed, which holds within its
branching fronds an astonishing abun-
dance of marine life. Here the young
turtle feeds unmolested while his ar-
mor undergoes the hardening process.

Whatever the young sea turtle eats
and wherever he eats it—facts not gen-
erally ascertained—one thing is cer-
tain, it agrees with him immensely.
He leads a pleasant sort of life, bask-
ing in the tropical sun and cruising
leisurely in the cool depths.

Once he has attained the weight of
twenty-five pounds, which usually oc-
curs within the first year, the turtle is
free from all danger. After that no
fish or mammal, however ravenous,
however well armed with teeth, inter-
feres with the turtle.

When once he has withdrawn his
head from its position of outlook into
the folds of his neck between the two
shells intending devourers may strug-
gle in vain to make an impression
upon him.—Harper's Weekly.

The Roar of China's Ducks.

Tourists in China are always sur-
prised by the number of ducks they
see. There are more ducks in China
than in all the rest of the world.
Their voices are a familiar sound in
every town and country spot of the
seacoast and the interior of the vast
empire. Even in the large cities ducks
abound. They dodge between the cool-
ies' legs. They flit squawking out of
the way of the horses. Their indig-
nant quack will not unseldom drown
the roar of urban commerce. Children
herd ducks on every road, on every
pond, on every farm, on every lake, on
every river. There is no back yard
without its duck house. There is no
boat, little or great, without its duck
quarters. All over the land there are
great duck hatching establishments,
many of them of a capacity huge
enough to produce 50,000 young ducks
every year. Duck among the Chinese
is a staple delicacy. It is salted and
smoked like ham or beef.—New York
World.

Red Tape and Matrimony.

Some of the reasons why a French-
man may not marry are given by a
correspondent of a Paris newspaper.
He has been trying to get married for
three years and has not yet succeeded.
French marriage law is a tricky thing
to deal with. If the prospective bride-
groom has not lived more than six
months at his address at the time of
the marriage he must get a certificate
signed by the landlord and concierge
of every house where he has lived pre-
viously till he gets back to one where
he did live for six months. Birth cer-
tificates are required and the written
consent of parents.

As no paper must bear a date more
than two months old, it often happens
that the marriage must be postponed
to get the papers renewed. The man
who had been felled for three years
once succeeded in making all his pa-
pers correct, when he was called up
for his periodical term of military
service, and this threw his papers out
of date.

Another time he arrived before the
mayor with his bride, but the cere-
mony was not performed, as a certifi-
cate of his first wife's death was not
forthcoming.

Fascination of the Third Rail.

"You can talk all you want about
the way some people want to jump off
tall buildings, but the men who walk
the elevated tracks can sympathize
with them," said a man the other day
whose business it is to work along the
elevated railroad lines and see that
everything is in good condition.
