THE THIEF ON THE CROSS

HIS WORDS TO CHRIST TAKEN AS A TEXT

DR. BLACK'S SERMON FRIDAY NIGHT

A Man Saved at the Last Moment—The Only Death-Bed Conversion Recorded in the Bible—Not Saved Keeping the Law but by Trusting in Christ, Who Kept the Law for Us.

Another large congregation was present in the Methodist church Friday night, and more interest was manifested than in any former service since this meeting began. Dr. Black read for a Scripture lesson that portion of the 23rd chapter of Luke telling of the crucifixion of Christ, and took as his text the 42nd verse, the words of the dying thief: "Lord remember me when Thou comest into Thy Kingdom."

These were the words, the prayer, of one of the two thieves crucified with Jesus. Reference was made to the sermon of the previous night wherein it was shown that men are not saved by keeping the law, even if they could keep it all, but they can be saved by repentance and through trusting in Christ. Jesus came to earth and lived a perfect life, thus keeping the law, and it is only by trusting Him as keeping the law for us that we are saved. If we call upon Him for salvation He will save us, for He never yet turned away one who cried to Him from an earnest heart.

The thief on the cross was a sinner who cried unto Christ and was heard. It is the only death bed conversion that is recorded in the Bible. While it shows that Christ has power to save even at the last moment, yet it is running a risk to wait until your dying moments to call upon Christ to save you. This thief was a wonderfully wicked man, who first joined his companion in crime in railing on Jesus, but he was a sinner who realized his condition and confessed his guilt. You take a long step toward heaven when you feel your sins. Salvation begins with a cry and a call for help. He had faith and trusted Jesus as one able to save him. It was a cry that was heard and answered.

"Today shall thou be with me in paradise," were the words of Jesus in answer to this cry for help. Not tomorrow, not next year or even at the day of judgment, but today. The soul will not stay in the grave, it shall never die, but if we are saved it goes at once to be with the Lord when our bodies go to the dust.

It was a sermon showing the tenderness and compassion of Jesus, and His readiness to hear all who call to Him from the heart, yet emphasized the truth that confession must be made before there is salvation.

At the conclusion of the sermon a great number of people stood to make confession, and later went forward and gave the preacher their hand in token of this.

Mr. Shore, the pastor, announced a good report from the cottage prayer meetings and that more of them will be held this afternoon. There was a good attendance at the morning service in the church. Service tonight beginning at 7.30. It is gratifying that the number of singers in the choir is increasing, but there should yet be more.

The services for Sunday will be as follows: Dr. Black will preach in the Methodist church at 11 a. m. and 7.30 p. m. Three services will be held in the afternoon at 3 o'clock, one in the Methodist church for men and boys over 15 years of age, one in the Baptist church for women and girls over 15 years of age, and one in the Christian church for both boys and girls under 15 years of age.

COTTON CONTRACTS VALID.

Case Decided That Carries Much Interest.

A case was tried in the term of Superior court just closed that is of especial interest to growers and buyers of cotton, as it establishes the validity of contracts to sell cotton for future delivery. The custom prevails more, or less in the cotton belt for farmers to make contracts in the spring to sell their cotton in the fall at a specified price. It is remembered that last year much cotton was sold in this way, and the price advancing several cents between the time of making the contract and the time of delivery. There were many farmers who refused to make delivery of the cotton as contracted. In some instances suits were entered against the sellers for the difference in the price of the cotton at the time of making the contract and the time it should have been delivered. It was one of these cases that was tried, entitled H. A. Gray vs. Verner Carson, and the verdict of the jury was in favor of the plaintiff, judgment being rendered against the defendant for the difference in the price of the cotton.

RIOTING IN MEXICO.

Government Issues Stern Orders for Repression.

Mexico City, Nov. 19.—The stern policy of repression ever instituted by the Diaz government was put into effect today against revolutionary agitators held responsible for continued rioting. Orders for wholesale arrest of those plotting against the government have been issued. The aid of the United States will be asked in arresting and extraditing political refugees who are directing affairs from Texas. Fifty are believed to be dead from rioting in Pueblo yesterday. Women took part in the fighting there.

Tickets will be sold 23rd and 24th, limited to return up to and including Saturday 26th. Trains leaving Greenville at 8.23 a. m., reach Norfolk at 1.35 p. m., and Richmond 2.00 p. m.

BUILD 18-MILE ROAD IN DAY.

All the Men in Kansas County Help in Record Construction Job.

Independence, Kan., Nov. 18.—Practically every able-bodied man in this county lent a hand to building a new road between here and Coffeyville, 18 miles away. About 15,000 men are engaged in the work. The road was completed in a day with the exception of spreading the oil, at night.

BLUE JACKETS DISORDERLY.

Rioting Between American Soldiers and French Civilians.

Cherbourg, France, Nov. 19.—Three hundred French sailors with fixed bayonets patrolled the water front today to prevent further fighting between American soldiers and police and native civilians. Shore leave from ships was stopped except upon personal application of Blue Jackets, each man being compelled to appear in position before his superior officer. High feeling prevailed today, but the police stopped manifestation of hostility along the water front. Admiral Verelard says he will make rigid inquiry into the fighting of yesterday.

RIOTING IN MEXICO.

More Than One Hundred People Are Killed.

Austin, Texas, Nov. 19.—A dispatch from the city of Mexico says the government has demanded the arrest in Texas of Francisco Modero, charging that a manifesto sent by him from San Antonio, calling on the people to overthrow Diaz was responsible for the rioting at Pueblo. The dispatch says more than 100 people were killed in rioting. Advice from San Antonio say Modero has disappeared.

ANOTHER GUN EXPLOSION.

Two Men Killed and Two Others Injured.

Nashville, Nov. 19.—Two men were killed and two injured this morning in an explosion at Indian Head Proving Grounds, Md. The disaster was caused by the explosion of a five-inch gun with which experiments were being conducted. Lieut. Arthur G. Coffee, U. S. N., was one of those killed. The accident was the result of premature explosion of a charge placed in the gun.

MR. THEO. SKINNER DEAD.

Prominent Young Business Man Dies Suddenly.

The announcement this morning of the death of Mr. Theo. W. Skinner came as a shock and filled many hearts with sadness. While about his duties on the tobacco sales, Friday morning, Mr. Skinner was taken with a fainting spell caused by an attack of acute indigestion, and fell to the floor. He was carried to his home on College street and medical attention given, and he was thought to be getting along well through the day until about 5 o'clock in the afternoon, when he grew worse and continued to sink until the end came about 11 o'clock.

Mr. Skinner was 33 years of age, and came to Greenville from Danville about ten years ago to engage in the tobacco business here as a buyer and became prominent on the market, quickly winning his way into the confidence and esteem of those with whom he came in contact. At the time of his death he was in the employment of the Hughes-Meadow Company.

In May, 1904, he married Miss Emily Higgs and the wife and three small children, all boys, survive him. These have the heartfelt sympathy of all in their sorrow.

If relatives who are expected arrive this evening, the funeral service will be held at the grave in Cherry Hill cemetery at 2 o'clock Sunday afternoon, the body leaving the residence at 1.40.

PRESIDENT WATCHES GUNNER.

General Drill Arranged For His Benefit.

Aboard U. S. S. Tennessee, Nov. 19.—President Taft saw the Blue Jackets of the Tennessee and Montana go through a big gun drill today. A martial scene was set for the benefit of the president and who expressed delight at the efficiency of the men. Guns were trained for 10,000 yards but no shots were fired after the drill. President Taft congratulated the gun squad officers. The squadron approached the Cuban coast this morning for the president's inspection of the site at Guantanamo for the proposed naval base for protection of Panama canal.

The president is spending much time in his cabin working on his message to congress. It is undecided whether the president will land at Charleston or Fortress Monroe. He will speak before the Virginia school teachers at Richmond Wednesday.

Fatten the Fowls Now.

Poultry should be fattened quickly to be tender and juicy. If the fowls are kept in good condition during the summer and early fall, ten days or two weeks of liberal feeding should put them in excellent condition for marketing. After they have commenced to fatten give them all they can eat four times a day. Turkeys ought not to be confined for any length of time. If fed liberally while they have a free run they can be put in condition for marketing within ten days. There is the time of year when the flock should be culled closely. The undesirable fowls will bring better prices now than ever, and if kept throughout the winter will only be an expense and a detriment to the rest of the birds.—Uncle Jo, in Raleigh Progressive Farmer and Gazette.

Wilmington Aviator.

This is awful. Here was Charlotte trying to fly by means of an imported air ship last week and failed, when yesterday Raleigh did fly some by the same means when just the other day Wilmington had a "fly" in a machine invented and made in Wilmington and the man who flew was a Wilmington man. What is more, the machine flew at the very first trial and sailed away finely. This is a fearful slam on Charlotte and the other cosmopolitan cities of the State. Wilmington is waking up. It would be just like her to put makers of other machines out of business. We do hope her machine will not turn to and get wrecked and kill the aviator for Wilmington. Like Greensboro has no population to spare.—Morris Journal.

The Currency Question.

That few business men understand the currency problem is no reflection upon their intelligence or general astuteness. The question is so involved, so confused with intricate details, so befuddled with a mass of side issues, that not one man in ten thousand even knows our present banking system. As for the plans advanced during the past few years to cure our currency method of its undoubted evils, only those directly connected with the subject have any thorough knowledge of the details. The efforts of the monetary commission, appointed at Senator Aldrich's suggestion have not been entirely successful in educating our business men. There is still considerable doubt as to the actual functions of the proposed, central bank idea, or the "United Reserve Bank of the United States," as it is termed by Mr. Paul M. Warburg, and almost equal ignorance of the advantages claimed by Mr. D. A. Thompson for the asset currency plan. The currency problem is of vast importance to every citizen of the country, and especially so to the manufacturing and general business man. Further delay in improving our currency system means further exposure to the perils of a possible panic. The present method of handling the currency must be changed. Beginning with the December number, American Industries will publish a series of concise, explanatory, popularly written articles on the various plans suggested for improving the currency system. These articles, will in fact, serve as primers, and not as advanced text-books, and are intended as educational literature for the busy man.—American Industries.

Something of a Farmer.

Mr. Fisher Helms, an old soldier who went through the whole war and carries five wounds, lives in Buford township, and this year made with his own hands three bales of cotton and nine two-horse loads of corn. He is 69 years old and the mule he works is 14. According to the way the pension sharks are robbing the people of the country to the so-called northern soldiers, many of whom never fired a gun, the amount of fighting that old confederates like Mr. Helms did would be worth about \$250,000.—Morris Journal.

The Old Beliefs.
Dr. Woods Hutchinson has just rendered a questionable service to humanity through his refutation of the once popular belief that cats will kill babies by "sucking their breaths." Any man of 40 or over, or any woman for that matter, if she will admit the age, who was blest with pious parents and the companionship of the hired help on the farm, must certainly remember how, when a child, he or she listened with terror to tales of this sort, and how afterward the normally quiescent eyes of poor tabby seemed to shine with a strange ferocity.

But cats don't suck breaths. Neither we suppose, do toads cause warts, if you handle them. Anyhow, if they did, one had only to rub the warts with a piece of fat meat, and then bury the piece in a secluded place. This always caused the warts to go away, as every boy knows. Perhaps, too, the cow wouldn't give bloody milk if you killed a toad? And what if the cow lost her cud? Are these doctors going to say that it isn't in order to make her a new cud or a half mackerel or herring? Maybe the bluebirds don't go down to the lower regions in winter, and maybe if one only dared to drink sow's milk, we wouldn't be able to see the wind and that its color isn't red, if one chose to find out? And, to return to cows, that no better way of locating them than to catch a big granddaddy-long-legs, lay him down on a fence rail, and repeat several times, "Granddaddy-long-legs, which way has my cow gone?" Doesn't he always crimp himself up at first and then slowly and reluctantly put forth one of his long feelers, and wave it in the proper direction? Ask any boy that ever tried this unflinching method.

These are a few of the old-time beliefs that must stand or fall with the cat story. If one goes, all go. And how few these are that have taken root in the childish minds of this country may be realized by reading the long list of similar superstitions still held in veneration in rural England as preserved in S. Baring-Gould's "Red Spider."

The Old Woman's Home.

The Raleigh Evening Times takes occasion to endorse the proposition for a home for the old women of the Confederacy, "One thing the legislature should do," says The Times, "is to make provision for the wives of old soldiers who are at the Soldiers Home. Room should be provided for these women at the home and husband and wife should be taken care of together. These old people should not be separated now. The home certainly can't be much of a home to the man who has to leave the companion of a lifetime behind in order to enter its doors. The legislature should remedy this and make provision for both the old soldier and his wife, as is done in Mississippi and maybe other States." But coming to the main proposition, The Times says: "After that is done the work will not half be completed. There will still remain many more. And after all the veterans and their wives are gone there will still be many noble women who will find it impossible to provide for themselves in old age. A home for these women for all time would be a proper memorial to these other women who rendered their share of service in the great conflict between the States."

This gives The Chronicle occasion to say that the legislature will be asked for an appropriation to aid in building the home that was suggested by Mr. Morse. The Daughters of the Confederacy already have the project in hand and have raised about \$500. It is their purpose to solicit contributions from the people of this State and with that and the aid to be retained from the legislature (Carr, Horne and Boyden will be dependent upon to a considerable extent) build a home that will be a credit to North Carolina and that will be a joy to the declining days of a band of noble women. It is not generally known, but there are two women of the Confederacy in the Mecklenburg county home, an institution commonly known as the poor house, and there are doubtless others in other poor houses in the State.—Charlotte Chronicle

Horse Dentists.

In every large city there are now dentists who devote their entire attention to horses, and they are kept surprisingly busy the year round. The equine dentist is of course provided with special instruments for the extraction and filling of the teeth of animals needing attention. It is rather interesting to observe an operation in horse dentistry. One of the instruments, called a speculum, presents the appearance of an ivory handle and four small bars of nickel working on a ratchet and crossing one another in such a manner as to form a hollow square that can be made large or small by the turning of a screw. Setting this device to the proper size, the horse dentist will slip it gently into the suffering animal's mouth, which, during the operation, is kept partly open by a groom, and when the instrument is fitted upon, say, one of the back teeth the beast's mouth is kept open as wide as possible.—Harper's Weekly.

The Parson Bird.

Among the feathered inhabitants of New Zealand there is a bird called the parson bird, or tul. It is about the size and shape of a blackbird, but has a pair of delicate white tufts at its throat and is a glossy dark green otherwise, which looks black in the sunshine. It will break off in the middle of an exquisite melody and indulge in a strange melody of sounds which are impossible to describe, but if you can imagine "the combination of a cough, a laugh, a sneeze, with the smashing of a pane of glass," it will be some approach to the idea.

A Canary's Ears.

There is no outer ear, such as animals have, but simply a small opening which is covered by feathers. It is quite surprising that birds should possess the very acute hearing which they do, while lacking the fleshy flap which enables the animal's to catch sounds.—St. Nicholas
