ENDOWMENT MEREDITH COLLEGE

\$20,000 RAISED IN 30 MINUTES
AT CONVENTION

\$150,000 TO BE RAISED AT ONCE

The Report of Mr. Vann, of the College, Adopted, and After Stirring Speech by J. W. Bailey, the Raising of the Endowment Was Started With a Vim.

Hendersonville, Dec. 7.—Following a magnificent address by Josiah William Bailey, of Raleigh, the Baptist State convention, moved mightily started the endowment fund for Meredith College. Before the taking of subscriptions, Rev. Livingston Johnson, of Raleigh led the convention in a special prayer for the movement.

This has been a glorious day in the first \$1,000 for the fund, Noah Biggs, of Scotland Neck, followed with \$5,000; C. J. Hunter, of Raleigh, followed with \$1,000; W. N. Jones, of Raleigh, gave \$1,000. Other subscriptions followed rapidly, and \$20,000 was promised in 30 minutes.

This has been a glorious day in the Baptist State Convention. It was the second day's session and opened this morning with a soul-stirring devotional service led by Rev. C. E. Maddy, of Statesville and during the day the convention heard a number of splendid reports and several epoch-making addresses. This morning Dr. Willingham of Richmond, on Foreign Missions; this afternoon Dr. Robertson of Louisville, on Ministerial Education, and tonight the climax came when J. W. Bailey, of Raleigh, in a magnificent address, opened the campaign for the endowment of Meredith College located at Raleigh.

The report of the trustees of Meredith College was read tonight and after outlining the success of this institution during the year the report called on the convention at the session to launch the campaign of raising \$150,000 for the endowment of the college. The General Educational Board has proposed to contribute \$50,000 if the Baptists of the state shall raise \$100,000.

The convention unanimously adopted the report, and Dr. R. T. Vann, after a short introductory address, introduced Mr. J. W. Bailey, of Raleigh.

The question of making changes in the date of the convention meeting came up this afternoon. The entire question was referred to a committee consisting of W. I. Johnson, Wake Forest; John E. Ray, Raleigh; E. P. Hobbgood, Oxford; C. L. Graves, Newbern; and T. W. Chambliss, Wadesboro. This committee is to formulate plans for increasing the attendance upon the convention, and report next year. The attendance upon the convention has been growing smaller year by year, and Dr. Johnson, of Wake Forest, in his address, stated that the denomination was facing a crisis and some steps must be taken to change the conditions.

Rev. J. M. Arnette, corresponding secretary of the Aged Ministers Relief Board, read the report of the board, which after discussion, was adopted. The report shows that 24 aged ministers were assisted during the year by the funds of the board. The convention met at Wadesboro five new beneficiaries were received by the board, and three of those on the board previous to that time have died. The board reported that nearly three-fifths of the Baptist churches of North Carolina do not contribute to this worthy cause. This report was discussed by Rev. J. M. Arnette Archibald Johnson and Rev. F. M. Jordan.

Mr. Jordan is one of the pioneer preachers of this state, and in his address he referred to the fact that with his own hands he had baptized more than five thousand people, having administered baptism in every stream of any importance in the State.

Dr. A. T. Robertson, of the Southern Baptist Theological Seminary, delivered a very interesting address this afternoon on the subject of "Ministerial Education," and following the address an offering was made for the seminary amounting to \$1,350.

The subject of Foreign Missions was considered at the morning session, and addresses were delivered by T. B. Ray, C. T. Willingham and R. J. Willingham, representatives of the

THE BOOKS WERE DESTROYED.

Legislative Investigating Committee is Blocked.

New York Dec. 8.—The startling fact that all ledgers, check books and other material relating to money transactions of the Metropolitan Turf Association had been destroyed in April, 1908, was testified to today before the legislative investigating committee by J. FIRE AT CAROLINA BEACH.

Hotel, Pavilion and a Residence Destroyed.

Wilmington, N. C., Dec. 8.—Incendiary fire at Carolina Beach late last night destroyed hotel and pavilion the property of Capt. John W. Harper, of this city, and a private residence. The loss is \$15,000 with but little insurance. There were no people staying at the beach and no occasion for any fire in any of the buildings, hence the general opinion is that the fire was incendiary. The hotel will be rebuilt at once.

FUNERAL OF MRS. EDDY.

Was Marked by The Utmost Simplicity—No Music or Flowers.

Boston, Dec. 8.—The funeral of Mrs. Mary Baker Eddy took place today. It was marked by the utmost simplicity. There was neither music nor flowers and only the burial ritual of the Christian Science church was read. The body was borne from the Eddy mansion on Chestnut Hill and placed in the receiving tomb in Mt. Auburn cemetery at Cambridge. Judge Clifford P. Smith, first reader of the mother church, had charge of services.

Steamers Collide at Sea.

London, Dec. 8.—The British steamer Rook rammed and sank the British steamer Blackburn today and 39 persons are reported missing. The Blackburn went down so quickly that practically all on board were forced to jump in the water. Seventeen were picked up by the Brook's boats there were 56 persons aboard the lost steamer.

Cotton Ginned to December 1st.

C., 8.—The cotton ginning report announced at the census bureau today shows 10,138,986 bales ginned from the growth of 1910 to December 1st, compared with 8,876,886 for 1909, and 11,008,661 for 1908. The percentage of the last two crops ginned to December 1st is for 1909 88.1, for 1908 84.1.

English Elections.

London, Dec. 8.—Polling in the general elections went on today in 40 divisions. At noon the totals elected stood: Unionists, 190; Liberals 124; Laborites, 24; Nationalists, 4. The Unionists displayed much strength at today's voting.

Foreign Mission Board at Richmond.

Dr. R. J. Willingham, the corresponding secretary of the board delivered what had been stated to be the best address on the subject ever heard at the State Convention. He moved his audience very deeply.

The report of the board of State Missions, read this morning, shows the following offerings for the current year: State missions, \$41,428.46; foreign missions, \$38,882.08; home missions, \$21,766.07; education, \$5,068.61; ministerial relief, \$4,448.65; Sunday schools, \$1,817.47; orphanage, \$52,998.00. The offering for State missions shows a gain of \$2,100.51. The board has on the roll 1,148 missions.

BARRETT GIVES ADVICE.

Urges Members to Strengthen Local Organizations.

On his way one from the Pacific coast, Chas. S. Barrett, president of the Farmers union issued the following statement to the officers and members:

I believe in clubs, not the kind you carry in your hand for the other fellow, but the kind you join with him for your mutual benefit.

If I had my way, the legislatures of every state would pass laws making it compulsory for the farmers in every military district to organize clubs in their neighborhoods for intellectual, moral, economic and financial improvement. After that I'd have a game warden appointed for each state to see that the club stayed organized.

The best "clubs" I know of is the local organization of the Farmers' union. Get every non-member around you to join, and then instill in each local the spirit of harmony and pull together.

Even outside the union, you can organize improvement associations. Let the members—and there couldn't be too many, for then it would be unwieldy—gather once a week at different homes, and make out plans to beautify their respective premises, and houses, to get good roads, rural phone union warehouses, co-operative enterprises generally, more and better schools, more and better churches.

Discuss also the best breed of hogs and cattle for your special neighborhood, the best method of curing meat, the best varieties of poultry, the most expedient diversification, how to bring in and cure the grumblers and how to keep other grumblers from developing. Let the women-folk in, too. You cannot do much without their co-operation, and since they are making your homes they deserve consultation.—Atlanta Journal.

The Disease Among Stock.

Dr. W. G. Christman, State veterinarian, who was called to Statesville to investigate the deaths among horses and cattle in this section supposed to be due to a dangerous contagious disease made investigations Friday in a number of cases and gave it as his opinion that the disease is not epidemic and there is no cause for alarm. The disease which is an intestinal derangement is purely local, said the veterinarian, and is contagious only by close contact. It has probably been started among the stock on the farms affected by damaged food stuffs and the general condition of the stock at the time. The local veterinarians seem to have the situation well in hand and no more deaths have occurred. Mr. John Gibson's mules, which were in a serious condition, are now improving, and are thought to be out of danger and other cases are being treated effectively by the local veterinarians.—Statesville Landmark.

Bold Express Robbery at Burgaw—Commander Robert Platt, U. S. N. Dead—Brutal Murder at Varona—Little Tot Refuses to Draw Jury at Durham—Robbery in Jones County.

Little Buck Valden, five years old, was sent for and produced in court to draw the grand jury. When the hat containing the names to be drawn was placed before him, he refused to draw a single name, on the plea that "everybody is looking at me." No amount of persuasion would move him. Money was offered, but to no effect. Clerk Green put a piece in his pocket, where he kept his hands buried, but he took it out, and laid it on the table saying "I don't want your money. I've got money at home. I've got eight cents." He was immovable, and delayed the court forty-five minutes. Finally they had to send for another boy. Judge C. C. Lyon took the proceedings very patiently. It was an incident unprecedented in court circles in this state. But Durham is always doing something out of the ordinary.—Durham Herald.

While the people at the Goldsboro Lumber Company's camp, near the Jones and Lenoir county line, were at supper Tuesday evening, some one entered one of the shanties and stole \$3600.00, belonging to Mrs. Bettie Watson and Mr. Lowry, both of whom are in the employ of the company. The money was sewed up in the bed tick of Mrs. Watson's room, and the thief must have been familiar with the fact.—Kinston Free Press.

One of the most brutal murders ever committed in Onslow county occurred at Varona Monday, when Tom Hardison colored, was shot to death by his 16-year-old son, with whom the father had remonstrated for wearing his best clothes on going out to work. A report says that the boy cursed his father shamefully and then took up a gun and shot him down like a dog. The negro boy was captured and placed in jail.—Kinston Free Press.

Information reached here Tuesday of a bold robbery which was effected Monday night at the office of the Southern Express Company at Burgaw. It was stated that the entrance was effected after the office had been closed for the day. The office adjoins that of the Atlantic Coast Line Railroad Company. The robbers secured several jugs which are said to have contained whiskey, and a number of suits of ready-made clothing. Nothing else was missed. However, it is possible that other things may have been taken also. The robbery was discovered early Tuesday morning.—Mt. Olive Tribune.

Durham, Dec. 7.—At a meeting last night of the Elks, a committee was appointed to select a site for the new \$50,000 temple which the order means to build at an early date.

Washington, Dec. 7.—Commander Robert Platt, U. S. N., retired, died at his home here late today following an attack of cerebral embolism with which he was stricken three weeks ago. Commander Platt was a native of North Carolina.

Women's Clubs.

It takes a woman to talk to women, provided she is in a place where she is sure to be respected, thus avoiding a hair-pulling. The other day the Rev. Mr. Aked, pastor of Fifth Avenue Baptist church in New York, took a fall or two out of men's clubs and now Mrs. Shannon Cummings Jones, a lecturer, has been talking straight goods to the women who belong to clubs. She is real rough. "What is far more objectionable," says she, speaking of the lack of time to devote to children "is the fact that many of the club women will not have children. They will not bear the pain and suffering that motherhood involves. They contemplate for months the trouble and anxiety a child brings; the self-sacrifices that are demanded of a mother and the care that a child must have and they refuse to go through it all. Selfishness? Oh, yes; but selfishness seems to rule the world today. Take the average woman with two or three children—the woman who belongs to seven or eight clubs (and when a woman joins the throng of club women she is seldom content with one or two organizations.) It is a case of continual go morning, noon and night. The child goes to school at half past eight o'clock. Sometimes before the mother arises. From then until 3 o'clock it remains under the care of a teacher. Returning home at half-past three o'clock of finds the mother out at a club meeting, a luncheon, or a bridge party. Sometimes it becomes retreat, even morbid, and brooding, and develops a melancholy nature. Often it confides in the servant's who, in many cases, are illiterate and uninterested. Sometimes, feeling sorry for the little one, a mother love for the child enkindles the domestic and in her own way she comforts the youngster, shows him the difference between right and wrong and, if she has time, will even take the trouble to establish a principle up to which the child will look for the rest of his life."

Were a man—unless he was awfully good looking and sweet—to say this the women could crucify him. No doubt they winced when this lady with the hyphenated name pumped it into them, but there was no rice call and the presumption is that she is still living and able to talk. Taxing Improvement Bonds.

The Burghaw Chronicle is very much interested in the subject of exempting drainage bonds from taxation and presents the reasons for its position in belief and convincing shape. "We hold," it declares, "that all internal improvement bonds, where the public is directly benefited, as for drainage or good roads, should be exempt from taxation. To exempt such bonds from taxation simply means a saving of this exempted tax to the farmers and land owners. The formation of drainage districts and the driving of good roads increase the value of lands, which in turn will increase the public revenue to a far greater extent than is represented by the mere tax on the bonds. In the case of drainage the improvement tends directly to decrease the prevalence of malaria, typhoid, and numerous other diseases thereby materially contributing to the health of the people. We trust that the legislature will give the relief demanded, and thus encourage these great movements for progress now on foot in the state."

The Chronicle's argument is sound. Drainage and good roads bonds are not any too easy to market even with the tax exemption, and it would seem that this much state aid to such enterprises would be consistent with wise constructive policy. It is not the locality alone which profits from the improvements referred to but the Commonwealth as a whole. The main objection raised against the proposal at the recent drainage convention in Wilmington argued that such exemption "smacked of class legislation in the interest of predatory wealth." This objection is not valid even on the most limited view of the situation, inasmuch as the property-owners affected include many classes and it is these rather than the capitalist purchasers who will benefit primarily from such exemption. From the standpoint of state progress the argument is still weaker. As few obstacles as possible should be allowed to remain in the path of the movement for internal improvement, and the hindrance of drainage and good roads on account of apprehension lest capital derive some advantage can only be the result of hopelessly confused ideas upon the subject.—Charlotte Observer.

Kicking Up A Row.

What is all this we hear about the state being blocked in its great Matanuskeet drainage project by private interests? We thought the wisdom of that project was so well understood and the benefits to be derived therefrom so well recognized by everybody that there would be no further attempt by anyone to hinder the work. And now, just when the state is ready to begin the actual work of draining the lake a great lumber company, which has made hundreds of thousands of dollars out of eastern North Carolina, and so far as we know, has put no money back into the state, bids up and blocks the state with the threat of long litigation because it owns 10,000 acres of land in the drainage district and would have to pay thereon, if the drainage act is carried out, a tax of one dollar an acre. Twice before has this corporation blocked the work, we believe, and each time it has lost in the lower courts. Now it threatens to carry the matter through all the courts of the land. It would probably lose again, but it would at the same time be putting the state to great expense and infinite delay. The improvements the state contemplates are worth \$300,000 to the state and worth a million to Hyde county, it has been estimated. In other words, if this great lumber company is to have its way the people of the state will be cheated out of one million three hundred thousand dollars, to save that company a direct outlay of ten thousand dollars. But this big company would lose nothing in the end, for like the rest of those people in the drainage district it would get its part in that one million increase in the valuation of Hyde county property.

If the state must fight in this matter we hope it will go into it armed to lick the trouble-makers to a frazzle, do it as quickly as possible and then go ahead and drain the lake. —Raleigh Times

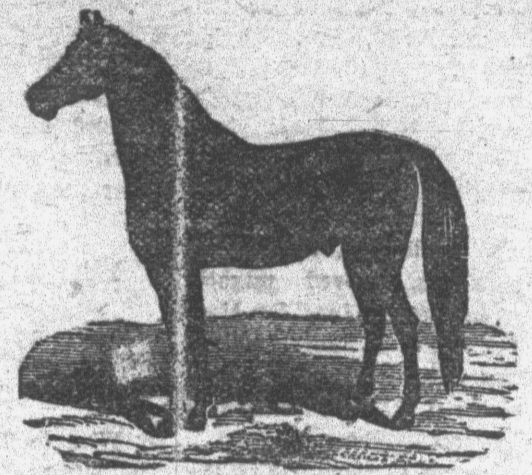

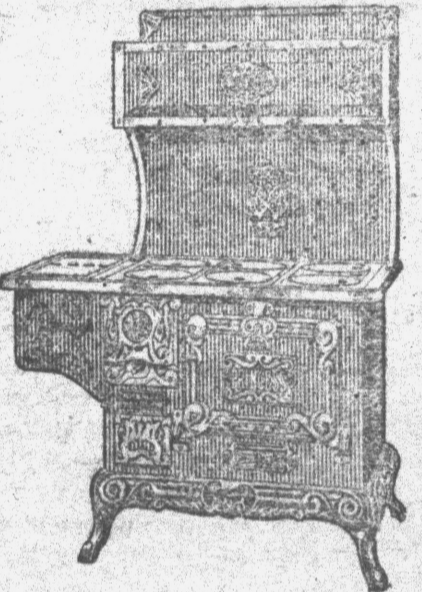

LOCUST PLAGUES.

**Onslaught of the Ravenous Tribe
During an Invasion.**
GLUTTONS BY THE MILLIONS.
The Devastating Armies Fly in Clouds
Dense Enough to Obscure the Light
of the Sun—The Hoppers That Come
After the Crops Are Devoured.
There are several species or varieties
of the migratory locust, which are
mostly to be found in dry, semitropical
countries, such as the south of Eu-
rope, Egypt, Syria and Morocco, for
their native home seems to be in the
countries bordering on the Mediterrane-
an, though migratory locusts are to
be found in regions as remote as South
Africa and South America, where they
form a veritable scourge to the agri-
cultivists. In Argentina, especially
the northern half of the country, they
are very destructive, for they will an-
nihilate the farmer's entire crop in a
few hours.
A locust invasion, writes John D.
Leckie in Chambers' Journal, is an
event not easily forgotten. The first
sign of the approaching incursion is
usually a long, dark cloud low on the
horizon. But the dark cloud is no
forerunner of rain. Instead of the
precious liquid, which the farmer has
probably long expected in vain, it por-
tends the approach of his greatest en-
emy, the omnivorous locust.
As the dark cloud comes nearer it is
seen to be composed of countless mil-
lions of locusts on whirring wings.
Soon the cloud appears overhead and
is sufficiently thick to obscure the sun,
which is only seen opaquely, as
through a mist, although the sky is
cloudless and the air clear.
Now we are in the midst of a dense
swarm of flying, whirring locusts,
which dash into our faces, enter our
houses and fill our rooms with their
presence. The air is simply alive with
them. All open wells must be instan-
tly covered or they will be polluted.
Fowls and turkeys welcome the ad-
vancing hordes. They simply fatten on
the locusts as they run around and
gobble them up. But this is no bless-
ing to the farmer—far from it, for the
flesh of poultry becomes so tainted by
this form of diet as to be quite un-
pleasant to eat.
So well is this fact known that as
soon as the locusts make their appear-
ance in the locality the price of eggs
drops to one-half or one-third of their
former figure, and even then there are
few buyers. All the animals about the
farmyard seem to be affected adverse-
ly, for even the horses have a strong
aversion to eat grass which has been
polluted by the presence of locusts, and
unless very hungry they will not touch
it.
The advance of the locusts takes
place as follows: First a few pioneers,
the advance guard of the vast army,
then the main body of the army, a host
which is as invincible as it is destruc-
tive. All true locusts are migratory by
nature, for the simple reason that, be-
ing gregarious in their habits, it would
be impossible for them to exist with-
out continual migration.
The ground on which they settle is
completely cleared in a few hours, and
they must perforce seek other fields
and pastures new, where they can re-
peat their depredations. For the same
reason the destruction which they ef-
fect is purely local. One district may be
completely devastated, while another
a few miles away is altogether spared
from their presence.
When the locusts have eaten their
fill the females commence to deposit
their eggs, which they do by making
an opening in the ground, in which
the eggs are laid. The infant locusts
soon make their appearance, scarcely
so large as a pea, hopping about in
countless swarms. In this stage of
their existence they have no wings,
but progress by hopping. While in
this state—that is, before their wings
are developed—they must be ruthlessly
destroyed.
Long trenches are dug, into which
the "hoppers" are driven by rows of
men, women and boys armed with
branches of trees, with which they
beat the ground, driving the insects in
the direction of the trenches. On the
opposite sides of the trenches sheets of
galvanized iron are placed upright so
as to form an effectual barrier.
On arriving at the trenches the "hop-
pers" fall into them and cannot easily
make their way out, especially as their
progress is barred by the wall of gal-
vanized iron in front of them, the
smooth surface of which affords them
no foothold.
The trenches are soon filled with mil-
lions of young "hoppers," the weight
of those above crushing to death the
under strata of their fellows. Earth
is then shoveled on the top of the
seething mass of insects, and they are
thus smothered and killed.
This is the most effective method of
exterminating the locusts, but in order
to insure the success of the operation
it is necessary that the attempt should
be properly organized and that all the
neighbors should act in concert.

LUCKY SWISS HOUSEWIFE.
She Lets the Rain Do All the Family
Washing For Her.
Swiss methods of laundering are origi-
nal, practical and labor saving. The
women there have learned well how to
make the best use of their opportuni-
ties with the least exertion. How they
use the tourists every one who has
traveled in the country of the Alps
knows. They also know how to make
nature do their housework.
In most of the towns everything that
is washed or cleaned is washed or
cleaned in one of the big watering
troughs that stand at regular intervals
along the main thoroughfares. Into it
goes everything from potatoes to hu-
man beings, and the only sanitary re-
gulation existent is that it must be
cleaned out with a large broom made
of brush or twigs after the potatoes
have had their bath. But when it
rains then everything else gives way
to the family wash, no matter if it is
Thursday or Sunday or Saturday or
Wednesday, for in Switzerland they
seek the rainy days for wash days, in-
stead of deploring a cloudy Monday.
The steady downpour provides run-
ning water in the village washtub.
Into the sweeping current the family
linen goes, and there it is whirled and
twirled about until every speck of dirt
is thoroughly rinsed away. The scrub-
bing board is not put into commission
at all. Occasionally the good housewife,
protected under the family umbrella
held over her head by one of her
youngsters, who is allowed to enjoy
the drips from that same umbrella,
takes a look at her wash and encour-
ages it with a gentle poke with her
husband's best cane. But the rest of
the day she enjoys to the full in her
snug chalet, while the elements do her
work. In fact, with her conscience at
rest that her day's tasks will be done,
she can spend her time gossiping with
her neighbor, whose conscience is also
at peace.
On the next day the wash goes
through a process of bluing and starch-
ing—all in that same basin—and final-
ly, when the sun shines, it is laid
out on the wonderful green grass of
the Swiss meadow and is there bleach-
ed to a snowy whiteness. If the glaci-
ers and the landslides were to ac-
commodate her by falling down over
her wash and ironing it out without
soiling the Swiss housewife would not
be at all surprised. In fact, it is not
to be doubted that she now regards as
an oversight the failure of Dame Na-
ture to provide an ironing board.—New
York Post.
