OPPOSE HEAVY APPROPRIATIONS

RESOLUTION ADOPTED BY BAPTIST STATE CONVENTION

AGAINST THIS TO STATE COLLEGES

The Convention Directs The State Board of Missions to Increase Appropriations by 25 Per Cent—Will Urge Legislation Against Social Clubs and Near-Beer Saloons.

Hendersonville, Dec. 8.—At the conclusion tonight of a magnificent speech by Dr. W. L. Potent, president of Wake Forest College—an address forceful, eloquent and a masterful plea for the denominational college, the convention was strongly moved. Rev. Livingston Johnson immediately offered a resolution concerning the proposed State bond issue for State colleges. The resolution was unanimously adopted and greeted with a chorus of "Amen."

The resolution is as follows: "Whereas, we learn that an effort will be made to have the next legislature pass a bill for the benefit of the State colleges; and

Whereas, we do not oppose a reasonable appropriation for the support of these institutions but,

Whereas, they are now receiving liberal appropriations amounting to \$179 per pupil, while the common schools receive but \$4 per pupil.

Whereas, as the denominational colleges, which are now educating twice as many young people as the State colleges are forced to increase their endowment to meet the competition created by the present appropriations to the State colleges, and

Whereas, the large appropriations to these institutions, made possible by a bond issue, would seriously cripple our denominational colleges; and therefore, be it

Resolved, That we, delegates to the Baptist State Convention, a body representing 224,000 Baptists, do most earnestly protest against any abnormally large appropriation, such as certainly would follow a bond issue."

Dr. V. I. Masters, of Atlanta, delivered a splendid address on "Home Missions."

President Dowd then introduced Dr. A. J. Vialin, of Canada, who touchingly told the story of the conditions and needs of the world in the Far East.

The third days session of the North Carolina Baptist Convention opened with soul-stirring devotional service led by Evangelist Geo. C. Cates, who is conducting a remarkable revival meeting here.

Rev. Charles E. Maddy of Statesville and Rev. Livingston Johnson, of Raleigh, delivered masterful addresses on State Missions, and so splendidly did they succeed in leading the convention that the State Mission Board was instructed to increase its missions appropriations 25 per cent, and exceed the coming \$50,000 for the evangelization of the State.

During the afternoon the convention spent an hour in a memorial service for those who died during the year.

The Biblical Recorder, the organ of the church, came in for discussion during the afternoon, and Rev. C. Whitlock, of Wilmington; Rev. H. C. Moore, Rev. S. F. Conrad, of Charlotte; Rev. T. W. Chambliss, of Wadesboro with others, addressed the convention.

Strong resolutions were adopted urging the next legislature to take steps to abolish the social club and near-beer saloon.

Tonight President W. C. Dowd appointed the following speakers for 1911: Foreign Missions, Rev. H. H. Hulton, D. D., Charlotte; Home Missions, Rev. W. R. L. Smith, Chapel Hill; orphanage, Rev. O. L. Powers, High Point; Sunday schools, Rev. C. H. Durham, Lumberton; Obituaries, Rev. A. F. Conrad, of Charlotte; State Missions, Rev. W. A. Johnson, Wake Forest; Biblical Recorder, Rev. W. C. Blanchard, Wilson; Ministerial Education, Rev. G. T. Watkins, Goldsboro.

The convention accepted the invitation of Brown Memorial church at Winston-Salem, and will hold its next session in the Twin City in 1911. Rev. C. L. Graves, of New Bern, will preach the introductory sermon and Rev. W. R. L. Smith, of Chapel Hill, is the alternate.

Business Continues Fairly Active With Collection Fair.

Richmond, Va., Dec. 9.—Bradstreet's tomorrow will say for Richmond and vicinity: Trade in most lines is of a satisfactory volume and traders as a rule have optimistic views for the near future. Bad weather has retarded the marketing of loose tobacco in the sun-cured belt and slightly less money is in circulation locally. To Erect a Monument to Patrick Livingston Murphy.

Dr. Murphy was justly regarded as one of the foremost alienists of our country, and was undoubtedly one of North Carolina's great men. He did great things for our state, in his remarkable work for our most grievously afflicted class. By his ability as a physician, his rare execution and administrative powers, his whole-hearted and untiring devotion to the successful management of the institution, and particularly to the welfare of its inmates, and by the honesty and sincerity of his character, he so impressed himself and his plans for the advancement of the great and beneficent cause in which his heart and life were bound up upon his board of directors, upon the legislature, and upon the people as to bring about the result now to be seen in the magnificent institution which stands unrivaled in the South. His work was an inspiration, not only for the alleviation of the sufferings of the insane, but also for the doing of greater things on other lines. He was no small factor in the upbuilding of our State.

It is proposed to erect to his memory, a bronze statue, to be placed in front of the magnificent main building overlooking to beautiful grounds, with its velvet lawn and noble trees which were his pride and joy in life.

The Shady Lawyer.

A long delayed campaign against the shady lawyer, that buzzard of civilization, seems to be under way in New York, and on Thursday of this week no fewer than three such fellows were bought to book. One came into court with a silly charge of mental incompetency against a man obviously sane. The charge was dismissed and the lawyer was ordered to pay the whole costs of the proceeding, not with his client's money, but with his own money. Another, seeking to postpone a case in order to have it tried by an "easy" judge, was exposed and denounced from the bench by a judge less complaisant, and will face the appellate Division later on. His client, poor victim, went to jail. A third, detected in an effort to conceal a witness, was arranged to prepare himself for a hearing on charges of contempt of court, neglect of duty, and obstructing justice. A heavy fine disbarment and perhaps even a prison sentence menace him.

A good day's work. Three shysters laid by the heels. A pity it is that every day does not see a similar onslaught upon such obstructionists and obfuscators, such masters of chicanery and downright frauds. Theoretically a lawyer is an officer of the court. Like the judge and the jury he is under oath to uphold the majesty of the law, to combat all attempts to evade and make a mock of it, to keep the ideal of exact and unyielding justice ever before him. But, as a matter of fact, he sometimes does nothing of the sort. His efforts are concentrated, not upon carrying out the law, but upon evading and nullifying the law, and to that enterprise he occasionally brings a talent for deceit which would do credit to a green-goods man.

Such shysters do a community incalculable harm, and it is to the interest of us all that they be kept under close surveillance and promptly punished when detected in their chicaneries. Their fellow-lawyers have weapons against them which, if relentlessly employed, would tend to keep them in order, but it is upon the bench that the responsibility for their prosperity really rests. The fact that shysters are so seldom exposed and disbarred is a proof, indeed that judges constantly neglect an important part of their duty.—Baltimore Sun.

STREET HANDS DON'T WORK.

The day laborers employed by the town on street and like work have struck for higher wages, they were paid a dollar a day, now they insist upon a quarter more. Some of them do not do more than a quarter's worth of work in a day. Thus far the authorities have not "seen the raise."—Tarboro Southerner.

The reference that some of the hands do not do more than a quarter's worth of work in a day, points out a condition that exists in most of the smaller towns in having public work done. We once heard a business man in Greenville say that he could get as much done for fifty cents as the town could get done for a dollar by which he meant that an individual could get twice as much done for the same money as the town could get. Of course there is a reason for this, and it lies in the fact that when an individual hires hands to work he usually looks after them and sees that they do it, while hands that go out to work for the town as a rule have no one to look after them and only do what they feel like doing, and the average street hand only feels like doing as little as possible. It would pay any town having much street work to employ a competent man to take charge of the hands, one who knows how the work should be done and who will make the hands earn their pay.

The Supreme court of the state has rendered a decision against roads requiring holders of mileage books to have mileage exchanged for tickets before they go upon the trains. In rendering an opinion, Chief Justice Clark said, "the requirement that the holders of a mileage book shall present it and obtain a ticket thereon, is an unreasonable regulation and therefore void."

Eastern Water Powers.

The traction deal recently consummated in this city excited widespread interest throughout the state and no portion of this comment has been more illuminating than that contained in the columns of our contemporaries to the eastward. The acquisition by the Southern Power Company of the trolley interests in Charlotte has served to call the attention of the eastern counties to the possibilities of waterpower development as never before. The Greenville Reflector thinks that the falls of the Roanoke river, above Weldon and those of the Tar near Rocky Mount should be made to furnish electricity for the entire eastern section of North Carolina. Commenting on this suggestion, The Kingston Free Press says: "The electric growth of the west will emphasize the importance of a development of these and other eastern water powers. It will be found that electrical development in the east, when fairly

under way, will proceed with great rapidity."

This desire of the east to develop its water power is noteworthy and should be encouraged in every possible way. Surveys would probably develop other sources of supply in addition to the two mentioned by The Reflector, and the art of long-distance transmission has been perfected to such a degree that widely scattered falls could be brought into co-operation in the matter of supplying energy. The development of such resources if handled with business skill and foresight, would make a contribution to the prosperity of that section which it would be well-nigh impossible to overestimate.—Charlotte Observer.

Women Braver Than Men.

It has always been maintained that women were more courageous at standing physical pain than men, but it is a new claim that they are braver more careless of their own safety, quicker to act than men in an emergency. Yet according to Herbert Longfellow, chief of the United States Volunteer Life-Saving Corps in the January Designer, not only women but children, are braver than men. He is quoted as saying:

It has been my experience that women and children are more heroic than men. They are more impetuous. A man thinks of his responsibility, of those dependent on him, and of his own personal well-being. Women and children think of nothing but the human life in peril. They act on the moment, so quickly that fear has no chance to sway them at all. It is in the nature of things that men are more frequently at the post of danger. Yet when opportunity presents itself a far larger percentage of women and children will risk their lives. Heroes are not those who deliberate upon their chances. Heroes are those who rush to the rescue without considering themselves at all. This women and children do."

With the completion of the deep waterway from Beaufort to Pamlico Sound Morehead City, Beaufort and Oriental will celebrate the event in an elaborate and appropriate manner. 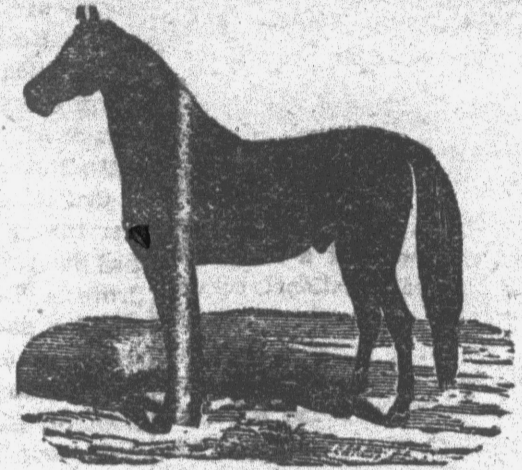

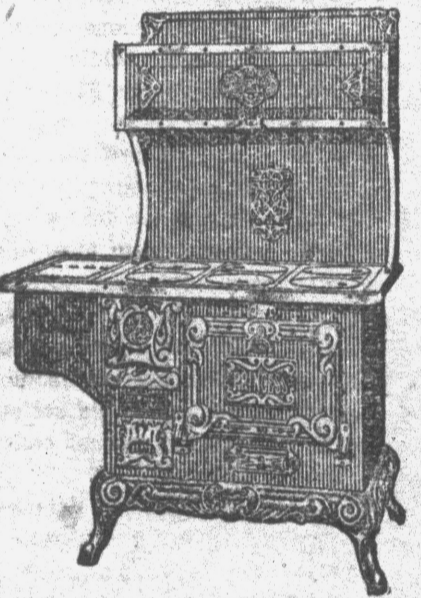

Two Dimensional Vision.

Most people do not know that they ought to be very thankful for having both eyes in one plane instead of having them one on each side of the head. If the latter obtained no one could tell that an object had more than two dimensions until experience and the sense of touch educated the brain to it. Any one can try it for himself. Shut one eye and look at different objects. They appear flat. With binocular vision two views of each object are obtained and neither is exactly like the other, so the idea of depth comes in.

The most easily shown example of the difference is as follows: Take a ring and hold it about two feet from the eye. With one eye closed it will take at least five trials to thrust a pencil through the ring, whereas with both eyes open it can be done on the first trial.

All animals with eyes on opposite sides of the head labor under this disadvantage, as do all insects. It is called two dimensional vision, as the idea of depth is not possible. All this is on account of the image thrown on the retina of the eye being in only two dimensions.—Philadelphia Press.

Woodcarvers of Burma.

The woodcarvers of Burma are the most skilled in the world. They select and cut the best logs along the Irrawaddy river in the dry season, and these are thrown into the shrunken stream. There they lie until the freshets of the rainy season lift them and bear them down to the populous cities below.

Then huge elephants are employed to drag the heavy logs from the stream and take them to the saw-mills. They are then worked up into timbers suitable for the woodcarvers. The carvers use the figure of Buddha or some other emblem concerning the Buddhist worship in the greater part. The details are worked out in a careful way.

Stems of boats are carved in an elaborate manner, and some of them would be worth a fortune in this country. The prow of the boat is usually ornamented with a figurehead of very elaborate carving. The art of woodcarving is handed down in the families in Burma, the children being taught by their fathers.—Wichita Eagle.

Tale of a Snake.

"Before he went fishin'," said the town story teller, "he swallowed 'bout a pint an' half of snake bite remedy, an' of course you know what that is. Well, after the snake bit him the reptile cut all sorts of capers, kaze the remedy went straight to its head. Last thing it tried to do wuz to swaller its tail, an' it got itself in the form of a hoop, an' I'm a liar ef the children didn't roll it around all day!"—Atlanta Constitution.

pecially on clay lands and follow
with cover crops wherever possible.
(2) Drain wet lands; make ter-
races and ditches, if you must have
them so that they can be worked
over; get out stumps, brushes and
stones; repair fences and outbuild-
ings.
(3) Lay out your work for next
year, planting crops with special re-
ference to the building up of soil fer-
tility.
(4) See that all farm animals are
well housed, that they are fed on the
feed they need, and that they are
kept comfortable.
(5) Haul out manure as made, if
possible; buckle down to the study
of fertilizing problems and see if
you can't get more for your fertilizer
money next year.
(6) Kill the hogs as soon as they
become fat and the weather admits;
it doesn't pay to keep a pig after he
has reached the "killing stage."
(7) Get catalogs from the im-
plement makers and study up on farm
machinery; try to arrange to do
cheaper work next year.
(8) Keep an eye on your school;
co-operate with the teacher; help and
encourage the children in every way
you can.
(9) Plan a reading course for the
winter evenings, one which will be
helpful to you and in which the
whole family can become interested.
(10) Get ready for Christmas;
don't make it a time of self-indul-
gence or of reckless spending, but a
time of gladness for the little folks
and of good-will to all men.—Raleigh
Progressive Farmer and Gazette.
