## "HOW TO KEEP GREENVILLE CLEAN"

REV. J. H. SHORE PREACHES ON CIVIC RIGHTEOUSNESS

TWO STRONG SERMONS ON SUNDAY

He Points Out Man's Duty to Government—Commends Officers of Greenville and Newspapers in Their Stand for Law Observance and Urged Their Support.

There are people in every community who will argue that it is the business of a preacher to preach the gospel. That is true. They should and do preach the gospel. At the same time the preacher who does not take interest in the government and civic righteousness of the community he serves, and fails to instruct his people along these lines, is not up to the full measure of his duty and opportunity. The preacher should have an interest in all things—moral, civil, political, educational, and business—that affect the welfare of the community in which he lives.

Rev. J. H. Shore, pastor of the Methodist church, is one who takes interest in these things. He has several times preached forceful sermons along the line of civic righteousness and a good effect upon the community has resulted. He preached two such sermons Sunday, using the same text for both, "Render therefore unto Caesar the things which are Caesar's and unto God the things that are God's." In these sermons he strongly emphasized man's duty to his government, from nation down to municipality, and the importance of having men who are clean in character and life to administer the affairs of government. He said there is a vast difference in a statesman and a mere politician. Some declare that in voting you do not vote for men but for principles, yet he failed to see how principles can be expressed and carried out except through men.

Mr. Shore also referred to improved conditions in Greenville that had passed under his observation since he came here two years ago, and what he had been told existed here in previous years. He commended the course of the mayor and aldermen for the stand they have taken toward having the law observed, and those newspapers, here and elsewhere, that align themselves with the forces for civic righteousness. He made especial reference to the large number of North Carolina newspapers that will not carry liquor advertisements in their columns, and said the people should give their support to the officers and newspapers that take a stand for morality and good government.

### EXPLOSION IN NEW YORK.

Kills Twenty-Four and Causes a Panic.

By Wire to The Reflector. New York, Dec. 19.—With a detonation which was heard for a mile and a half, a boiler in the new power house of the Grand Central station exploded this morning. The explosion of the boiler was followed by the explosion of a gas main under the building. Workmen who filled the building were trapped by fire and the explosion overturned a rush hour street car near by. At 9.30 twenty-four bodies had been recovered. At that time estimates of the dead varied, the police believing they would number twenty-five. Windows in all buildings for blocks away were broken and panic reigned in all crowded elevator trains. Street cars were lifted from the rails and pedestrians thought an earthquake had struck the city. The explosion occurred during the morning rush hour.

### REDUCED PULLMAN FARE.

Upper Berths Cost Less than The Lower.

Washington, Dec. 19.—After January 20th, next, Pullman sleeping car rates throughout the country will be \$2 for lower berths and \$1.60 for upper berths for a ride of 12 hours. This decision was handed down today by the inter state commerce commission. The traveling public, it is estimated, will save \$1,500,000, annually by this decision. The Pullman company has agreed to the reduction which applies to all railroads in the country, except New York, New Haven and Hartford, Great Northern and Milwaukee.

### British Elections Once Again.

By Cable to The Reflector. London, Dec. 19.—British general elections ended today with polling in a few scattered constituencies and with government coalition in absolute control. Party totals announced this afternoon were Liberals, 271; Laborites, 42; Irish Nationalists, 73; Independents Nationalists, 9; Unionists, 272; Coalition majority, 123. Last parliament it was 124.

## TRAINING SCHOOL FOR THE WEST.

Mr. W. C. Allen, of Waynesville, writes a strong letter to the Raleigh News and Observer, urging that the coming legislature pass a bill providing for the establishment at some suitable point in western North Carolina of a teachers' training school, similar to the one in Greenville for the eastern part of the State. Mr. Allen's argument for such a school is right and in keeping with suggestions advanced when the movement was in progress for the establishment of this eastern school, that its success should be followed by the establishment of another in the western part of the State. The central school at Greensboro, the eastern school at Greenville, and the western school at some town in that section, are not more schools for the training of teachers than the State needs. The people of the west came to the aid of the east in establishing the eastern school, and we hope there is not a single eastern representative in the legislature who will vote against establishing a similar school in the west.

was a hard job. There is a lesson in it; read every line of it:

In a grove of pines and oaks or in an "old field" in one of the Western (or Eastern or Northern or Southern) countries of South Carolina stands (or leans) a little wooden house of one story. Its dimensions are about 20 feet by 15. The roof is old, and the rain drips through it at times. In not one of the four or five windows is the sash whole, a paper substitute for glass keeping out the weather with indifferent success. The house has stood since the day its frail walls or planks were reared, defying paint and all other pretense of good looks. The interior is not celled or plastered, there are straight hard benches with perpendicular backs that proclaim rigid standards of virtue, and a little, ancient stove that bears many scars and has lost some of its limbs. The yard about the house is consistently and harmoniously ugly with the house. The rains have washed gullies through it, the trunks of the trees having suffered from a ruthless axe or jack-knife and tin cans, and scraps of paper litter its borders.

This little building is a schoolhouse, a veteran rural schoolhouse in South Carolina, where, it must be said, some men and some women have obtained the beginnings of a solid and useful education. Some good teachers, from time to time, have taught in the little house—though no one of them has remained more than a year or two years.

Three hundred yards or less from the schoolhouse stands a church—a rural church. An architect planned it and its lines are tasteful and beautiful. It has stained glass windows and an iron fence surrounds it. The grounds tell of diligent attention and affectionate interest. Of course, the church is painted and the floors are carpeted and the walls are not without decoration. It meets every requirement for comfort and its students in being attractive. The church cost about \$8,000.

The parents of the boys and girls who go to school in the little old house contributed the money that built the church and they pay the pastor—they pay him a decent salary, too, and cheerfully. Moreover, these same parents who pay the teacher of the school \$50 a month are now contributing \$70 a month for the support of a missionary of their church, who is also a teacher, in Peru.

What we have said is a plain statement of facts—though we have purposely endeavored to conceal the identity of the church and school by changing some of the details of the description as it was given to us. We suspect that its essential lines will fit more than one community in South Carolina. The moral of the tale is outstanding—no store of common sense would make it stronger than the unvarnished narration of the facts.

The explanation, for an explanation there is, of the difference in the behavior of this God-fearing and intelligent community toward their church and their school is that the church has a leader and the school has none. The pastor of the church is an earnest, faithful man devoted to his work, and capable of stirring the latent zeal and love of his flock to activity and sacrifice for the Master's cause. Hence, little girls and boys are in Peru learning from a teacher, supported by the people of this church, who teaches in a better schoolhouse than these same people have for their own little girls and boys. Yet the people of this prosperous South Carolina community of farmers are zeal and eagerness for education, but they are dormant. No leader has aroused them to the value and necessity of a respectable schoolhouse. The county superintendent of education, whose salary is \$600 a year, has seldom visited the school and the salary falls, anyway, to command the services of a trained and enthusiastic leader in education.

Were the people and teachers of the party of which this community is a part directed and inspired by an educational leader having for his work the same zeal and efficiency that the pastor of the church has for

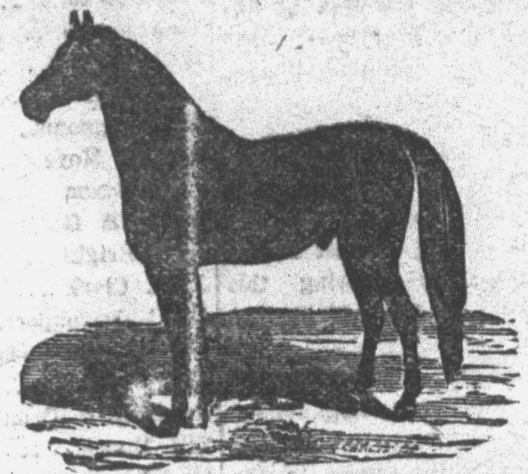

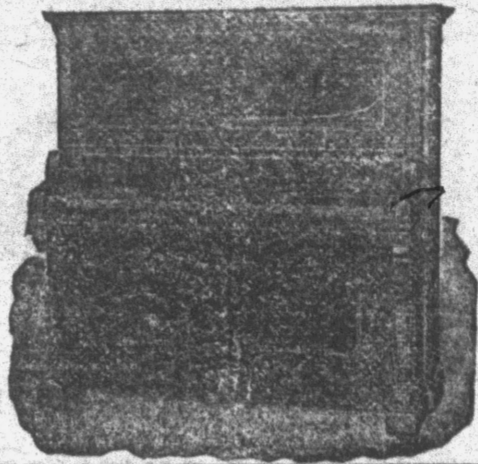

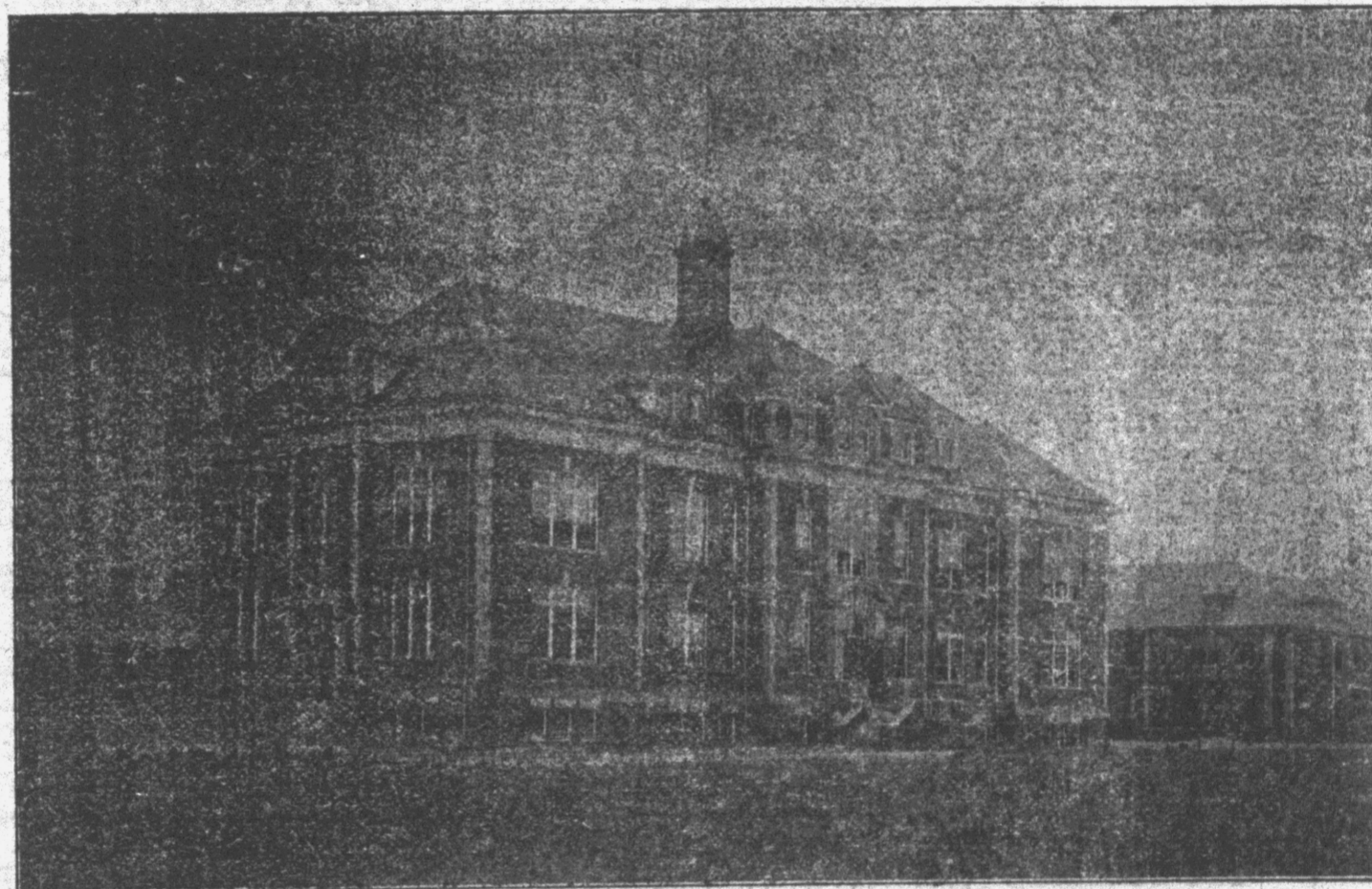

**THE HESSIANS.**

**They Were Good Soldiers, and Some Became Good Americans.**

There is a popular belief among some people that the Hessian mercenaries brought here by the British government to fight the Americans remained here after the war was over and that their descendants constitute a considerable element of the Pennsylvania Germans of today. Comparatively few remained here after the war, because the British government was under contract to return such as escaped the casualties of the war after it was over. The few that remained made good citizens, as they made the very best soldiers against the Americans, and whenever it was practical to do so they were put in the most responsible places by the British commanders.

The intense hatred at one time against the so called Hessian soldiers, some of which still lingers with the present generation, is very unjust, because they did not volunteer to fight against the Americans, but they were forced into the British service by the impetuous German princes who sold them to the British like so many slaves. The Hessian soldiers would sometimes take a notion to desert, and they invariably found refuge among some of the German colonists. A considerable number of them were left behind from time to time on marches, on account of sickness or wounds. These always found a ready welcome among German settlers; few of them ever found the way back to their native land.—"Pennsylvania Germans," by William Beldeman.

**LIBERTY BELL.**

**Its Connection With the Declaration of Independence.**

The famous Liberty bell was cast in London in 1752, brought to America and subsequently recast in Philadelphia. It bears the inscription, "Proclaim Liberty Throughout the World and to All the Inhabitants Thereof." It was cracked while being tolled after the death of Chief Justice John Marshall in 1835. It is kept on exhibition in Independence hall, Philadelphia. It has had a fictitious importance owing to the popular belief that its ringing proclaimed the adoption of the Declaration of Independence on July 4, 1776. Concerning this belief, however, Friedenwald in his "Declaration of Independence" (1904) says:

"There is no shadow of authority ever for associating the ringing of the bell with the announcement of the agreement upon Independence. The mythical legend of the blue eyed boy waiting outside the door to give the signal to the man in the bell tower is the product of the fertile imagination of one of Philadelphia's early romancers, George Lippard, who first gave currency to it in his appropriately called 'Legends of the Revolution.' This book was published in 1847."—New York American.

## OLD CRIMINAL LAW.

When Prisoner's Counsel Was Not Al-  
lowed to Address the Jury.

It seems hardly credible that less  
than a century ago counsel were not  
allowed to address a jury in defense  
of a prisoner. Sydney Smith first  
preached against this cruel law.

He pointed out that, while in any  
court where property was concerned  
counsel was heard on both sides, in a  
court where human life was trembling  
in the balance only the prosecuting  
counsel was heard, and it was unfair  
to match a prisoner, unaccustomed to  
marshal facts and unable to speak,  
against skilled counsel, whose sole  
purpose for its own reputation was to  
win a case. Sydney Smith's eloquent  
words led to the passing of the pris-  
oner's defense act, 1820, which alter-  
ed the practice.

Another unjust practice which was  
peculiar to the Old Bailey was that  
when an accused person was acquit-  
ted he was obliged to pay the fees of  
Newgate or go back for want of mon-  
ey. So many unfortunate prisoners  
died in Newgate through this that Al-  
derman Brown, lord mayor in 1733,  
caused an order of the court to be  
made that when any accused persons  
were acquitted by their country they  
should instantly be discharged in  
court without paying any fees what-  
soever, an order which has been strict-  
ly adhered to ever since.

Of the challenging of jurors one re-  
members a tale from Ireland. The  
prisoner was hard to satisfy, and jury-  
man after jurymen was asked to leave  
the box. However, all things come to  
an end, even in Ireland, and at last  
the swearing of the jury was complet-  
ed. And then the prisoner leaned  
over the dock and sought the ear of  
his solicitor. "The jury's all right  
now, I think," he whispered, "but ye  
must challenge the judge. I've been  
convicted under him several times al-  
ready, and maybe he's beginnin' to  
have a prejudice."—London Chronicle.

**The Doctor's Bad Memory.**  
This story is told of Dr. Pirrie, the  
great Scottish surgeon, in "Recollec-  
tions of Fifty Years."

"Once when a lady patient entered  
his consulting room he received her  
with effusion, crying:

"My dear madam, I have done noth-  
ing else but think over your case. I  
could not get a wink of sleep all last  
night for thinking of you!"

"The lady accepted it all as 'gospel  
truth,' and after some professional  
questions and answers she innocently  
remarked:

"Was it not a dreadful thunder-  
storm last night, Dr. Pirrie?"

"So I am told," he naively an-  
swered, "but I'm such a sound sleeper  
that I didn't hear a clap o' it!"
