## SOME TIMELY RECOMMENDATIONS

### ATTORNEY GENERAL BICKETT'S BIENNIAL REPORT

### DECREASE IN NUMBER OF CRIMES

Number of Criminal Cases Has Decreased 2,644 During the Past Year—Judiciary is Hardworked and Underpaid—Election Law Should be Amended—Sale of Near Beer an Unmitigated Nuisance.

The following extracts are taken from the biennial report of the attorney general:

The state is an immense business corporation. It collects and disburses every year \$3,500,000, and every dollar of this must be collected and expended according to law. It follows that this department must give many opinions on questions of large and vital interest. The more important of these opinions are published in this report. In addition to the official opinions, we have written many hundred letters to private citizens of the state. While these letters are, of course, without official weight or protection, the citizen who writes a letter to a state officer is entitled to a courteous reply, and, while it takes no little time, we have endeavored to answer every letter with reasonable promptness.

#### Criminal Statistics.

The law requires every criminal case tried or in any way disposed of in the superior courts of the state to be reported to this office. The report for the year ending July 1, 1909, shows a grand total of 12,149 cases; for the year ending July 1, 1910, a grand total of 9,505 cases, a decrease of 2,644 cases. This must be gratifying to every citizen of the state.

#### Against "Picked" Jurors.

As a legislator I took the position that in the selection of the jury the state and the defendant should be placed upon equal terms. I am still of that opinion. Neither side should be allowed to "pick the jury." The number each side is allowed to stand aside is comparatively immaterial, but the state and the defendant should be allowed the same number of peremptory challenges. The judge should be allowed to order a jury to be summoned from some adjoining county when in his opinion, the ends of justice would be thereby subserved. A change of venue is troublesome, expensive and works unseemly delay. But a change of venue can be ordered with little additional expense and no delay. In my opinion such a change in the law would make for justice.

Again, upon a written request of either party, it should be the duty of the judge to order the sheriff to go outside of the court house, and beyond the crowd that usually surrounds it, and summons tall jurors. The elimination of the professional juror is greatly to be desired.

#### Multiplicity of Indictments.

Both time and money are wasted by sending a different bill of indictment for each of a series of violations of the same law. Below the grade of felony the solicitor should be allowed, and it should be his duty to charge any member of violations of the same law in a single bill. Take, for example, the crime of selling intoxicating liquors. If all sales, of which there is any evidence, could be charged in a single bill not only would time and cost be saved, but with the defendant's entire record with respect to the violation of this particular law before the jury the chances of obtaining a just verdict would be greatly increased.

The same principle should apply to carrying concealed weapons. The solicitor should also be allowed to couple with the main offense charged all offenses connected with or growing out of it. For example, in an indictment for an assault with a deadly weapon there should be coupled the charge of carrying a concealed weapon, if such should appear to be the fact.

#### Assault Upon Women.

There should be a law protecting the person of a woman from violence or indignity, which falls short of an attempt to commit rape. No matter how rude or how revolting may be

## THE STARKEY BLOCK.

### What Greenville Boys Are Doing in Wilmington.

In keeping with the general development and improvement of valuable properties in the business district comes the announcement that Mr. M. L. Starkey, owner of the building on the north side of Princess, between Front and Water streets, formerly occupied by the Morning Star, has accepted plans and awarded the contract for the entire remodeling and improving of the brick structure, which now occupies the lot. The improvements to the building, which will be converted into a combination store-apartment house, will represent an expenditure in excess of \$10,000. The entire valuation of the property when the plans in contemplation have been finished will represent a sum total of at least \$20,000. The work on the building will be started within the next two or three weeks and the contractors will be required to finish on or before May 1st.

"The Starkey Block," as the remodeled building will be known, will be one of the handsomest and most attractive structures in the downtown district and it is a certainty that there will be a great demand for the stores and apartments.—Wilmington Dispatch.

### NEWS ITEMS TAKEN FROM OUR EXCHANGES TODAY

### CONDENSED FOR OUR BUSY READERS

30,000 Bushels of State's Cotton Seed Sold for \$35.75 Per Ton—Two Boys Ruined at Chocowinity by Accidental Discharge of Gun—Twenty-one Chickens Smothered to Death Near Concord by Farmer.

At a recent meeting of the directors of the State prison, Superintendent J. J. Laughinghouse was authorized to ask for bids for 30,000 bushels of cotton seed, these bids to be received by December 22. Yesterday the bids were opened and it was found that Mr. M. C. Braswell, of the Battleboro Oil Mills had made the highest offer, \$35.75 per ton. Mr. Braswell was notified by wire that his bid had been accepted.—Raleigh Evening Times.

A terrible accident happened in Chocowinity last night at the home of Mr. Robert Hill. His oldest son and one Mr. Frank Daniels were engaged in loading and unloading a gun standing near them were the two sons of Mr. Hill, aged respectively, seven and three. By accident the gun went off and the right shoulder of the younger boy was shot off and his arm nearly amputated. The older boy's hand was nearly severed just above the wrist.—Washington News.

Mr. Wade Cline, the new manager of the Luberger Poultry Farm, had the misfortune to lose 21 of his finest chickens last Tuesday. He was moving them from the city to the farm and had them in a wagon bed which was covered over with slats. The birds all crowded in one corner of the bed, and when he got to the farm he found 21 of the chickens had smothered to death. They were Rhode Island Reds and Buff Leghorns and were of his breeding stock, and were worth about \$1.50 each.—Concord Tribune.

One of the troubles with our electric light plant was discovered Saturday when scores of large eels were discovered to have almost completely choked up the water wheel. They were removed and the lights have been much better since.—Snow Hill Standard.

### Don't Shoot Sunday.

Christmas is usually observed here with the promiscuous use of fireworks, the shooting beginning at dark Christmas eve and continuing through Christmas day and night. Christmas coming this time on Sunday, it is to be hoped there will be no desecration of the Sabbath by shooting fireworks on that day. When more than a century ago the great statesman, Thomas Jefferson, advocated the idea that nations could live at peace and that war was an unnecessary thing, the people of that day and time, both great and small, hooted at the idea and counted Jefferson but as a theorist of the first water. From every avenue of access they sought his political downfall for this and additional reasons which they thought put him in the class with the theorists; nevertheless, he strictly adhered to his original idea that nations could live at peace, throughout his entire career, and historians have seen fit to include this as one of the great principles that makes his name immortal as a statesman.

While more than a century has passed since Jefferson advanced that theory, yet it was only last week that a great body of men known as the American Society for the Judicial Settlement of International Disputes, composed of wise diplomats, learned jurists and able lawyers, from the world over, gathered at Washington City for the purpose of arriving at a conclusion as to what the sentiment was in favor of this great idea, that would mean the abolition of war and place in its stead a world peace. The outcome of the discussion at this world-wide gathering showed conclusively that the general trend of sentiment was gaining ground rapidly in favor of the abolition of war and the urgency of establishing a permanent court of arbitral justice. And these words, uttered by M. Jessorand, the French ambassador, present at this meeting, point most strikingly toward the trend of times on this great question of so much vital interest to the world at large: "Mankind longs for less troubled days and moves toward this not inaccessible goal."—Webster's Weekly.

Anent the Christmas buying the Raleigh News and Observer utters this timely warning.

Buy your Christmas presents early but, remember, not to buy more than you can pay for in January. Our Christmas celebrations and gifts are becoming too costly.

This may not be a welcome suggestion at this glad Christmas time, but it is better to ponder it now than to have it forced on one's attention in the glad New Year. ## GRIDIRON HEROES.

Ones Who Never Win Places in  
the Football Hall of Fame.

AND THEY WEAR NO "LETTER"

These Practically Unknown Men Are  
the "Scrubs," Who Help to Keep the  
Varsity Team on Edge—They Play  
the Game For the Game's Sake.

There is no royal road to a thorough  
knowledge of American college foot-  
ball. The preparation of the varsity  
eleven is long and hard. The mills of  
the coaches grind slowly, and they  
grind exceedingly fine. There is noth-  
ing in store for much of the good ma-  
terial that in the end must be re-  
gated to the side line. These men,  
wrapped in gray blankets, who line  
the low fence surrounding the field  
on the day of the big game, are the  
scrubs, or second team men.

There is a paradox in their situation  
—their only chance for personal glory  
lies in the defeat of the varsity eleven.  
There comes a time in many a big game  
when a coach, realizing that the day is  
lost, that his varsity men have done  
their utmost to no purpose and are be-  
ing swept steadily down the field, will  
throw into the game scrub after  
scrub, hoping against hope that these  
men will play better than they really  
have a right to and so turn the tide.  
And even ten seconds in the big game  
give the scrub his letter.

So it is in after years that one may  
point out many a wearer of the letter  
who was not nearly so good a football  
player as many scrubs. It has hap-  
pened, too, that a man has fought for  
years in the hope of making the eleven,  
has improved slowly, if surely, has  
been sent into the big game as a for-  
lorn hope and has played a game the  
like of which has not been seen on the  
field that season.

Even scrubs take their triumphs  
and their disappointments differently.  
There are not a few who are proud to  
have been on the second team in the  
year that the first eleven swept all  
before it. They have no varsity let-  
ter, but the discriminating know that  
they were better players than some  
of the varsity men of other years.  
There are other scrubs who bemoan  
the fact that they were not in college  
when the general average of the play-  
ers was low and they would have  
been almost certain to make the first  
team. Be it said, however, for the  
honor of the second team that in-  
stances of the latter type are rare. A  
scrub player learns the lesson of  
self sacrifice. It is his but to be walk-  
ed over daily by the varsity, while  
most of the instruction and encourage-  
ment are lavished on said varsity.

As a rule, however, there comes at  
least one week in the season when the  
scrubs are pampered and petted and  
made much of. The varsity is in the  
throes of a "slump," is lagging, dis-  
pirited and sullen. It is then that the  
scrub team suddenly finds that it  
is being taught to play the game just  
as if it were to take the field as the  
first choice against the foe. There is  
a coach for almost every man, there  
are words of encouragement, much  
valuable instruction and a new esprit  
de corps. Under the new inspiration  
the second team sweeps the flagging  
varsity off its feet, humiliates the first  
string players to the uttermost, while  
the coaches cheer the scrub and jeer  
the varsity. At least once a season it  
is very good to be a scrub, for at  
least once a season the scrub de-  
feats and humiliates the team that  
has proved perhaps a terror to all its  
outside rivals. Nothing has such a  
salutary effect on the varsity as the  
eating of humble pie once in awhile.

In late years the scrub is getting  
more consideration than in the old  
days. Yet the men play principally  
for the love of the game and in order  
to make the going as hard as possible  
for the varsity. Sheer loyalty and the  
thrill of battle keep them at it year  
after year. They learn football from  
the ground up. They see the big  
games from the side lines and, know-  
ing the signals, have a peculiar advan-  
tage over any other spectator. With  
a knowledge of the signals one may  
criticise the handling of the big team  
in the big game—may more readily  
understand the strategy of coach and  
quarterback.

It is this opportunity to analyze the  
big games, coupled with the chance to  
get practically as good coaching as the  
varsity, that makes excellent coaches  
out of many scrub players. Some of  
these scrubs have gone back to college  
and turned out freshman teams that  
have been able to fight the varsity to  
a standstill and so have astonished the  
very coaches who taught them. There  
have been instances of this at nearly  
every big institution in the east.  
Sometimes the services of these ex-  
scrubs have been eagerly sought by the  
veteran varsity coaches, and many a  
man without a field reputation has  
proved to be no mean strategist.

It is really these ex-scrub men who  
keep up the high average of interest  
in the game. They are turned out  
yearly at the rate of five or more to  
every varsity player. The varsity man  
may lose interest in the game in after  
years, but the scrub practically never.  
It is they who are the backbone of the  
pilgrimages to West Point, and it  
is they who talk football far into the  
night in the club and chop house.

The scrubs, in a word, all unbonored  
and unsung as they are, are the back-  
bone of the game in the colleges and  
out of them. They play the game and  
they watch it for the game's sake.—  
New York Post.

the indignity inflicted upon the per-  
son of a woman, if it does not appear  
that serious damage was inflicted, or  
that there was an assault with intent  
to commit rape, the punishment is  
limited to imprisonment for thirty  
days or a fine of fifty dollars. A case  
of this kind came to the supreme  
court about a year ago. A simple as-  
sault upon a woman should be made  
a misdemeanor, punishable by fine  
or imprisonment, or both, in the dis-  
cretion of the court.

I respectfully call attention to our  
overworked and under paid judi-  
ciary. All over the state the dockets  
are congested, entailing enormous  
expense and vast inconveniences. It  
often costs as much to continue a case  
as to try it, and a delay of justice  
frequently amounts to a denial. The  
state owes it to the citizens to pro-  
vide for trials in court "speedily and  
without delay." The number of  
judges should be increased and salar-  
ies should be paid commensurate  
with the supreme importance of the  
work committed to their hands. I  
think the salary of the judges of the  
supreme court should be \$5,000.

The expense allowance to the su-  
preme court judges should be in-  
creased to \$1,000. I have talked  
with a number of the judges, and all  
of them say that in riding the cir-  
cuits their expenses amount to at  
least \$1,000 a year. The expense al-  
lowance should cover the bills for ex-  
penses. To this end I submit, for the  
consideration of the general assem-  
bly, the following plans:

1. Let the state be divided into  
two large circuits, one for the east  
and one for the west. Such a divi-  
sion would be large saving of time and  
money, and would preserve the bene-  
fits of the rotating system, and re-  
move some of its burdens. The  
judges would not hold the courts of  
a district oftener than once in four  
years, therefore such a division can  
be made without a constitutional  
amendment.

2. There should be, in each cir-  
cuit, ten districts—nine large dis-  
tricts and one small one; the judge  
riding the small district can then be  
held in reserve as an emergency  
judge, to be sent to any county when  
the judge assigned to hold the courts  
of the county is incapacitated for any  
reason. It is a costly and cruel de-  
fect in our present system that there  
cannot be a marriage, a birth or a  
death in the family of a judge with-  
out demoralization to the public busi-  
ness. It would be an ideal arrange-  
ment to have two judges at large, but  
this would require a constitutional  
amendment.

### Supreme Courts.

In my opinion the chief justice and  
associate justices of the supreme  
court are the hardest worked officials  
in the state. Their labors should be  
lightened. This can be accomplished  
in one of two ways. First, by the  
establishment of an intermediate  
court of appeals. More than one-half  
of the states in the union have such  
courts, and when once established  
can sit in the eastern and western  
circuits, and the courts would thus  
be brought nearer to the people, and  
the expense of litigation decreased.  
These courts should be empowered  
to finally dispose of all but the most  
important cases. The United States  
Circuit Court of Appeals has saved  
the supreme court of the United  
States from complete inundation, and  
a state court of appeals will do the  
same for the supreme court of the  
state. Not only would the labors of  
the justices of the Supreme court be  
lightened, but cases would be much  
more speedily determined.

The same result could be accom-  
plished, though possibly in a less  
desirable way, by increasing the  
number of associate justices from  
four to six. The supreme court could  
then work in two divisions, and by  
the addition of two justices the work-  
ing capacity of the court could be  
doubled. This plan has been adopted  
in a number of the states in the  
union, and gives entire satisfaction.  
The general rule is that if all the  
judges of one division do not agree  
the case is submitted in conference  
to the entire court, but if the divi-  
sion that hears the case is unanimous  
in its opinions, the case is never sub-  
mitted to the other division at all.

Of course either of the above meth-  
ods would require a constitutional  
amendment, but I trust it is not blas-  
phemy to say that in some respects  
the state has outgrown the constitu-  
tion.

The election law should be amend-  
ed in several ways.

1. There is, at present, no method  
provided for a new registration when  
a new precinct is established. This  
should be remedied.

2. The constitution declares that  
elections should be frequent. I have  
a respect amounting to reverence for  
the wisdom and virtue of the  
fathers. It should not be forgotten,  
however, that the constitution was  
made for man and not man for the  
constitution. After thoughtful con-  
sideration I am of the opinion that a  
general election once in four years  
is as frequent as the interests of the  
state require. I am at a loss to un-  
derstand why the judges should be

"All 5 francs posted after tomorrow  
will be inexorably refused."

By the Sunday morning seventy-  
seven postal orders for 4 shillings each  
had come in, and the next morning  
eighty-two more arrived. The gull-  
ible public had sent in not 500 francs,  
but 735 francs in a week. Having  
proved their point and won their bet,  
the two boulevardiers naturally re-  
turned the postal orders to the ingenu-  
ous senders.
