H. Griffith.

Mr. Roach was postmaster at Cox-

### MEETING OF TEACHERS.

North Carolina Association of Super-  
intendents and Principals.

The twenty-sixth annual session of  
the North Carolina Association of  
City Public School Superintendents  
and Principals will be held in Raleigh  
January 26, 27, 28.

For a quarter of a century this as-  
sociation has been helping to shape  
the educational destiny of North Car-  
olina and today it is one of the most  
potent factors in educational pro-  
gress.

It was organized by such men as  
M. C. S. Noble, Alexander Graham,  
and E. P. Moses, and the two first-  
named are still members of the as-  
sociation.

These with many others who are  
now leaders in education got inspira-  
tion from these annual meetings that  
enabled them to plan more wisely  
and to prosecute their work more  
efficiently in that period of forma-  
tive growth in our graded school  
systems. The influence of this asso-  
ciation has touched every part of the  
State and it must be admitted that  
there is no class of educators in the  
State who are working out their prob-  
lems more wisely or practical than  
the graded school men.

The programs of these annual  
meetings touch administration, su-  
pervision, course of study—in fact,  
every phase of graded school work  
as viewed from the superintendent's  
viewpoint.

The work of the association has  
been so vitalized during the last  
three years and has become so in-  
tensely practical that the city school  
men look forward to these meetings  
with eager anticipation and await  
with impatience the distribution of  
the printed proceedings. Only those  
superintendents who are unavoid-  
ably detained will miss these meet-  
ings.

### The Value of Trees.

An Indiana man who recently  
chopped down a noble walnut tree  
belonging to a neighbor was sued for  
damages by the owner of the prop-  
erty, and a local magistrate gave  
judgment for \$25 against the offender.  
The verdict was evidently based solely  
on the estimated commercial value  
of the tree, and the figure seemed  
ridiculously low, even from that  
point of view. They look at such  
things in a different way over in New  
Jersey, as a brief narrative will prove.  
Mrs. Mary V. Nevins of Merchants-  
ville, had growing in front of her  
residence a row of five beautiful map-  
les, which formed part of the land-  
scape and possessed an enduring  
charm for their owner and her neigh-  
bors. These trees were all killed by  
gas escaping from a main which, it  
appears, was not properly cared for  
by those responsible. The court took  
the same view of the case, too, for  
when Mrs. Nevins sued for damages  
the other day the jury promptly  
awarded her a judgment for \$2,000.  
Manifestly the New Jersey estimate  
is something like the real thing.—  
New York Evening Mail.

### ROBBERS HOLD UP TRAIN.

Special Train Takes Possé in Pur-  
suit.

### NORTH CAROLINA ITEMS

Of News Happenings Far and Near  
Within Its Borders.

Winston-Salem, Jan. 2.—Charles  
Pruitt is the name of the postmaster  
at Chuckle, Wilkes county, under  
whose home, in the basement, revenue  
officers destroyed a complete il-  
licit distillery and eleven hundred  
gallons of beer, last Friday. The  
post office is in Pruitt's home, and  
officers were advised that the dis-  
tillery had been operated under  
Pruitt's home ever since his resi-  
dence was built eight years ago.

Thomas Moore, the 15-year-old son  
of Mr. Whit. Moore, of Everetts, while  
out rabbit hunting Saturday after-  
noon, had the misfortune to meet  
with a very serious, if not fatal ac-  
cident. It seems that young Moore  
was standing on a stump watching  
his dogs and in some way lost his  
balance and in falling his gun dis-  
charged, the entire load hitting him  
at close range, shattering his right  
hand and wounding him also in the  
stomach.

Greensboro, January. 2.—After a  
year of declining health, Major Joseph  
Motley Morehead breathed his last  
yesterday morning at four o'clock,  
at the age of seventy-one years. Al-  
though his death was not unexpected  
the sad reality cast a gloom over the  
whole city, for the grand old patri-  
ot was a general favorite and an  
object of wide attention to the com-  
munity. He leaves surviving, a wife  
and one son, James T. Morehead, Jr.,  
a partner in the practice of law with  
his uncle, Col. James T. Morehead.  
One sister, Mrs. Whitfield, of Rich-  
mond, also survives.

Mr. Davis J. Gregory, one of Union  
county's most practical and up-to-  
date farmers, brings in one of the  
finest records in cotton growing that  
has been heard of in several years.  
Mr. Gregory planted seven acres in  
cotton and from the seven acres gin-  
ned eight bales, the average weight  
of the bales being 593 pounds and  
the average amount he received per  
pound being fourteen cents. He also  
got from his cotton 269 bushels of  
cotton seed and received the market  
price for this, the seed bringing him  
\$107.95. Mr. Gregory used \$20 worth  
of commercial fertilizer on the seven  
acres of land and some manure that  
he got from his stables. Mr. Gregory  
in giving out this said that he did  
not do it in a boasting way, but to  
show the farmers of Union county  
what could be done on seven acres  
of land by giving it proper attention.  
—Union Progress.

### Farmers Fully Awake.

We note with satisfaction that the  
question of a state dog tax has been  
debated favorably in the North Car-  
olina's Farmers' Union and is now un-  
der official advisement. In reply no  
one has so much to gain from the  
elimination of worthless and super-  
fluous dogs as the farmer. He gains  
directly in becoming enabled to raise  
sheep, as well as through the in-  
creased funds for educational pur-  
poses thereby provided. Heretofore  
our legislators have shied away from  
this matter because of a fear that the  
farmers were not sufficiently enlight-  
ened regarding it. Once convinced  
that there is no resentment in store  
they would come into line quickly  
enough.

## DEADLY BATTLE WITH ANARCHISTS

POLICE AND SOLDIERS BESIEGE  
THEM IN BUILDING

WORST CONFLICTION IN CENTURY

Anarchists Detected Manufacturing  
Bombs and Their Quarters Raided  
—They Battle With Soldiers and  
Police and Set Fire to Building in  
Hope of Making Escape.

London, Jan. 3.—Six anarchists  
were killed and a score of police,  
soldiers and inspectors are wound-  
ed in a desperate battle between a  
band of anarchists besieged in a  
house in the East end and twelve  
hundred soldiers and police today.  
The battle raged over eight hours  
and was watched by over half mil-  
lion people. It was most specta-  
cular conflict in a century in the  
history of London. The men fought  
to their death in the burning build-  
ing which had been set on fire by  
themselves with the hope of escap-  
ing under the smoke. The battle  
started with two hundred police.  
This was soon increased by more  
police, soldiers and fire engines.  
Firemen tried to drown out the men  
but were unsuccessful, then the pol-  
ice tried to fire the building, but  
failed. Machine guns were used by  
the soldiers but the anarchists fought  
on desperately. During the battle  
thousands of shots were exchanged.  
After it was over and police entered  
the building, six bodies were found  
together. These were barely taken  
when the roof crashed in. Police  
think it possible there are others in  
the building. They declare the an-  
archists were manufacturing bombs  
with the purpose of exterminating  
Royalty at the Coronation of King  
George in June. The battle started  
at 6 o'clock this morning and was 3  
this afternoon when it ended.

### Number of Dead Increased.

London, Jan. 3.—Beside the six an-  
archists, two firemen were also killed,  
making the total number dead eight.  
Some of the anarchists committed  
suicide, shooting themselves  
with almost their last bullets.

# A NUT HARD TO CRACK.

## Judge Eure Runs up Against a Chicken Case in His Court.

A lawyer doesn't often get stalled; he is always ready to fight, yet one ran up against a row of stumps yesterday in Judge Eure's court. A man had been arrested charged with killing a chicken, belonging to a woman, his next door neighbor. The woman swore it was her chicken—a rooster; the man swore it was his and on Saturday afternoon, it being in his yard, he caught it and killed it. The woman swore it was her rooster, because hers had his tail always up, while the one belonging to the man carried his down, "like he was hacked," she said. It required some time to get the facts from the excited witnesses on both sides, then, when the evidence was all in Mr. David Stern, who appeared for the defendant, a white man, moved to dismiss, alleging that the warrant charged "wilfully, maliciously and cruelly killing a chicken," and that the evidence did not sustain such a charge. He said he presumed the city attorney, Judge Shaw, would agree with him, but that officer did not; he asked for conviction. Then Mr. Stern frankly confessed that he did not know how to make an argument, for if cutting off a chicken's head with an axe was not killing a chicken, he did not know why; that a chicken was brought under the cruelty to animals act and there was nothing to sustain it. Judge Shaw made quite an extended argument, but at its conclusion Judge Eure dismissed the case. The defendant was, however, fined \$2.50 for cursing when the woman claimant of the rooster came over to remonstrate with him for killing her chicken.

The incident shows that a lawyer does not know every time when he is making a good argument. Mr. Stern confessed he was "up a tree," yet he won his case.—Greensboro Record.

## Women Who Drink.

The drink habit among women in treated in a vein of strong reprobation by the Christian Work and Evangelist (New York). The practice is of recent growth, but its prevalence in the circles of society in our cities calling themselves respectable and even Christian is gaining a wider and wider world. "Women not only drink cocktails before dinner now in New York but they drink strong wines and much champagne, and it is no uncommon thing to see them so flushed with drink that they lose all sense of modesty and say loose things that, bad enough in men, sound horrible in women." This journal gives some specific instances: "At one dinner party given not many miles from here, the company being made up of members of society whose names many would recognize, and who go to church on Sunday, one of the women drank so indulgently that she ran from the table and, in the presence of a dozen men, attempted to climb a pillar in the room, amid the clappings and cheering of the drunken guests. Another woman had to be put in her carriage at the close of this dinner, and before the company had broken up they attempted to sing a Christian hymn, about which gathered the tenderest association of years, to a comic opera tune. These were people who are received into our so-called best society and such actions do not bar them from social recognition. A woman who is connected with some of the most prominent families in New York and who, according to the papers, has just taken a suite at one of our best hotels, gave a stag party once, a party for women only, and at the close, while half intoxicated and smoking a big cigar, hurled a plate at the butler's head, an act which nearly cost her very serious consequences."—Literary Digest.

## Punishing Married Loafers.

The law dealing with wife desertion provides for the punishment of men, "who abandon and fail to support their families." The "and" is ambiguous. It has been found impossible to punish men who "hang around" their families and live on the hard-earned dollars of their wives and children. Chief Justice Olsen will endeavor to put an "or" in place of the "and" in the law. The change is necessary and just, for married loafers and shirkers who do not abandon their families are often worse than deserters. But if the law is amended merely to provide for the imprisonment of such loafers the poor families will gain little or nothing. If the former could be compelled to work for the State and their earnings were paid to the wives, a real reform would be achieved. Such proposals have been made at meetings of criminologists, but the difficulties in the way are enormous. Let us hope that the threat of imprisonment may prove sufficiently deterrent.—Chicago Record-Herald

## Breeding Cotton.

The Department of Agriculture seems to have been meeting with success in its experimental breeding of a new kind of Egyptian cotton, as indicated in a report just made public. The report says that the breeding work of the past seven years has developed several superior strains and two very distinct varieties which are now ready for testing on a field scale. The two varieties—the Yoma and the Somerton—developed from an imported stock of the Mit Afifi variety, represents a wide departure from the characteristic parent type. In their large pointed bolls and lighter colored fiber they more nearly approach other Egyptian varieties, which are also believed to be derived from Mit Afifi and probably originated in the same manner as "spots" or "mutations." One of the new strains represents typical Mit Afifi in the shape of its bolls and in the deeper color and other characteristics of its fiber, but is not ably superior to the average of that variety, at least as grown in the United States from imported seed. This strain which was grown last year on a field scale, likewise exhibited a high degree of uniformity.—Charlotte Chronical.

### Mattamuskeet Drainage.

It appears that there has been a  
radical misapprehension on the part  
of the general public as to the atti-  
tude of the John L. Roper Lumber  
Company towards the Mattamuskeet  
drainage proposition. This company  
owns some 10,000 acres in the area  
affected, part of which is timbered  
and part marshy. When the drain-  
age plan was first broached the man-  
agement naturally investigated the  
situation with a view to protect its  
interests in the premises. When the  
benefits to the several lands included  
in the tract were assessed the com-  
pany decided to accept the liability  
assigned them, amounting to about  
\$10,000. Just after this assessment  
had been filed with the state board  
of education and before it had been  
confirmed, an expert from the United  
States Department of Agriculture  
suggested that the plans as outlined  
should be submitted to a board of ex-  
pert engineers before putting them  
into operation. This idea commended  
itself to the lumber company as a  
prudent one, and when the state an-  
nounced an intention of selling its  
interests without making any pro-  
vision for such an examination, the  
management of the company raised a  
very natural objection.

The Washington, N. C., News pub-  
lishes a letter from President Millard  
of the lumber company to Governor  
Kitchin setting forth the facts recited  
above and also conveying the wel-  
come intelligence that the company  
and the state board of education have  
argued upon an expert engineer who  
will immediately give a thorough  
scrutiny to the plans which have  
been adopted. In his reply to this  
communication, Governor Kitchin de-  
clares that he is satisfied that the  
Roper Lumber Company sincerely de-  
sires the drainage of this district, and  
as Mr. Kitchin has all along been in  
touch with the progress of the mat-  
ter, this official declaration serves as  
an entirely clean bill of health so far  
as any unnecessary delaying of the  
worth on the part of the company is  
concerned. There can scarcely be  
questioned, that benefit will be de-  
rived from an expert's suggestions as  
to the details of so large a piece of  
work and that there will result a  
saving both in time and effort. The  
fact that this expert has already been  
agreed upon leads to the belief that  
the review of plans will be made at  
once and that actual work upon the  
project will not be much longer de-  
layed.—Charlotte Observer.

### Population and Roads.

There is not a county in North  
Carolina which is not eagerly  
awaiting the announcement of the  
census figures. There has been con-  
siderable gratification in all which  
have shown material increase of pop-  
ulation. Taking this sentiment as its  
text, The Reidsville Review preaches  
a little sermon on good roads  
which is as pointed as it is true.  
"Rockingham county," says the Re-  
view, "has actually shown a loss of  
population in the rural districts,  
while the adjoining county of Guil-  
ford, which has a magnificent sys-  
tem of macadamized roads, shows a  
gain in population of over 21,000,  
nearly 60 per cent. in ten years. As  
agricultural lands go, Rockingham is  
the better county of the two. Today  
there are dozens of good farmers who  
have left this county and settled in  
Guilford solely because they wanted  
to get the benefit of good roads."

The Asheboro Courier says that  
Randolph as well as Rockingham has  
lost population to Guilford on the  
same account, and it is probable that  
some other neighbors could testify to  
the same thing. Guilford leads all  
the counties in the matter of per cent  
increase in population during the  
past decade, and its intelligent road  
policy is in no small degree respon-  
sible for this fact. Moreover, what  
the highways have done for Guilford  
other highways will do in every meas-  
ure for other counties.—Charlotte  
Observer.

### The Duty of a Newspaper Man

We have for the past few days  
thought upon the real work of a news-  
paper man, that is the work that really  
counts for most. Shall it be the  
purpose of the newspaper to build up  
or tear down, to discourage or to en-  
courage people to make the most of  
their opportunity?

Answering the question from the  
broad standpoint of the highest devel-  
opment and the greatest good to the  
greatest number, which we feel is the  
correct premises, we say unhesitatingly  
that the newspaper should be above  
all things optimistic in its construc-  
tion and a constructionist along safe  
and conservative lines. Again, some  
one will say that it is the duty of a  
newspaper man to "knock" wherever  
the necessity requires. We can't see  
it that way.

Does the carpenter strengthen a  
plank by knocking it in shape. Not  
much. If he hammers on one end and  
there is much spring to the board the  
chances are the other end will spring  
up and hit him in the eye. But he  
does try to strengthen the board by  
planing and dressing and putting it  
into a vise until he gets it straight.

Of course now and then he finds a  
board so warped he cannot straighten  
and so, under these circumstances, the  
only course to pursue is to throw the  
board aside. And so it is with some  
other proposition in life. If after pa-  
tient handling you can do nothing, you  
simply have to quit the job; and yet  
after all how many of us let up be-  
fore we have done the best we could?

But think of the spirit of optimism  
the editor of a paper must be able  
to maintain to keep the affairs of the  
community in good shape. Since ex-  
ample is better than precept he must  
above all things set a good example.  
He must not be selfish in order to  
encourage liberally in others. He  
must always be an optimist in order  
to encourage in others a spirit of op-  
timism. No matter how many clouds  
hover above his own horizon, or how  
much difficulty he finds in keeping  
himself or his own affairs in a proper  
state of equilibrium he must at all  
times be hopeful and faithful in order  
to encourage a spirit of hope and  
trust in others.—Wilson Times.

### A Parole Board.

The report of the state board of  
public charities contains a recom-  
mendation that the board of direc-  
tors of the state's prison be empow-  
ered to serve as a parole board, with  
the additional suggestion that a spe-  
cial officer be appointed to see that  
released prisoners observe the terms  
of their parole or be remanded to  
prison. The idea behind the recom-  
mendation is that a chance should  
be given the inmates of the prison  
to show whatever desire for improve-  
ment they may feel. Naturally life  
prisoners would derive no benefit  
from the proposed system, but oth-  
ers whose terms are for a definite  
number of years would be offered by  
it an incentive to good behavior dur-  
ing incarceration and a gleam of  
hope after their release. The propo-  
sal does not contemplate any inter-  
ference whatever with the pardon-  
ing power of the governor.

Penology as a study is still in its  
infancy. Under the conditions of  
modern civilization it is quite neces-  
sary for society to protect itself  
against evil doers, but the aged-old  
theory of purely vengeful punish-  
ment is rapidly giving way to plans  
of a reformative nature. We believe  
that the creation of the parole board  
suggested by the report quoted would  
be a step in advance. The environ-  
ment of the state's prison is not con-  
ducive to a repentant frame of mind;  
indeed, the influence is all in the  
other direction. A paroled man un-  
der the eye of a parole officer would  
have more than ethical reason for  
behaving himself; there would be the  
very lively fear of returning to jail  
again. Consequently there would be  
considerably less likelihood of his  
going wrong after his release than  
if his full sentence had been served.  
The careful attention of the legisla-  
ture should be directed to this por-  
tion of the report.—Charlotte Obser-  
ver.

### Fall Care of the Calves.

With the approach of fall, every  
year, numerous complaints come to  
us of calves that not doing well.  
They cease to grow, get thin and  
finally take scours and many of them  
die. Those that do not die go into  
the winter in bad condition and  
with the hard usage and scanty feed  
common in winter, fail to make satis-  
factory growth. A little attention be-  
fore they get in bad condition, would  
be profitable. As the grasses, espe-  
cially Bermuda, get dry they are  
less digestible. They should be given  
a little extra care and feed at this  
time.

There are two or more species of  
small worms that infect the stomach  
or lodge in the coats of the intes-  
tines that are responsible for some  
of these troubles. Good feed and  
care will largely enable the calves  
to withstand the troubles coming at  
this season of the year.

If scours occur, take the calves up  
and feed lightly on cowpea hay and  
just a little grain of some sort, and  
give a dose of turpentine and oil  
every second day until about three  
doses have been given. For a calf  
six months old 2 to 3 teaspoonfuls of  
turpentine in a quarter to a half-pint  
of raw linseed oil will be about the  
right dose. As a tonic give about 10  
grains each of dry sulphate of iron  
and powdered aux vomica twice a  
day for ten days or two weeks.—  
Progressive Farmer.
