JANUARY TERM PITT SUPERIOR COURT

JUDGE GARLAND S. FERGUSON PRESIDING

THERE ARE MANY CASES FOR TRIAL

Grand Jury Drawn and Notes on Judge Ferguson's Charge—He Makes Strong Points on Personal and Property Rights and Laws Affecting Society.

The January term of Pitt Superior court for the trial of criminal cases convened this morning with Judge Garland S. Ferguson presiding and Mr. F. G. James representing the State for Solicitor Abernethy who was unable to get here the first day of court.

Judge Ferguson said in his charge that for the last eight years he had traveled over the State of North Carolina, and is convinced that there is much to be learned about the State. We have a great State in wealth, population and material progress. We have a law abiding citizenship as a whole, but still there are those who want to have their own way without respect to the rights of others. Therefore it is necessary for us to have courts to suppress the evil dispositions of some men.

A term of court should be looked forward to with a feeling of confidence by all law abiding citizens, as a time when offenders shall be dealt with according to their misdoings. Our forefathers deemed it wise to place the executions of the law in the hands of the citizens. No person can be brought to trial except through the citizenship of his State, a jury of whom is selected to hear the sworn evidence against the offenders and these must pass upon his guilt or innocence. It depends therefore, upon the citizens whether a community shall have law and order.

Judge Ferguson then went into the crimes against personal rights and liberties property, society, and such as affect the general welfare of the people. As to character he said the chief glory of the State is the honor of its men and virtue of its women. Character comes from years of right living and right thinking. The man who accumulates such character contributes more to his State than can be measured in money, and he has the right of protection to his character. The same is true as to the virtue of our women and the law says this must not be assailed.

We get our first principles of government in the home. Every man has the right to make regulations for the government of his own home, and when he has proper rules for the government of himself and his family there is less need for law and reformatories.

We are not a people who live each one to himself nor each family to itself, but all are interested in the welfare of each other and what one does has more or less effect upon others.

In referring to the duties of officers he said it would be great economy if every county would employ a competent accountant once a year to go over the records and see that all the taxes are properly accounted for and applied.

Judge Ferguson's charge, was a good one, and touched upon many other points that space does not permit mentioning.

Immediately after the charge which consumed about an hour, the docket was called in readiness to taking up the cases for trial. The docket is a large one.

NORTH CAROLINA ITEMS.

Of News Happenings Far and Near Within Its Borders.

Oxford, Jan. 16.—The trial of Nathan Montague is progressing orderly with military guarding the court house. While there is a big crowd here, there has been no demonstration of any kind. It is expected the trial will be completed and the negro returned to the penitentiary this afternoon.

Reidsville, Jan. 14.—At a largely attended mass meeting held at the county seat today a bond issue bill was adopted and will be sent to the legislature for passage by that body. This measure will permit a vote in this county on a proposition to issue \$500,000 in bonds for permanent roads. The fund will be expended by a commission, composed of a Democrat and a Republican from each of the eleven townships.

Washington, Jan. 14.—The work of constructing the mammoth fertilizer factory of the Pamlico Chemical Company of this city has almost been completed and nearly all the machinery has been installed. This large manufacturing plant is situated on Pamlico river, about 2 miles below the city, and is one of the largest of its kind in the state. The company is composed of a number of Washington's most prominent and influential business men, as well as several prominent business men from other parts of the state. The plant will begin operations on full time, it is understood, next Monday. A high grade of fertilizer will be manufactured.

That Charlotte ranks with the first in almost everything has been frequently demonstrated. The latest acquisition in the listing of the "firsts" is that of Mrs. Addie Ward, of the Calvine community settlement, who is a great-grandmother of nine months standing and yet is only 46 years of age.—Charlotte Observer.

Wasted Sweetness.

We were told a few days ago of a very unusual occurrence that befell a man living near Siler City. This man had bought a jug of molasses and carried it to his home and placed it in his bedroom near the fire. About midnight he was awakened by a report as though of a gun and hastily arising found that the molasses had become so heated that the stopper was blown out by the concentrated workings and the molasses was pouring out of the jug in a stream. Seizing the jug, he placed it in a large tub, but in a few minutes the tub was overflowing. All the vessels in the house were pressed into service and filled, but still the flow continued, nor did it cease until the floor was covered ankle deep. It was certainly a sticky time and much sweetness wasted, and that man is yet wondering what process of nature generated a house full of molasses out of only a gallon jug! And, we ourselves, are almost tempted to doubt the correctness of this, though our nature is so credulous and tender that we generally believe most anything. We would be glad for some of our correspondents or exchanges to give an explanation of the above profligacy.—Siler City Grit.

Scotland's Crop.

The county that gets ahead of little Scotland will have to move fast. With 15,000 people, it produced 26,000 bales of cotton this year, or about a bale and two-thirds to every man, woman and child in the county. The Laurinburg Exchange estimates that this cotton, including the seed, was worth not less than \$80 a bale, giving the total crop a value of \$2,080,000. Add to this the quarter of a million received from the melon and cantaloupe crop, Scotland's other money-maker, and those 15,000 people got nearly two and one-half millions from their soil.

While credit is being given to progressive Scotland for this most enviable showing it might be well to reflect for a moment on how this result was brought about. The natural fertility of the land does not suffice to explain it. The people who are farming that land are keenly alive to the advances which are being made agricultural lines and are busy in putting them into practical application, and it is this feature of the record which is the most important.—Charlotte Observer.

BACK TO OXFORD TO STAND TRIAL

FOUR MILITARY COMPANIES GUARD THE PRISONER

THE TRIAL PROCEEDING QUIETLY

Raleigh Military Company Leaves Penitentiary Guarding Prisoner and Reinforced by Three Other Companies to Guard Court House—Trial Likely to be Short.

Raleigh, Jan. 16.—Nathan Montague, the negro who assaulted Miss Mattie Sanders and murdered her father, J. S. Sanders, and her little nephew, in Granville county, was taken from the penitentiary to Oxford today to stand trial. Because of intense feeling in the county, four military companies have been called out to guard the court house and protect the negro. A Raleigh company left here with the negro.

The Franklin company joined them at Franklinton and two more companies awaited them at Oxford. The negro has been in the penitentiary for safe keeping since committing the crime in December. Sheriff Wheeler, of Granville county, expects a speedy conviction and said he would probably have the negro back in the penitentiary tonight.

It is reported here that farmers in Granville have bought all the ammunition in Oxford and are determined to put the negro to death. The strong military guard will probably prevent any outbreak. The negro's crime was an unusually brutal one, and though the evidence is circumstantial it is conclusive.

Danger of Same Blunder.

One of the biggest blunders a state legislature ever made was the passing of the railroad legislation—the passenger rate regulation—by the general assembly of North Carolina of 1906-'07. It became necessary to call the assembly together in extraordinary session to correct the error. From indications the present legislature is in danger of committing the same mistake. The mileage book and railroad regulation is the burning issue. It is ridiculous to try to frighten the railroads into abandoning their mileage book ruling by threatening to make a maximum rate of two cents a mile. It is more, it is childish.

When you are prodding the railroads you are placing the tariff into your business and into your purse. The railroads have developed this country. Without them we would be removed back more than a half century. No corporations give as much in return for their "takings" as the railroads.—Salisbury Post.

MOB VIOLENCE IN KENTUCKY.

Three Prisoners Taken From Jail Sunday.

SENATOR COTTEN PROPOSES DOG TAX

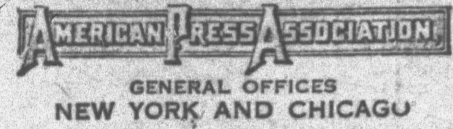

THE TORRENS SYSTEM.

There is a prospect that the South Carolina legislature will provide that state with the Torrens system of registering deeds. Somebody has a chance to make himself famous in the North Carolina legislature by championing and passing that measure for this state.—Charlotte Chronicle.

The New State Building.

Sentiment for a new State building seems to be growing. The need for such a structure was emphasized at the meeting of the North Carolina Historical Society, by both ex-Governor Jarvis and Associate Justice Walker. The former urged that "a million dollars of bonds be issued for a great fireproof State building on the square now occupied by the old agricultural and Supreme court buildings, north of the Capital square. He said this could be done with an annual tax of only two-thirds of one per cent on the \$600,000,000 of property assessment in the State." Mr. Walker spoke of the importance "of furthering the literary spirit among the people of the State, and urged that there be further strenuous effort to prevent the loss of what has been gained through lack of protection of records and historic material through fire—a hazard that now constantly threatens them with destruction." We doubt if there is a State in the Union that has a more valuable collection of records than North Carolina, yet these records have no better security from destruction than so much furniture stored in a warehouse. These records are of a nature that cannot be protected by insurance. Once lost, they would be gone forever, and no insurance policy in the world could cover the loss. The remedy is a fire-proof building, in connection with which, the different departments of the State would be provided for. A building suitable for the purpose would cost \$1,000,000. That sum would not be excessive, and as ex-Governor Jarvis has pointed out, could be secured at a rate of taxation that would be no burden at all on the people of the State. It is to be hoped that the legislature will give North Carolina this greatly needed building.—Charlotte Chronicle.

To Save Time and Expense.

Not only is the proposition of Ma-
jor Graham to strike out the pro-
vision making the fact one is not a
freeholder a ground of challenge but
the act ought to pass the further
provision that the fact that one has
served as a juror within the last two
years should also be omitted as a
ground for challenge, except, per-
haps, the fact that he has served as
a tales juror.

These causes are no advantage to
a defendant, as the State has the
same opportunity and the only effect
of such causes of challenge is ex-
pense and delay.

Much time is consumed inquiring
about these matters and the judges
have to order a larger venire to make
allowances for these challenges and
many counties pay special venemen.
Besides, it is a great inconvenience to
the public as well as loss to take a
large number of the people from their
business in this day, and time is an
important reason why this measure
and the one introduced by Mr. Bat-
tle reducing the number of challeng-
es in capital cases should be pass-
ed.

To take as many as 200 men from
their business at certain times of the
year is a serious matter.

The experience and wisdom of leg-
islators like Major Graham and Mr.
Battle is well worth consideration.
Any measure that saves time, ex-
pense and works no hardship on any
one ought to pass.

The lawyers ought to want these
measures to pass and many of them
do, because it expedites trials and
relieves the crowded dockets.

Mr. Clement Manly, when presi-
dent of the Bar Association, recom-
mended some important changes in
our jury laws along this line which
has never received proper attention.
—Raleigh News and Observer.

The Sunshine.

These January evenings recall the
pithy observation that by day the
sun shines but that at night the sun
shines. The so-called stars are really
stars, many of which are unspoke-
nly bigger than the earth's sky king and
some of which doubtless have their
own system of planets dancing around
them. Such a sun is Sirius, the dog
star, which at this season of the year
glows brightest over in the south-
east. Thousands of astronomers are
studying it tonight and the crowds
on their way home from the theater
will find it worth while to look up
for a moment to this great show of
the heavens.

The beams that strike their eyes
have been eight years in reaching
this world. Sirius is such a long
long way off in the blue. If it were
nearer it would blur our own sun as
the sun would blur a candle at noon-
tide.

Astronomy is an old-fashioned and
as is sometimes supposed, rather a
visionary study. Busy men and wo-
men are content to leave the stars, or
the suns, to the poets. Yet, it is astron-
omy that determines our clocks and
calendars. The old sages were right
after all when they imagined that the
stars ruled over human lives, for
they direct the going and coming of
ships, they are the measure of the
hours, the guide of commerce through
time; they regulate the affairs of
people who forget they are in the
heavens.

January is a great month for watch-
ing the stars. Many of them that are
dim in other seasons or that betake
themselves to some hidden paths of
the universe are now in the center
of our earthly stage.—Atlanta Journal.
