WHAT THE LAW MAKERS ARE DOING

PROCEEDINGS OF THE N. C. GENERAL ASSEMBLY

VERY QUIET DAY IN BOTH BRANCHES

Bills to Appoint State Building Committee and Erect Administration Building Chief Matters of Importance Before the Senate—House Busy on Committee Reports and Passing Bills—But Few New Ones Senate—Tuesday.

The senate had some petitions, of local interest only, and acted on a number of bills that had been sent over from the house. The only new bills of general importance introduced was the one by Senator Boyden, of Rowan, to appoint a state building commission and erect an administration building, the bill provided for a bond issue of \$1,000,000 for this purpose.

Several bills passed their second and third reading.

House—Tuesday.

The house heard reports of committees on numerous bills, and many passed third reading. If the new bills introduced nearly all were of local nature. The only ones approaching general interest were:

Coxe of Randolph: To equalize compensation of clerks in state offices.

Doughton of Alleghany: To make owners of dogs liable for damage.

Nunn of Craven: To regulate proceedings against delinquent insurance companies.

Clement of Halifax: To amend marriage law.

POSTAL SAVINGS BANK.

WRECK ON COAST LINE.

Two of Crew Fatally Injured and Fourteen Cars Demolished.

FLAGS AT HALF MAST, A SHIP OF DEATH

Battleship Delaware Reaches Port With Dead Soldiers.

Norfolk, Jan. 18.—With her flags at half mast, a veritable ship of death, the battleship Delaware arrived here today from Guantanamo. She had on board the eight men who were killed and one seriously injured from boiler explosion yesterday. Several others were slightly injured. The vessel's arrival here was delayed by the snow storm and gale. It was compelled to anchor and wait several hours for the gale to die down.

PASTOR ALONG RIGHT LINE.

Declares For Amendment to Sabbath Law.

Preceding his sermon Sunday night Rev. A. J. Moncrief, pastor of the Tabernacle Baptist church, spoke forcibly regarding needed amendments to the Sabbath law, and the "co-operative bar room" proposition. Mr. Moncrief said:

"I announced this morning that I wished to say a word this evening preceding my sermon, to the members of the general assembly about two things that body ought to do during the present session. I am glad to see so many here, and extend to you a most hearty welcome to all of our services. You are here as the representatives of the various counties and districts of the State, charged with a grave responsibility to the whole commonwealth. To you are committed the affairs of the State, and the interests of all the people. Two matters will probably come before the assembly during this session in which I feel an interest, because of their moral significance. They are matters deserving careful thought and careful legislation.

"The first of these is an amendment to our Sabbath law. The law as it now stands would be very good if there were any penalty attached, but without this it is a farce. One who has not the proper respect for the Sabbath, nor for other people who have, and who was disposed to violate the law for profit or pleasure, would not be deterred by the insignificant penalty of one dollar. This has been proved by experience right here in Raleigh, and elsewhere. An amendment ought to be added to that law fixing a penalty that would make the law worth while. Those who will not respect this great Christian institution for itself ought to be made to by an effective law for its observance.

"The other thing which ought by all means to be done is to strengthen and improve our prohibition law, which has been so great a blessing both morally and materially to the State. If it is possible for the law to be so interpreted as to make legal the "co-operative bar-room" of that fashionable Charlotte club it ought by all means be so improved as to make impossible forever henceforth any such interpretation. While I am quite confident that the weight of legal authority, and the opinion of the vast majority of the thoughtful people of the State, are against such an interpretation, and heartily approve the dissenting opinion handed down in the case, yet it ought not to be possible for any such construction to be placed upon the law, for if such institutions as that "co-operative bar-room" can do business under the law we might as well have a license system. If the law can't prohibit that sort of business we ought not to call it a prohibition law. "A bill has already been introduced to prohibit the sale of near-bet, and it ought to pass without opposition. If ever a long-suffering people have endured enough of reproach and borne enough of disgust the people of this city and State have in this near-beer nuisance. It is a cheap slop, intoxicating and vicious, and its sale is manifestly a violation of the spirit of our prohibition law, and ought to be stopped."—Raleigh News and Observer.

BILL NYE DAY IN THE PUBLIC SCHOOLS OF N. C.

To Pay Tribute to Dead Heroism 4th, Wednesday in February.

Raleigh, Jan. 17.—Wednesday February 22, has been appointed by Hon. J. Y. Joyner, state Superintendent of Public Instruction, as "Bill Nye day" in the public schools of North Carolina. A special hour will be set aside on that day for the teachers to read to the pupils a biography of Bill Nye, and a brief program of his writings will be carried out.

Superintendent Joyner has been in correspondence with the Bill Nye memorial committee of the North Carolina Press Association for some time, and the final arrangement were completed today after a conference with Mr. J. P. Cook, treasurer of the committee. The program for use in the schools, embracing the instructions from the state superintendent to the county superintendents and the teachers, will be sent out by the committee in ample time. Incidentally, the movement contemplates voluntary contributions from the school children to the Bill Nye memorial fund, which is to be applied to the erection of a handsome building at the Stone-wall Jackson Manual Training School at Concord. Every child in the state attending a public school, will be asked to bring one penny or more on Thursday following Bill Nye day, which will be applied to this purpose. Superintendent Joyner is taking most kindly interest in this great movement, and has responded nobly to the petitions of the committee, a co-operation which is heartily appreciated by the committee, as well as all the editors of the state, who are deeply interested in the memorial cause.

COMMANDER AND THREE OF CREW FOUND DEAD

Twenty-Seven Rescued From German Submarine.

WEARING OUT.

Mr. Thad R. Manning in the last issue of his paper, the Henderson Gold Leaf, has a pathetic editorial. He has been engaged in the active management of his paper for twenty-nine years, and he has worked so hard, he says, that he is now "laid up for repairs," to use his own words in a Richmond hospital. Preferring to wear himself out by hard work rather than to "rust out" as he again expresses it, he has labored in and out of season, to give his people a good paper. In putting his life into the paper he has given his life to it, and now retires brokers in health and in all probability will never be able to take up the pen again. He has done a fine work for his town and section, and retires with the love and confidence of his people and his newspaper bretheren, who will hope that his malady may prove less serious than is now supposed, and that he may once again take his place in the great work he now relinquishes.

With the retirement of Mr. Manning, we can recall only three editors in the state who have been connected continuously with the same paper for twenty-nine years. They are: Maj. H. A. London, of the Pittsboro Record; Mr. D. J. Whichard, of The Greenville Reflector, and the editor of The Times.—Concord Times.

Good Roads Bond Issue.

"Issuing bonds," remarks The

Wilmington Chronicle, "is a serious matter. It becomes a question as to

whether the resulting good overbalances the inevitable attendant evils. Bond issues always beget a spirit of extravagance, often breed graft and always entail a burden of taxation upon unborn generations. But often a bond issue is attended with more good than evil and in such cases it is wise to issue bonds. It is simply a question of wisdom for the people to decide." It is possible that The Chronicle's apprehension of extravagance and graft may be somewhat too intense and it is certainly fair that "unborn generations" should be pledged in advance to bear their reasonable share of the burden of improvements which will be of sufficient permanence to be of lasting benefit. None the less, our contemporary's line of reasoning is quite sound and contains a timely suggestion to advocates of bond issues for highway purposes. If bond issues are to be carried everywhere they are needed their advocates must get down down to hard-pan and show the voters just wherein consists the advisability of the step. The arguments brought with this end in view will naturally vary from county to county.

An apt illustration of this "showing" is to be found in a communication to The Fayetteville Index, dealing at length with many phases of the good roads problem. The correspondent of The Index cites the fact that Cumberland county is paying approximately the sum of \$12,000 a year towards road building in the shape of convict support and equipment. For this outlay it is receiving something worse than fair road making and as regards some townships nothing at all. A taxpayer is quoted whose road tax amounted to \$3.35, but in whose township not a single mile of road has been established by the convict force. Thus, under the present bondless system, Cumberland is spending a sum equal to 5 per cent. interest on a bond issue of \$240,000 without receiving an adequate return. The Index's correspondent estimates that an issue of \$300,000 would put a modern highway through every township in Cumberland. A simple calculation is sufficient to show the enormous benefit which the addition of only a few thousand dollars over the present expense would bring about. A single swallow does not indicate a summer nor does the above example in county arithmetic enough to demonstrate the necessity of bonds in Cumberland. It is of prime importance that the good roads organization take pains to inform themselves thoroughly in order that not a single piece of evidence like the above, but dozens may be brought to bear on the electorate. It is only by such missionary work, based on accurate facts, that the people at large are to be thoroughly aroused to their interest in this important phase of progress.—Charlotte Observer.
