OUR MISSIONARY WRITES AGAIN

MISS LAURA COX TELLS OF HER WORK IN MEXICO

A REAL FISH STORY THAT IS TRUE

Progress of Pupils in the Missionary School—They Learn English Rapidly—How To Handle The Obstinate—She Enjoys Weekly Visits of The Reflector.

My Dear Reflector:

I am greatly, yes, greatly, indebted to some one for the dear old paper of my native county, for I have received the "weekly" regular since I've been in Mexico. I am sure no one at home or abroad delights more in reading its pages. Of course, I get news from a number of friends, but I'm always very eager to see The Reflector.

Well, may I give you some notes that have been very interesting to me and I feel sure that they will be of interest to some, if not all of you. Allow me to tell you a fish story first and then I'll give you some interesting facts about the natives of Mexico. Here goes my story: It's a real fish story, but unlike many others in that it is a true one, although it may sound like it is not. One day before Christmas, Mr. and Mrs. Marrs had a number of friends to visit them and in the afternoon they invited me to join them and take a boat ride. I am always ready to go, you know, so of course I said (conscientiously) with great pleasure. I was ready in a few minutes, so we started. After we had gone some distance from land we looked across the bay and saw a number of men in boats fishing. Our captain took us over to them so that we might see them catch fish. Just before we reached the fishing boats we passed a gang of pelicans, I am quite sure there were 150 or 200 in the gang. To me they were perfectly beautiful as they swam across the gulf. As you all know, they are larger than a swan and have very large bills. These were the color of a turkey. Well, now to my fish story. When we finally reached the place where they were fishing, we were very much interested in "the fishermen's luck." In a few minutes one caught a fish 1 1/2 yards long, and wide in proportion. It was so large he had to kill it with a club before taking it in the boat. I thought that was an extremely large fish, but one day since then I saw a man on the street with one thrown across his shoulder and while the main part of its body was on the man's shoulder its tail almost touched the ground.

Well, we left the fishing boats and went to the rock cave I told you about before, and while there gathered a number of five Americans and a number of board and as we were leaving the cave I wish you could have heard them sing "Nearer My God to Thee" in Spanish. Two of the Mexicans were ministers. One is an evangelist—can talk English real well. Several years ago, he went to our own Seminary at Louisville and took the work there. As I sat and listened I thought "What hath God done for these people." Only a few years ago without the true gospel and now singing His praises with all their soul. The missionaries say that when one is turned to the true Christ that they are the bitterest foe the Roman Catholic have. We finally reached the shore and all felt that it was an afternoon well spent.

Now, may I tell you a few things about our school? On Friday night before Christmas we had a short program and a Christmas tree for the children. In the English department, of which I have charge, there are about twenty-five pupils. Their parents are so anxious for them to learn English, I felt that part of the exercises should be given by my pupils. So Mrs. Marrs, in her own sweet Christian way, came to my rescue and composed a song for me and I wish you could have heard them singing it with me. They did not understand all its meaning, of course, but they were perfectly delighted with the idea of singing in English, and many like little birds.

When one gets off I have to let him entirely alone till he gets cool. That is the only way I can manage them at all. I had to hold a boy not long ago to keep him from going home. We have to do all sorts of ways to let them know we are their friends. Ordinarily they are all O. K.

One day this week I was reading a very simple little story to my 3rd grade and one of the grown girls heard me say, "For Jesus Christ's sake," and she said "Who is Jesus Christ?" You can imagine how my heart went out to her. She is a very dear girl, and if I can only be the means of helping to bring her to the true light, I'll be so happy. We have to be very careful, of course what we do and say. Sometimes it's very hard to know, but we have to lift our eyes and look to the hills as did David, for we know that God is a present helper and will guide His children in the right paths.

If at any time any of you feel that you have the time, I'll be glad to hear from any of you. I am always glad to hear from my old State.

WHAT THE LAW MAKERS ARE DOING

PROCEEDINGS OF THE N. C. GENERAL ASSEMBLY

TO VALIDATE PITT COUNTY BONDS

Bill to Establish Teachers' Training School in Western North Carolina, Community Getting It to Pledge Sum at Least as Large as Appropriated by State for Buildings.

Senate—Monday

The senate had only a brief session and the most important matter presented was a bill to establish a teachers' training school in western North Carolina. The bill provides for an appropriation of \$25,000 for building and equipment and \$10,000 annually for maintenance. The county or community getting the school required to pledge an amount at least as large as that appropriated by the state.

Senator Cotten introduced the bill authorizing the commissioners of Pitt county to issue bonds to build a court house and a jail. This bill is to validate the sale of bonds recently made by the commissioners for \$75,000 for this purpose.

On Saturday Senator Cotten introduced the bill authorizing the people of Greenville township to issue bonds not exceeding \$50,000 to build good roads in the township.

House—Monday

Representative Thorne introduced a bill similar to the one in the senate validating the sale of bonds by the commissioners of Pitt county.

The only new bills not purely of a local nature were:

Norman: To amend the laws of 1907 relative to divorce.

Carr of Duplin: To protect the forests of the state from fire.

Wall: To prohibit sale of merchandise in any state buildings and grounds on Sunday.

Allred: To amend the revision of 1905 relative to sampling commercial feed.

The Rousing of Granville.

The people of Granville county are awakening to the splendid results which may be obtained by the persistent use of the road drag and are setting about securing these results in most business-like fashion. It is reported that not until about two weeks ago had the drag been used in Granville but within that time ten have been put to work and the commissioners have ordered ten more. When these latter are ready for use it is planned to have them operated upon a schedule so that when one farmer has worked a stretch of road bordering upon his property for a time he will be able to turn the drag over to its next user immediately. If this plan is a success it means that twenty road drags will be in constant use for something like eight hours a day and the resultant improvement to the roads can be readily imagined. But the plan means more than this. When the farmers realize the marvelous things which may be accomplished by a little co-operation they will be loath to see any public enterprise attempted without such co-operation. And if the farmers of Granville or any other county once become thoroughly welded into a compact mass behind the wheels of the car of progress, there need be no limit set to what may be expected.—Charlotte Observer.

NOTES FROM THE UNIVERSITY

CHAPEL HILL VICTORIOUS IN FIRST BASKET BALL GAME

REV. B. W. SPILMAN'S ADDRESSES

University Y. M. C. A. Sent Large Delegation—Twenty Three Baseball Games Scheduled—Team for The Coming Season Not a Very Strong One.

Chapel Hill, N. C., Jan. 31.—The University was victorious in her first game of basketball played in the gymnasium Friday night with Virginia Christian College. The score was 42 to 21. The local quintet showed unexpected team work in the second half and proceeded to pile up the score.

Everybody interested in the success of Carolina athletic teams is delighted at the announcement that Mr. Branch Bocock has signed up to coach the varsity football team next year. Mr. Bocock has coached the V. P. I. team for the last two years and has turned out some great teams up there. He is well acquainted with climatic conditions in the South and is better fitted to handle a team of Southern boys than a Northern coach. He graduated from Georgetown University where he also studied law until he received his license.

Rev. B. W. Spilman, Baptist Sunday school evangelist, delivered addresses at the Baptist church last Sunday. He made a strong plea for Sunday school workers to re-double their efforts to keep the big boy interested in Sunday school. Mr. Spilman devotes his entire time to Sunday school work among the colleges and universities of the South and East.

The Chapel Hill Y. M. C. A. sent a delegation of ten men including Mr. E. P. Hall, general secretary, to the inter-state convention of Young Men's Christian Associations which met in Raleigh the last three days of the week just closed. This was as large a delegation as was sent by any college in North Carolina and South Carolina. The Chapel Hill association is in a flourishing condition now. There are 325 men in the Bible study group, and the Missionary group which was organized last spring included 315 and bids fair to reach a still larger figure this year.

Manager E. F. McCulloch has announced the schedule for the baseball team. There are 23 games, 11 of which are to be played in Chapel Hill. Oak Ridge, Wake Forest, Davidson, Guilford, South Carolina, V. P. I. and the University of Virginia, all have arranged games. The two Virginia games will be played in Greensboro and Charlotte, April 8 and 9th, and the third game in Charlottesville, April 21st.

The outlook for material for the team to play this schedule is very poor. Only one member of last year's varsity is back who is sure that he will play his position. This is Captain Hackney, of Wilson.

TESTING ROBIN'S SANITY.

Judge and Jury Have Him Under Examination.

NO NEW YORK SENATOR YET.

Republicans Drop Depew In Effort to Break Deadlock.

NORTH CAROLINA HAPPENINGS

NEWS-ITEMS TAKEN FROM OUR EXCHANGES TODAY

CONDENSED FOR OUR BUSY READERS

Notorious Blockader Shot in Yadkin—The Harnett Reporter Burned Out—Representative Woodson of Cleveland Sick—The Negro Anti-Tuberculosis League in Raleigh.

Statesville, Jan. 30.—Cleveland McBride, a notorious blockader, who has been defying the officers of Iredell, Davie and Yadkin counties for some time, was shot and probably fatally injured late yesterday afternoon by a posse of Iredell officers, who were attempting to arrest him. The shooting occurred just across the line in Yadkin county, near the home of James Haynes, a friend of McBride's, and the injured man is being cared for in the home of Haynes. A message received here tonight is to the effect that the blockader is still alive, though his recovery is hardly expected. He has pistol wounds in his head and back and one leg is sprinkled with shot.

Lillington, Jan. 30.—Fire of an unknown origin yesterday afternoon completely destroyed the building of the Harnett Reporter, of which J. E. Ligon was publisher. The loss to the plant, which was comparatively new, is estimated at \$1,500, with no insurance. The loss to the building is not known at this time. Editor Ligon had but recently taken over the paper, coming here several weeks ago from Greensboro, where he was connected with the Greensboro Daily News. He had gotten out but two issues of the paper. It is announced that the paper will continue, orders having been wired for new equipment.

Raleigh, Jan. 30.—The Negro Anti-tuberculosis league will hold its second annual convention at Shaw University here tomorrow, January 31, and there will be addresses by a number of prominent physicians, both white and negro and well known laymen interested in the subject. President J. B. Dudley, of the negro A. & M. college, of Greensboro, is president of the league.

Raleigh, Jan. 30.—Rev. J. C. Woodson, representative from Cleveland county, was taken violently sick in the State house today and is reported by his physician to be a very ill man tonight. He has not been carried to the hospital.

THERE IS A DIFFERENCE IN ROADS.

If two railroads running from Greenville to Norfolk solicited your shipment of cotton, and one of them agreed to land four bales in Norfolk for \$1.00, and the other would land only one bale for \$1.00, by which road would you ship if you had twelve bales? Now this same twelve bales of cotton has to be brought to the railroad station over some sort of country road before you can ship it. Over a good hard surfaced road you can haul five or six bales per load with a two-horse team, while you can haul only two, or possibly three, over these same roads in their present condition. Do you want to change these sandy roads to good ones? It will not cost you any more in taxes, because the same rate of 15 cents on the \$100 valuation you are now paying will be sufficient to make this change if properly applied.

PENNY WISE AND POUND FOOLISH

There are men who have no hesitancy about giving a direct mortgage to buy a farm, to build a house, to buy a horse, a buggy, a piano, to run their crops, or even to get a washing machine right. Yet those same men will lift their hands in horror at the suggestion of giving an indirect mortgage to build good roads, even when they will never be called upon to pay the principal and only their proportional part of the interest. At the same time the mortgage for the good roads, while not adding anything to their taxes, will save them enough on the wear and tear of horses and vehicles and lost time to enable them to pay off their direct individual mortgage. If they would look at the situation logically, they should be able to see it in this light. But we will always have some people who are "penny wise and pound foolish."

There are men in Pitt county who a little less than four years ago took sides against issuing bonds to establish East Carolina Teachers' Training School, with the expectation of landing in office before now on the popularity such opposition won for them. Those same men today could not get votes enough to be township constable if they tried. In less than four years from now the same thing can be said of some of the opponents to bonds for good roads.

We would hate very much to have the community in which we live and get our living brand us as a man always opposed to progress and

Letting Down The Bars

The tendency in North Carolina between 1885 and 1910 was to let down the bars in North Carolina as to divorce laws. Almost every legislature added a new cause for divorce, our court dockets became crowded with divorce cases, and this State bid fair to emulate those Western States of which it might be said: "Come in. Divorces while you wait." There were hardships in each case which caused additional causes, nearly every one of which was to cover a special case. The constitution will not permit the legislature to grant a divorce, and this inhibition caused a resort to the plan of making a general law to meet a certain case, which, of course, opened the flood-gates and increased the number of divorces. It had grown to be a serious evil in North Carolina and the people became aroused, delegations came to Raleigh, and after long hearing and much discussion, the legislature repealed every new cause for divorce and went back to the code. Some good people wished then to repeal some of the causes in the code, but after a long consideration it was decided to press a return to the code causes and repeal all others. This was wise and no act of the general assembly in a generation has been more widely approved.

There seems to be a disposition to re-open this question and add new causes. It is to be hoped this legislature will not take that backward step. There will be plausible reason urged for granting new causes and good men will urge them from high motives but the door once opened we shall see still further causes and the divorce mill will be set in motion.

North Carolina in signal ways has declared for the code law on divorce, and to depart from that is to re-open a Pandora box of evils.—Raleigh New and Observer.

A Growing Evil.

The author, David Graham Phillips, is the latest victim of the bullet of an assassin, but, fortunately, there is still a slight hope for his recovery. Without wanting to be heartless, we might add that it is fortunate that the man who fired the shots then turned the pistol on himself with fatal effects. Fortunately, we say, because the would-be murderer, who, we understand, is wealthy and, in a way, prominent, had he lived, would no doubt have furnished the country with another instance of the sickening spectacle of a trial with a plea of insanity, with so-called experts on one side testifying one thing and so-called experts of equal expertness on the other side justifying another thing. One side would have the prisoner absolutely insane and immune from punishment, and the other would have him a common criminal.

This brings to mind two things that have only of recent years crept into our civilization to any extent: the killing of prominent people by fanatics or criminals, and the insanity plea in the courts supported on expert testimony. Both are to be regretted. Both are blots on our national good name. The whyforse we do not attempt to analyze. But we do say that if there were fewer experts who essay to tell a man's sanity or insanity by examining a button taken from his coat and fewer lurid accounts of prominent murders and murderers in the newspapers there would be fewer shots fired and fewer useful lives ended.

Fortunately, this poisonous virus of assassination has not to any extent invaded the south, but we should keep ourselves on guard to crush it out in no uncertain manner if it should appear.—Greensboro News.

Opinions of The Supreme Court.

The Chief Justice was for many years on the Supreme bench of Louisiana, and for several years he was in the United States senate. He was sixty-five years old in November. On March 12 he will have been a member of the Supreme court at Washington for seventeen years. He is large of physique and large of brain and heart—with such talent for the expounding of our constitution and law, and such gifts of clear and keen analysis, that he may well help us to keep from losing faith in the value of our most distinctive political institution. For undoubtedly there is nothing so distinctive in our system as the Supreme court; and the authority we repose in the men who constitute this high tribunal could only be justified by intelligence, wisdom, and character on their part. Happily, the Supreme court has justified itself through the whole course of our one hundred and twenty years' or constitutional experience. The questions it has to answer are fraught with the great consequences; and many of them in the past have been decided by a bare majority of one vote in a tribunal of nine. Yet, for working purposes, the country has nearly always accepted in perfect good faith the majority opinion, even when that of the minority might have seemed equally wise; and there has been surprisingly little harsh assault in all our history upon either the good faith or the intelligence of the court.

Justice White himself has delivered minority opinions in some of the greatest cases that have been decided in recent years. He did not agree with his colleagues in the decision that overthrew the income tax some years ago, and his minority opinion in the Northern Securities case seemed to many of us at the time as more convincing than the opinions expressed by the majority. Interpreting a written constitution is by no means an exact, scientific thing about which trained and logical minds must necessarily agree. We have before us a period of great critical activity on the part of our highest tribunal. We may feel confident in having a bench made up of men of fidelity and conscientious industry, as well as of legal learning and intellectual power. And it will be most reassuring if these nine men can agree in their opinions upon the great cases that are soon to come before them. It is quite possible, however, that they may differ in their views. Again and again Justice White has differed from the majority of his colleagues, and his dissenting opinions have brought every resource of a powerful logician to bear upon the destructive analysis of the prevailing arguments. No outside critics of the courts have been as relentless in assault as have the dissenting judges themselves.—From "The Progress of the World," in the American Review of Reviews for January.

The Farm in the Days News.

The elopement of a dutchess or the discovery of a comet are of trivial importance beside the upshooting of a grain of corn.

It is doubtful that this truth ever will be, or ever could be, applied to the pages of a newspaper, that everyday mirror of things as they are. It is a significant fact, however, that newspapers are giving more space and prominence to activities and ideas from the farm. The boy who wins a prize for raising an excellent quality or amount of corn finds his picture printed along with that of aviators and governors. The campaign against the boll weevil receives a bigger head than a revolution in South America. The itinerary of the agricultural train that is soon to start upon its journey through Georgia will be reported as carefully as the sessions of congress.

This means two things: First, that the farm is getting closer to the daily life and interests of all people, and second, that the public at large is becoming more concerned over what happens on the farm. There was a time, and that not

very long ago, when things agricultural jogged along the beaten road they had followed for decades. The methods and largely the ideas of one generation were pretty much the same as those of the one before it. A crop was a crop, a cow was a cow, and the seasons were so many monotonous repetitions of planting and harvesting. Nothing new really happened on the farm, however delightful its staid life might be. But today—why, agriculture is a strong rival of politics and society for interesting stories and surprising developments. Scarcely a four and twenty four hours goes by that some important meeting of farmers is not told of, some new movement for the betterment of the land is started, or some record of the field is broken. In all of this there is cause for keen satisfaction, for in the long run the good fortune of us everyone may be traced back to the soil.—Atlanta Journal.

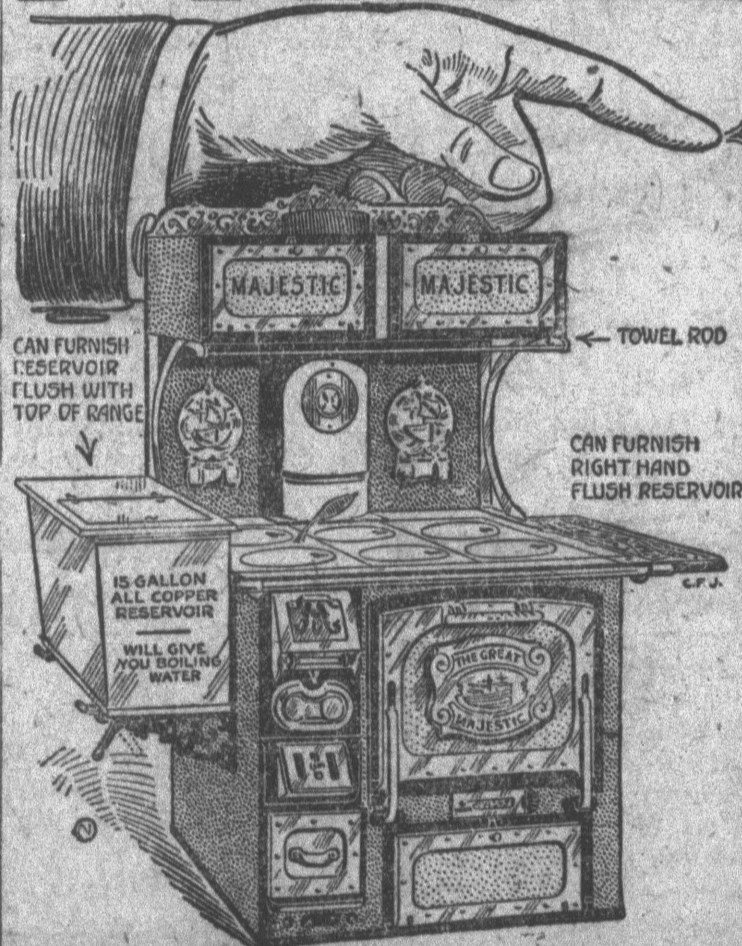
