### NEWS ITEMS TAKEN FROM OUR EXCHANGES TODAY

### CONDENSED FOR OUR BUSY READERS

**Postmaster Appointed for Raleigh—Farmer Killed Near Benson in Runaway—Boston Boyd Captured in Wilson—Yarborough House in Raleigh Leased.**

Winston-Salem, Feb. 15.—Mr. J. C. Brann, one of the largest tobacco growers in this section, with a farm at Hamptonville, Yadkin county, has invented a tobacco case, which he believes will be of immense advantage to the weed industry and make his name blessed among tobacco growers. The apparatus, is successful, will put the tobacco leaf in order for shipment and sale on the warehouse floor. At present, the majority of farmers have to depend on the weather to season their leaf. A model of the invention is being made and it will be sent to the patent office at Washington soon.

Raleigh, Feb. 16.—The Yarborough house has been leased by B. F. Griffin and several associates for ten years, and they will take charge when Howell Cobb completes his hotel, about May 15th. The Grimes Realty Company, which owns the Yarborough house, has contracted with Griffin and associates to thoroughly remodel the Yarborough and convert it into one of the handsomest and most convenient hotels in the South, expending \$50,000. Mr. Cobb, retiring proprietor, will run the Raleigh (formerly Park), which he will have completed by May 15th.

On account of the epidemic of measles now raging in Snow Hill, it was thought best to close temporarily the Snow Hill school. It was closed Wednesday afternoon of last week and is to re-open as soon as convenient. There have been over 40 cases of measles among the children of town—Snow Hill Standard Lenoir.

Washington, Feb. 16.—The senate this afternoon confirmed the appointment of Willis G. Briggs to be postmaster at Raleigh, the Morehead-Butler faction of the State Republican party thereby losing out in its attempt to defeat Mr. Briggs through objection of Senator Carter, of Montana, who was acting in their behalf.

Sheriff Nnn went to Wilson this morning to get the negro, Boston Boyd, who escaped from him several weeks ago, when he left him in the custody of a colored hackman, while he went for the jail keys. Boyd was arrested in Wilson last week.—Kinston Free Press.

Littleton, Feb. 16.—Mr. J. P. Alston one of the county's most prominent citizens was burned to death in his home here this morning about four o'clock. He was about 45 years of age. He was a bachelor and lived all alone in a small house, about one-quarter of a mile from town. He had been drinking much of late and was under the influence of whiskey yesterday. The night operator at the depot discovered the house on fire and gave the alarm. Many rushed to the scene, but nothing could be done to save the house or its inmate, as the house was a mass of flames when they arrived. The charred body of Mr. Alston was found in the ruins.

Wilson, Feb. 16.—Chief of Police O. A. Glover, who was so severely wounded on February 3rd while attempting to arrest Lewis West and his gang of desperadoes, and who has been in the Wilson Sanitarium ever since, was released from that institution this afternoon. He is now with his family and the whole state will be rejoiced to know that he is now on the road to an early and complete recovery.

Charles B. Plyler, of Union county, will not be electrocuted today. Yesterday Governor Kitchin exercised executive clemency and changed his sentence to imprisonment and hard labor in the state prison for life. In the last two days urgent appeals have been made in Plyler's behalf.—News and Observer.

### NORTH CAROLINIAN WINS HONOR

**Son of Judge and Mrs. B. L. Long, of Statesville Awarded Scholarship**

On last Friday, February 10, Mr. Mac Robbins Long of Statesville was awarded a scholarship to advance American artists abroad. The award is conferred as a tribute to merit and distinction achieved in his specialty in portraiture, without restrictions and without application on his part for the award. It is conferred so that he is at liberty to seek his own school or teachers abroad and spend two years in pursuit of his studies. It carries with it an allowance of \$1,200. It is the first distinction of the kind awarded a Southern artist. In May last Mr. Long finished the course in the Art Students League of New York and has since then been pursuing his work in his studio in Statesville, preparatory to going to Europe to complete his course. He has accepted the scholarship and will in a few months, after completing the work in which he is now engaged, enter one of the famous schools abroad.

Mr. Long is the only living son of Judge and Mrs. Benjamin F. Long, of Statesville. He was formerly a student of Horners and at Davidson College. He early gave evidence of artistic talent which soon became so pronounced that he definitely determined to make it his life work. Since that time he has devoted his time exclusively to it, with what splendid results the signal honor just won serves to indicate. Not only does he possess unusual natural talent and is already finely trained, but he is passionately devoted to his art and dedicates all his attention to its mastery, with an interest and an industry which are unflagging. His hundreds of personal friends and those of his family feel a keen pride in his achievements and a confident belief that the future holds even better things in store for him.—Charlotte Observer.

### POST OFFICE ROBBED OF \$2,500 IN MONEY AND STAMPS

**An Organized Band Working in West Virginia.**

### Plague Spreading in Russia.

London, Feb. 17.—Dispatches from St. Petersburg saying the bubonic plague has invaded Europe and caused thirty deaths in the Russian province of Astrokhan, resulted in steps being taken for the inauguration of a campaign to protect English ports from the plague. It is probable that in a short time a general quarantine against Russian shipping will be declared.

### Annexation Resolution Turned Down.

Washington, Feb. 17.—The house foreign affairs committee today in executive session turned down the Bennett resolution directing the president to enter into negotiations with Great Britain looking to annexation of Canada. Bennett was the only member to vote for a favorable report. This ends the matter.

### QUICK TRIAL FOR WEST.

**Governor Kitchin Will Probably Order Special Term.**

Governor Kitchin has been requested to call a special term of Wilson county court to convene at once for the trial of Lewis West and his accomplices in the killing of Deputy Sheriff Munford and the serious wounding of Chief of Police Glover.

West and his three associates are now being held in the penitentiary for safe-keeping.

The court will in all probability be called to convene within the next two weeks and the negroes will be conveyed to and from Wilson for trial on special trains and under full military guard, and will also be guarded during the process of the trial.

It is understood that steps are to be taken to arrest a number of negroes, whose names West has given as members of the desperado gang. West claims that either of the five negroes that were in the house at the time might have killed Deputy Sheriff Munford. The five men are Dave Young, Wade Williams, Matthews Mebane, Ed. Nelson, and Jim Simms.

The military guard has not been ordered as yet to go to Wilson as special guard, but it is very probable that it will be, as there are yet grave fears of trouble. The governor is determined, if possible, to prevent a lynching in North Carolina during his administration and will at all times order out full military guard. It might be said with certainty the National Guards will be present when Lewis West is tried in Wilson.—Raleigh Times.

### THIRD NATIONAL PARTY.

**La Follette and Followers About to Break Away.**

Washington, Feb. 17.—Senator La Follette and other Republican progressive leaders are about ready to break away from old time Republican moorings and lead the movement for a third National party. Forseeing that the 1912 convention will be dominated by Taft or the conservative wing of the organization, they believe that it is said only a few grudging concessions to insurgents will be granted either in the convention or in legislative matters. They are emphatically opposed to a compromise, and believe no time should be lost in forming a third party with a comprehensive radical program.

## WHAT THE LAW MAKERS ARE DOING

### PROCEEDINGS OF THE N. C. GENERAL ASSEMBLY

### STATE BUILDING AND FARM SCHOOL

**Senate Consumes Day Talking About These—House Has a Flood of New Bills, but as Usual, Most of Them Are of Local Nature.**

### Senate—Thursday.

The senate took all the morning part of the day's session in considering the Boyden bill to appoint a State building commission and authorizing a bond issue of \$1,000,000 to erect an administration building. There were several speeches both for and against the bill, and numerous amendments were offered. Some of the amendments proposed reducing the amount of bonds to \$500,000, while others wanted to cut the amount down to \$250,000.

The bill to establish State farm-life schools also came up as a special order and brought out much discussion.

### House—Thursday.

The house had a busy day with committee reports and the introduction of bills. Some of the new bills were:

Dillard of Cherokee: Authorizing the governor to take necessary action to settle disputed boundary line between North Carolina and Tennessee.

Taylor of Hertford: To change the name of Chowan Baptist Female Institute to Chowan College.

McPhaul: To prevent the sale of pistols and cartridges to minors.

Carr of Durham: To create a state tax commission and a state board of equalization of taxes.

McNeil: To amend the divorce law of 1905.

Williams of Swain: To increase the pay of the employees of state hospital at Raleigh.

Anders: To protect the public against drunkenness and profanity.

Ewart: To make the prohibition law effective.

The child could not swallow and yet it was thirsty and cried for water. Every time it saw water it would go into spasms. Its sufferings were indescribable.—Statesville Landmark.

### THE LOCKED HORNS.

**Finding of Two Dead Bucks Tells the Story.**

Oftimes we have heard and read tales (and doubted them) of two magnificent stags, or buck deer, meeting in dense forests and engaging in mortal combat over the possession of some fleet footed doe, fighting to the death, sometimes their antlers becoming entangled, both dying finally from utter exhaustion; but never have we heard of such in this section until a few days ago.

Last week a proof of such an encounter was found by Mr. Latham, superintendent of the road force on the Cognac-Hamlet road. The bucks, both full grown and beautiful specimens, were found head to head, their horns locked in this deadly tangle, so tight that they could not be pulled apart.

These stags had been dead for some time—possibly since last spring, when they had met in mortal combat over some timid fawn. The antlers, still entangled, were sawed off and put on exhibition at Hoffman.—Rockingham Post.

That North Carolina has a seaport that ranks fourth in the South in handling commerce, is something to be proud of. Only three other cities—Galveston, New Orleans and Savannah—handle more sea-going traffic than Wilmington.

It takes an effort to get business in these days, and neither an individual nor a town can draw much merely on past prestige. Greenville needs some united activity along this line. We have a good town all right, but that fact alone is not going to make business for the business men unless there is an effort to bring it.

After a fight extending over years, congress has passed the Appalachian forest reserve bill, which carries an appropriation of \$2,000,000 a year for the conservation of forests. North Carolina is one of the states that will profit directly by this bill, as some of the lands to be purchased by the government are in our mountain ranges.

**Selecting Poultry Breeds.**

Few books on poultry and still fewer poultry papers will advise a beginner as to what breed of birds to select. Usually the indecision is as between Leghorns, which produce many eggs, and other birds, which are the better winter layers. Then, again, the matter is befogged by cer-

tain declarations in other quarters that the Leghorns will lay as well as any other fowls if given proper treatment. Dwight S. Anderson gives his experience in the Farm Journal as follows:

The matter of choosing the variety of chickens to be kept is an important one; there are many points to be considered. It is, altogether, such a complicated matter that a book might easily be written on the subject. It will not pay you to experiment very much. You will have to take somebody's word for it, if you are not already more or less experienced.

These two facts have been true in my personal experience: White Leghorns lay more eggs in a year's time than any other breed. Plymouth Rocks lay more eggs during the winter than White Leghorns. A few years ago I tried the following system with some success: I kept both Plymouth Rocks and White Leghorns. The Plymouth Rocks laid the most eggs in the winter, and the White Leghorns laid the most eggs in spring and summer. In July, when the heat was intense, the Plymouth Rocks (because of their size, I believe) stopped laying, but the White Leghorns kept right on "doing business at the old stand" in winter, the White Leghorns laid few eggs, probably because the energy of their thin little bodies was consumed in keeping warm; but the Plymouth Rocks turned out on an average four eggs each week.

I never had any trouble keeping two breeds. I have heard it said that only one breed can be successfully kept, but I won't believe it until somebody gives me a good reason. I found it paid me to kill and market my Plymouth Rocks in the summer, just after they had stopped laying, and market my White Leghorns for roasters in the fall, just when they had started to molt. Thus, at a nice profit, I disposed of my two-year-old stock at a time when they were nothing but an expense, and still had eggs in marketable and profitable quantities, all the year round.

**First Colonial Assembly.**  
The first legislative assembly that ever met in America was at Jamestown, Va. Governor Yeardley, feeling that the colonists should "have a hand in the governing of themselves," to use his own language, called the assembly together at Jamestown, July 30, 1619. It consisted of the governor, council and "burgesses," as they were called, chosen from the various plantations. The laws passed by this body had to be ratified in England; but, in turn, the orders from London were not binding unless ratified by the colonial assembly. In 1621 these privileges were embodied in a written constitution, the first of the kind in America.—New York American.
