PROCEEDINGS OF BOARD ALDERMEN

BUSINESS TRANSACTED AT THE REGULAR MARCH MEETING

TOWN TO BUY A PAIR OF MULES

Street Committee Makes Report of Work Done—Establishing Property Corners—Miscellaneous Matters Requiring Attention of the Aldermen.

The board of aldermen met in regular monthly session, Thursday night, all eight of the members present. In the absence of Mayor Wooten, Alderman Flanagan, mayor pro tem, presided.

The street committee reported much work had been done the past month cleaning drains, putting in tiling, and trimming shade trees. In respect to the drain on Sutton Lane the committee recommended extending the drain down the lane to the bridge. The committee also reported that a corner had been established at the Cobb property on Cotanch and Fifth streets, and a corner at the Norfolk Southern railroad property on Tenth street.

In respect to the Lassiter ditch the committee recommended that tiling be put in and the ditch filled.

The street committee was instructed to have filled an old well on Read street.

The finance committee reported that finances were in better condition and recommended that interest be paid for 30 days on notes due the banks, with extension for that period.

No other standing committee had any report.

The fourth street paving matter was referred to the sidewalk committee with power to act, and if necessary lay the incomplete portion of the cement sidewalk.

An error in the taxes of the Greenville Banking & Trust Company was ordered corrected.

T. A. Duke asked permission to sell on the streets fish caught in his seine. The matter was referred to the market committee with instruction to provide him a fish stall in the market house.

R. T. Evans and R. W. King were relieved from poll tax for 1910, charged in error.

Aldermen Nobles and Van Dyke were authorized to have the hand fire engine repaired.

Aldermen Edwards and Nobles were authorized to purchase a pair of mules for the town.

Bills as approved by the finance committee were ordered paid.

The clerk was instructed to get up statement of amounts due the town for paving and curbing and turn same over to the finance committee.

The clerk was instructed to write the International Harvester Company in regard to machinery they had stored in the town in June, 1910, which was not listed for taxation.

A FARMER WHO BRINGS IN THINGS TO SELL

KIND OF FARMING THAT PAYS.

Raises Plenty of Supplies and Some to Spare.

There is not a better farmer in the county, nor a more successful one, than Mr. William McArthur, of Beaver Dam township. His success can in large degree be accounted for in the fact that he makes everything count. In addition to the so-called money crops, he raises a plenty and to spare of home supplies, and his barns, smoke house and pantry are never empty. And he rarely comes to town without bringing along something to sell to make such purchases as he needs. Thursday he brought in a wagon with two bales of cotton, and on top of the cotton was a pen of collards. The town folks were hungry for "greens," too, and bought them at 5 cents a head almost as fast as they could be handed out.

THE PRESSURE OF "BUSINESS."

The Man Who Stands for Principle Will Command the Confidence.

Long since the Louisiana senators surrendered to the doctrine of protection because of the sugar interest of the State. Later on, our North Carolina representatives, with one single conception, listened to the same song of the siren on the lumber schedule, and last week two or three of our trusted leaders refused to vote for the Canadian reciprocity agreement, for fear the farmers (oh, how many crimes have been committed in the name of the farmers) and the mica miners would suffer. The business question, with some men, has come to be the biggest of all questions. Senator Tilman brutally blurted out the truth several years ago when he remarked as an excuse for his vote on a certain question that since the "swag" was going to be handed out he was determined that his section should have its share. "Swag" moves the world. Before its power principle falls prostrate, and men forget the things that, before they shouted themselves trate, and men forget the things like sign of the times that we so weakly yield to the demands of the dollar, ignoring the great truth that in this world there are some things that are better than money. What if the farmers do fail to get \$1.00 a bushel for their corn, must the whole nation suffer because any one class of men, however, numerous, or intelligent or honorable may profit thereby. And suppose the price of mica is reduced, must the nation be deprived of a law that will lower the price of the necessities of life, on that account? It is refreshing, however, that a majority of our national law makers stood with President Taft in this vital matter and saved the day. This falling in the dust before the demands of "business," is growing tiresome, and the time is coming back when the man who stands upon principle rather than upon financial considerations will command the confidence and admiration of the public.—Charity and Children.

WHAT THE LAW MAKERS ARE DOING

PROCEEDINGS OF THE N. C. GENERAL ASSEMBLY

THE STATE PRIMARY BILL PASSES

To Amend Charter of Winterville High School—The Koonce Insurance Bill Gets Through the House—Foxes and Possums Get More Protection.

Senate—Thursday.

The Hobgood State primary bill passed its third reading by a vote of 29 to 18. Amendments, to exempt the Republican party from its operation, and to exempt any party in any county by resolution of the county executive committee, were voted down.

A large number of local bills passed their final reading. A few new bills were introduced, among them being one by Senator Davis to amend the charter of Winterville High School.

House—Thursday.

Even the house did not take time to introduce many new bills, owing to the shortness of time in which they might pass, but one member discovering that the foxes and possums in his county were not protected, put in a bill for their protection, and another offered an amendment to the game law in his county.

Quite an amount of work was done in putting bills through their final passage.

The Koonce bill to provide a joint commission to investigate the conduct of fire insurance companies brought out more discussion than any other up during the day. Numerous amendments were offered and the bill finally passed by a vote of 63 to 39.

Vaccination Against Typhoid Fever.

It is not unlikely we shall be vaccinating against typhoid fever, as we do now by routine against smallpox, also that we shall be using, by hypodermic injection or otherwise, curative agencies in typhoid. Here is a means of prophylaxis and cure still very much sub judice, nor is it by any means to be understood to have gained general acceptance in medical science. One may, however, state definite conclusions thus far reached. Inoculation against typhoid is now, I believe, a measure to which all soldiers in the British and other European armies must submit. Captain F. F. Russell, of the Army Medical School at Washington, D. C., after an extensive and continual study of this subject, reports that vaccination against typhoid undoubtedly protects to a very great extent against the disease; it is an indispensable adjunct to other means of prevention among troops and others exposed to infection; the statement that vaccination should not be carried out in the presence of an epidemic is not justified by the facts at hand; the procedure is easily carried out, and only exceptionally does it provoke severe general reaction; no outward results occurred in a series of 3540 vaccinations. Compulsory vaccination is now urged for all candidates ambitious to enter the United States army. Typhoid vaccination is beyond prescription advisable for the removal of typhoid bacilli from the discharges of "typhoid carriers," concerning whom no rule limiting quarantine or isolation can be applied, for the protection of others.—John Bessner Huber, M. D., in American Review of Reviews.

NORTH CAROLINA HAPPENINGS

NEWS ITEMS TAKEN FROM OUR EXCHANGES TODAY

CONDENSED FOR OUR BUSY READERS

Mr. Thomas Hicks of Near Tarboro, Loses Barn and Contents—Mr. Mabe Johnson, of Chatham County, Instantly Killed by Falling Tree—Chadbourn School House Burned.

Tarboro, March 2.—Mr. Thomas H. Hicks, who lives a few miles from Tarboro, had the misfortune Tuesday night to lose, by fire, his barn and contents. The barn was a large, new one and a half story building containing between 250 and 300 barrels of corn; about 150 bags of peanuts, 75 bushels of field peas, also a quantity of soja beans and hay—all of which was lost with the exception of about 65 bags of peanuts. A nearby building containing several hundred bags of peanuts came very near being burned also, and it was only due to the heroic work of the tenants of the farm that it was saved.

Oxford, March 2.—News has just been received here of a fatal accident which happened near Bonsal, Chatham county, Tuesday afternoon. Mr. Mabe Johnson, while cutting logs for Scott & Duncan, lumbermen, was struck by a falling tree and instantly killed. Mr. Johnson, who had cut down a tree which lodged against another, was cutting on the second tree, when it broke near the top and fell upon him, crushing his head into a pulp.

Kinston, March 2.—A test trial was this evening of the home made Santos-Dumas monoplane, made by Bailey Brothers and Gray. The trial on Main street was a decided success as to moving on the ground. The first exhibition of flying will begin next Tuesday. Every part of the machine was made by these young men and all material was secured here except the fifteen-horse power engine. The ingenuity and mechanical skill displayed in manufacturing this machine and the success of the first trial was quite a surprise to every one.

Chadbourn, March 2.—Chadbourn high school building was burned at 8:30 tonight. The origin of the fire is unknown. The entire inside was blazing when discovered. The building contained six rooms and cost \$4,000. Insurance \$2,500. A \$300 piano was burned and all of the pupils' books, including a school library.

The vault of the Rouse Baking Company, whose building was destroyed by fire in the conflagration at LaGrange Sunday night, was opened for the first time since the fire Wednesday afternoon and all the contents were found to be intact and uninjured. The vault was built fire-proof and resisted the heat, etc., thereby saving everything that had been placed in it.—Kinston Free Press.

FATAL EXPLOSION.

If The Locusts Should Come.

The discovery in a Connecticut excavation of thousands of the seventeen-year locust has been widely heralded, says the Pittsburg Dispatch, as presaging the temperance of the periodical cicada this year. The federal bureau of entomology, however, has issued a bulletin that ought to reassure that element of the country's population which has been worrying over the prospect of such a visitation.

When the locusts appear in great numbers, says the bulletin, it naturally causes considerable alarm and arouses fears for the safety of shade trees and orchards. The actual damage, however, is usually slight except in the case of newly planted orchards and even by vigorous pruning back after the cicada has disappeared much of the injury caused by the egg punctures can be obviated. Ordinarily repellant substances, kerosene emulsion or carbolic acid solutions, have little effect upon the invaders, but a thorough spraying with Bordeaux mixture or lime wash is apt to cause the locust to hunt a more desirable tree.

The bureau has suggested that the most reliable means of protection is to collect the insects in bags or umbrellas from the trees in early morning or late in the evening, when the cicada is somewhat torpid. Such collections, it is added, should be made each day, a requirement, however, that is likely to encourage a disposition to trust to the other assurance that the actual damage is usually slight.

"It may not be generally known," states the bulletin, "that there is also a thirteen-year locust as well as a seventeen-year insect. The thirteen-year cicada flourishes in the South, especially the lower half of the Mississippi valley. The other extends from the Atlantic to the Alleghany mountains. It has been reported regularly every seventeen years since 1724, the last in 1894. Although there is some confusion as to whether the locusts appearing west of the mountains are of one brood or the other, the preponderance of evidence indicates that they belong to the thirteen-year species. The fact there are two—one appearing at thirteen-year intervals and the other at seventeen—explains the popular confusion of mind when the cicada is reported in other than the seventeen-year periods."

So, with the assurance given us above by Uncle Sam's entomologists, let us plant and prune our orchards and sow our fields in hope.—Houston Post.

Convocation in May. The Convocation is now sitting in Westminster, under the presidency of the Archbishop of Canterbury, and has been considering, among other things, a proposal to modify and shorten the Second, Fourth and Tenth Commandments, and it is with these fragments or divisions of the Divine Law that the Dean of Winchester will have to deal. He has not made up his mind apparently what he will do about it, but he is said to be inclined to boil down the Tenth Commandment to this irreducible minimum, "Thou shalt not covet," which is a very good sentiment in itself, it must be admitted, but it is in no sense better than the old thing as it stands.

As to the modification of the Second and Fourth Commandments, the Dean has not considered what he will do. Both of them are rather long, but they are very good. We do not believe that they can be improved materially by the Convocation of Canterbury, nor do we believe that the Convocation of Canterbury has the least idea of breaking up the Tables, but that it is only trying to adjust the Word of God to the business conditions of this very energetic age. Cutting down the Fourth Commandment of four words would give the golf players a chance to make another drive, or the bridge player to take another trick, while the old-fashioned people would be saying the rest of the word as it is written in the law. As for the Fourth Commandment, which the Dean of Winchester is to boil down, why not cut it out altogether? But in tinkering with the Law, it would be well for the Convocation at Canterbury to refresh their minds as to the conditions under which these Commandments were given thousands of years ago to Moses on Mount Sinai. The Lord came unto him in a thick cloud so that the people might hear Him when He spoke, and believe Him forever after the Commandments had been delivered, which were to be a law unto the people so long as the world shall stand.

These Ten Commandments which "have always been esteemed as the most precious rule of life, and are the basis of all Christian legislation," are now under consideration in one of the Courts of the Lord for amendment and revision. There is a thrilling story about the fate of Uzzah, one of the sons of Abinadab, who was attending the Ark of God on its way to Zion, and how, when putting forth his hand to steady it as it was passing over the threshing floor of Nachon "the anger of the Lord was kindled against Uzzah; and God smote him there for his error; and there he died by the Ark of God" The Dean of Winchester will also find in the last chapter of the Book of Revelations this warning: "If any man shall take away from the words of the book of this prophecy, God shall take away his part from the tree of life, and out of the Holy City, which was written in this Book."

Why should there be any attempt on the part of any religious convocation of Conventile or other body, composed largely of indifferent scholars, to meddle with the work of the Almighty? Why not cut down some of the ceremonies of the church itself—the singing, the praying, the preaching, and let the only thing that is in all worth while stand as it was made by the Lord God Almighty.—Times Dispatch.

The treachery and daring of the Apache Indians appealed to the vicious instincts of a certain class of young Parasians and they were quick to imitate in real life the blood-curdling maneuvers they witnessed at the show. Two Kinds of Reclamation.

One reclamation-dam for irrigation purposes in far-away Idaho will cost \$1,000,000. In North Carolina \$1,000,000 spent in draining our immensely fertile swamp area would reclaim more rich lands than can ever be made available by that Idaho project. In addition to this, we have an equable rain fall and a superb climate winter and summer, while all this splendid agricultural region is within 18 to 30 hours, by rail, of the great Northern and Canadian markets supplying more than 30,000,000 people. Transportation by regular refrigerator trains to all points North completes the conditions which made this part of North Carolina the ideal location for home-seekers. The worst thing about it is that home-seekers do not know it. We do, but, as for them, they are not long-distance mind-readers.

There is a big difference between reclamation by irrigation and that by drainage. In the far west, expensive plants and much labor and capital will be expended in watering crops after the land has been reclaimed, while in North Carolina rich reclaimed swamps lands will be watered by the most ideal rainfall conditions prevailing in America. Here there is the additional advantage that in the rare event of drought the drainage canals also will afford the means of irrigation. In many sections the canals can also be utilized for economic transportation, such as is demonstrated by boating rice from the fields to the storage barns and threshing places. We have in Eastern North Carolina a country of wonderful possibilities, but we have not yet adopted any plan by which we can make home-seekers sit up and take notice—Wilmington Star.

The Presidency and the Primary.

How shall we ever get to an effective direct popular choice of presidential nominees if it is thought desirable? My answer is that it must come through the national organizations of the political parties themselves or through congressional legislation, for which perhaps a constitutional amendment may be prerequisite. Any one of the national party organizations can at will introduce the direct primary for presidential choosing and either do away with national nominating conventions altogether or continue them only for platform making and the contingency of no nomination at the polls. A constitutional amendment could abolish the Electoral College, which we all know has become ornamental, and give us direct popular election of presidents. It could predicate such an election on a direct primary nomination or it could combine it with a preliminary election and a subsequent by-election to determine between the presidential race horses polling the highest votes in the trial heat. Such changes in our machinery of government would be decidedly radical and are not to be expected to materialize in a day or a year. If the demand for direct presidential nominations, however, should become general and insistent, one of the political parties might respond to it in the hope of striking a popular chord and scoring an advantage over the political enemy. In the meanwhile the sporadic efforts of Oregon, and States that may follow suit, to project a presidential primary on the installment plan must be at best only experimental.—By Vivtor Rosewater in American Review of Reviews.

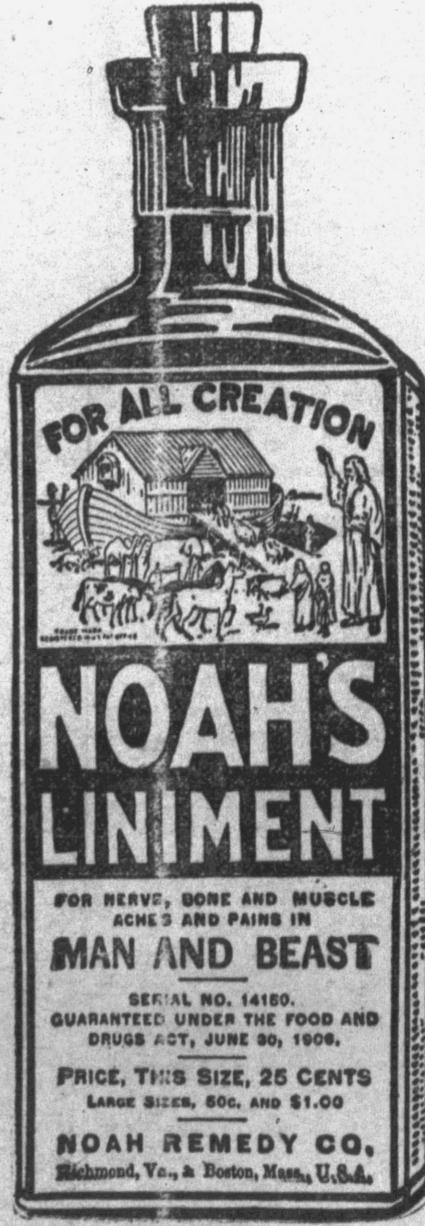

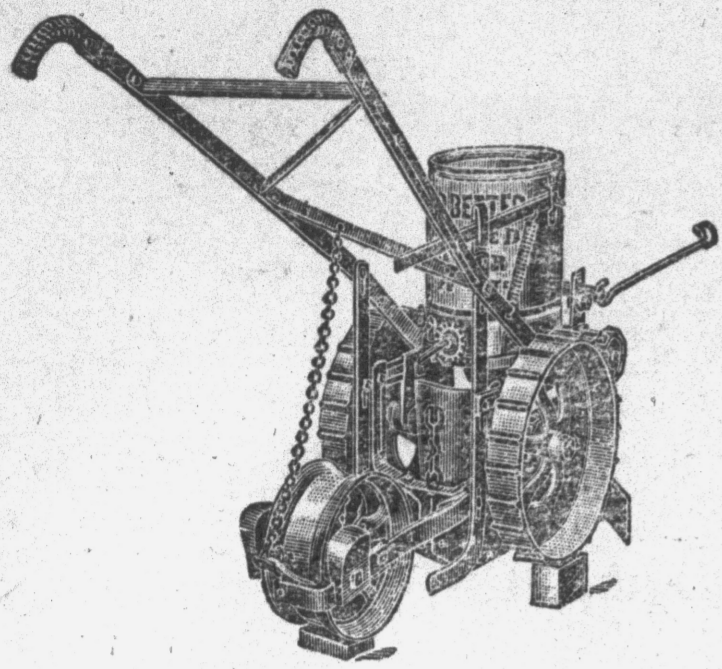

It is reported in West Publishing Company's Cases of Interest an action is brought against a railroad company to recover damages for being ejected from a train. Appellant prior to purchasing his ticket, had been drinking with some friends whom he had met. After boarding the train, the car being warm, he fell into a stupor. The conductor, passing through, collected his ticket without the passenger's knowledge. Soon after, the conductor again demanded a ticket of the appellee, who this time awoke and began a fruitless search for "that ticket." After hunting in every pocket except the correct one, that of the conductor, that official and the brakeman helped him off. He was now left in a helpless and deplorable condition, and moreover, his overcoat and baggage were left on the train. After wandering aimlessly about for a time, he was found by some boys who took him to a hotel. He spent a bad night and became so sick that a physician was necessary. The next morning when he "came to" he knew nothing about being put off the train or where he was, or how he got there. Upon learning the facts, he brought this action for being so humiliated and recovered \$250. Appellant contends that plaintiff was not entitled to recover, because when he was put off he was too drunk to understand or comprehend what was being done, and therefore, could not have been humiliated. Appellee insists that when he regained his senses he was deeply humiliated, for he had occasion frequently to explain to his friends how he came to be ejected from the train, thus causing him much chagrin. The court of Civil Appeals of Texas holds that it was immaterial whether he experienced the humiliation at the very time of his ejection, if he was prevented from so doing by his inebriated condition, because to hold otherwise would be equivalent to saying that one committing an indignity upon another might escape liability, if it were shown that at the time of the commission the person was unconscious of or insensible to such indignity, notwithstanding the fact that upon regaining consciousness he might intensely suffer by reason thereof. The judgment was affirmed. —Charlotte Chronicle.

BUT IT WILL COME.

Election of Senators by Popular Vote.

But for the fact that it contained the section providing for federal supervision of senatorial elections, which would have meant interference at any time, such interference being directed by the party in power, as might be engineered by a few narrow-minded or decidedly biased persons, the resolution for the people to vote direct on their senators would have carried yesterday in the upper branch of congress. Senator Root, undoubtedly an able man, but who is also unequivocally a "slick politician" stood to the fore in behalf of government supervision, sounding a warning that certain people would take advantage of certain others. So by the votes of southern senators the resolution was defeated. It would only have required a change of a small number of votes to have carried the resolution, such a change supplying the two thirds necessary. In favor of the resolution was a fine majority, but fourteen votes under two thirds. In the minority, however, voted such southern senators as Bacon, Tillman, Palfalfero, Percy and Money, and it would have only required a small change to have carried the proposition. Many southern senators voted for the resolution regardless of the threats complied in the Southerland resolution, as presented, because they were willing to "face the music" and meet the foe even on his own grounds but other senators would not go that far. From a spirit of daring, perhaps, the former position was right, and certainly the southern senators in this class, including Senators Overman and Simmons, were willing to carry war into the enemy's camp for the sake of the principal—the rule of the people—but the other senators were cautious, and, after all, their caution may be productive of great good; of obtaining the reform in unencumbered shape, as it should be enacted.

The fight is not over by any means, and Senator Borah, who led the attack, on behalf of the people, has declared that it will be punished at the next session of congress. So it may be well that it was defeated in such form, as yesterday, because there is no use in accepting a compromise in the matter; there is no necessity in making a compromise with the devil. The people have got to rule, and for the senate not to be willing to submit the question to the legislators to pass on is strange, though there is a reason in such men like Senators Root, Dewey and Lorimer opposing any proposition for the people's rule. —Wilmington Dispatch.
