

## PROCEEDINGS OF THE BOARD OF ALDERMEN

### MEETING THURSDAY NIGHT

#### Hear Complaints—Elect School Trustees and Miscellaneous Business

The board of aldermen met in regular monthly session, Thursday night, the mayor and seven members of the board being present.

R. W. King appeared before the board requesting a donation for the Confederate veterans, and on motion \$100 was donated.

F. C. Harding appeared in behalf of H. C. Edwards in regard to widening the street in front of his property north of court house. The matter was referred to a committee consisting of Aldermen Carr, Nobles and Van Dyke for investigation.

J. L. Little appeared requesting refund of taxes charged against him in error, and correction was ordered.

Dr. Laughinghouse appeared in regard to tax against Commercial Knitting Mills, his complaint being referred to a committee consisting of Aldermen Carr, VanDyke and Bowen for investigation.

An appropriation of \$50 was made to Hope Fire Company to defray expenses of two delegates to the state firemen's convention, the board also paying the per capita tax of the company for membership in the association.

Policeman Clark was directed to call attention of the Water and Light Commission to the hydrant near the corner of Dickinson avenue and Ninth street, and request them to put the hydrant in proper condition for use.

The committee appointed for that purpose reported they had purchased a pair of mules for the town at a cost of \$663.

The street committee was instructed to carry out the order of the board in regard to cutting down trees on Fifth street where necessary to widening the street.

Trustees of the graded school were elected as follows: D. C. Moore and G. E. Harris for one year; C. W. Wilson and T. M. Hooker for two years; W. B. Wilson and J. L. Little for three years; F. C. Harding for four years.

Some correction were made of errors in tax list.

The different officers made their reports for the past month.

Bills as appeared by the finance committee were ordered paid.

### ADVERTISE FOR CONGREGATION.

#### Pastor Reinsner Advises Methodist Conference to Use Newspapers.

Cambridge, Mass., April 6.—The Rev. Dr. Christian F. Reinsner, pastor of Grace Methodist church, New York, advocated the employment of advertising by churches, at the annual New England conference of the Methodist church, held here today.

"Advertise your churches in the newspapers and keep in touch with newspaper men," he said.

Dr. Reinsner gave illustrations of how he advertised his church services on billboards, in newspapers, in street cars and by means of circulars.

"It is a great mistake," he continued, "for clergymen to keep aloof from newspaper men and refuse to be interviewed. Why, everybody reads the newspapers, and if you want to get your interests before the public, you must advertise in this important agency. They will always treat you fairly if you give them reason for doing so. Why, I never could get a congregation in my New York church did I not get the newspapers on my side."

"I send them weekly every item of news in my church and then they can pick out what they want to publish. You must use business methods in the churches today. A wide-awake business man will always do the same."

"Advertise your church and you compel the people to come in. If I had money I would put a display 'ad.' in the newspaper every week, and tell the people what I was trying to do for religion in my neighborhood."

## JAMES SHELBY THOMAS

### Commissioner of Education of The Southern Commercial Congress.

Washington, April 7.—Parents and teachers in the Southern States will be interested in the fact that on June 1st, James Shelby Thomas, dean of Virginia Christian College, of Lynchburg, will become commissioner of education for the Southern Commercial Congress. His work for the congress will carry him to all states in the South, for the purpose of bringing about a quicker exchange among all educators, of educational ideas and of school improvement suggestions. He will also work out a plan for the Southern Commercial Congress, whereby it can assist college and other students of the South to secure or complete their education along scientific lines.

The education purpose of the congress is to work for the guidance of pupils in the common schools of the South, so as to prepare them for useful careers, though unable to go to high school or college. It is also proposed that those taking education above the public schools, shall have their minds directed towards technical studies, since the approaching great day of the South in agriculture, in manufacturing and in general development will call for thousands who are scientifically trained. It also believes strongly that the school growth and guidance of the South should be based upon the needs of each community and should not be artificially forced by those who do not know the educational problems the South faces.

It is an unmitigated bore, but you couldn't live without it. ## NORTH GERMAN LLOYD

### STEAMER AGROUND

#### OFFICERS TO ENFORCE ORDER.

#### Princess Frederick Wilhelm Sent For Passengers, 1,720 in Number.

New York, April 7.—The North German Lloyd liner, Princess Irene, was still aground today, all efforts to float her having failed. The liner, Princess Frederick Wilhelm, of the same line is on the way to rescue her and will take off 1,720 passengers. The sea was rough this morning and it is thought to be doubtful if transfer can be made. The stranded vessel is in no danger. There is some excitement among the steerage passengers. In view of possible outbreak, all officers were given guns this morning, so as to be able to enforce order.

#### RESIDENCE BURNED.

#### W. H. Harrington, Jr., Loses Home and Contents.

This morning between 12 and 1 o'clock the home of Mr. W. H. Harrington, Jr., about three miles north of Greenville, was destroyed by fire, together with the entire contents, except one or two pieces of light furniture. Origin of the fire is unknown. Mr. Harrington and some men rooming there had narrow escape from being burned, the house was far gone when they awoke. There was some insurance on the house but none on the furniture. Mr. C. D. Harrington lost his furniture, which was stored there, also, insured.

### PULLS A BLIND TIGER

#### JIM WHITLEY WALKS IN TRAP.

#### "Caught With the Goods" and Bound Over to Superior Court.

In the building on the corner of Cotanch and Fifth street, almost opposite the city hall and in full sound of the mayor's office, is what is believed to be the worst blind tiger joint around Greenville. It used to be a livery stable, known as the "Rainbow stables," and in the days so used regarded with more or less suspicion. In recent times it has been cut up into various apartments, several shops for negroes being on the first floor, part of the upper floor having an amusement hall on one side of which are numerous rooms reached by dark passages. It is a dive right, and an ideal place for carrying on crime.

That things have been going on in that building there is no doubt, but they have been hard to catch. Thursday night, however, Policeman G. A. Clark set a trap which was sprung and landed the game. The officer got a negro to help him work the trap, gave the boy a marked half dollar and told him to go in and buy a bottle of whiskey. The boy went in and approached Jim Whitley, colored, telling the latter he wanted a half pint, passing over the marked coin. The bottle of whiskey was handed out and turned over to the officer who was hid close by. Officer Clark rushed in to Whitley's room and found the marked coin in his possession. There was also plenty of evidence about the room of its being fitted up for carrying on the blind tiger business.

Whitley was called before Mayor Wooten for a hearing this morning. He waived examination and was bound over to Superior court in the sum of \$300.

#### EX-SENATOR A NOVELIST.

#### Hansbrough, of North Dakota, Author of Political Romance.

Minneapolis has been chosen as the birthplace of the first political novel written by former Senator Hansbrough, of North Dakota, a man who has been educated in the school of politics through 20 years' service in Congress. Printers and binders now have the manuscript and the volume will be issued soon.

The title is "The Second Amendment." Its author declares that he intended to write a political novel and yet it fairly melts with romantic love-making. The story is set amid thrilling scenes, the first of which opens in the United States Senate. The plot revolves about a group of strange events of lifelike characters that belong to the present day.

"Out of the maelstrom of human endeavor a new political party is evolved; also a paramount issue that appeals to both reasons and conscience. The name of the new political entity is the "Altruistic Party." Scenes are laid in Washington, Mexico, New York, Chicago, St. Louis and at the capitol of a Western State, where some remarkable things take place under the primary election system.

Of course, there is a heroine, a Senator's sweet heart. He breaks the heart of one pure noble-minded girl, who, but for the necessities of a realistic political novel, deserves a far better fate. Two other beautiful characters, rare types of womanhood, are dealt with more leniently and live happily ever afterward, while the real heroine, through her own athletic spirit, eventually receives her reward.

The moral is suggested in these quoted lines from Richard Brinsley Sheridan as a foreword:

Believe not each accusing tongue,  
As most weak mortals do,  
But still believe that story wrong  
Which ought not to be true.

## KING COTTON.

### The Greatest Money Crop in The World.

Cotton is the greatest crop of the South and must remain so. It is a definitely assured fact now that the coming of the boll weevil, while it means in most cases a great change in methods, will not stop the raising of cotton. Diversified farming must follow in the wake of the weevil, and should precede it in the sections not yet infested; but diversified farming in the South means, not less cotton, but more—a smaller acreage to be sure, but a much larger yield per acre and a gradually increasing total crop.

We have said before, and we believe it still, that cotton is the greatest money crop in the world, and we have also said, and still believe, that when the farmers of the South once realize the possibilities of this crop when properly grown, the cotton belt will become the richest agricultural section of America.

Before this can come to pass, though, there must be some radical changes from the methods of farming now in general use. Not only must the one-crop system be abandoned, suitable rotations adopted and more live stock raised, but there must be much better methods of handling the cotton crop itself. There is a widely prevalent idea that the average Southern farmer knows all there is to learn about cotton growing; but one may well doubt if the facts in the case sustain this view. The average cotton crop is not a profitable crop; and the increase in the average acre-yield of cotton in the last fifteen years has been only 3.8 per cent. Almost every other crop in the South makes a better showing. The boll weevil accounts for some of this, it is true, but in states not yet reached by the weevil, the average yield has increased very little. More to blame than the boll weevil is the old notion that cotton will grow anywhere and that anybody can grow cotton. Haven't we believed that the negro, with one scrubby mule, an excuse for a turning plow and a sweep or two—that any negro thus equipped and with just enough intelligence to scatter the seed in a furrow, chop the plants to a stand, and run around the rows, was fully competent to make a crop of cotton? Have we not said that the negro couldn't learn to handle improved machinery and was unfit to work any animal except a mule, and so made practically no efforts to teach him better methods of farming, but allowed him to go on ruining the land with his slipshod methods, raising little crops of cotton at great expense? Then has not this cotton been forced on the market in the fall and so helped to depress the prices of the entire crop?

All this must be changed. We have no patience, in the first place, with the idea that the negro—the average negro on the Southern farm—can not be taught to handle better stock and more complicated machinery. We even believe that he can be taught to take interest in the maintenance of soil fertility, and can learn the essential factors in the working out of this problem. But these things the

white farmers of the South must chiefly teach him, and before they can do this they must do two other things. (1) They must learn them for themselves, and (2) they must abolish the irresponsible negro cropper, quit turning their lands over to him to be worked with inefficient equipment and in any sort of manner. If the land is to be worked by tenants, these tenants should be furnished proper equipment, they should be compelled to farm the land, not merely work it in cotton, and the lease, wherever possible, should be for a term of years instead of for a single season.

Big cotton crops can never be made on poor lands, with one-horse equipment, and by men who have no knowledge of any save the crudest methods of farming.—Raleigh Progressive Farmer.

## INCREASED SCHOOL TAX LOST.

An instance has come out in which the recent legislature only half did a thing. A law was passed by that body purporting to increase the public school tax 2 cents, by which something like \$400,000 would have been added to the school fund of the state. At the same time the legislature failed to observe the constitutional equation between the ad valorem and poll tax, increasing the latter 6 cents. With the purpose of getting this oversight corrected Governor Kitchin brought suit in the name of the state against Auditor Wood to compel the latter to make the change in the poll tax. The case was carried before Judge F. A. Daniels who held that the increased tax of 2 cents was unconstitutional, because of the failure to observe the equation. The case was appealed to the Supreme court.

## WILLIAMSTON TAKES THE LEAD.

Williamston township in Martin county recently held an election on the question of issuing \$40,000 in bonds to build good roads in the township and the measure was carried. This is the first township in any Eastern county to take such a step, but it will not be long before Greenville does likewise. A bill was passed by the last legislature giving authority to Greenville township to vote on the proposition of issuing bonds for \$50,000 for building roads in the township. We do not know just when the election will be held here, but certainly inside of six months, or when the farmers get through with their busy season. In the meantime the sentiment for good roads is growing and the bond issue will carry when the question comes to a vote.

In the death of Dr. S. A. Knapp, which occurred a few days ago in Washington City, the agricultural department of the government lost one of its most useful members. Dr. Knapp had long been connected with the department, and no man has done more to advance the agricultural interests of the country than he. All over the South he was well known, his work, especially in the cotton belt, being prominent. It was under his direction that the farmers of the infected districts learned to combat the boll weevil and lose their fear of that pest.

The Charlotte Observer is authority for the statement that in the recent contest for the nomination for mayor of that city "money was used in the purchase of votes and much drunkenness prevailed." That is a shame-

## Lawyer's Gowns.

The wearing of gowns by the lawyers taking part in a court since presented by a recent theatrical attraction arouses The Asheville Citizen to mild regret that the custom is not more widespread in this country. "Those who believe in surrounding the administration of justice with all dignity possible," thinks The Citizen, "would like to see the adoption of the gown by lawyers in all the courts of the country. There is something out of place in a lawyer in ordinary attire addressing a gowned judge." That the adoption of The Citizen's suggestion would make for added dignity in our court rooms, there can be but little doubt. America inherits legal customs as well as the common law from England, and it is a matter of regret that the former were so much abbreviated when the latter was swallowed whole. The laying aside of the barrister's gown was a result of the country-wide desire for democratic simplicity which came in the wake of the first struggle with England. Public men like Hamilton and John Adams, who failed to admit that anything English was necessarily wrong were looked at askance by the body of the people and allowed but brief opportunity to apply their principals in executive or other offices. The fact that several generations of American citizens have accustomed themselves to attending court at which the members of the bar have been undistinguished by dress from the spectators makes it very improbable that any proposed return to the old customs of our ancestors will meet with favor.—Charlotte Observer.

A few years ago the farmers of this country, blessed with bounteous crops, could scarcely secure enough cash for their surplus which went to feed and clothe the nation, to buy the bare necessities that they were unable to make on their farms.

Now the crowded populations of the cities and towns can scarcely make enough from their labor to buy their food and clothing and pay their rents. This is true of those even who have steady jobs, while countless thousands, out of work half of the time, drift to the slums and to degradation.

Yet all the time the country has been producing plenty for all. More than enough food, more than enough clothing from the fields; while the mines and the forests give up more than is necessary for warmth and shelter.

Backward and forward the country seesaws between these hard conditions of city life. What is the trouble?

Who has blundered? Where are the weak points in our system? No one seems to know. Standpat statesmanship says it has ever been thus and must go on.

Progressive, constructive statesmanship, says these things are unnatural and unnecessary, it is our business to look for the cause and see wherein government is responsible and what can be done to remedy them.—Monroe Journal.

### Keeping Boys on the Farm.

And now the blame is laid on the city girl who goes into the country to teach school. This is the hint of a Chicago banker at a meeting last week to encourage the farm boys to stick to the farm. The hint should be given to the city girl herself, who could let it be understood that she liked the farm and the farm boys, and she intended some day to settle down and be a farmer's wife, and milk the cow and tie the calf, and scoop up the hens' eggs and hew the country sausage and feed the hollyhocks, and do all those charming things that changes the cheeks to rose and the voice to music.

If this is attended to in the right way, the city girl will keep the boys on the farm, and save a large portion of the nation's glory. The country girls could do all this—but there is the trouble, they seek the city, too.—Ohio State Journal.

### A Question of History.

If one were asked when and where the greatest civil war of all times came to an end he would be puzzled to name the day and place. The question came up in a debate during the short session of congress concerning a claim for cotton seized after June 10, 1865, and many interesting facts were brought out. Lee surrendered at Appomattox, April 9, 1865; Johnson at Durham Station, N. C., now the city of Durham, April 26; Taylor at Citronelle, Ala., May 6; while the battle of Palmetto, in Texas, was fought May 13, the Confederates winning the victory. As a matter of convenience the government decided that the war closed June 1, 1865 while the Supreme court, as appeared by citations in the debate has assigned different dates to mark the legal termination of the war. It is really said to have closed at different times in different states. By an act passed in March 1867, congress, for certain purposes it had in mind, even decided that the war ended officially on August 20, 1866.

It is perhaps impossible to say when as a matter of fact the war ended, but it is well settled that the last shot was fired at the battle of Palmito Ranch, which was fought on the spot when General Zachery Taylor 19 years earlier had defeated the Mexicans of 6,000 men in the opening conflict of the Mexican War. The battle of Palmito Ranch was fought on May 13, 1865, and no hostile gun was afterwards fired on the land. Why then should not that day and that place go down in history as the final date and scene of the close of the great Civil struggle?—Goldsboro Argus.

### Mothers of Yesterday.

There was once a generation of mothers who would not have found it necessary to appeal to the town council for the protection of their children's morals. They would have laid down the law at home and it would have been obeyed, with a full realization of the consequences that would have followed its violation. The domestic fiat would have gone forth and that would have been the end of the matter.

The mothers of the old-fashioned type would have resented any delegation of material authority to a municipal body. They knew and exercised their powers of home control and jealously guarded them. They decided how their children should amuse themselves and woe to the youngster who disregarded their instructions.

Is the old race of mothers extinct, and with them the home restraint of children.—New York World.

### A True Story.

That the South, ever since the war has stood back and eaten at the second table, so to say, is true. Our people have been modest; they have refrained from pushing their part of God's country forward because of the charge sure to be made that the South was again "in the saddle."

Discussing the situation at present, the Columbia State says:

In the organization of the house of representatives of the sixty-second congress the influence of the South is dominant. Speaker Crisp was a Southern man and Mr. Carlisle lived as far South as does Champ Clark, but in the former houses controlled by the Democrats since 1861, Northern men were more conspicuous as chairman and members of important committees. By reason of the period of Democratic depression in most of the Northern States, the Democratic members are as a rule the senior members and find themselves with superior claims to the choice assignments.

For a long time, Southern Democrats in congress were inclined to stand back and wait until their Northern brethren had been served with tidbits. They were plainly suspicious that the country held the South under suspicion and they were different about accepting what was handed them lest Northern voters take alarm. The same party timidity that so far has prevented the serious consideration of a Southern man for the Democratic nomination for president or vice-president has caused the Southern Democrats in congress to conduct themselves with extreme modesty.

In the house of representatives that met Tuesday the Southern men will hold the strings. They have boldly claimed their own in the organization of the body and perhaps for the first time there seems to be a complete ignoring of the prejudices against them that have been recognized since the war between the sections.

In a sense the South will be on trial. If the leaders in the house of representatives should fail to exemplify a broad-gauged and non-partisan statesmanship, the old mistrust of the Southern Democracy would easily be rekindled in the North.

It must be confessed that the country is agreeably surprised at the way the party has managed things so far. We were told that the Democratic caucus would be a failure—that there would be dissensions, etc., but exactly the opposite resulted. Men had their views but they were submerged and the majority ruled. It looks as if the Democrats have grown in wisdom.—Greensboro Record.

### Cruel to Ourselves.

Most of our suffering are self-inflicted. We are cruel to ourselves. We feather the arrows of our enemies, and make the wounds rangle, which otherwise they were powerless to inflict. We anticipate misfortunes which never come. We brood over injuries at which it would have been far wiser to smile. We neglect or despise the joys which God otherwise would freely give us. We will not know the things which make for our peace, and in things which we know naturally, like brute beasts made to be taken and destroyed, in these we corrupt ourselves. Ah, how true, how true it is that heaven seems to be "everywhere if we would but enter it, and yet almost nowhere, because so few of us can." Alas, my brethren, all this might be otherwise, but as we ruin our bodies by excess and ignorance, so we ruin our minds by greed and care.—Canon Farrar.

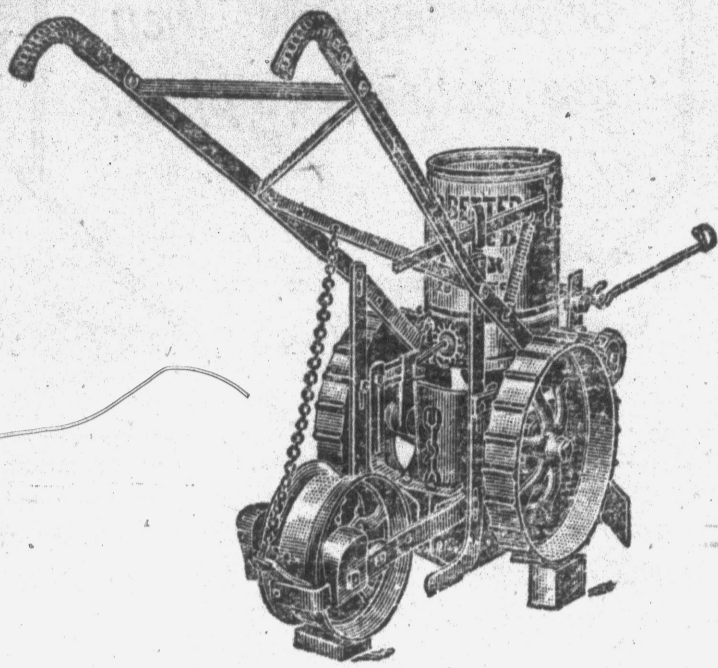
