THE MEN OF GREENVILLE USING THEIR TALENTS

IN THE MEN'S PRAYER LEAGUE.
The Meetings Every Sunday Are Well Worth While.

That the men of Greenville, at least a large number of them, are rightly using their talents is shown by the attendance and interest in the Men's Prayer League that meets every Sunday afternoon, and the good work the league is doing. It is not merely a gathering to pass away time, but the hour is spent profitably and all who attend are helped.

The subject discussed in the Methodist church Sunday afternoon was "Using Our Talents," and the leaders, Messrs. W. M. Pugh and E. A. Moye, made talks that left a deep impression for good. They showed how all should rightly use the talent God has given to His glory and to helping our fellow man, the greatest reward coming through our service to others.

Some others of the members also made short talks, the suggestion being brought out that the league interest itself in the establishment of a Y. M. C. A. or some similar organization for the benefit of the men and boys of the community. This is to come up for consideration later.

The meeting next Sunday will be in the Presbyterian church. That day being Easter Sunday the subject will be "The Risen Christ." Text, Matt. 28:6; Mark 16:6; Luke 24:6; Acts 17:3; I Cor. 15:13, 14, 20; Col. 3:1. Leaders, Messrs. F. R. Stretch, W. S. Moye and H. B. Smith.

Object Lesson For Cities.

If even the plan of American municipal government should have shown itself to advantage, it should have done so in the late primary for mayor of this city. Both candidates were men of high character as well as business ability. Yet there is the usual talk of money and liquor used. Who could conceive such scandal as following an election for president of Davidson College or the Southern Railway? Both of these are corporations, as is the city of Charlotte. Why should a municipal corporation be so organized as to have its election considered, in common gossip, dependent upon corrupt or demoralizing methods—this, too, even when both candidates are of unimpeachable character?

Discussion always brings us back to the position that the plan of American city government is wrong. It has caused city government to be the one conspicuous and undeniable failure in our governmental system. Ambassador James Bryce, the ablest foreign observer of our institutions, point out this striking fact in the first edition of his "American Commonwealth" almost a generation ago, and he has lately reaffirmed it in the second. We made the mistake of following the analogies presented by the state and Federal government, whereas the problems and conditions are very different. In other words, we undertook to conduct administrative corporations—and city government are nothing else—along inappropriate lines.

It is not alone sufficient to adopt a form of city government called "commission" by name but cities should have an essentially non-political administrative department whatever the alderman or other legislative body may be. Winston is apparently considering with favor the simplest and best form of administrative government, in that there is contemplated an intervening body whose duty shall be to select administrative officers for competence and discharge them for incompetence or malfeasance. All experience shows the need of revising the form and character of American municipal government, and we seem to be moving slowly but surely toward the change—Charlotte Observer.

SOLVING THE RACE PROBLEM.

Negro Treated Better in The South, Tennessean Declares.

Oswald Garrison Villard, the editor of the New York Evening Post, is concerned over the future of the negro race. He says that "a wave of color hysteria is sweeping over the country." He is fearful lest more avenues of progress will be closed to those of the darker race. "Despite the fact he has for years been told that if he acquires property and buys himself a house all will be well with him and his family; if he does so in a section of a city, whether it be New York, Seattle, Baltimore or Richmond, in which he may assure to his children good association, pure air and clean streets, he is assailed."

This is not to be denied and students of the race problem ought to recognize it and seek a remedy in some different manner. If whites and blacks in this country are thrown into competition and pursue the same avocations or seek to live side by side in the same communities there will be a conflict. The negro problem is more clearly settled in the South. Certain avocations are pursued by one race only. Segregation has more nearly been brought about. Each race must develop its own civilization. The South understands the colored man and treats him better than does any other section.—Knoxville Sentinel.

What Ended the Civil War?

It has been, as a rule, taken for granted that the South was worsted in a fair fight in the field. This is so in a moderate degree only; for the fight was not wholly a fair one. Differences of forces in the field may be set aside, as the fight being on the ground of the weaker, any disproportion in numbers was largely annulled. But the army of the North was lavishly equipped; there was no want of arms, food, raiment, ammunition, or medical care. Everything an army could have the Federal forces had in overflowing. On the other hand, the Southern army was starved of all necessities, not to speak of the luxuries which the abounding North poured forth for its men in the field. The South was in want of many of these necessities even in the beginning of the war; toward the end it was in want of all. It was because of this want that it had to yield. Gen. Joseph E. Johnston, writing General Beauregard in 1868, said truly: "We, without the means of purchasing supplies of any kind, or procuring or repairing arms, could continue this war only as robbers or guerrillas." The Southern army finally melted away and gave up the fight because it had arrived at the limit of human endurance through the suffering which came of the absolute want brought by the blockade.—Admiral French E. Chadwick, in American Review of Reviews.

OLD NORTH STATE NEWSY HAPPENINGS

GATHERED FROM EXCHANGES.
And Briefly Stated for Our Busy Readers.

Beaufort, N. C., April 8.—This harbor will be made accessible for entry of vessels at night when the range lights on Beaufort Bar and in the harbor have been put in operation, for which purpose the lighthouse steamers Jessamine and Juniper arrived today. Dredging operations for the deepening of the water over the bar have been completed.

Raleigh, April 8.—The biggest blockade distillery seizure in this state in a great while was reported here today by W. K. Merritt and J. E. Cameron. It was of 750 gallons capacity with full equipment, and was taken northwest of Fremont, while another of 225 gallons capacity was captured within a short distance of Kingston and in 350 yards of the Norfolk Southern Railroad.

Goldsboro, April 8.—At his home on the farm this afternoon there "fell to sleep" Wayne county's oldest citizen, Mr. William Howell, familiarly known for his military record, running back beyond the Mexican to the Indian wars, as "War Bill" Howell. He was 105 years old by authentic chronicle and we doubt if there is an older man in the state. He was a farmer by vocation and was active as such up to the very time, of pitching the crops for this year, when he was taken sick and lingered down to the end, which came at 12 o'clock today.

Several days ago a hen belonging to Mr. E. Hastings, of Glass, laid three eggs in one day, as was noted in the Tribune. Since that time a hen belonging to Mr. John C. Correll, who has attained quite a reputation as a chicken breeder, has duplicated the trick. Mr. Correll says that he does not know whether the notice in the Tribune inspired his hen to perform the feat or not, but if there are any doubting Thomases he has the hen, the eggs and the witnesses to establish conclusive proof.—Concord Tribune.

Greensboro, April 7.—News from Yancey county today is to the effect that Charles Murphy, who killed John Simmons in December because he refused to give him a drink of liquor, was found guilty of murder in the first degree. Judge Lane set June 20 as the date for electrocution. Counsel for the defense gave notice of an appeal to the state Supreme court. The murder was one of the most revolting in the history of western North Carolina and the trial which has been in progress for ten days has been attended by large crowds, men and women displaying equal interest.

Greensboro, April 8.—Judge Daniels today sentenced Moses Speaks, who was yesterday evening convicted of murder in the second degree, to 30 years in the state penitentiary. This was the case for the killing of his wife at High Point about two months ago. In the case for the murder of his son-in-law, Will Miller, at the same time the solicitor took a nol pros with leave. Judge Daniel and Solicitor Gattis will recommend to the Governor that Speaks be confined so as not to have the opportunity of doing harm to any other prisoners. Thirty years is the maximum penalty for the crime of murder in the second degree. Speaks is now 46 years old, so he will hardly live out his term.

Spencer, April 8.—A man hunt was indulged in in Spencer on a large scale yesterday when it was learned that Charles M. Pennington, a well known young man here, had just returned from Asheville and other points with his bride, who, prior to her marriage, was Miss Willie Mae Stewart, a daughter of Mr. and Mrs. Luther Stewart, of Davis county. The young couple landed here and made an effort to escape their friends, who assembled in large numbers. They were chased over town from house to house and finally the hunt was given up. A short time afterwards the bride and bridegroom were found under a house, where they had taken hiding to elude their friends and to escape the serenade which was attempted.

MUTINY AMONG THE CHINESE SOLDIERS

SEIZE THE MILITARY BARRACKS!
And Threaten to Destroy City—Foreigners Flee for Protection.

London, April 10.—Many foreigners near Canton, China, are in danger of death as a result of a mutiny of Chinese soldiers of the northern military zone. They are today in flight to Hong Kong seeking protection of the consulates. The uprising is so serious that a large section of the city of Canton is threatened with destruction. Mutineers have seized the barracks and threaten to burn the city. Dissatisfaction has spread to the out posts and thousands of soldiers have joined. Loyal soldiers are being sent to quell the mutiny. The trouble was started by the self appointment of the prince regent as commander in chief of the Chinese army.

HELPS IS NEEDED.

Situation in China Grows More Alarming.

Shanghai, China, April 10.—Although hundreds are dying daily from starvation in this region, the death rate, it is believed, will increase, as the fund and supplies for relief are inadequate, and because of decreased vitality of people. The death rate is growing alarmingly. The United States transport Beauford, which left Seattle early in March with food supplies will afford relief at a few points for only fifteen days.

MEMORIAL TO CONGRESS.

Uncle Sam Asked to Keep Hands Off The Mexican Revolution.

In a special editorial to the citizens to tell the paper the news the Greenville Telegram makes some pointed remarks. It is our duty so nearly that we clip it in as follows:

"On the part of many people there seems to be a misunderstanding of the attitude of the newspaper with reference to gathering and publishing the news. The primary object of newspaper publishing is to secure and disseminate news—all legitimate news—therefore, the newspaper wants it day by day, take it whenever it can be offered or whenever it can be found; and the public may rest assured that the news gatherer or reporter is always grateful to persons who supply news items or information leading to the securing of news. Many persons misunderstand the newspaper's attitude in regard to news gathering and publishing. Some feel that the newspaper is indifferent to the news item they have to offer, does not care for news from that source, or feel a delicacy about talking to a reporter about news which concern them personally or their families or those with whom they are closely connected. Some few people appear to be averse to talking to reporters about anything and shut up like clams when a reporter approaches.

Concentration of Effort.

Concentration of effort is a very important factor in achieving success. Many an undertaking, backed by ample enthusiasm to have carried it through, falls because efforts were scattered or ill-directed. This applies with great force in the matter of boosting a community. Care should be taken to avoid the overlapping or unnecessary duplication of efforts. A correspondent of The Durham Herald in a thoughtful communication answers the question: "What lack I yet?" as regards that city with the phrase: "A female college." We cannot but think the suggestion open to the charge that any movement for the founding of such an institution would tend to dissipate rather than concentrate the efforts which are being expended to build up Durham.

In the first place, Trinity College has an excellent co-educational department and plans are being rapidly matured to extend its scope and increase its facilities. It seems that the principle outlined above would require that Durham do what it may to make this department adequate for all the needs the city may have or may develop in this direction. To establish another institution for the higher education of women within rifle shot of Trinity would mean the unavoidable duplication of equipment and effort alike.

From a broader standpoint what North Carolina needs today is not so much the establishment of more girls' colleges as more earnest support of those already in the field. There can be no question that the careful training of the girls of the state is a most pressing problem, but it is more than doubtful whether this object is to be best attained by multiplying institutions which—largely from their very number—cannot hope to offer facilities possessed by colleges of the first rank. It is the quality of the training bestowed and not the number of places which is going to count.—Charlotte Observer.

Chaplains and Tents.

The general staff reports that the assembly of the three brigades composing the maneuver division near San Antonio required just 10 days.

The regiment which first entrained left 38 hours after receiving orders. Much of the delay is ascribed to the lack of cars ordered of the railroad companies. If it took 10,000 men 10 days to travel an average of 1,000 miles, how long would it require to send 100,000 men to the coast, if such a movement were necessary?

The troops moved in light marching order, which, however, includes much impedimenta not needed or permitted in the field. Some of the supplies were lost on the way and are still missing. No standing tentage in sufficient quantity was provided by the appropriate staff department, so that a large part of the troops are under shelter canvas—an unnecessary hardship.

But what they lack in canvas they make up in chaplains. Not less than 12 chaplains officiate at the fine edifice given the post of Fort Sam Houston by the citizens of San Antonio—Catholics, Episcopalians, Methodists and Baptists. There is some satisfaction in knowing that although there is no prospect of an armed conflict with Mexico or with any other nation, no soldier will risk joining the grand review of the heavenly host without being properly shriven.—Cleveland Leader.

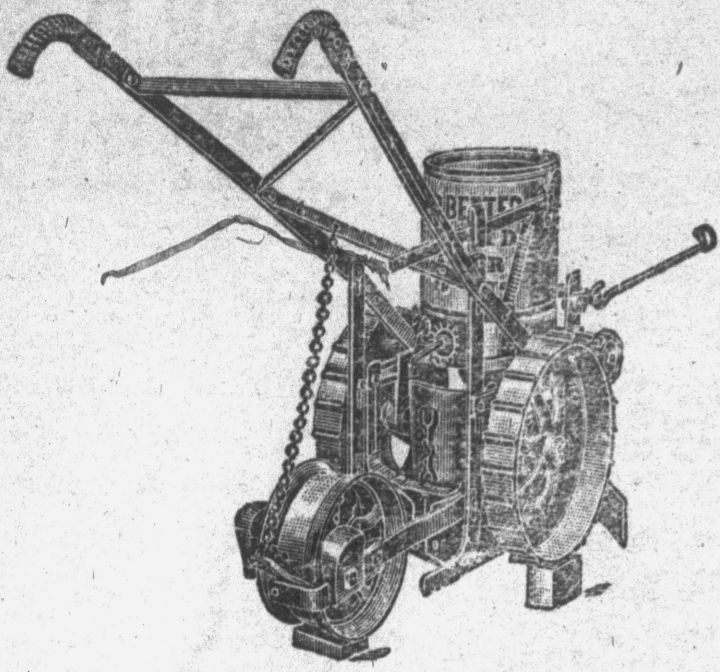
