## PITT COUNTY BOY WINS ORATORICAL MEDAL

### LEADS A. & M. COLLEGE CONTEST

His Subject, "The Greatest Asset" Handled Admirably.

The Pullen and Leazer Literary societies of the A. and M. College held their annual oratorical contest yesterday evening at 8 o'clock, in Pullen hall.

Mr. J. L. Martin, of the Pullen Society, was president, and Mr. C. W. Lee, of the Leazer, was secretary.

The first speaker was Mr. W. R. Mann, whose subject was "The Defenselessness of the Pacific Coast." He discussed the present weakness, or rather unpreparedness of our coast defenses, and was in favor of stationing permanent troops along the Pacific Coast. Mr. Mann, who is a Pullen member, spoke convincingly, and showed thorough preparation and much practice.

Mr. C. L. Cruse, of the Leazer, spoke on the subject "The Awakening." The development of the new world, especially the South, was his theme. The awakening along the lines of commercial and interior development were discussed, as well as the building up of the South after the Civil war. The improved methods of farming were touched upon.

"The Need of More Rapid Increase of Our Navy" was very convincingly discussed by Mr. T. H. Stafford, of the Pullen Society. He told of the development of the navies of other countries, and argued for a stronger navy, not only as a guarantee against invasion of American soil, but also as a protection of our commerce.

The medal for the best oration delivered, which is offered annually by President Hill, was won by Mr. J. P. Quinerly, of the Leazer Society. His subject was "The Greatest Asset," and in his oration he discussed the growth of our medical research—the discovery of the germ theory—and other important strides in the improvement of public health. He spoke of the great loss of life among the American soldiers during the Spanish-American war from typhoid fever, as compared with that from the bullets of the Spanish troops. He was in favor of government appropriations for medical research. He gave an account of a case in Indiana where a woman applied to the state for help when she was afflicted with the Great White Plague and was refused aid; then he gave an account of a farmer who, when his hog was taken sick, applied to the agricultural department for aid, and aid came on the next train, when the department sent an expert to the farm, and the hog was restored to health. This, he declared was one of the greatest mistakes that the government could make.

The judges were as follows: Rev. Dr. T. W. O'Kelley, Rev. W. D. Poe, Mr. L. C. Broughton.

Dr. O'Kelley announced the result of the decision, and said that he enjoyed the speeches—all of which were well prepared and contained some good thought.—Raleigh News and Observer.

Mr. Quinerly, the winner of the medal, is a son of Mr. J. P. Quinerly, chairman of the board of county commissioners. He is one of the leading students of the A. and M. College and a boy of whom his county has the right to feel proud. He is going to make his mark in life.

## NURSES AND SUPPLIES.

Hurried to The Seat of the Mexican War.

Washington, April 17.—Medical supplies and Red Cross nurses are today being rushed to Douglas, Arizona, by direct order of President Taft, in anticipation of a battle of Mexican federals and insurgents near Augua Prieta. President Taft took this action because of a request from Carlos F. Teran, head of the Red Cross at Douglas, who telegraphed that nurses and supplies were needed. The president, after a conference with Miss Boardman, of the Red Cross, directed that \$2,500 be telegraphed to Mr. Teran and six trained nurses were sent from San Francisco and the head army nurse from Hot Springs, Ark.

## IN THE WAR ZONE.

The Insurrectos Still Hold Augua Prieta.

Douglas, Ariz., April 17.—Insurrectos still hold the Mexican town of Augua Prieta today, although the Federals under Col. Reynolds Diaz, drew nearer and skirmishing between out posts of the rebels and regulars were continuous during the night. It is believed the Federals will make an effort to take Augua Prieta at once, since it has been learned that the Mexican army of insurrecto forces under General Madero is marching toward town.

## THE VALUE OF GOOD SEED TO THE FARMER

### PLANTING AFFECTS HARVEST.

Agricultural Department Will Make Free Tests of Seed Samples.

Now is the time the farmers of the state are preparing for the harvest time, which means the money they shall realize and upon which their living depends. But what shall it be? To no inconsiderable measure, it depends upon what kind of seeds are sown. Often absolute failures are caused by planting poor seed that will not grow, or, still worse, seed that is badly adulterated with serious weeds, which entirely ruin the land for certain agricultural purposes, often upon which the farmer most depends.

That there is a great difference in the farm seeds sold in the state is forcibly shown by the difference in the results of the analyses made at the seed testing laboratory of the department of agriculture, co-operating with the United States department. For example, the results of the 125 tests of red clover seed made this spring by the seed laboratory, ranged all the way from 50 to 99 per cent. pure seed and from 20 to 97 per cent. germination. Some contained no weed seeds at all, while others contained more than 90,000 to the pound. Some samples contained more than 50 per cent. of dodder or love vine, which is the worst of all pests that occur in clovers and alfalfa. This great difference in the quality of seed is not only true in cases of red clover, but of all the farm seed.

Not only the loss of money paid for the seeds, which is really a small item, but the failure to obtain crops can be prevented by knowing the value of the seed which is planted.

The department will make tests of all agricultural and vegetable seeds for any farmer in the state free of charge and reports will be sent to him promptly. In case the seed does not come up to the standard of good

## Let Men Alone

Four men in Pennsylvania were recently sent to jail and fined for using U. S. mails to sell divining rods—that is, rods which enable one to locate metals or minerals in the ground. The Postoffice Department is going after a whole lot of these swindlers and the day of the fraudulent advertiser is fast passing. Better protection, however, than the National Government can possibly give can be given each farmer by himself. The thing to do is to let the fakirs who make such extravagant claims alone. Southern farmers have paid thousands of dollars for fertilizer receipts which were valueless or worse, when they could have written to their farm paper or to their experiment station and found out just what the mixtures were really worth, or at least, could have found out, without paying one cent, much more about fertilizers than these recipe sellers could ever tell them. Before us as we write is a circular from an M. D. in Washington, D. C., who has some sort of plan—he does not say what—for getting rid of the boll weevil, the leaf weevil of alfalfa and the insects which infest fruit trees. He also hints that he is death to hookworm. He attacks the scientists of the Department of Agriculture and the experiment station for the use of poisons in combatting these insects and claims that his method will be the "natural" one. This man may be acting in perfect good faith, we do not know; but we do know that when any man comes along with secret receipts to sell or makes claims for his goods which common-sense should teach one are unreasonable, the best plan is to let him strictly alone—Progressive Farmer.

The Great German Poet's Analysis of "the Melancholy Dane."

Figure to yourself this youth, this son of princes; conceive him vividly, bring his state before your eyes and then observe him when he learns that his father's spirit walks. Stand before him in the terror of the night when the venerable spirit appears over him. A horrid shudder passes over him; he speaks to the mysterious form; he sees it beckon to him; he follows it and hears. The fearful accusation of his uncle rings in his ears, the summons to revenge and the piercing oft repeated prayer, "Remember me!"

And when the ghost has vanished who is it that stands before us? A young hero pausing for vengeance? No! Trouble and astonishment take hold of the solitary young man. He grows bitter against smiling villains, swears that he will not forget the spirit and concludes with the significant ejaculation:

The time is out of joint. O cursed spite, That ever I was born to set it right!

In these words, I imagine, will be found the key to Hamlet's whole procedure. To me it is clear that Shakespeare meant in the present case to represent the effects of a great action laid upon the soul unfit for the performance of it. In this view the whole piece seems to be composed. There is an oak tree planted in a costly jar which should have borne only pleasant flowers in its bosom; the roots expand, the jar is shattered.—From "Wilhelm Meister."

## SACKING A THEATER.

Tribulations of the Drama in New York in 1765.

Here is an account of the sacking of a theater in New York from the Gazette of May 3, 1765:

"The play advertised to be acted last Monday evening having given offense to sundry and divers inhabitants of this city, who thought it highly improper that such entertainments should be exhibited at this time of public distress, when great numbers of poor people can scarce find means of subsistence, whereby many persons might be tempted to neglect their business and squander that money which is necessary to the payment of their debts and the support of their families, a rumor was spread about the town that if the play went on the audience would meet with some disturbance from the multitude.

The audience escaped in the best manner they could. Many lost their hats and other articles of raiment. A boy had his skull fractured and was yesterday trepanned. Death is his. Several others were sorely set upon and injured. But we heard of no lives lost. The multitude immediately demolished the house, carried the pieces to the common, where they consumed them in a bonfire."
