TRAINING SCHOOL NOTES

HAS SEVERAL ENTERTAINMENTS

Members of Faculty Visit Other Schools.

President Wright attended the fourteenth meeting of the Educational Conference of the South recently held at Jacksonville, Fla.

President Wright has delivered the literary address at the closing of the following schools: Mt. Olive, April 14; Stantonsburg, April 28; and Jacksonville May 2.

Mr. W. H. Ragsdale attended the closing exercises of the Grifton Graded school April 27th and 28th.

Mr. C. W. Wilson will attend a picnic and educational rally this week at the closing of the Saratoga school.

Miss Crane, secretary of the Virginia-Carolina territory of the Y. W. C. A., spent two days at the school recently. Her visit was a great help to the organization.

On Sunday evening Miss Jenkins showed a number of interesting pictures of Korea that her mission study class has collected. She used the magic lantern. The lantern is a source of much pleasure and profit.

The second year class gave a most delightful vaudeville performance on the evening of April 22nd. There were some very amusing original features, a hypnotic show and a minstrel number; tableaux, an illustrated song, a beautiful gavotte and a clever play.

The senior class served a delicious luncheon to the faculty and Ex-Gov. and Mrs. Jarvis on the afternoon of April 29th. The luncheon of four courses, prepared and served by the class, reflected great credit upon both the class and the instructor, Miss Pugh.

The one year class gave on Saturday evening, a unique entertainment, presenting a sample copy of the Ladies' Home Journal. The magic lantern was used for throwing poster headlines. The cover picture pages and advertising department were shown in tableaux; the other departments were dramatized.

Miss Dabney, teacher of primary methods, has visited several schools near by. By observing the actual work in the school room she is brought in much closer contact with the teachers.

Every indication is that the summer school this year will be much larger than last year. The school has received at present one hundred per cent more applications for attendance than at this time last year. Many county and city superintendents and high school principals will avail themselves of the opportunity of attending the course in school administration to be conducted by Dr. George D. Strayer, of Columbia University.

The school has been forced to reject twenty-one applicants to the spring course for lack of room.

VERDICT FOR PLAINTIFF.

Jury Awards Mr. Cromartie \$6,300 Against Railroad.

A suit that attracted much interest in the present term of civil court was that of Mr. Avon Cromartie against the Atlantic Coast Line. While at work for the railroad Mr. Cromartie lost a considerable portion of one foot which maimed him for life. He sued the railroad company for \$20,000, and the jury gave him a verdict for \$6,300.

THE LEGISLATIVE MILL

Of The Making of Laws There Is No End.

In a document recently prepared by Herbert Putman, librarian of congress, is included an illuminative table showing the number of laws and resolutions passed by the congress and the state legislatures in two periods. In Washington the number of bills introduced has risen from 20,893 in the Fifty-sixth congress to 44,363 in the Sixty-first. Fortunately this proportion of increase did not obtain in the number of laws enacted. In the Fifty-sixth congress this was 1948, including 1505 private acts and resolutions, and in the Sixty-first 823, including 288 private measures. Thus in the earlier congress 443 public measures were passed, and in the later 594. In private measures the Fifty-ninth congress exceeded all others in this group; it took favorable action on 6249.

In the state legislatures the years 1906 and 1907 seem to have been particularly productive. The table prepared by Mr. Putman shows the output to have been:

The decrease in the number of private bills adopted by congress can be explained in large measure by executive extension of the pension system, although this has apparently had little if any effect on the number of bills introduced. A great proportion of acts of state legislatures are of merely local interest and need cause nobody not directly affected any concern. There are numbers of state laws men and travelers, however, and to keep track of these is a well-nigh hopeless task.

Mr. Putman's contribution to the statistics of statute making is incidental to a review of the practices of various members in the different task of bill drawing. The absurdities and contradictions into which members fall in preparing measures the notorious. There is a movement in congress in favor of the creation of a bill drafting bureau, manned by experts, and the examples of muddled English and inexact phraseology that abound in the measures submitted in senate and house may be thought to indicate the desirability of such an institution.—New York Sun.

Another Governor Who Gets Results

Now that gubernatorial records are under general discussion, it is worth while to consider Hiram Johnson of California. Johnson was elected last fall after a primary fight in which he routed the old forces which had held the dominant part in that state enthralled for so many years that voters had come to think them irresistible. The legislature elected was in sympathy with the governor and in less than three months this record of progress has been established:

Initiative, referendum and recall were submitted to the people.

The authority of the state Railroad Commission was increased, and a constitutional amendment prepared to increase it still further.

A constitutional amendment granting the ballot to women was left to the people.

A law limiting the employment of women was established.

The party circle was abolished, and a sorter ballot adopted.

The Oregon plan of electing United States senators was written into a statute.

An employers' liability law was enacted.

A commission was authorized to investigate the state's natural resources and propose laws for their protection.

All this in less than three months. Not all these projects will appeal to citizens who believe in the stability of responsible government. But the Californians have not been idling away their time. The governor has not sat by complaining that his hands were tied.—Virginian-Pilot.

REGULATE COLD STORAGE.

Senator Heyburn Has Been Doing Some Investigation in Washington.

Senator Weldon B. Heyburn, of Idaho, is hopeful of getting his cold storage bill through the Sixty-second congress. This is a measure of great importance to the consumer and to the health of the community. It aims to protect the public against decomposed meats, poultry, fish, eggs and butter, and, in view of its antecedents, is not to be regarded as a visionary proposition.

The jurisdiction of the bill necessarily is confined to the District of Columbia and other possessions of the United States, for, of course, congress cannot regulate the wholesale and retail trade of any state. It can and would by this bill prohibit the transportation between states of any of the articles included within the prohibitions, but it could not, of course, reach local dealers by law. Hence in a measure the Heyburn bill will serve rather as a model for the states to copy than an instrument of direct regulation.

A provision to interest the innocent consumer is one that "no food product enumerated shall be placed in cold storage if diseased in any way." Only recently the senator received a letter from a large packer protesting against this prohibition, and he is chucking merrily over it. "This man actually wants the privilege of selling diseased meat," he commented "That would seem to be proof enough that my bill is needed."

The same paragraph prohibits the storage of products caught, handled, or slaughtered in any unsanitary manner.

"You might think that unnecessary, too," said Senator Heyburn, "but let me give you an illustration. Take the case of poultry. I know specifically of one state where poultry is killed and handled by negroes. They pull out the long feathers with their hands, and then, wetting their fingers in their mouths, proceed to finish stripping. I do not need to say any more than this to indicate the danger to health from such a practice—from tuberculosis, for example.

Senator Heyburn, like Dr. Wiley, is always on the alert to detect food impositions. In February they served him a piece of "fresh shad" in a Washington restaurant.

"Is this shad fresh?" inquired Heyburn of the waiter.

"Oh, yassir, yassir, dat shad puf-fickly fresh, responded the attendant.

Heyburn said nothing, but started on a little investigating tour of his own. He found that the shad was caught last fall.

Shad is one of the most luxuries of Washington life, and it is said to be no uncommon thing for the dealers to keep the fish in ice through the winter and then in the spring touch up their eyes and color their gills to make them look as if they had just come out of the water.—William E. Brigham, in the Boston Transcript.

MEXICO UNABLE TO

PROTECT THE FOREIGNERS

MAY APPEAL TO UNITED STATES.

Americans and Germans Fear Attack And Are Alarmed.

Mexico City, May 3.—Officials of the Diaz administration find themselves in a diplomatic corner in expectation that the United States government will demand assurance regarding Mexico's plan for the relief of 100 American and German citizens threatened by rebels and bandit forces besieging the city of Cuernavaca. The relief troops are only sufficient to guard Mexico City against rebel attack, and it is impossible to send aid outside.

Foreign residents at Cuernavaca say the rebellion is strengthened by a strong anti-foreign sentiment and threats are made by insurgents to treat foreigners as prisoners of war if the city falls. Mexico City realizes the seriousness of the position. Rebels are drawing near and Americans fear attack. In extreme exigency American troops stationed in Texas could be rushed over the hastily repaired railroads. Companies of volunteer citizen soldiers in Mexico City are being drilled daily. The Mexican cabinet is to consider the situation and will possibly appeal to the United States.

OHIO BRIBERY CASES.

No Immunity Will Be Granted Legislators.

Columbus, Ohio, May 3.—No immunity is to be granted to legislators in the Ohio bribery investigation, which was resumed by the grand jury today. The announcement made by Attorney General Hogan, who will push the case, caused state senators and representatives to restrain their ardor to testify. Witnesses are flocking to the jury rooms to tell what they know. Governor Harmon and Judge A. Z. Blair have testified.

ARBITRATION TREATY.

Bond Between United States and Great Britain.

An Unequally Shared Boom.

There has been more or less of an impression in this country—that the English cotton manufacturing industry is enjoying exemption from the depressed conditions found everywhere else. For this belief there appears to be little or no foundation in fact. English manufacturers are complaining quite as loudly and advocating reduced time quite as insistently as their fellows in the United States or continental Europe. They are having lean times, though, it is true, no such times as Lancashire has faced almost with despair in the past. Apparently they are neither better nor worse off just now than American manufacturers. They would be much worse off but for one of the most singular booms in the history of the British empire—a boom which has arisen in several British colonies, principally India, and which reflects more or less benefit upon the islanders at home. India is raising nearly twice as much cotton as she raised a few years ago, and the aggregate price received is nearly four times what it was then. Through this cause and good crops generally she has heavily increased her contribution to British trade. At present the British Isles, including even Ireland, are enjoying exceptional prosperity. The cotton manufacturing industry, however, lags sadly behind.

Senate Progressives in Good Standing

The senate, as our readers must remember, still remains Republican by a majority of nine. There has, however, been a very wide difference of view between the so-called "Old Guard" or "stand-pat" Republicans and the well-organized group of Republican progressives. These progressives are now in a position to turn the scale. The masterful leaders of high-church Republican orthodoxy are no longer in the senate, and their remaining adherents are more tolerant and accommodating. It has begun to dawn upon the minds of certain Eastern senators that the so-called "insurgents" are representatives of large masses of intelligent Republican voters. It was not so very long ago that these progressive Republicans were solemnly declared to be excommunicated by the real heads of the party. All aid and comfort was withdrawn from them. The fires of the inquisition were cheerfully lighted in many states in order that the insurgents might perish for their sins of non-conformity. But so swiftly have things changed that it almost makes one dizzy to keep up with the evolutions of Republican faith and practice. The head of the party, having excommunicated Cummins and the Republican progressives who did not like the Payne-Aldrich tariff, has now called the Democratic congress in special session to hasten the battering-down of that very tariff wall; and so far has the overturn gone that Cummins and the insurgents have already become the chief reliance of those Republicans who wish to save tariff protection as a principal and to some extent as a practical policy.—American Review of Reviews.

THE EUROPEAN METHOD

Of Paying For Her Waterway Improvements.

One feature of European waterway control which the United States should adopt is the method of local and national participation in improve-ments. This policy prevails particularly in France, Germany and Austria. In France interested localities are required to contribute at least one-half the total expenditure for the construction of new waterways. The government then gives to the contributing localities the privilege of levying tolls on the traffic over the new construction to reimburse themselves for the funds, principal and interest, so advanced. As soon as the debt and interest are paid the right to collect tolls ceases and is not renewed. In Germany, the construction of inland harbors in usually left to the municipalities, corporations and other interested parties who also own the sheds, warehouses, and docks. For the construction of new works, the provinces and corporations are required to guarantee the cost of administration, working and maintenance, and also to guarantee the yearly 3 per cent. interest on about one-third of the estimated capital, and one-half per cent. to the sinking fund from the sixteenth year onward.

The success with which this method has been attended in Europe demands that it be adopted in the United States. In the first place, the federal Government should not impose a tax on the country at large for the benefit of a single locality. Many projects now most insistently demanded would not be advocated if the localities interested were to be taxed for their share of the cost. This method of co-operation between the central government and the specific localities has been followed with most beneficial results in Europe.—American Review of Reviews.

Grow More Grass.

Sod on a soil during the rainy, or winter season, will stop washing—whether that sod be lespedeza, oats, rye or Bermuda grass. Broad, shallow terraces, with a slight fall, assist materially here in preventing the soil from washing. This style terrace, with effectual work at his Station. If there is any land on earth that can wash faster it is not within my knowledge.

If the rolling upland was sodded in Bermuda grass and then cultivated the soil would at least hold its own, and any leguminous crop would be very beneficial and effectual. There is great opposition to the use of Bermuda grass on land that is to be cultivated. As for my part, I would rather cultivate Bermuda sod than to cultivate poor land. Take your own choice.—Progressive Farmer.
