MAY MEETING OF THE COUNTY COMMISSIONERS

TWO SPECIAL TAX ELECTIONS.

Change in Boundary Line of Swift Creek and Chicod Townships.

The board of county commissioners met in regular monthly session on the first Monday, with four of the members present.

The following aggregate sums were drawn on the treasurer for current expenses: For paupers, \$235; county home \$229.30; superintendent health, \$25; clerk superior court, \$110.27; solicitor, \$101; sheriff, \$94; constables, \$27.72; justices of the peace, \$48.36; witness tickets, \$498.97; bridges and ferries, \$65.45; court cost \$51.30; conveying prisoners, \$2.30; elections \$2; jail \$14.50; smallpox, \$29.85; indexing records, \$227.25; printing and stationery, \$29.36; register of deeds, \$12.95; court house \$3,531.63. Salaries—sheriff, \$333.33; clerk, \$250; register, \$250; treasurer, \$423.33; county roads, \$290.91; county stock law, \$52.25; Belvoir stock law, \$185; Bethel roads, \$623.06; Chicod roads, \$3.20; Greenville roads, \$1.95.

The several officers made their reports for the past month, which were approved and ordered recorded. The collections were as follows: Sheriff, \$22.40; clerk, \$197.70; register of deeds, \$222.

A petition from citizens of Swift Creek township, asking for a change in the boundary line of Swift Creek and Chicod townships, was presented, and was granted. The change is as follows: Beginning at a point where the Taft road crosses Indian Well swamp, and runs down said swamp to Long branch; then up said Long branch to White's camp on the Taft road; then with the Taft road to the beginning. This change was made for convenience to the voting precinct.

Special tax elections were ordered held in two school districts in Falkland township, in No. 1 on May 31, and No. 3 on June 2. The registrar and poll holders for No. 1 are: J. L. Warren, G. W. Satterfield and W. L. Brown, and for No. 3 E. C. King, C. H. Mayo and F. G. Dupree.

SLAY BIRDS FOR PLUMES.

Unspeaking Cruelties Practiced in Quest of The Aigret.

At the hearing on the Shea bird protective law before the fisheries and game committee of the assembly at Albany next Wednesday there will be presented affidavits showing the manner in which the supply of heron aigrets for millinery purposes is obtained. These affidavits have been obtained by the National Association of Audubon Societies for the Protection of Wild Birds and Animals.

"We gathered these affidavits," said Mr. T. Gilbert Pearson, secretary of the association, to refute the story which has been widely circulated to the effect that aigret plumes are picked up from the ground and that the birds are not killed in order to get them.

One of the affidavits to be presented was made by A. H. Meyer, for nine years a collector of aigret plumes in Venezuela. In his sworn statement Mr. Meyer says, in part:

"I am thoroughly conversant with the methods employed in gathering aigret and snowy heron plumes in Venezuela. The birds gather in large colonies to rear their young. They have the plumes only during the mating and nesting season. After the period when they are employed in caring for their young it is found that the plumes are virtually of no commercial value, because of the worn and frayed condition to which they have been reduced. It is the custom in Venezuela to shoot the birds while the young are in the nests. A few feathers of the large white heron can be picked up of a morning about their breeding places, but they are of small value, and are known as 'dead feathers.' They are worth locally not over \$3 an ounce, while the feathers taken from the bird, known as live feathers, are worth \$15 an ounce.

"The natives of the country, who do virtually all the hunting for the feathers, are not provident in their nature, and their practices are of a most cruel and brutal character. I have seen them frequently pull the plumes from wounded birds, leaving the crippled birds to die of starvation, unable to respond to the cries of their young in the nests above, which were calling for food. I have known these people to tie and prop up wounded birds on the marsh, where they would attract the attention of other birds flying by. These decoys they keep in this condition until they died of their wounds or from the attacks of insects. I have seen the terrible red ants of that country actually eating out the eyes of these wounded, helpless birds, that were tied out by the plume hunters. * * *

"To illustrate the comparatively small number of dead feathers which are collected, I will mention that in one year my associates and myself shipped to New York eighty pounds of the plumes of the heron and thirty-two pounds of the little recurved plumes of the snowy heron. In this whole lot there was not more than five pounds of plumes that had been gathered from the ground, and these were of little value."—Ex.

PASSING 'EM ALONG.

Many Fakes Are In The Profession of Begging.

Most people are of the opinion that begging is one of the hardest conceivable ways of making a living but there have always been and in all probability always will be individuals who prefer it to more legitimate lines of endeavor. There are beggars and beggars. Some are broken-down specimens who really could not make a living at any other business; others exercise energy and perseverance which would infallibly win respect of other callings. Charity workers have no more constant problem than the one presented by the necessity for sorting, as it were, the wheat from the chaff among those appealing for public assistance.

Formerly it was the all too general custom for a community merely to shift responsibility in this matter. Persons found to be unworthy were merely forbidden to beg in that particular community and curtly ordered to move on. This is one of the poorest methods of handling the problem that could be devised. It merely creates a circulating band of dead-beats who prey on community after community without limit. The more advanced method contemplates an attempt, at least, to solve each case in the town in which it originates, without resorting to the futile expedient of passing the beggar along to a neighboring town. The files of Secretary Myers of the local Associated Charities are well stocked with illustrations of the various methods of solution tried.

A curious incident occurred during the past week which calls attention to these two diametrically opposed ways of handling beggars. It appears that a woman of good appearance turned up recently in Asheville with a money-soliciting proposition which had strong recommendations superficially but which would scarcely hold water when analyzed. One prominent business man and two ministers signed documents recommending her, but were careful to instruct her to present them elsewhere. She journeyed promptly to this city, where Secretary Myers as promptly took her in hand.

The Asheville gentlemen are scarcely to be censured severely, although their action was certainly unwise. Application is made to a very busy man to do thus and so, and the getting rid of the interruption is much more likely to loom large in his eyes than the eventual results of the method he takes to accomplish that end. Nevertheless, such passing on of beggars from town to town must be eliminated if society is really to grapple with the problem of the dead-beat. Not infrequently a knight of leisure is brought to see the error of his ways and is transformed into an industrious and useful citizen, but such improvement is not possible as long as he is allowed to work a community for a day or so and then obligingly encouraged to seek fresh pasture. It is only when the path of idleness becomes steep that work will begin to allure. To make the former rocs-strewn and easy is to condemn its occupants to walk long therein.—Charlotte Observer.

Reclaimed 3,000 Acres Land.

The state's prison authorities have just completed the dyke on the Roanoke river by which 3,000 acres of very valuable farm lands of the state farm are reclaimed that went to waste when the former dyke was swept away several years ago. The new dyke is sixty feet at its base and forty at the top. The additional land is to be restored to cultivation this season, and to this end an unusually large number of state convicts will have to be concentrated on the Halifax farms. At the same time there is increasing demand for them on railroad and other works at \$1.50 per day, the statement being authoritatively made that the governor and council of the state could easily place at least 1,500 more than they have.—Weldon News.

OLD NORTH STATE

NEWSY HAPPENINGS

GATHERED FROM EXCHANGES.

And Briefly Stated for Our Busy Readers.

Brevard, May 3.—Gaston Neill, who lives near here, this morning while in the woods peeling tan bark, was instantly killed. The tree had been cut down and lodged in another small tree. He, with a companion, had gone to work on another tree nearby. While working on this tree, the other tree rolled off and started down the mountain. He attempted to get out of the way but the tree caught him, breaking his neck and leg. His companion succeeded in escaping uninjured.

Reports made by the fertilizer inspectors to the state agricultural department indicate an increase in acreage of cotton 8 per cent; of corn 5 per cent; a decrease in acreage of tobacco 8 per cent; large increase in the amount of fertilizer to be used on corn, wheat, slight increase in acreage, condition about as last year. All report great damage to the fruit crop from frosts.—Raleigh Daily Times.

Henderson, May 3.—A big fire occurred here late tonight. The Carolina Bagging and Tile Company's plant is completely wrapped in the flames at this hour, and it is believed will be completely lost before the flames are extinguished. Also the Carolina Buggy Factory and Capital Buggy Factory are in great danger from the flames. The cause of the fire has not yet been ascertained.

Raleigh, May 2.—A message was received here this afternoon from Richmond to the effect that H. O. Bannister, for three years manager of the Western Union office here, had dropped dead in the union station there at 1:30 o'clock this afternoon. The death of Mr. Bannister, it is claimed, is a sequel to the tragedy enacted when his wife and child were asphyxiated in a bathroom here January 8, 1911.

ADVERTISING.

All Towns Might Take a Lesson for This.

One of the greatest lawyers in the country, in arguing the case of the federal government against the American Tobacco company in the supreme court of the United States, says:

"There is no word in the Sherman act to forbid the acquisition of property; the most valuable acquisitions by the American Tobacco company were of good will, trademarks and brands."

In this last sentence is contained the strongest possible argument that could be advanced in favor of advertising. The lawyer might have gone just a little further and said that these trademarks, brands and good will receive their value almost entirely from the liberal use of advertising space.

The business of the American Tobacco company has doubled recently in a very short period of time. One of the founders and chief director of the world-wide business of this great corporation gave as his reason for this increase the fact that his company kept making goods just a little better than its competitors, and that it convinced the buying public that they were better by judicious use of advertising:

"If we have a monopoly of the tobacco business" said this official, "it is because the public goes into the stores and calls for our goods and will have no other. The public does this because we make our goods better than the goods of our competitors, and, then, we let the public know that they are better. We might have ever so much better goods than our competitors, and if we did not let the public know that we had them we would go into bankruptcy in a very short time."

With this wonderful example of the result of intelligent, persistent advertising under their own eyes every day, many of the merchants of Durham are content to sit idly in their stores complaining of lack of business, when a little advertising would bring them more business than they could handle. Thousands of dollars go out of Durham every year to the retail trade of other cities, because the merchants of Durham are not progressive enough to let the consumers know that the goods they desire can be purchased at home. To the merchant who knows how to advertise judiciously, dull seasons are unknown.—Durham Sun.

LORIMER INVESTIGATION.

Senate Will Change The Hour Of Meeting.

Prisoners To Be Arraigned For Murder.

CAMMORISTS TRIAL.

INTERVENTION ASKED.

Why China Suffers From Famine.

First of all, we may inquire why such conditions obtain. Why is it that the Oriental gets such low wages, and has such a low earning power? "An over-crowded population," somebody answers, "in China, for example, four hundred million people—one-fourth the human race—crowded within the limits of one empire. This is the cause."

I don't believe it. There is a limit, no doubt, beyond which increase of population, even with the most highly developed system of industry, might lead to such a result, but I do not believe that this limit has been reached even in China. The people in England live a great deal better to-day than they did when England had only one-tenth its present population. The average man in your country has more conveniences, comforts, and a better income than he had in your grandfather's day when the population was not nearly so dense. The United States with a population of ninety million pays its laborers vastly better than it did when its population was only thirty million.

The truth is that every man should be able to earn a little more than he consumes; there should be a margin, an excess, which should constitute his contribution to the "common wealth," the race. Our buildings, roads, railroads, churches, cathedrals, works of art—everything which makes the modern world a better place to live in than the primitive world was; these represent the combined contributions of all previous men and races. And society is so able to handle men that they produce any fraction more than they consume the more men the better the world.—Clarence Poe, Progressive Farmer.

In any line of trade, for it is these workers that pay their salaries and it is a pity that there are such pin-headed, contemptible and foolish men in charge of the school at Annapolis as to object to the working people being on friendly terms with the students.

In the departments of the government is where true democracy and friendly feeling should prevail. When the superior officers assume to dictate the associates of those under them this ceases to be a free country.

The working classes are just as good as the members of other more fortunate classes, and this is being demonstrated every day when cases like that of the young man in question arise. In this case he will take for a life companion one of the working classes who has the qualities and courage of a gentlewoman.

That the young woman was denied recognition in Annapolis society is a disgrace to the institution, a disgrace to the nation, and a disgrace to our civilization. The young man is to be commended for the attitude he assumed and those responsible for the insult should be given several swift kicks and barred from the society of respectable people.

Assuming that our contemporary has its premises correct, we heartily endorse what it has said. A working girl can be a gentlewoman and a lady in America, no less than those who spend their days in changing fine dresses, attending teas, card parties and tilting their haughty noses with scorn if they happen to pass in the street or see an honest work-girl. The commander-in-chief of the army would be justified in summarily removing any officer whose foppishness and snobbery would lead him to take such a stand as is quoted in the foregoing, assuming the only criticism that could be made of the young woman was that she was a "working girl." To do otherwise would dishonor thousands of good mothers, and outrage the virtue of a vast majority of American girls—the girls who will be the mothers of the future greatness of this country. Glory to the young man who would slap such silly twaddle and foppish tommyrot in the face and stand by his "working girl." He is more fit for an army officer than his scramble-brained chief—who is his superior by suzerainty and not on merit.—Greensboro News.

The Head of The Family.

What makes a person the head of a family?

It had innocently been imagined that the existence of a family of children dependent on and living with parents was one of the necessary factors if there was to be a head of the family. But a Solomonic decision by a member of the State Commission of Taxation casts a shade of doubt on the supposition.

As usual, the new woman and her little ballot are at the bottom of this doubt. The Tacoma woman's equal suffrage association questioned Commissioner Rockwell as to who, as the head of a family, was entitled to the \$300 exemption from taxes.

The commissioner's answer gives broad scope to the idea of a family and its head.

According to him, a single person and a dependent, of this be an adult brother, a partly dependent adult sister, an aunt, an uncle, or the dependent minor children of a brother or sister, form a family from the point of view of exemption from taxes, and the support of this quasi "family" is its head. The dependent of dependents need not even live with the person providing support.

The law plays many pranks with law ideas, but this legal idea of what makes a family and its head, from the point of view indicated, works havoc with ordinary notions about them.—Spokane Spokesman-Review.

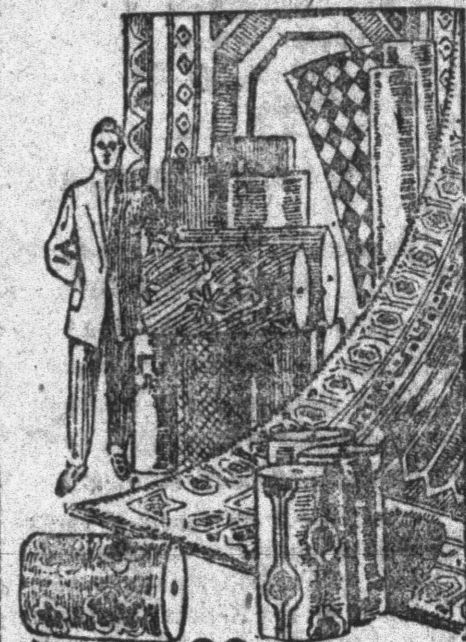

CITY OF BALTIMORE AND CITY OF NORFOLK

PLY BETWEEN NORFOLK, BALTIMORE

Chesapeake Steamship Co. Put Into Service Finest-Steamers on the Bay—Has 148 Staterooms, Equipped With Wireless Telegraph and Extensive System of Telephones—Sunday Service.

The steamer City of Norfolk, the newest steamer of the Chesapeake Steamship Company, is due to arrive from Baltimore on her maiden trip between Norfolk and Baltimore this morning, (May 1).

With a large number of passengers and a large cargo of freight the new steamer in command of Captain Thomas, who is well known here, owing to his frequent visits here in command of other vessels of the Chesapeake Steamship Company, left Baltimore at 6:30 o'clock last night.

As she has not had her trial trip in Baltimore, it is thought that she will be let out on her trip down the Chesapeake Bay, to see what she really can do.

Her contract calls for her to make the trip between Norfolk and Baltimore, a distance of 185 miles, in ten hours, which is at the rate of eighteen-and-a-half miles an hour, and if the performance of her sister ship the City of Baltimore can be used as a comparison, she will have no trouble in filling contract requirements.

Mr. Key Compton, president of the Chesapeake Steamship Company and a large party of Baltimoreans are coming down on the vessel, and will remain over here until she sails on return to Baltimore on Monday night.

Miss Celestine Finley, who christened the boat with the proverbial bottle of champagne, when she was launched at the ship yard of the Maryland Steel Company, at Sparrow's Point, Md., on December 3, last, is also on board the vessel.

Telephone System and Wireless. With her big sister ship, the City of Baltimore, the City of Norfolk will be one of the finest vessels plying in the bay trade, not only in construction, but also in accommodations and comfort for the passengers.

These two vessels have all modern arrangements and besides having wireless, have a private branch telephone exchange, extending to all staterooms on the vessel.

Upon the arrival of the vessel at either Norfolk or Baltimore, the telephone lines are connected up with the switchboard at the telephone exchange there, so any one can telephone from the boat to his home, announcing his arrival, or for them to send his automobile or cab to meet him.

The City of Norfolk and the City of Baltimore Sister Ships.

The City of Norfolk and the City of Baltimore are sister ships and are of the same design and construction. Their dimensions are as follows: Length over all, 310 feet; length between perpendiculars, 296 feet; beam moulded at deck, 46 feet 6 inches; beam moulded at water line, 42 feet; beam moulded over guards, 60 feet; depth of hold, 18 feet; draft at ordinary trim, 13 feet 3 inches.

The machinery will consist of a four-cylinder, triple-expansion, surface condensing engine, cylinders measuring 24-40-47-47 inches by 24 inch stroke. There will be four single and Scotch boilers, 13 feet 6 inches diameter by 11 feet 4 inches long, and 190 pound pressure.

Each vessel will have a licensed passenger capacity of 400 people and a carrying capacity of 650 tons of high-class merchandise freight. The latest type refrigerating plant with a capacity of 6,000 cubic feet will be installed on each vessel.

New Steamer Has 148 Staterooms.

There are 148 staterooms, located as follows: seven on the main deck, 83 on the saloon deck, and 58 on the gallery deck. Twelve of the rooms will connect with baths, which will have hot and cold, fresh and salt water, when ten additional rooms will have hot and cold, fresh and salt shower baths.

They will be lighted throughout by electricity. The main saloon is furnished in mahogany, while the gallery deck and staterooms are in white and old ivory. An attractive feature of the new vessel is the dining room, which is located on the gallery deck forward. This enables the passengers to have a view of the harbors of Norfolk and Baltimore while they are enjoying their meals and the outboard trip.

Another innovation to be installed by the Chesapeake Steamship Company is a Sunday boat on the trip between the two largest cities on the
