In a neat speech, Prof. C. W. Wilson introduced Dr. Charles E. Brewer, of Wake Forest College, who delivered the annual address. Dr. Brewer said that to select a subject for an occasion of this kind, to bring the proper message to those going out from such an institution to take their respective places in the world, gave him much concern. He realized that in the journey of life there would be times when the up-grade would be met, and then all the enthusiasm possible would be needed. They would need faith in God, faith in their fellow man and faith in themselves. When faith goes, hope is gone. The love of humanity for each one is measured by that one's love for humanity.

"Our Country, Its Foes and Its Friends," was the subject chosen by Dr. Brewer. Owing to the lateness of the hour he spoke rapidly, some of the points of his magnificent address being touched upon only briefly, yet with sufficient clearness to carry force in every sentence.

He said there is every reason to feel proud of our country. It has the finest land in all the world, and our coasts are the gateways to all the world. All other nations in their traffic have to come by us. It leads in products, the South alone practically supplying the cotton for the world. It leads in opportunities. There is absolutely no ban upon any profession, it matters not how humble it may be.

He spoke of only two foes to our country. The first was commercialism, which sinks its roots into the very foundation and eats out the heart. It is commercialism that seeks the making of large dividends by the destruction of competition. Men love to speculate. In this there is something which attracts them and

STANDARD OIL CO. IS DISSOLVED

SUPREME COURT HANDS DOWN DECISION MONDAY

UPHOLDS VERDICT LOWER COURTS

Declares The Standard a Monopoly in Restraint of Trade and Operating in Violation of Anti-Trust Law—Six Months to Wind up Affairs.

After The Reflector had been printed and mailed Monday afternoon, the following special was received:

Washington, D. C., May 15.—Late this afternoon the United States Supreme court handed down a decision dissolving the Standard Oil Company. The opinion of the court was unanimous. Chief Justice White read the decision which completely upheld the verdict of the lower courts. The Standard was given six months by the court to wind up its affairs. It was declared to be a monopoly in restraint of trade and operating in violation of the Sherman anti-trust act.

Oil Company Will Obey Mandate of Court.

New York, May 15.—The Standard Oil Company decided to withhold a statement on the Supreme court decision until a study has been made of the dissolution order. Announcement was made today by Mortimer Elliott, general solicitor of the Standard, that the directors for several months have been planning re-organization, expecting an adverse decision. The business is to go on as usual within the scope of the decision. He says further that complete obedience to the mandate of the court will be followed by the company.

About two nights out of each seven we lodge in a home wherein dwelleth a mother and a dear little girl, just passed the thirteenth anniversary of the day when she first saw the light, and that day was the glorious Tenth of May. Her mother is a great lover of nature—birds, cats and in fact, all of God's creeping things and those that can't creep, for 'tis a truth she would walk 5 miles through the sun to see a new born baby if it chanced to be a white one and a girl. And I really think half that distance she would go if it were a colored one. The little girl and her mother feed the cats, the dogs, the birds and whatever else may chance to come their way, and no animal is allowed to be hurt while under their guardian eyes, and to in any way disturb a bird that is within their protecting care, you had as well thrust a blow at either the mother or little girl. We have known the mother more than once to get out of her bed at 11 o'clock on a cold night, when she had dreamed that the pig had not had its supper, and draw on a heavy cloak and her sandals and go forth to feed it, because she thought it was hungry. It is no wonder that the song birds gather in flocks about this home and with the dawning of the morning warble their sweetest song, and while we do not rise up early to follow after strong drink when we are there, the carols of those birds are so sweet that we can't resist these beautiful May mornings we long for aurora, harbinger of day, that we may listen to the song bird's sweetest lay. Moral: Be kind and gentle to everything and with their best service they will repay.

We daily read of some victory achieved by those who are at war in Mexico. While this Christianized world is pleading for peace, and the settlement of all disputes by arbitration, and this is sure to come, for surely peace has her votaries and heroes no less renowned than war.

Did he whimper? No, but he bore it with all the fortitude of that boy that stood on the burning deck, not from fear of a storming father, but because he was made to think that he was a hero, and indeed he was.

PEACE EXPECTED TOMORROW

WITHOUT SOME HITCH IN NEGOTIATIONS

INSURRECTOS CAPTURE A CITY

Overpower Federals and Massacre Five Hundred Soldiers and Citizens—Blood Flows Through Streets of City—Washington Cabinet Discusses Situation.

City of Sombretet Captured.

Mexico City, May 16.—Details of the capture of Sombretet by the Insurrectos was received here today, and tells of the massacre of five hundred federals and citizens. That the Insurrectos threw sticks of dynamite under the federal calvary, and then charged on them, shooting down everything in sight in the assault on the federals. The Insurrectos numbered two thousand, the federals defending numbered two hundred. Louis Maya, a chieftain, was killed, and the town looted. The massacres was such that the streets ran with blood.

Peace Probable Tomorrow.

El Paso, Texas, May 16.—Dispatches from the seat of war in Mexico disclose the probability unless some unforeseen hitch occurs in negotiations between Madero and Carbajal, of successful peace treaty between the warring factions, and a cessation of war and establishment of peace tomorrow.

CABINET SESSION TODAY.

Considers Several Matters of Importance.

Washington, May 16.—The president and his cabinet held a session today and give consideration looking to the dissolution of the steel trust, upon which procedure light has been thrown by the decision of the Supreme court of the United States in the Standard Oil Company, handed down yesterday. The arbitration treaty with England was discussed, also the Mexican situation, as it affects citizens of the United States.

VICTORIA MEMORIAL UNVEILED

In Presence of British and German Royalty.

By Cable to The Reflector. London, May 16.—The Queen Victoria memorial was unveiled today in the presence of British and German royalty. King George, Queen Mary, Emperor William and the Empress of Germany walked from Buckingham Palace to the scene amid the cheers of thousands who had thronged the way.

RIGHT TO BE HONEST.

Doctors are forever discovering new diseases. Why they have not discovered that some men die of enlargement of the heart is not clear. The other day a messenger boy in New York found a certified check for \$55,000 on Broadway. Instead of cashing it, which he could have done, he looked up the owner and returned it to him. Then the generous man gave him a dollar! It is getting so it is no inducement to be honest.—Greensboro Record.

While the owner of the check might very justly have given the boy a much larger reward, still that boy's consciousness of having done right is worth more to him than the whole check would have been. In circumstances like this people should not be honest for the hope of reward, but because it is right. Money is a good asset to have, but incomparable with character. People should need no inducement to be honest, but should be honest from principle.

TRUST DISSOLVED.

For sometime on every Monday, the day for decisions to be handed down, decisions have been looked for by the United States Supreme court in the cases of the government against the Standard Oil Company and the American Tobacco Company. Late Monday afternoon the decision was handed down in one of these cases, of the Standard Oil Company, the court upholding unanimously the verdict of the lower courts that it was a monopoly in restraint of trade and operating in violation of the anti-trust law. The fight has been long and hard. It remains yet to be seen what will be the result of this decision.

It matters not how many good things Greenville may have, there are not too many and is room for more. A few manufacturing enterprises would not overcrowd us at all, and something to give profitable employment to a thousand or two more people would be all the better. You can hear business men say that owing to the fact of country trade being divided among towns of close proximity, no one town can get its mercantile support from that source of trade alone. If this be true, the best thing to do is to enlarge local conditions to bring in more people to make more trade. The town that holds out the best inducements will get the most business. And let these inducements be known by judicious advertising.

Let The Veterans Talk.

Reports from the various towns indicate that North Carolina Wednesday did honor to its Confederate dead in fitting and eloquent manner. There were oratory and flowers and revelry of tender memories. As a general thing, those selected to make speeches were worthy scions of real soldiers—none more representative than the orators at Charlotte, Salisbury, Gastonia, Shelby, Greensboro and other towns. But it occurs to The Chronicle that it might be well next year, to have a diversion—to make it an old soldiers' day in the truest sense of the word. Instead of the speeches, how would it do to have a series of short talks from the veterans, giving brief reminiscences of the battles in which they participated? That would be history in actuality, instead of history in eulogy. At the exercises in each town, half a dozen veterans might be put on the programme for brief talks and out of these talks some bits of fast-fading history might be caught and preserved. The time is at hand to catch history, for the opportunity grows less each year, and the veterans who participated in the great scenes of the four-years' war are the ones to add the closing chapter. The Chronicle believes an innovation of the sort suggested would not only be profitable, but add entertainment and revive interest in the annual observance of a day that must be always sacred to the south.—Charlotte Chronicle.

ABOUT ISSUING BONDS.

Anson County Bond Issue of \$300,000 Defeated.

Anson county voted last week on a bond issue of \$300,000 for roads and the measure was defeated. The Wadesboro Ansonian, which heartily favored the proposition, says the campaign was a mild one and it is inferred that the issue was not pressed. The Ansonian says:

There seemed to be unusual prejudice against issuing bonds on account of the fact that interest is a necessary part of a bond issue. Some of those who used this point as an objection borrow money at a higher rate of interest than the proposed bonds could have drawn, and the principal is the same. They forget that a man who rents a farm or a home will within 15 or 20 years at most, pay enough rent money to buy the property he is enjoying.

This same objection is figured in the Iredell campaign. It is remarkable that men who have to borrow money, or go in debt for something, at times, as most everybody does, or who rent farms, or homes, should suddenly become so impressed with the idea that it is a calamity to make a public debt. Hundreds of people in Statesville have bought and built homes and business houses and paid mortgages through the building and loan association, which is exactly the same principle as that submitted in the county bond issue for roads. Moreover, if nobody ever borrowed money all the banks would necessarily go out of business and men who had money would find it practically valueless. They could not loan it so that it would earn something. Few people who had no money would ever be able to accumulate property, for they could not borrow to get a start. Of course one should always be prudent so as not to make a debt beyond capacity to pay, but this certainly did not apply in the Iredell road bond issue.—Statesville Landmark.

Getting Toward The Superlative.

It can be said that the local trend everywhere in North Carolina is towards the superlative degree in everything. Standpatism is being ignored in communities where formerly to advocate any change meant an order to leave the place. Better homes, larger buildings, increased municipal betterments, greater industries, improved highways, bigger theaters, parks, and always something longer, materially.

It was not many years ago that a bond issue proposed for county roads or municipal improvements would cause alarm, and bring a public meeting to offer protest. The change from this condition is most noteworthy. A few days ago Iredell county voted by a big majority \$400,000 for good roads, and except general congratulation no comment is made upon this liberal bond issue. Nearly every town in the state has voted bonds for streets, water-works, sewerage, electric lights, and this with issues to about the tax limit.

With all this movement towards the superlative, materially, there is an equal movement towards the educational. All this tends towards a higher and greater appreciation of this state the creation of civic and state pride that has a substantial foundation for its pride. It is the most hopeful and encouraging feature of the day, that all North Carolina is working towards the superlative in all things.—New Bern Journal.

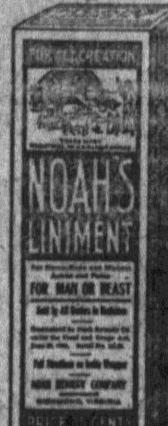

HIGH HONOR FOR POETESS

Sister Antonio to Have Degree Conferred by Cardinal at Emmitsburg

Sister Mary Antonio, formerly of Pittsburg and for many years a member of the faculty of St. Xavier's Academy, Beatty, Pa., is to enjoy the distinction on June 16 of being the second member of the Mercy order in the world to be honored for literary attainment. His Eminence Cardinal Gibbons, acting for the Sisters of Charity at St. Joseph's Academy, Emmitsburg, Md., at the commencement exercises of that institution, will confer on Sister Antonio the degree of doctor of literature, in recognition of her literary work in the service of morals and religion. Several hundred Pittsburg and Philadelphia alumnae of St. Xavier's are planning to go to Emmitsburg next month for the occasion.

Under the nom de plume of "Mercedes" Sister Antonio has written poetry and prose for nearly all the big magazines in America. Her pen productions have frequently been reproduced and favorably commented upon in other countries. The London Standard recently wrote a magazine in which one of her poems appeared and asked concerning the identity of "Mercedes". The information was not forthcoming, because the editor of the magazine himself did not know her right name. This is the first time that the identity of "Mercedes" is made public. Sister Antonio's books are to be found in all important libraries of the country.

Sister Antonio is a native of Philadelphia and is a full cousin of Mother Katherine Drexel, a member of the noted Eastern family of that name. Her father was Anthony J. Gallagher, a pioneer of the Quaker City, and her early education was obtained at the select school at St. Mary's, Sixth and Spruce streets, Philadelphia. Sister Antonio entered the order of the Sisters of Charity after she had attended St. Joseph's Academy, at Emmitsburg. As a member of this order she remained until the close of the Civil war, when she became a Sister of Mercy.—Pittsburg, Dispatch.

its uncertainty draws them on. They want to get something for nothing without giving adequate return, without regard for the commandment, "Thou shalt not steal." Commercialism fastens its roots upon the business world. It springs up as a great tree and falls upon every department of life. It shows itself in official life in various forms of dishonesty and graft. It invades the affections and takes out of patriotism its beauty and romance. It is shown in spending as well as in making money. The tendency is to live on credit. We can well afford to borrow money to put in education or to put in roads, for in these we see something to come in return.

The other foe mentioned was immigration, which he said had been so excellently discussed in the essay of one of the graduating class that he would hardly do more than refer to it. One-tenth of our population is foreign born, and counting the children born in this country of foreign parents, one-third of our people are foreigners. There is danger of our being foreignized faster than we can Americanize the foreigners.

Coming to the friends of our country, Dr. Brewer said the Christian church is first and is our crowning glory. The second is public opinion. The sober sense of any country is reliable. People may do things that are wrong, but they win before the bar of public opinion of their misdoings. The third is our public schools, the pride of our people. He regretted that there were some who did not believe in special taxes for schools, and some opposed to the education of the negro and the foreigner. Upon education and ignorance there should be no division of sentiment. The fourth friend is diplomacy. Under this heading he gave several incidents wherein American diplomacy had surpassed and startled the world in bringing about arbitration and settlement between nations in strife.

Dr. Brewer's was a great speech that rang true and forceful in every sentence, this comment being only a brief reference to some of the many good things he said.

The speech in presenting the diplomas to the graduating class was made by Prof. C. W. Wilson, of the Training school. It was like a gem of rarest value, in words most appropriate.

Higgs, Josephine Fleming Little, David Columbus Moore, Jr., Inez Dare Pitt-Maggie Nina Savage, Drury Gill Spain, Benjamin Franklin Taylor, Mamie Ruth Tunstall.

Graduates in music were Mary Lucy Dupree, Vashti Deans, Marguerite A. Higgs, Betty Pearl Fleming, Inez Dare Pittman, Mamie Ruth Tunstall, Pattie Bruce Wooten.

The presentation of diplomas was followed by the marshals entering, bearing huge bouquets of flowers for each of the graduates. They were just loaded down with flowers. It was then announced that one of the graduating class had something to say. Mr. B. F. Taylor arose and calling their teacher, Prof. Brewer, to the front, in most appropriate words thanked him for his untiring efforts and devotion in helping the class, and in behalf of the ninth and tenth grades presented him with a gold watch chain. Up in Wisconsin the lawmakers propose to discourage legislative trading of votes by making it a felony. Any legislator who agrees to vote for the bill of another member on condition of receiving the others vote for his own pet measure becomes a criminal, provided the governor approves the law that has been enacted by both houses of the Wisconsin legislature.

A trade is as much a barter as a sale for money is. The valuable consideration is the test. And if our personal liberties can properly be interfered with to the extent of a prohibition of vote-selling, and the prohibition might as well be extended to vote-swapping likewise.

Some of these days, when lobbying is forbidden and vote-trading is forbidden and deadlocks over the election of senators is no more, representative government will begin to get back its reputation.—Omaha World-Record.

New York, May 16.—Editorial comments are saying the Supreme court's decision in the Standard Oil case will benefit the country. It is regarded as protecting legitimate business, but knocking out illegal combinations. The stock market opened strong on initial transactions. Standard Oil was below last night's closing. The general list was up fractions to three points.
