

## INTERESTING LETTER FROM WASHINGTON

### NEWS OF THE CAPITAL CITY.

#### Arizona and New Mexico Statehood—Fight Against Reciprocity.

Washington, May 29.—After having worked eighteen years for the admission of Arizona and New Mexico, as separate states of the union, the Democratic majority of the house found it a genuine labor of love to pass the statehood resolution.

In voting for the admission of the territories as states, the house neither indorsed nor condemned the recall of judges. What the house actually did was to indorse local self government and the right of the state to control its own affairs.

For 60 years New Mexico has been at the doors of congress for admission. Arizona has also long contended its right to statehood. The 1908 Democratic platform pledged the "immediate admission of these territories as separate states." This pledge was carried out before the Democrats had been in control of the house three months, which action was in striking contrast to the jugglery the statehood measures have been receiving year after year at the hands of the now minority of the house.

The debate in the house on the statehood resolution indicated plainly what would have been the result had the Republicans still been in the majority. They would have admitted New Mexico with the gerrymander of her legislature, and would have made the recall of judges a pretext for keeping Arizona indefinitely out of the union. This is plainly seen by the speeches and votes of the Republicans in favor of immediate admission of New Mexico and against the admission of Arizona.

The real motive for this was in the promise that New Mexico would elect two senators to reinforce the declining Republican majority in the senate, and in the certainty that Arizona will elect two Democrats.

Indications are that the Democratic house will reduce the tariff on raw wool by one-half. They would be carrying out the promise contained in the national Democratic platform of 1908 which was that "gradual reductions should be made in such other schedules as may be necessary to restore the tariff to a revenue basis."

#### Reciprocity Threatened.

That the reciprocity measure is in a precarious position in the senate, is admitted even at the White House. Practically the same interests and the same methods that became famous through saving the seat of Lorimer, are factors in the fight against reciprocity. The lumber interests, for instance, are anxious to have reciprocity defeated, and the gigantic paper trust is equally hostile to the measure.

It has only been within the last day or two that President Taft has realized how serious is the position of reciprocity. Two weeks ago, and even as late as a week ago, reciprocity appeared to have a safe majority in the senate. The fight against the measure was carried on very quietly, just as the fight to save Boss Lorimer was conducted. Suddenly it developed that the powerful interests which still control the senate had apparently secured enough pledges to defeat reciprocity.

The Lorimer tactics contemplate a long delay during which time the finance committee will ostensibly proceed with its investigation. Then, when the opposition sees that it has the votes to crush the treaty, they will allow it to come to a vote.

Senators Stone, of Missouri and Williams, of Mississippi, both Democratic members of the finance committee, are working earnestly to save reciprocity. But they are finding it uphill work in the committee, which is dominated by the reactionaries.

#### Where Fight Comes From.

From a suite of offices in Williams street, New York—which is just at the edge of Wall street district—an expensive campaign against reciprocity is being waged. A force of stenographers and writers is sending broadcast literature telling the farmers they will be ruined by reciprocity. Senator Stone has had the men in charge of the bureau subpoenaed in order that the finance committee may ascertain whether it is the National Grange or Wall street that is really behind the movement to discredit reciprocity.

## GOVERNMENT AFTER THE STEEL TRUST

### WILL HAVE HEARING THURSDAY

#### Much Depends On Testimony Of The Trust President.

Washington, May 29.—Upon the testimony of Judge Gary, president of the steel trust, before the house committee next Thursday, depends whether the government will institute civil and criminal prosecution against the trust. The question is whether Roosevelt in sanctioning the absorption of the Tennessee company by the trust absolved the trust's culpability. Seaton Kellogg may represent the government.

## HANRAHAN CORRESPONDENT GROWS REMINISCENT

### A DREAM OF THE BY-GONE DAYS

#### A Home, Though A Cabin, Where Love and Contentment Reign.

Hanrahan, N. C., May 29.—A while ago I took a stroll and wandered into a lovely forest (which are becoming so scarce that they are charming to me) and becoming weary, I sat down on the brow of a hill to rest and refresh myself beholding the beauties of nature in her beautiful form. I was not looking down for a sprig that might mark the place of some one dead, but was looking up, thinking of life and not of death, and behold, I found that I was under the canopy of an acacia tree, the emblem of life and immortality. So I sat there and listened to the songs of the birds, feasting my eyes on the flowers and stately trees; and while thus enraptured, I must have dozed a little and dreamed that I heard a voice from the cleft of an adjacent rock. It was not an uncouth and harsh voice exclaiming that I am more guilty than you all, but it was a still, small voice whispering, and said, Why sit here musing? Get up and do something for your fellow man, for each and every man is your brother, and the world is growing better. And you have your part to do, however humble that part may be, only strive to do it well. Then he thought, can the world be growing better? and I contrasted a few scenes that come under my own observation.

Scene first.—When I was a wee tot "down on the farm," my dear mother, of blessed memory, and I one day went to a home. It was a hut built of logs and daubed with clay. The chimney which extended nearly across one end of the cabin was made of split logs notched up until it reached the funnel. The funnel was built of small sticks, rived up and they were piled up in a four-cornered square and then the whole thing was covered in clay. Every thing about the premises was neat and clean, the pine table was as clean as the marble counter of a soft dunk store, the home-made corded bedstead was polished until the post frame, on top of which immaculate curtains hung, even glistened, the floor made of 12-inch boards was whiter than many bread trays of even these days, the homespun, and it was homespun, and home-woven sheets and pillow cases were as clean as soap and water and brawny muscle could make them, and as smooth as a Chinese laundered shirt. On either side of the house with one end sticking behind the boards that were nailed over the cracks, were rows of cotton brooches towering one above the other, and these were spun by that woman's own hands. The seed were picked from the cotton that made the brooches by the fingers of two little children, one a boy and the other a sweet girl, that sat at her mother's knees, around that huge fire on that winter day, and listened to my mother and their mother; for children even now love to hear what mother and the company have to say. The man of the house was in the forest which surrounded the house, cutting wood to replenish this huge fire place.

As the afternoon was growing toward nightfall, the father emerged from the forest into the path that led from the forest to the main road, the eager, watchful eyes of the two children spied him, and they forgot what their mother and mine were talking about, and with swift unshod feet (though it was cold) they ran to meet him. I followed and when they came to this horny handed son of toil, he stooped and kissed and caressed them, and spoke very gently to me. He gathered his two tots, one underneath each arm, and told me to crawl on his strong back, which I did, and thus he conveyed us to the cabin. At the door he deposited us and greeted his wife with a loving smile, an spoke pleasantly to my mother. Then he made ready for his second and last meal for that day. They only ate twice a day in winter. The meal consisted of Indian corn-bread baked in an oven on the hearth, sweet potatoes roasted in the ashes, home-made bacon and winter collards boiled in a pot hung on a crane. They had no biscuits in those days, except on Sunday and when company came, and mother had told the good woman that we could not stay for the meal, but I had already eaten some of those delicious potatoes and wanted some of those collards, when mother said

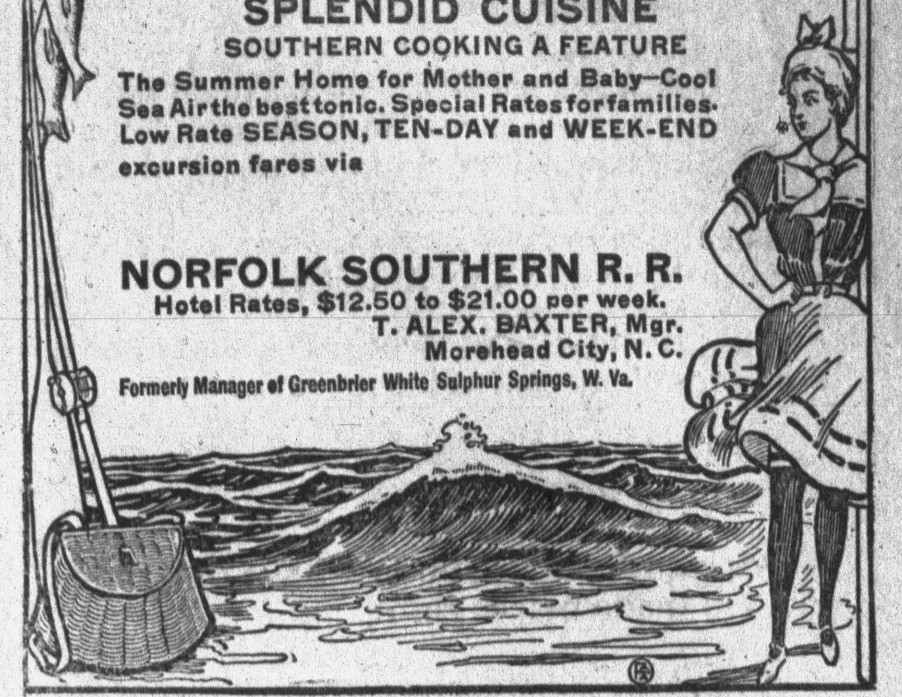

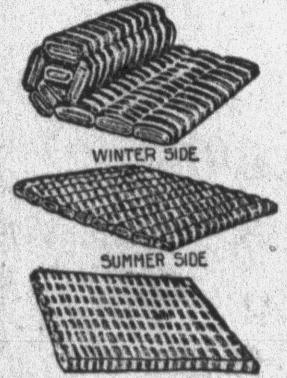

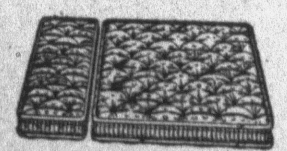

## NORTH CAROLINA HAPPENINGS

News Items Gathered From Our Newspaper Exchanges

### CONDENSED FOR OUR BUSY READERS

Early this morning Mrs. Reuben Combs, a young lady who had been married only a short time, was found dead in the yard at her home in the vicinity of Stony Point, this county. When found Mrs. Combs was dressed in her night clothes. No particulars of the tragedy could be learned, the news reaching Statesville through a message asking for the coroner.—Statesville Landmark.

The four-year-old daughter of Mr. and Mrs. C. F. Pinnix was struck by a delivery wagon of the Columbia Steam Laundry on South Elm street at 3 o'clock this afternoon and badly hurt about the face and head. The accident occurred almost in front of the Grissim drug store and the little girl was carried in there at once and put in the care of physicians.

The mother of the child was also on the street, but at the time the child was hurt it appears that it had left its mother and started to cross the street alone. The mother arrived almost as soon as the little one was borne into the drug store. According to the opinion of the physicians examining the child no bones were broken and, although painful, the hurt is not fatal or very dangerous.—Greensboro Record.

Statesville, May 26.—Sheriff Deaton and Coroner Moose were called to the vicinity of Stony Point, some 12 or 14 miles from Statesville this morning to investigate the death of a young woman, Mrs. Reuben Combs, who was found dead in the yard of her home just before daylight this morning. There is no telephone connection with the vicinity in which the tragedy occurred and details cannot be learned at this time. One report says that the young husband of the woman missed her from the house and on going out to investigate found her lying in the barnyard in her night clothes, dead. It is further reported that on being carried to the light it was found that the young woman had been bruised about the neck and head, and that a heavy stick was lying near her. No definite information is available, however. Deceased was a daughter of Mr. W. H. Beard, who lives four miles from Statesville and she and Combs ran away to South Carolina and were married about two months ago. Shortly after noon news came that the coroner's jury had completed the investigation and finds that the young woman died from natural causes. The husband testified that he missed her from the house at 5 o'clock and on making investigation found her in the barnyard cold in death. She had become ill and left the house without her husband's knowledge.

The crops of North Carolina have been damaged to a great extent and promise to be endangered further by the drought that has prevailed in almost every section of the state, especially in the southeastern portion. Mr. W. W. Holding, a prominent citizen of Wake Forest, who was in the city yesterday, stated that in his section not more than half the cotton was up and that the rest would not get out of the ground until the dry spell was broken by rain. This condition, from the best that can be learned, prevails nearly all over the cotton section of the state.

When seen yesterday afternoon, Col. Benham Cameron, who owns one of the largest farms in the state, situated in the northern part of Durham county, stated that the need of rain in his section was imperative in order to secure a crop any ways near the average. He stated that the small grain, hay, etc., stood in great danger and that it was impossible to set out tobacco plants, except by watering them, which was a slow and unsatisfactory process.

State Horticulturist W. N. Hutt reports that, on account of the prolonged drought the apples and what peaches escaped the late freezes, are dropping off. One man reported having lost 20 per cent of his apple crop in one week. The peaches, he said, were already done for, they having practically all been killed by the late frosts.

The strawberry crop, says Mr. Hutt is cut in two, and from the way it looks now, the season is about over, as far as they are concerned.

According to the statistics at the local weather bureau the rainfall this far in the month is short.

The rainfall of yesterday was welcomed by the farmers in this section.—News and Observer.
