MR. WOOTEN THE NOMINEE

Though Lacking Three Votes of Having a Majority

MR. JAMES WITHDRAWS FROM RACE

The Primary Brought Out Almost the Full Registered Vote—Second Primary Avoided by Withdrawal of Next Highest Candidate—Election Will Be Held June Fifth.

After a warmly contested campaign for the nomination for mayor of Greenville, which had been conducted in the most friendly spirit and without any strife or bitterness, a primary was held Monday. All day long the three candidates and their friends worked hard and the result of their efforts is shown in the very large vote. There was a total of 388 votes cast, which was only about 30 short of the full registered vote of the town. Of the votes cast the three candidates received the following:

W. F. Evans	59

From this it will be seen that Mr. Wooten, the present mayor, fell short only three votes of enough to secure a nomination over the combined number received by both of his competitors. Under the rules governing primaries, that only the two receiving the highest vote can remain in the race in case a second primary is held, Monday's vote eliminated Mr. Evans and left Mr. Wooten and Mr. James to finish the contest.

Mr. James, having decided not to ask for another primary, the nomination goes to Mr. Wooten.

M. Wooten the regular Democratic nominee for mayor of the town of Greenville, to be voted for at the regular election to be held on the first Monday and 5th day of June, 1911.

DECISION ON TOBACCO TRUST

Handed Down by United State Supreme Court

TRUST REMANDED TO LOWER COURT

Given Six Months to Create a Condition in Harmony With The Sherman Anti-Trust Law—Justice Harlan Dissents From Justice.

At six o'clock Monday afternoon, after the paper for that day had been printed and mailed, The Reflector received the following special in regard to the decision of the United States Supreme court relative to the suit of the government against the American Tobacco Company and its accessories:

Washington, May 29.—The Supreme court today ordered the tobacco trust to be remanded to the United States Circuit court, southern district of New York, for dissolution within six months, unless it conforms with the Sherman anti-trust law.

In further explanation of this decision, the following is taken from the morning papers:

The American Tobacco Company and its accessories and subordinate corporations and companies, including the English corporation, today were held by the Supreme court of the United States to be co-operators in a combination illegal under the Sherman anti-trust act. The court sent the case back to the lower court with directions to hear further the parties, so as to ascertain whether a new condition cannot be created in harmony with the law. Justice Harlan, in part with the court's opinion, and dissented in part.

The tobacco trust decision is characterized by Attorney-General Wick-ersham as a most comprehensive and sweeping victory for the government. The trust is held to be a combination in restraint of trade—a monopoly in violation of law.

The decision affects 65 American corporations, 2 English corporations, and 29 individual defendants. An opportunity is given the trust to disintegrate and recreate a condition of transaction of business not repugnant to law.

If, at the end of six months, the corporations fail to bring themselves within the law, a receivership and dissolution by court decree will follow.

The trust is held to have been guilty of intimidation and clearly to have shown a purpose to stifle competition. Chief Justice White announced the decision, which was practically unanimous, although Justice Harlan dissented on several points.

As in the Standard Oil cases Justice Harlan resented the application of the "rule of reason" to the Sherman anti-trust law.

The court having held the defendant corporations guilty of conscious wrong-doing, Justice Harlan "is not at all anxious" to perpetuate any new combination growing out of them.

Trust Will Conform to Decision.

New York, May 30.—The tobacco trust will conform to the Supreme court decision. The officials meet today in their main office, 111 Fifth avenue, to consult with Delancy Nicoll, chief counsel, and line out a plan for rehabilitation before the expiration of the six month's limit.

DR. F. M. MOYE DEAD.

Was One of The State's Most Prominent Masons.

Masons especially throughout North Carolina learn with regret of the death of Mr. F. M. Moye, which occurred Sunday at the home of his nephew, Mr. W. M. Ward, in New Bern.

Dr. Moye was one of the most prominent Masons in the state and has held the highest offices in the gift of that fraternity. Being one of the best informed on Masonic work, he was for years grand lecturer, in which capacity he visited and instructed lodges in all parts of the state.

Dr. Moye was a native of Pitt county, and was born August 7th, 1839. In his Masonic work he often visited Greenville, where he had a host of friends.

FATAL WRECK.

A Score of Persons Reported Killed—Nurses Sent to the Scene.

THE SUPREME COURT ADJOURNS

Wisconsin Adopts Income Tax Amendment.

Washington, May 30.—The United States Supreme court held a ten minutes session this morning and adjourned for the term.

In the house Speaker Clark presented a communication from the legislature of Wisconsin, declaring that the legislature of that state had adopted the tax income amendment. President Taft and Senator Curtis made speeches at the memorial day exercises in Arlington cemetery. The day, which was fittingly observed here, opened with a G. A. R. parade, followed with the decoration of graves.

The department of justice officials declare that the more they study the decision in the tobacco trust case, the better pleased they are with it. The point most liked is the possibility of a receivership.

MAN KILLED BY 9-YEAR-OLD SON

Silas Cameron, of Granville County, the Victim

DONE IN DEFENCE OF HIS MOTHER

The Man Was Maltreating His Wife When The Boy Secured a Shotgun And Killed Him Instantly—Sheriff And Coroner Gone To Investigate.

News reached the city this morning of the murder Sunday night of Silas Cameron, a well-known farmer of Granville county, by his 9-year-old son.

According to the reports brought here today by visitors from Granville the murdered man was maltreating his wife Sunday night about 10 o'clock. The young son took the part of his mother and securing a shotgun fired at his father. The whole load took effect and he died almost instantly.

The home of the murdered man was in the extreme northern part of the county in the vicinity of Bullocks.

Sheriff Wheeler and Coroner Bryan left Oxford this morning for the scene of the crime, but a report of the result of their investigation has not been received here. It is thought that the young murderer will be arrested and held for trial.—Durham Sun.

STILL UNDER DEBRIS.

Bodies of Engineer Lindsey and Fireman Dooley Not Yet Recovered.

Ellenboro, May 29.—Two wrecking crews are still at work removing the debris from yesterday's wreck in an effort to recover the bodies of Engineer J. M. Lindsay and Fireman Roy Dooley, which are pinioned beneath 17 coal cars and two engines in Puzzle creek, near here.

The cause of the accident will perhaps never be known and the only eye witness to the tragedy that cost the life of three men—two white engineers and a negro fireman—were some boys standing nearby when the train plunged into the burning trestle and fell to the water below.

Engineer R. M. Green, who was dug from his burning cab in 30 minutes after the wreck, had his body badly mutilated and probably his neck broken. Early Lewis, his negro fireman, and Lon Nealy, a negro brakeman, are in a hospital recovering. Physicians say Nealy's back is not broken and he will recover.

The trestle was not burning when the engine went through, but the heavy weight of the train caused the collapse. The wreckage caught fire but was extinguished in a few minutes.

ESCAPED FROM HOSPITAL.

William Brown, a Negro Shot by Officer Tindall Got Away.

William Brown, the negro who was shot several days ago, by Deputy Sheriff Louis Tindall while resisting arrest, made his escape Saturday night from the James Walker Memorial hospital. At last accounts he had not been recaptured. To judge from the negro's successful get away he must have been possessed of guilty conscience and felt that he would fare badly in court investigation of his illegal attempts to get away from Officer Tindall. The exact hour of Brown's departure from the Walker hospital is not known. It is stated that he succeeded in getting out of the ward by climbing over a transom. The police department was notified Saturday night that Brown had gotten away and officers have been on the lookout for the man since that time.

It will be remembered that Brown was arrested by Officer Tindall in the northern section of the city and that the negro made desperate efforts to strike the officer with handcuffs. The deputy was finally compelled to shoot the negro in self defense, the bullet lodging in Brown's side.—Wilmington Dispatch.

WILL THE PARCELS POST BANKRUPT THE COUNTRY MERCHANT? Some are being made to believe that it will. We have never been able ourselves to figure out how it would injure them the least little bit. All this talk about the big mail-order houses fails to impress us for the simple reason that the country merchant can use the post office just the same as the farmer or the mail-order man, and so long as he keeps what the farmers want and sells at a reasonable price they are going to buy of him rather than of the man in a distant city. Stronger evidence is still to be found in the fact that the small merchants have not been injured in other countries by this same parcels post. It hasn't turned the trade of Great Britain or France or Australia over to a few big mail-order houses, and we do not believe any such results will follow its adoption in America. In any case, should this country be deprived of a convenience enjoyed by every other civilized nation just because it might injure the business of a few thousand retail merchants? It seems to us that the millions of farmers are also entitled to consideration.—Raleigh Progressive Farmer.

For American Ambassadors.

National dignity and self-respect require that proper provision be made for our representatives abroad, so that they might live in accordance with the standard already set up by the representatives of other nations, and that a poor man might follow a rich man, or the reverse, without occasioning any diverse comment. This reform has now been accomplished by the passage of the Lowden bill, which will, in time, result in our government owning a residence in every country to which it sends ambassadors, one that will compare favorably with those of other nations, one to which American citizens can point with pride, and to which they may go feeling that they have citizen's rights therein.—American Review of Reviews.

That's a good story a Greensboro man brought back with him from a visit to Kentucky recently. While in Hopkinsville, that State, he met a somewhat aged man named Markham, a brick layer. 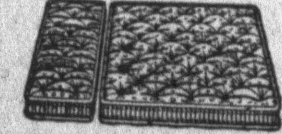
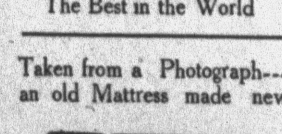
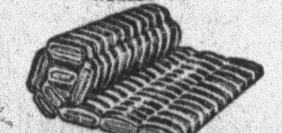

NORTH CAROLINA HAPPENINGS

News Items Gathered From Our Newspaper Exchanges

CONDENSED FOR OUR BUSY READERS

A telegram received here today announces the death of Mr. T. C. Pearson Sunday while en route from Texas to Durham, the death occurring on the train. Mr. Pearson is well remembered here where he was formerly engaged in business. He was a member of the firm of Sneed-Markham-Pearson company and was one of the most popular men in the city. He left Durham several years ago for Texas, where he hoped to improve his health. Realizing that the end was near, he started for home last week, desiring to be in the city when the last hour arrived. In this he was disappointed. Death overtook him on the way and only the remains will reach the city for their last resting place.—Durham Sun.

Ellenboro, May 20.—Pinned beneath their engines in Watkins creek, on which are piled 17 cars of coal, are the bodies of Engineers Lindsay and Greene, and Fireman Dooley. Two others are perhaps fatally injured as a result of a double-header Seaboard Air Line coal train going through a wooden trestle three miles west of Ellenboro, and about two miles east of Bostic at 5:15 yesterday afternoon.

On arising this morning, Rev. C. G. Lowe, the pastor of the Baptist church, found that his clothing had been disturbed on the chair on which he had placed them upon retiring, and upon investigating further he found that his trousers had been swiped out along with about twelve dollars in money that was contained in the pockets. Lowe has reason to regret exceedingly his loss, he is still grateful that he had taken his watch from his pocket and placed the same under his head, and he declares that this act on last night was an exception, for which he is grateful today.

Bingham found an egg laid by one of his hens that measured around from end to end 8 inches and its circumference measured 6 5-8 inches, and the egg weighed 3 5-8 ounces. For this information we are indebted to Mr. J. H. Rogers, who claims he saw the egg, therefore bears testimony to the above statement.—Waynesville Courier.

ANGER AND FEAR DESTROY MIND

There is Only one Perfect Antidote for These two Destroyers.

Science is sounding a warning which is quite in keeping with Paul's exhortation to "put off all these: anger, wrath, malice," and his statement that "fear hath torment." Dr. George Crile, professor of Clinical Surgery at the Western Reserve University, described before the American Philosophical Society the other day the effect of fear and anger on the brain. He showed that the mind is greatly impaired and the brain cells disintegrated through fear or anger. Dr. Crile presented also his theory for a remedy: He said:

"It has occurred to me to utilize as an antidote for fear and worry an appeal to the same great law to which the origin of fear is due, namely, the law of self preservation. I have found that if an intelligent patient suffering from fear is made to see, so plainly as to amount to firm conviction, that his brain, and, indeed, his whole being, was physically damaged by fear, this same instinct of self-preservation will, in proportion to his conviction, banish worry and fear. It is hurling a threatened active, militant danger, whose ravages are both certain and known, against an uncertain, perhaps a fancied one. In other words, fear itself is an injury which, when recognized, is instinctively avoided. In a precisely similar manner anger may be softened or banished by an appeal to the stronger instinct of fear or physical damage, such as the physical injury of brain cells. This play of one primitive instinct against another is to be compared with the effect upon two men quarreling, when a more powerful enemy of both comes threateningly on the scene."—Christian Herald.

HAS NO MORALS.

What Governor Woodrow Wilson In A Speech Says.

"The trouble with the corporation is that it is an invention. It is not a moral unit, as person is. A person has a definite, calculable character. His neighbors and associates, at any rate, know what kind of a man he is. They know the motives that govern him, and the influences that will control him. They know how he can be restrained by opinion and punished by law. But a corporation escapes these measures and restraints. It is not anybody in particular. Its very actions are often, if you look into them, just a series of moral compromises, made up of as much of the varied judgments of different people as can be put together in one determination or action. Therefore, the ancient complaint that a corporation has no body to be kicked or soul to be damned.

"Neither is the corporation a social unit. Those who hold its stock are generally scattered through a score of communities, and those who manage it are often, likewise, residents of different parts of the country, affected by different bodies of opinion, governed by different motives and environments. And so it is hard to bring to bear upon a corporation the judgment of any community, or of any state, even. It is a device for combining a very large variety of persons, and often a large variety of interests, over the space of many varied sections of the country."

Don't Neglect the Manure.

Too many farmers lose sight of the fact that, commercial fertilizers should supplement and not entirely replace the farm manures. It has been the general experience of successful farmers that the best way to utilize farm manure is in combination with commercial fertilizers. Kalnit and acid phosphate may be employed as preservatives, and at the same time improve the fertilizer value of the manure, since all farm manures are comparatively poor in these two elements. This does not imply that the two kinds of fertilizers should necessarily be composted or applied at the same time. It may be desirable to apply the manure at intervals of several years, while the fertilizers might be applied annually.

Its lasting or cumulative effect on soils gives to farm manure one of its greatest values. Probably no other fertilizer possesses, to so great a degree, the power of restoring worn soils to productiveness and giving them lasting fertility.

This results not so much from the actual fertilizing constituents supplied, as by improving the mechanical condition of the soil, improving its texture and increasing its water-absorbing and water-holding power. Experiments in both England and in this country have shown that the influence of manure may be perceptible from 5 to 20 years after application.—Progressive Farmer.
