SUPERINTENDENT COUCH REPLIES TO "H"

SAYS WATER PUREST IN STATE.

Tide Does Not Force Water Back, but Arrests Downward Flow.

Greenville, N. C., July 13, 1911.
Editor Reflector:

We notice the article signed "H." in yesterday's paper, relative to sewerage contamination of the city water supply. We do not as a rule reply to articles that are based on wild conjectures or surmises, but in order that there may be no groundless fear in the minds of the public, we wish to call attention to the obvious facts in the case.

Greenville's water works have been installed about seven years and the sewer system about four years. During that time there has been no epidemic of fever or other disease that could possibly be attributed to the use of city water, nor have there been any isolated cases that could be so attributed. Any one of intelligence knows that if our water supply had ever been contaminated with sewerage, the disease and deaths resulting would have been fearful.

Our water is analyzed every month by the state laboratory of hygiene whose sole purpose is to detect and report any condition that would render the water unhealthful or unwholesome. The writer has been superintendent of this plant for over two and a half years and in only two instances during that time has there been any sign of harmful bacteria in the water, and then not in quantities that would indicate any sewerage contamination whatever.

The effect of tide this far up the river is not to force water back, but to arrest the downward flow until the tide goes out. The question of the effect of the tide has been raised before yesterday's article came out, and the Water and Light Commission have already taken steps to get authoritative data on this point, through the U. S. government and the State Board of Health, not that there is any reason to believe that there is any back flow, because the water analysis would show it, but in order to allay the fears of the public. If the investigation should reveal that there is any improper condition, it will be immediately remedied.

Relative to swimming above the intake, we simply try to enforce a state law to which we are duty bound. We do know that the water above us comes down, but we have no reason to believe that the water down stream comes up.

An investigation will show that our city water is one of the purest and best in the state or any where else, and to rush into print with any such unfounded surmise or speculation as in yesterday's article, serves no useful purpose and might do infinite harm.

DR. WILEY MAY LOSE HIS JOB.

Mrs. Lee in Hiding—Senatorial Fight in Mississippi.

Washington, July 13.—Senator LaFollette today introduced a cotton and wool amendment to the reciprocity bill now before the senate. Testimony before the Hardwick committee now investigating the sugar trust showed that the railroads have discriminated in favor of the trust in lighter charges.

Dr. Wiley may lose his job as he has allowed Dr. H. H. Rusby to collect illegal fees from the government amounting to twenty dollars per day as an expert pharmacist. President Taft is having this matter investigated.

Miss Kelsey, who married Edward Valentine Lee, the navy paymaster's clerk, who defaulted to the amount of forty-six thousand dollars from the battleship Georgia, is in hiding at Colonial Beach, Virginia. She tries to escape interviewers.

A hot fight for senator from Mississippi is now in progress. Governor Vardaman expects to succeed Senator Percy.

Washington, July 13.—Senator LaFollette scathingly arraigned President Taft in a speech today on the Canadian reciprocity bill. He declared Taft has not kept his pre-election pledges and denounced practically all acts of the president's administration. He said Taft and the Republican party are recreant to tariff reform pledges.

Washington—The government paid to "special" assistant prosecutors \$1,161,483 from 1900 to 1911 in addition to \$2,345,035 in salaries to the same period, according to a report furnished the house committee on expenditures in the department of justice.

Fire Horror Grows.

The twin infants of Mr. and Mrs. Hurley Griffin died yesterday afternoon at their home on West Depot street, their death occurring only a few minutes apart.—Concord Tribune

Mr. J. J. Moody, who has been a good gardener for fifty years, says that the present is the worst time he has ever seen on gardens with the exception of one year, probably 1881.

Robinsonville, July 12.—Gwyn, the 6-year-old son of Mr. A. F. Ghorhely, a prominent merchant and hotel man of this place, was kicked in the head by a horse here and instantly killed.

The final vote on the special tax for those outside of Kinston, but in the district designated by the legislature, to come into the Kinston graded school district was 54 for to 1 against. The total registered vote was 71.—Kinston Free Press.

Twenty cases of typhoid fever may not be a great deal but it is said there are more than twenty cases in Hillsboro, and the people are accusing Eno river as being responsible for it. Bad on Eno, and worse on Hillsboro.—Mebane Leader.

The stockholders of the Vance Cotton Mills met Friday at the mill and declared a semi-annual dividend of 3 per cent on the entire stock of the mill. The stock of the mill was increased some time ago from \$100,000 to \$130,000 and the dividend was declared on the latter amount as stated.—Salisbury Post.

Washington, D. C., July 12.—Ensign R. S. Young, Jr., of Concord N. C., disappeared from the destroyer Perkins at the New York navy yard last night, leaving a note stating that he intended to drown himself. The young officer had slightly overstayed his shore leave and had been called upon for an explanation.

Charlotte, July 12.—While standing in the rear doorway of his residence near the Chadwick Mill during a terrific electrical storm, Mr. Thomas J. Capps was struck by lightning and instantly killed. His hand was above his head, resting on the frame of the door, when the fatal bolt leaped from out the overhanging cloud, struck the chimney of the house and flashed down the door frame shattering it to fragments.

Asheville.—Pearson Davis, the 14-year-old son of Alfred Davis, who lives near Beech, was seriously injured Friday afternoon about 2 o'clock by being thrown from a mule. His lower jaw bone was broken, the muscle of his face badly torn and nearly all the teeth in his upper jaw knocked out or loosened. The boy was riding the mule and when opposite a pile of stones, the mule became frightened at something and threw him, his face striking the stones.

A young negro boy about 17 years old, named Sylvester Bryant, was drowned this afternoon at 2 o'clock near Union Point. The young boy had been in the employ of the firm of E. H. and J. A. Meadows for a number of years and today when he was drowned he was running a gasoline boat of Mr. Thomas Williams, towing a vessel in port. The tow line post on the gasoline boat on which the boy was sitting pulled out, knocking him overboard and he sank to the bottom before aid could reach him.—New Bern Journal.

Elizabeth City, July 12.—This city and section was visited by one of the most terrific storms ever known here this afternoon. While no reports of damage to vessels out, in the sound have yet reached here, watermen are expecting reports of much costly damage and perhaps some fatalities. The wind blew at a terrific pace and trees and telegraph poles throughout the city went down. The large smoke-stack at the plant of the Dare Lumber Company was blown down and other damage done. This city is in darkness tonight, electric lights being put out of commission.

STORE BROKEN OPEN AND ROBBED

J. SHEHDAN AND BRO. VICTIMS.

Amount Taken Not Known—Blood Hounds Sent For.

Sometime during Wednesday night the store of Jos. Shehdan and Bro. near the Atlantic Coast Line depot was entered by an unknown party and some of their goods was taken, the exact amount of which cannot be learned at the time this is being written, because the store is closed waiting for the bloodhounds to be brought from Tarboro to trail the thief.

Entrance to the store was made through the front door by breaking a glass and unlocking it from inside. A back window was found open and it is thought the escape was made from there.

This is the second time someone has entered Jos. Shehdan and Bros. store, the first robbery occurring soon after they opened here about eighteen months ago.

Early this morning Policeman G. A. Clark got on the trail of a negro, whose actions led Mr. Clark to follow him up. About 9 o'clock he was located in the neighborhood of the negro graded school, but escaped to the woods of the branch between Mr. R. A. Tyson and the Anderson place, where he was located about two p. m. Sheriff Dudley and several others were now with Mr. Clark. Being cornered in the swamp, the negro, who proved to be Andrew Wilkins, was soon caught. With him were some of the goods which have been identified as some taken from Mr. Shehdan's store.

Sometime during the day while they were after the negro a pistol was fired by someone unknown and when the negro was captured, it was found that a ball was in his left thigh. He was taken to Dr. Skinner's office who looked after his wound, but failed to locate the ball. Later he will be given a hearing on the charge of robbery.

In this case, Mr. Clark did more than his duty. Of course, he succeeded. While to him is due so much credit, others also did their duty, but he was there from start to last. That's Mr. Clark.

Pony For Ayden.

The express office in this city was called upon Tuesday to "entertain" practically all day, a gentle (?) banker pony, shipped by express from Beaufort to Ayden. The pony was crated and gave the officials of the express company here all the fun they were looking for. All day was the express messenger kept busy repairing the damages done to the crate by the gently kicking and protesting pony. Fire in Halifax.

Halifax, N. C., July 12.—On Saturday night about 11:30 o'clock, the residence of Mr. Chas. E. Hargrave, who resides two miles south of town, was destroyed by fire with about half its contents. The family had retired for the night about ten o'clock, and were awakened by hearing a roaring sound very near them, and upon investigation found that the sound was issuing from the closet, the flames having burned through the other room and were reaching out for everything in sight, the house being all timber. The house, with the other things lost, will amount to nearly \$2,000, with no insurance. Mr. Hargrave states that he is very positive that the building was set on fire by rats, as there had been no fire in the house during the day.

100-Story Sky Scrapper.

Mortimer, of New York, said that plans for a 100-story building, 1,200 feet high, have been drawn and that such a structure is a probability of the near future in New York.

Governor Asks Prayer For Rain.

Richmond, July 12.—Governor Mann issued a proclamation Tuesday calling upon the people of the state to pray for rain. Within an hour of the time the document left his hand refreshing showers fell upon the capital, at least reducing the temperature 20 degrees from the maximum, which was 97, in about twenty minutes.

Last Sunday evening over three hundred chairs had been placed but these were soon filled and as the crowds continued to come one hundred and fifty more chairs were brought out. Because a girl who had typhoid fever three years ago was allowed to wash milk cans on her father's farm there is an epidemic of the fever in Englewood, a Chicago suburb. The case was discovered by the health department. Thirty-four persons taking milk from the girl's father are ill. She is what is known as a "carrier" of germs.

Now Is The Time To Get Busy.

The danger to health from the house fly has been studied by scientists, has been exploited by physicians, has been discussed by entomologists, has been acted upon by boards of health in our cities, has been considered by all kinds of organizations and societies, but little of this agitation has found its way into the country districts. The fly problem is one which the farm man and farm housewife must of necessity work out together. I know a man who made screens for his house last season—two doors and four windows, complete, well made, well hung—at a cost of \$1.25. His near-by neighbor, in an unscreened house, had a case of typhoid fever in the home which cost the family \$300, not to mention the suffering, anxiety, and fatigue which a long, serious illness means to the entire family.

Because the fly has been found to be an important factor in the spread of typhoid fever, it has been fittingly termed the "typhoid fly." It might be called the "tuberculosis fly," or "diphtheria fly" because it picks up these germs and carries them into our homes. There is an enormous increase in the death rate of children from diarrheal diseases during the summer months. The fly is a responsible for it. A single fly speck may contain 3,000 germs. Have we thought seriously of the expense of disease and drudgery to a family, to a community? How often have we in blindness regarded an epidemic of disease in our families in the community as a cruel manifestation of providence when the means of control lay easily within our power.—Mrs. F. L. Stevens, in Progressive Farmer.

Saving the Children's Money.

The long-down-out litigation over the question of the payment by ex-Clerk of Superior Court Nelson of monies due the school fund has been adjusted satisfactory to all parties. The board had formerly collected without having to bring suit the sum of \$3,000 from Mr. Nelson. That was three years ago. But the board claimed \$4,000 more, which Mr. Nelson's attorney advised him not to pay. Acting attorney for the board, David Stern, brought suit for the amount and the matter has been hung up in court ever since. Finally a compromise was arranged, and at the last meeting of the board it was definitely settled that Mr. Nelson is to pay the sum of \$3,000 and the case goes off the docket.

This \$6,000 added to possibly \$2,000 collected from ex-Clerk Clapp foots up the net sum of \$8,000 that the board of education by firm, kind but steady insistence on the right of the school children of the county, has rescued from two powerful and strongly-entrenched officials.—Greensboro Record.

Now, Boys, Be Careful.

Because a youth whom she loved had ceased paying her attentions, Sarah Wimmer, twenty, daughter of Mr. and Mrs. William Wimmer, of Babylon, L. I., committed suicide at noon yesterday by throwing herself in front of an express train of the Long Island Railroad. She was instantly killed.

Cigars for Kings Cost \$2 Apiece.

The fact that Cuba has sent King George a coronation gift in the shape of 10,000 of the finest Cuban cigars, valued at about \$4,000 (\$20,000), which works out \$4 (\$1.92) a smoke, reminds one that the late King Edward was a connoisseur of cigars. Shortly before his death His Majesty placed an order with a New York firm of tobacco brokers for 500 cigars, which cost no less than \$400 (2,000). Frequently King Edward paid \$750 (\$3,750) for a thousand cigars, and the margin of profit, even at that unprecedented price, was exceedingly small, says London Tit-Bits.

As a matter of fact, the cigars took three months to make, each leaf passing through the hands of two "selectors," and it required the examination of thousands of leaves to obtain those that were uniform in color and size, and free from veins. When the cigars were finished—the workmen received 3s 6d (84 cents) for each cigar. They were 8 inches in length and, at the thickest part, one inch in diameter.

The German Emperor does not like cigars so much as enormous cigarettes, which are made specially for him. The Emperor of Russia, too, smokes cigarettes with carboid mouthpieces, in preference to anything else. King Alfonso, of Spain, never smokes cigars, but is a keen and constant cigarette smoker. The Khedive of Egypt also smokes numerous cigarettes, while Pope Pius X is the first pope known to smoke a cigar, or, indeed, to make use of tobacco in any form.

A Parisian tobacconist a short time ago, being summoned for not possessing a certificate establishing his right to call himself a purveyor of cigarettes to Her Majesty Queen Margherita, of Italy, proved that he regularly supplied Her Majesty with cigarettes. He also declared that the empress of Russia is a devotee of smoking, and frequently receives consignments of perfumed cigarettes from London. The queen of Roumania, too, he said, is also a great smoker, while the queen-mother of Spain and the exiled queen-mother of Portugal are confirmed victims to the habit.—Cincinnati, O., Tobacco Journal.

HAYTI'S NAVY.

The Sea Fighting Force Hit Coral Reef.

At last accounts Hayti's new navy, just purchased from Italy, was hard aground and abandoned. The news was brought here yesterday by the steamship Allemania, of the Hamburg-American line, arriving from West Indian ports.

The navy of the black republic consists of the cruiser Umbria, renamed the Antoine Simon. According to the officers of the Allemania, it had set out from Port-au-Prince carrying the president, his staff and a large number of followers. It was a gala occasion and all that was needed to make it a gorgeous success was competent crew.

The vessel cleared the harbor before breaking down. Then she proceeded to drift. A tender which was following was summoned to take off the president, and it came alongside in such a fashion as to leave all of the headgear trailing in a wreck overboard. The president and his staff made a more or less dignified transfer to the half wrecked tender. Immediately afterward the naval hope of Hayti was bestriding a coral reef off Gonaves.

The Allemania took off the stranded warriors and landed them at Cape Haytien.—New York World.

The Giving of Presents.

The Statesville Landmark copies what the Chatelaine had to say in The Chronicle in the matter of the Taft silver wedding, in contrast with some events of a similar kind held by old-time gentle-born Southern folk. In those days it was the custom to give the departing guests silver souvenirs. No presents were received or expected. The custom is now just the reverse. In its usual intelligent way, the Landmark comments; "The President and Mrs. Taft missed a splendid opportunity to set an example that needs to be set—and that is to stop the discriminate giving of presents at weddings, anniversary celebrations and the like. When one is invited to these affairs he feels compelled to give a present and often it is given grudgingly, complainingly could hear what is said, could know the thoughts and feelings of many of those who send presents, they would not be happy in receiving them. But it is a custom that goes on. The President and Mrs. Taft did not need what was given them. They had plenty of silverware. But the numerous government officials members of congress and others invited to the silver wedding felt that a present was compulsory. Many of them complained and gave grudgingly; some who gave doubtless could ill afford it. What a splendid example it would have been had the President and Mrs. Taft barred all presents at the celebration. Then their friends who wished to give them a remembrance as a token of regard could have sent it afterward. If some one will establish the custom of cutting out presents on such occasions so that there will be no display and those who do not want to give need not, a great and needed reform will have been inaugurated."

Very true, but the Chatelaine and The Landmark and the Chronicle are never going to live to see a return to the well-bred customs of the old South. In these days, many wooden, tin, silver golden and all sorts of anniversaries are held generally for the presents that are expected, and that is the plain unvarnished truth.—Charlotte Chronicle.

Look For The Comet.

Baltimore, July 12.—The new comet reported from Kiel, Germany, discovered July 6, was seen at three o'clock Monday morning by Dr. John R. Hooper, chairman of the astronomical section of the Maryland Academy of Science. The observation was made from his home on Linden avenue.

Dr. Hooper said the comet appeared in the constellation of Auriga, in right ascension 4 hours 46 minutes, north declination 34 degrees. It is an unusually bright telescopic object and can be seen with a 2-inch glass.

A Shirt Sleeves Preacher.
Norfolk, Va., July 12.—G. W. Cox, pastor of Burrow's Memorial Baptist church here, preached in his shirt sleeves Sunday night to a countless congregation. The heat was intense with the congregation suffering from its severity, when the preacher relieved the situation by suggesting that the male members of the congregation remove their coats, while he preached in his shirt sleeves. The men removed their coats while the women all took off their hats. The Baptist Ministers' Conference today congratulated Rev. Mr. Cox upon his bravery.

Ordinance Notice.
"Section 1. Every occupant of a lot on any street shall keep the sidewalk clean and clear of weeds, grass and other rank vegetation as far as such lot extends. If, after written notice by the chief of police, or street commissioners, requiring him to remove the things prohibited by this ordinance, he shall fail for twenty-four hours to remove the same, he shall be fined five dollars for each day thereafter it may so remain."

Always Something Else.
Washington, July 12.—The United States government is the owner of the most powerful quick firing long range aerial gun in the world, and one which it is declared will prevent the swiftest and most highly perfected aeroplane or dirigible balloon from getting near enough to New York to even make observations. No hostile aerial fleet could get within twelve miles of New York without becoming a perfect target and being sent to the earth in bits, so it is asserted.

Finds Tree Under The Ground.
While digging a well on his farm, two miles east of Sullivan, Ind., John Alzman found an old hickory tree, 25 feet under ground. One of the limbs had been chopped in two with some kind of a blunt instrument, and under the limbs was a peck of hickory nuts. The chopping is believed to have been done by prehistoric men. Alzman had dug through hard pan, yellow clay and shale before he reached the tree. The limb of the tree which had been chopped will be sent to the state museum at Indianapolis.

Sentenced to Whip Each Other.
Petersburg, Va., July 12.—Because they went swimming Sunday in forbidden waters, a half dozen negro boys faced Justice Dunstan, of Ettick next morning and were handed one of the oddest sentences that court has ever given. Justice Dunstan ordered that the boys be whipped and that each boy whip another. The switches went the rounds, and it is stated that the sentence of the court was properly carried out.

The "road improvement train" of the Southern Railway company, which is touring the South in the interest of good roads in conjunction with the United States department of good roads arrived in Asheville Wednesday from Marshall, gave a stereopticon lecture on good roads and made an exhibition of the train used by those making the tour. This work is being done by the Southern free of charge and only in the interest of a good system of roads throughout the South.—Asheville Citizen.

The rest of the defenders stood some on one side of the road, some on the other, ready to discharge their rifles into what might be the left of the assailants.
