OUR WEEKLY LETTER FROM THE CAPITAL

SOME VITAL WASHINGTON NEWS.

Matters That Give The Falsehood to Republican Principles.

(By Clyde H. Tavenner.)

WASHINGTON, Aug. 14.—Are the American people competent to rule? And if they are competent, have they the right under the constitution to do so?

Here are two vital questions directly involved in a veto by President Taft of the Flood resolution granting statehood to Arizona and New Mexico—territories which have these many years been eligible to admission as states, but which have been barred out, first, because certain big interests in the territories desired it, and second, because the Republicans feared Arizona would send Democratic senators to congress.

The impression that the White House press bureau (Secretary Hiles, manager), would have gone out to the country is that the veto was made necessary by the Flood resolution which established the recall. This is erroneous. The fact is, both branches of congress were careful not to go on record either for or against the recall. The resolution simply gives the people or Arizona the right of local self government; the right to vote on the question of recall, and to themselves determine whether they desire the recall.

So the president is not vetoing the recall of judges when he vetoes statehood. What he really is vetoing is the right of the people or Arizona to decide for themselves the form of Republican government under which they wish to live. "You folks in Arizona are not intelligent enough to select the form of government under which you are to live," is the ultimatum the president lays down by vetoing the statehood resolution. Mr. Taft would have his will prevail instead of the will of two-thirds of the people of Arizona.

A White House Influence.

In the haze of scandal that hangs over the Taft administration, the form of Charles P. Taft, capitalist, busy multiplying his dollars, is plainly discernible. As the curtain is lifted on each succeeding scene of scandal the president is in evidence, and around him, shaping his course, are men who know exactly what they want; men who are the acknowledged agents of the forces that are trying to shape humanity to the dollar.

When he was elected he inspired many who are known as progressives with the belief that he had made his choice between public and private interests. Perhaps he had. But always before his mental vision he must naturally see his brother and his brother's wealth. From his nativity, wealth and its emblems have been the be-all and end-all of this son of plutocracy. Yet he has a good heart. His great handicap is that he has these men who know what they want around him—men to whom the public good is the last consideration.

Therefore it would seem that it matters little what large schemes are planned or prophesied, so long as Mr. Taft sits in the executive chair. The president has as little chance to succeed as the executive of the nation, as a man in any other walk of life might have if he tried to serve two masters.

Canadians Are Wary.

The Republican argument that a high tariff is necessary to maintain "the high American wage" is shown up as a farce, by the presence in several American manufacturing communities of agents of Canadian manufacturers, who are gathering figures to show that Canada cannot compete against American wages.

The Canadians, for instance, are learning that men work in the steel mills twelve hours a day, and seven days a week for a dollar and a half a day. It is because they do not wish to compete against the cheap foreign immigrant labor employed by the steel and other trusts that some of the Canadians are urging the defeat of reciprocity.

And yet, the Republican protectionists have argued all these years that the great danger of American labor was the possibility that it might have to compete with cheap labor of other countries. The information gathered by the Canadians knocks the logs from under that ancient contention,

Busy Week for Edmonton.

EDMONTON, Alta., August 14.—One of the busiest weeks of the summer for this city began today, when the provincial annual meeting of the Alberta Medical Association was opened this morning with a large number of leading physicians from Alberta and other provinces in attendance. The convention, which will be addressed by several distinguished members of the medical profession, is scheduled to remain in session until Wednesday, the opening day of the Edmonton fair, which will fill the rest of the week, ending with a grand fete on Saturday.

Grenfell Cup Polo Tourney.

MONTREAL, Aug. 14.—The eyes of the polo world are to be turned this week toward Montreal, where the contest for the Grenfell Challenge Cup, presented by the Messrs. Grenfell, members of the English polo team which visited America last year, and intended to represent the polo championship of Canada, is to take place. Several teams from the United States, in addition to the Montreal, Toronto, and other Canadian teams are to take part in the competitions.

Oregon Development League.

ASTORIA, Ore., Aug. 14.—A large and representative attendance marked the opening here today of the annual convention of the Oregon Development League, an organization of the commercial and industrial clubs of the State. The convention will last three days. The opening session, which was presided over by President Theodore B. Wilcox, was devoted to the exchange of greetings and the work of organization.

London Has Radium Institute.

LONDON, Aug. 14.—The new Radium Institute, in the establishment of which King Edward VII. took an active interest during the latter years of his life, was formally opened today for the treatment of patients. The institute is conveniently located in Riding House street, near Portland place. It is to be conducted on the lines of the Radium Institute in Paris, and both curative and research work will be carried on.

National Road Building To Be Democratic Policy.

Speaker Clark plans to make good roads an issue of the next campaign. As a member of the Lincoln Memorial commission Mr. Clark is advocating the building of a great highway from Washington to Gettysburg, "as the nucleus of a great system of national roads built by the government in co-operation with the states." The majority of the commission favors a marble arch in Washington, which the speaker says would form a fine meeting place for English sparrows, but which would not fit in with the practical character of the great Lincoln. The speaker has induced the president to defer action until legislation can be passed permitting the building of the road. He will then work for the adoption by the government of a national road building policy.

Wickersham An Issue.

That Attorney General Wickersham will become a campaign issue by 1912 is regarded as certain by those who are looking ahead. Wickersham has permitted Taft to be besmirched in the Pinchot and other matters. Wickersham was on the side of Ballinger against Pinchot just as he is at present against Dr. Wiley. Developments in the steel trust investigation furnished fresh evidence that Wickersham exemplifies the alliance between the Republican party and monopolists. In the opinion of many the sequence of all this will be that Taft will get many a whack over Wickersham's shoulder.

Competition or Trusts? Which!

When the Sherman anti-trust law was passed legislation was directed toward the prohibition or destruction of monopolies. Roosevelt, Taft and Wickersham have not the idea of trust dissolution. They advocate instead that the existence of the trusts be recognized and legalized, but that their greed be curbed by government regulation. It remains to be seen whether the people are ready to confess that the competitive system is obsolete; to abandon a system which affords free reign for individual enterprise, and to establish in its place a centralized government with the business of the whole country in its hands.

COTTON GOODS OF N. C.

The Census Bureau's Tentative summary For 1910.

WASHINGTON, D. C., August 14.—A preliminary statement of the general results of the thirteenth United States census of manufacturers of cotton goods, including cotton small wares, of North Carolina, was issued today by Census Director Durand. It contains a summary comparing the figures for 1904 and 1909 by totals, prepared under the direction of William M. Steuart, chief statistician for manufacturers, bureau of the census. The figures are subject to such revision as may be necessary after a further examination of the original report.

The summary shows percentages of increase as follows: 69 per cent. in the capital and in the value added by manufacture; 62 per cent. in the salaries and wages; 54 per cent. in the value of products; 47 per cent. in the cost of materials used; 39 per cent. in the number of salaried officials and clerks; 32 per cent. in the number of establishments; 30 per cent. in the average number of wage earners employed; and 23 per cent. in the miscellaneous expenses.

There were 281 establishments in 1909, as compared with 212 in 1904, an increase of 69, or 32 per cent.

The value of product in 1909 was \$72,680,000 and \$47,254,000 in 1904, an increase of \$25,426,000 or 54 per cent. The average per establishment was approximately \$259,000 in 1909 and about \$223,000 in 1904.

The value of product represents their selling value or price at the plants as actually turned out by the factories during the census year, and does not necessarily have any relation to the amount of sales for that year. The value under this head also include the amount received for work done on materials furnished by others.

FUN BEGINS AT CAMP PERRY.

The Opening Volleys were Fired Today.

CAMP PERRY, O., Aug. 14.—On the famous Ohio Rifle Range, on the southern shore of Lake Erie, the opening volleys were fired today in the three weeks of rifle battling—the annual tournament of the National Rifle Association and the annual matches of the National Board for the promotion of rifle practice. The competitions have brought together the picket rifle and revolver shots from all arms of the United States service (the army, the navy, and the marine corps) and from the national guards of the states and territories and the District of Columbia. The tournament was inaugurated today with an entirely new feature, the enlisted men's team match, a contest at 600 and 1000 yards for teams of six from the United States infantry, cavalry, navy and marine corps, and from the national guard.

Rich Lands in a Lottery.

BISMARCK, N. D., Aug. 14.—Books were opened today for the registration of prospective settlers on the fertile lands of the Fort Berthold Indian Reservation, which the government has decided to throw open to actual settlers. The reservation which is only twenty miles from the Great Northern Railway, contains 242,000 acres, well watered by a number of rivers. The drawing, to determine the order of precedence among those registered in selecting the most desirable tracts will take place in a few weeks.

Primaries in Nebraska.

LINCOLN, Neb., Aug. 14.—According to the provisions of the state primary law all parties in Nebraska will hold their primaries tomorrow. Nominations are to be made for supreme judge, regent of the State university and railroad commissioner. The Republicans, Democrats, Populist and Socialist have tickets in the field. In most cases the Democrats have endorsed the same candidates.

Wisconsin Postmasters Meet.

GREEN BAY, Wis., Aug. 14.—The double convention of Wisconsin postmasters opened here today with a large attendance of fourth class postmasters. They will remain in session two days and on Wednesday the two days' session of the convention of the Wisconsin Association of Postmasters, the general body, will be opened.

UNION PRINTERS IN SESSION.

The I. T. U. Meets in San Francisco Today.

SAN FRANCISCO, Cal., Aug. 14.—The fifty-seventh annual convention of the International Typographical Union opened in this city today with delegates in attendance from the local branches throughout the United States and Canada. Addresses of welcome were made by Mayor McCarthy, the officers of the union and others, and were responded to by President James M. Lynch. The convention will continue its sessions about five days, during which time much important business relating to the affairs of the organization will be transacted. The principal matter to be considered and acted upon is the contract between the union and the Newspaper Publishers' Association. The present contract expires this year, and it is said a large majority of the membership favor its renewal with possible changes of a minor character.

The initial session of the convention included the presentation of the annual reports of the several officers. These reports showed the present membership to be 56,185 a gain of over 4,000 during the year. During the year the organization paid a total of \$122,671 in old-age pensions.

To Commemorate Famous Indian Battle

MARION, Ind., August 14.—This City presents quite a martial appearance today, the numerous soldiers and Indians gathered here to take part in the great military and historical spectacles to be given every night this week at Goldthwait Park, in which the Battle of the Mississinewa, fought near Marion in 1812 between soldiers under Col. Hamilton and the Indians, is to be reproduced. The spectacular shows to be given during the week and in which the last of the Miami tribe of Indians, including several descendants of Chief Gabriel Godfrey, who fought so valiantly in that battle, will take part, have been arranged by the Mississinewa Battle Ground Association, for the purpose of raising funds for the purchase of the battle ground, which will be dedicated to the memory of the American soldiers and Indians who fought and died there.

Harmon Avoids Bryan.

COLUMBUS, O., Aug. 14.—The Jefferson club, the insurgent Democratic organization of Franklin county, held its annual outing at Olentangy park today with William J. Bryan as the guest of honor and principal speaker. Governor Harmon declined an invitation to attend the gathering. The reason for his declination, according to his friends, was his desire not to meet face to face in his own state capital in the Nebraska leader, who has openly declared war upon him as a presidential candidate.

Iowa Tennis Tournament.

DES MOINES, Aug. 14.—The best tennis talent of this and several of the neighboring states is represented in the sixth annual tournament of the Iowa Lawn Tennis Association, which was opened on the courts of the Golf and Country club. The tournament is to decide the Iowa championships. The winner of the singles will play the present champion, Fred Bailey, of Des Moines, and winners of the doubles will meet the present title holders, W. S. Gilman and C. S. Carey of Sioux City.

Pharmacists Meet in Boston.

BOSTON, Mass., Aug. 14.—Pharmacists from all over the United States and Canada are gathering in Boston for the annual convention of the American Pharmaceutical Association, which will hold forth here during the greater part of the week. In connection with the convention there will be meetings of the national association of boards of pharmacy and the American convention of pharmaceutical faculties.

Fisher to Inspect Alaska.

SEATTLE, Wash., Aug. 14.—Secretary of the Interior Fisher has booked passage on a boat sailing tomorrow for Alaska. The purpose of the trip is to familiarize himself with the actual conditions in the northern territory. Special attention will be given to an inspection of the lands about Controller Bay and those along the Bering and Copper rivers.

Colorado Labor Men Meet.

COLORADO SPRINGS, Colo., Aug. 14.—The delegates to the sixteenth and largest annual convention of the Colorado State Federation of labor, which opened here today for a session of three days, were warmly welcomed in an address by Mayor H. F. Avery of Colorado Springs. But little business was transacted by the convention and the greater part of the day was devoted by the delegates to trolley rides to Colorado City and Manitou and a visit to the Union Printers' home at Knob Hill. Several prominent labor leaders will address the convention at the sessions tomorrow and Wednesday morning. Tomorrow evening a concert and dance at Stratton Park and on Wednesday evening a smoker at Temple Theatre will constitute the entertainment feature of the convention.

Togo Sight Seeing in New York.

NEW YORK, August 14.—Admiral Togo, now on a visit to the United States as the guest of the American government, had another extremely busy day today. During the forenoon he received an umber of more or less official visitors from distinguished military naval and civic representatives. At luncheon he was the guest of honor of the Japan Society of the Peace Society of New York, on which occasion several informal addresses were delivered. In the afternoon the admiral, accompanied by Capt. Potts, chief of the Naval Intelligence Bureau of the United States navy department, went on an extended sight-seeing tour of the city, returning in time for a dinner arranged in his honor at the Knickerbocker Hotel.

Golfers Gather at Omaha.

OMAHA, Neb., Aug. 14.—Leading golfers of the West, representing clubs from every part of the territory lying between the Mississippi river and Los Angeles and Seattle, were assembled at the Omaha Country Club today at the opening of the eleventh annual tournament of the Trans-Mississippi Golf Association. Entries for the tournament total nearly 300, the largest in the history of the association. Play began this morning with the first half of the qualifying round of thirty-six holes. It will be Saturday before the tournament is concluded. The amateur championship cup, now held by Harry Legg, of Minneapolis, is the prize all the golfers are pursuing, and the Brock team cup is the big prize for team or club championship.

The Antiquity of Man.
It has been known during a long time that in western Europe a man existed during the glacial epoch. We now know that the great ice age consisted of different glacial times separated by interglacial times. In glacial times the snow line dropped 3,000 or 4,000 feet below its present level in the Alps, whereas in interglacial times it lay about 1,000 feet higher than at present. Thus the temperature seems to have been higher in the interglacial periods than it is now. There is abundant evidence, in the opening of Penck, that man existed during the beginning of the last glacial epoch. There is some reason for thinking that at least 20,000 years have elapsed since the last glaciation and that the man whose jawbone was found in 1909 near Heidelberg lived 200,000 years ago.—Scientific American.

SEVENTY-TWO HUNDRED PEOPLE

Treated For Hookworm Disease In Twenty Days in Four Counties.

In the counties of Sampson, Robeson, Columbus and Halifax 7260 victims of hookworm disease have been treated at the state and county dispensaries. Nearly double this number have been examined. During the first five days the dispensaries were open only 615 cases were treated, whereas during the last five days 2508 were treated. During the twenty days there were treated in Sampson 1682 cases; in Robeson 1352; in Columbus 3047; and in Halifax in 12 days 1169 cases.

The county board of education, to show their spirit of co-operation, are having sanitary privies installed at all the school houses being used as dispensaries.

After about two weeks the dispensary work will move into new counties. Cumberland, Onslow, Wayne and Northampton counties have made the necessary provision to have the dispensaries next. The commissioners and people generally are highly pleased with the work of the dispensaries.

FIRE IN WASHINGTON.

A GRANITE BOMB.

Jack Frost Hurlled It Down Into the Yosemite Valley.

Delicate frost tracings on the window panes seem to be the work of fanciful and harmless sportiveness, but the hand that forms them is capable of greater deeds and of other kinds. Mr. J. Smeaton Chase, in "Yosemite Trails," describes an experience that must have been wonderfully impressive to the spectator. He had been spending some weeks in exploring the Yosemite valley and the "great rocks," like El Capitan, that wall it in.

Standing one day of late autumn about the middle of the valley, I was startled by a report like a cannon shot, which filled the whole valley with echoes that roared and boomed, repeated and multiplied, in a long continued, glorious tumult.

As the deafening sound died away in sullen mutterings under the vizzor of El Capitan I was able to distinguish the point of attack by the long, clattering descent of a vast quantity of rock.

The night had been a cold one in the valley, and on the seven to eight thousand foot levels of the upper rim the temperature must have dropped almost to zero.

Frost, working quietly with his Archimedean lever, had just succeeded in shifting from the shoulder of the sentinel a trifle of fifty tons or so of granite. For near a thousand feet the bowlder fell sheer, swift and silent; then, striking the cliff, it burst like a bomb, shattered into a myriad flying shards and splinters and dislodged a smother of fragments that trickled down to the valley in a stream that lasted for minutes.

Then from the spot where the bowlder had struck dust began to rise into the sunny air, slowly building up and burgeoning like a summer cloud and every whit as snowy. It was the flour of granite, powdered instantaneously by the terrific shock.

ARRESTED IN NORFOLK.

Two Negroes Admit Having Killed Another on Excursion Train.

Frederick Leroy Stanley and Marlon Harrald, both negroes, are locked up in the Second police precinct station, charged with murder, the crime having been committed in Washington, N. C., last Tuesday on an excursion train. Their victim was Oscar Hill, also colored.

Early last night a negro put in his appearance at the uptown police station and informed Sergeant Dozier, in charge, that two negroes who had killed another in North Carolina were in the black belt.

Sergeant Gwynn, Police Detective Strawhand, Patrolmen Jones and Trueblood were detailed on the case and within a short while they brought in the two negroes. Both admitted their guilt and produced the gun which was used in killing Hill.

The North Carolina authorities have been notified of the arrest and officers are expected to arrive today for the prisoners.—Norfolk Virginian-Pilot.

This is the murder that was committed last Tuesday on the negro excursion coming from New Bern to Greenville. The negroes arrested in Norfolk were taken to New Bern by officers Sunday.

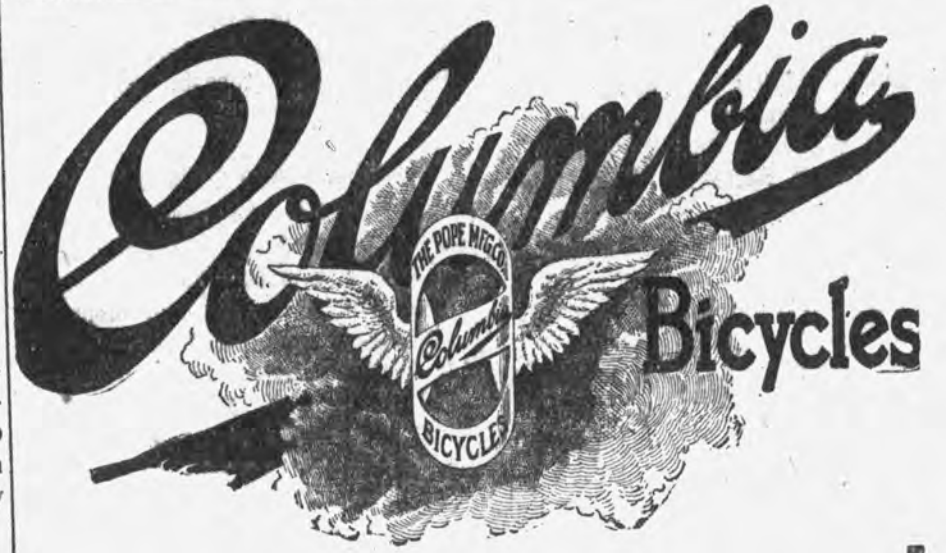
