

WOMEN FAST TO AID SUFFRAGE

A SOLID WEEK OF SELF-DENIAL.

Election to be Held in California October 10th.

NEW YORK, Aug. 15.—The week of self-denial which the women suffragists of this city have voluntarily imposed upon themselves in an effort to aid the women of California who need funds to carry on the campaign for women's rights, with a view to carry the suffrage proposition at the election to be held in that state on October 10, began today in all seriousness. To celebrate the opening of this period of self-denial the suffragists of Greater New York gathered at Clason Point this afternoon and partook of a luncheon, the menu of which included hard-tack and other primitive and inexpensive articles of food which many of the women did not even know by name.

The luncheon had been arranged by leaders of the suffrage movement in this city to launch the self-denial movement in an appropriate manner and to give the suffrage advocates a foretaste of the "simple life" to which they had committed themselves for the period of a week. The undeniably plain menu of the luncheon had an exhilarating effect upon the suffragists and with every address the enthusiasm increased.

It is not alone by fasting, however, that the New York women devoted to the suffrage cause expect to help their sisters in the far West. Many hundreds of letters have been received by women suffragists of prominence, in which the writers, women of every rank and station of society pledge themselves to deeds of self-denial. Some of the poorest enthusiasts, most working girls, promised to cut down their luncheon allowance and deny themselves the luxury of riding home in a street car, to contribute to the California campaign fund. Others pledged themselves to forego soda water, candy and ice cream for a whole week, still others promised to deny themselves certain additions to their summer wardrobe, and to mend their old stockings, instead of purchasing new ones. Of course, the money thus saved, is to be contributed to the war fund. The range of sacrifices which the women suffragists have voluntarily imposed upon themselves is quite extensive and varied in accordance with the social and financial conditions of the women.

Many of the wealthy or comparatively wealthy suffragists have decided to deny themselves some pleasure, from an expensive book to a week-end party or a trip to Europe and some business women or professional women have pledged themselves to contribute a certain percentage of their income or salary for the week. It is expected that by the co-operation of the supporters of women's suffrage in this city and by the faithful fulfillment of their pledges of self-denial a large sum of money will be raised and it is hoped that the sum thus realized will be of material aid to the women of California in their fight for woman suffrage.

Togo to Visit Boston.

BOSTON, Mass., August 15.—Boston is in readiness to receive Admiral Togo, who reaches the city this evening to begin a visit that will continue until Friday afternoon, when he will depart for Buffalo and Niagara Falls. The city has made no elaborate preparations for the entertainment of the distinguished visitor, for the reason that he comes more or less as the guest of the government and during his stay will be in the hands of the navy yard officers and Rear Admiral Dowels of the Fore River Shipbuilding Company.

CARLISLE, Ky., August 15.—Confederate veterans who are proud of the fact that they fought under Gen. John H. Morgan, rounded up for their annual reunion today at Parks Hill, this county. Many of the veterans came from distant points to renew acquaintance with their old comrades and to exchange reminiscences of the stirring times of fifty years ago. The reunion will continue over tomorrow.

In addition to the regular delegates the attendance included the candidates for office and numerous other party leaders. The gathering has attracted added attention for the fact that it is the first convention in the history of the state to meet after the party had named its ticket.

Plans for the general betterment of theatrical conditions, and particularly for meeting legislative and other opposition to theatrical interests, also were discussed by the managers.

It was on this date, in 1781, that Felipe de Neve, governor of Alta California, gave to the settlement the name of Los Angeles.

Convention of Baptist.

BRIDGETOWN, N. S., August 15.—The Women's Baptist Missionary Society began its annual sessions here today preliminary to the annual convention of the United Baptist Convention of the Maritime Provinces, which is to have its formal opening Saturday morning. The gathering has attracted many prominent members of the denomination.

Illinois Farmers in Session.

CARMI, Ill., August 15.—Four hundred local branches of the Farmers' Educational and Co-operative Union of America were represented by delegates at the opening here today of the annual State convention of the organization. The convention opened with a picnic at the fair grounds, President C. S. Barrett making the opening address.

To Present Steuben Statue to Germany

NEW YORK, August 15.—Representative Bartholdt of Missouri sailed on the Kaiser Wilhelm II. for Germany today to present a replica of the Baron von Steuben statue to the Emperor on behalf of the people of the United States. While abroad Mr. Bartholdt also will attend the annual meeting of the Interparliamentary Peace Union.

Volunteer Firemen at Rochester.

ROCHESTER, N. Y., August 15.—Rochester is in gala attire in honor of the 5,000 volunteer firemen who have gathered here from cities and towns throughout New York for the annual convention and tournament of their State association. The four days' program calls for a big parade and numerous prize contests, in addition to the usual business session.

Louisville Welcomes Elks.

LOUISVILLE, Ky., August 15.—Louisville gave a hearty greeting today to the Elks assembled here from all over Kentucky for their annual State reunion. The day was given over to the reception of the delegates, who represented twenty-five lodges scattered over the State. The business sessions of the gathering will occupy tomorrow and Thursday.

BIG RAT KILLING ON THE FARM

GREAT IMPROVEMENT IN CROPS.

Thinks The Picnic Dinner Not A Good Idea.

AYDEN, N. C., Aug. 15, 1911.

Editor Reflector: It is now just one month since the drought was broken in our immediate locality. On the 12th of July we had a very good rain and on the 13th I went to your town, Mr. Editor, and on the way noticed it had rained very little with you, and for some distance out toward our home. Before I got back home I was caught in the rain near at home and it proved to be a right large rain. From that time down to now we have had from one to two big rains each week, with the exception of one week. We had some tobacco to get drowned. The water in our hog lot well rose three or four feet and is now plentiful. So it was a little strange to us to see so much in the papers about the scarcity of water in Charlotte and Raleigh just at the time we were having an excess. We see from friend A. J. M.'s letter in last week's paper that he must not have had the rain we have.

Our crops have improved wonderfully and we are now housing a much better crop of tobacco than we have had for two or three years. I don't mean to say it is good, but better than for the two or three previous years, on account of so much rain for those years.

Think friend Moyer better abandon the dinner idea in connection with the fair, as it will make a handicap to the ladies who have to prepare it and there will be too many interested in the dinner and not the fair. I think farmers make a mistake of spreading big dinners to the public because the harvest looks favorable.

I and the two boys had quite a little fun a few days since rounding up and killing rats. The corn pile got pretty delicate in the barn, and it looked like the rats got hungry and were trying to eat it all up. So I called the boys up and we had a rat killing. We got them all run into a place just under the floor on top of the back sill to the barn, then I had one of the boys to put a piece of wood pump piping at one hole and one boy remained in the barn to run them back from that way while I punched them with a ploe and made them run into the piping. We got ten without much trouble and took the piping and held one end over a barrel with water in it so as to make sure of them as they ran out. But we had to twist them out like twisting a rabbit out of a hollow. We killed some while running up the posts, etc., and wound up with 21 dead, enough to eat corn enough every night to feed one team at least one meal.

Writing about tobacco, I would say I have been making it for 20 years, at least, and have been sitting up with it from midnight till day a good part of the time, and in that time have never made but three or four crops that amounted to much. A good crop is seldom made. We have been curing three weeks now and just finished topping our last today. Will be curing three weeks more if the worms don't finish it up before then.

YOUNG BEATTIE INDICTED.

Only Four Witnesses It is Said Will be Heard by The Grand Jury.

CHESTERFIELD COURTHOUSE, Va., Aug. 14.—A true bill charging murder in the first degree was returned by the grand jury of the Chesterfield circuit court today, against Henry Clay Beattie, Jr., of Richmond.

He will be tried for his life as the alleged murderer of his young wife, the victim of Middlethian turnpike tragedy of July 18, last.

After the grand jury had brought in the indictment court adjourned until later in the afternoon, when the date of the trial is expected to be set.

Beulah Binford was not called before the jury as a witness. Neither was Paul Beattie, cousin of the accused man, who says he purchased a gun for Henry. Both remained in the ante-room during the time the jury was in session, expecting to be called as witnesses.

The indictment covers broadly all degrees of homicide from murder in the first degree to manslaughter.

The indictment charging murder in the first degree was in the hands of the clerk when the grand jurors arrived and with but four witnesses to be heard, spectators prepared for only a brief wait before the document would be handed in formally and a date fixed for the trial. Beattie will be kept in jail at Richmond during today's proceedings.

Will Introduce But Four Witnesses.

The commonwealth decided that only four witnesses would be heard by the grand jury. They are Thomas Owen, uncle of Mrs. Beattie, T. P. Pettigrew, called to testify as to the finding of the shotgun, Dr. Wilbur Merder, who was on the Owen lawn when Beattie drove up with the body of his wife, and Paul Beattie, a cousin of the defendant.

LAURIER OPENS CAMPAIGN.

Canada to Have Warm Contest on Reciprocity.

OTTAWA, Ont., August 15.—With confidence that the result will be favorable to the cause for which Liberalism stands in the present contest, Sir Wilfrid Laurier journeyed to Simcoo, today to deliver his first platform address in what promises to be the hottest political fight Canada has seen since the days of Sir John Macdonald and the National Policy. From now until the date of the election every politician, from the Prime Ministers of the Dominion of the humble canvasser, will continue actively at work. Political conventions and campaign meetings will be held in every part of the country, and reciprocity with the United States will be the staple subject of discussion. Sir Wilfrid Laurier plans to cover the eastern provinces thoroughly. He will spend the coming week in the province of Quebec, to which he will devote particular attention in an effort to stem the Nationalist movement which is regarded as the most ominous element in that province. After leaving Montreal the premier will spend a week in the Maritime Provinces and will then return for the wind-up of the campaign in Ontario.

Commodore Preble Remembered.

PORTLAND, Me., August 15.—Exercises were held today in commemoration of the 150th anniversary of the birth of Commodore Edward Preble, one of the most distinguished officers of the American navy in its early days. Commodore Preble was born and died in Portland and Fort Preble, guarding the entrance to Portland harbor, was named in honor of his memory. Commodore Preble is best remembered for the warfare he conducted against the Barbary pirates, who menaced American shipping in the Mediterranean. In the year 1803 his ships bombarded Tripoli six times and destroyed all the pirates' craft. The Pacha finally asked to negotiate and the American officers operations eventually resulted in the peace of 1805, by which the tribute that Europe had paid for centuries and the slavery of Christian captives were abolished.

Irish Catholic Benevolent Union.

TOLEDO, O., August 15.—Fully two hundred delegates were in attendance at the assembly room of the Hotel Secor in this city today, when the thirty-eighth national convention of the Irish Catholic Benevolent Union was called to order for its four days' session. Before the formal opening of the convention the delegates attended solemn high mass at the Church of the Good Shepherd, with the Rev. Patrick O'Brien as celebrant. An elaborate program for the entertainment of the delegates has been arranged by the members of the local St. Cecilia Society. Until 1901 the conventions of the Irish Catholic Benevolent Union were held annually, but since then they are held every other year. The convention of 1909 was held at Atlantic City.

California Red Men Hold Council.

SAN JOSE, Cal., August 15.—The Great Council of the Red Men of California was opened here today with impressive ceremonies and will remain in session through the rest of the week, closing Saturday with a big celebration. Many matters of interest to the members of the order will be discussed at the meetings of the Council.

The Scene of the Trial.

LYNCHINGS NORTH AND WEST.

When they start out to lynch a negro in the North they make the worst kind of a brutal job out of it. In Coatesville, Pa., a negro killed a policeman. The negro, wounded, was carried to a hospital. That night a mob of a thousand, including a large number of women, stormed the hospital, broke in, took the negro and the cot on which he was lying, marched to the outskirts of the town, built a fire of straw and fence rails, placed their victim on this and burned his body to ashes. If that thing had happened in the South, Boston would froth at the mouth about it. The same day that the above occurred, Durant, Okla., had a similar lynching, the only difference being that the negro was shot to death before his body was burned.

A Western college professor has decided that "hymns, as sung in our churches today, constitute a form of meaningless memory which should have passed out with the middle ages, a type of worship which never achieved anything and never will." We are not afraid to venture the assertion that the man who made this declaration has never possessed enough real Christianity for his soul to be stirred by a gospel hymn.

POLITICS AND POLITICIANS.

The next national convention of the Socialist party probably will be held in Milwaukee.

The Socialists of Massachusetts have nominated a complete state ticket, headed by James F. Carey, of Haverhill, for governor.

In all probability the Democrats of Arkansas will determine the state's choice for the presidential nomination at the regular primary election next March.

At a Democratic barbecue in Boston next month Governor Harmon, of Ohio, will deliver the first address he has made in the east since he became a candidate for the Democratic presidential nomination.

When the Illinois Federation of Labor meets in annual session in Springfield in October steps will probably be taken to create a new political party, for the primary purpose of improving labor conditions.

There is said to be a possibility that Senator Nelson, of Minnesota, will not be a candidate for re-election next year. He will be 70 years old at the expiration of his present term, in March, 1913, which date will mark the close of eighteen years of consecutive service in the senate.

The National Progressive Democratic League is to be formally launched within a few weeks, when articles of incorporation will be filed at Trenton, N. J. Colonel William C. Liller, of Indianapolis, is at the head of the organization, which is to be to the Democratic party what the National Republican Progressive League, organized last year, is to the Republican party.

NEGRO BOY KILLED.

Slain By Another Boy of Same Race.

Dr. C. O'H. Laughinghouse, county
coroner, was called out to the Wind-
ham farm, in Faldand township, to
hold an inquest Monday afternoon.
The facts as brought out at the in-
quest are about as follows:

On Sunday, August 13th, Heber
Harris, colored, aged 13, was shot and
killed. Mack Harris, aged 12 or 14
years, said that Heber shot himself.
Alex Daniel, aged 13, said he saw
the shooting, that Mack was in the
house and when Heber came up
Mack raised the gun and shot Heber;
then Mack ran across the cotton patch
and came back after a while with his
mother and father.

The coroner's jury thought there
was sufficient cause for Mack to be
held for investigation by the grand
jury, hence their verdict was that
Heber Harris came to his death from
a gun shot wound inflicted by Mack
Harris.

"THIS IS MY 46th BIRTHDAY," Edwin L. Norris.

Edwin L. Norris, the present gov-
ernor of Montana, was born in Cum-
berland county, Kentucky, August 15,
1865. He received his education in
the country schools, and in 1886 gradu-
ated from what is now Western Ken-
tucky Normal school. During the
next two years he was engaged in
teaching school at various points in
Kentucky, Tennessee and Texas. His
spare time was spent in the study
of law. In 1888 Mr. Norris moved to
Montana, and during the next year
he finished his legal studies and was
admitted to the bar. In 1896 he was
a successful candidate on the Demo-
cratic ticket for the Montana senate,
and four years later he was elected
lieutenant governor on the ticket
headed by J. P. Toole. Mr. Toole and
Mr. Norris were the only two Demo-
crats elected on the ticket in that
year. In 1903 Governor Toole re-
signed, and Mr. Norris became gov-
ernor, and in 1908 he was re-elected.

ENDS LIFE IN HOTEL ROOM.

Ben. K. Ryder, of Littleton, Shoots Bullet Through His Heart.

Placing the muzzle of a 22-calibre
revolver, of a cheap make, to his heart
yesterday afternoon about 5 o'clock,
in his room in the Lynnhaven Hotel,
Benjamin K. Ryder, 30 years of age,
of Littleton, N. C., a traveling sales-
man for a patent medicine house, pulled
the trigger and caused his im-
mediate death.

The body was found across the bed
by a negro bell boy, who had been
sent to the room of Ryder to call him,
he having expressed a desire early in
the afternoon to catch a Baltimore
boat. No cause has as yet been as-
signed for the suicide. The dead man
did not leave any instructions with
reference to the disposition of his
body. He has a wife residing in Lit-
tleton.

Ryder often visited Norfolk. He went
to the Lynnhaven Hotel last Satur-
day and was assigned to room No.
221. He was seen about the hotel
lobby several times yesterday and ap-
peared to be in the best of spirits.
During the afternoon the traveling
salesman went to his apartment after
leaving a call for 5 o'clock.

No one heard the shot fired. When
the bell boy knocked on the door and
did not get a response the office was
notified and investigation followed.
Ryder had on his under clothing,
shoes and top shirt. The pistol was
at his side. Evidently, he propped
himself up with the pillows and plac-
ing the pistol at his side, fired the
fatal shot. There were powder burns
on his clothing, but not a visible sign
of a death struggle.

A search was made of the clothing
and effects of the dead man, but no
note or letter was found written by
him. There were several letters in
his pockets, written by Mrs. Ryder,
his wife. The baggage of the dead
man consisted of two suit cases.

The police department was notified
and Chief Kizer made a personal in-
vestigation. Coroner Knight after-
wards viewed the body and ordered it
turned over to Undertaker H. D. Oliver
to be prepared for burial. The family
was communicated with last night by
the hotel and the body will be shipped
to Littleton today. Coroner Knight
stated last night that he did not know
whether an inquest will be held over
the remains. This will be decided
upon by Dr. Knight this morning.
There are no suspicions of foul play.
—Norfolk Virginian-Pilot.

FALKLAND AND BRUCE.

Post Offices Will Not Be Discontinued.

For some days past the rumor had been going around that the post offices at Falkland and Bruce, in this county would be discontinued the first of September, the patrons of those offices to be supplied by rural delivery routes after that date. The attention of Congressman Small was called to the matter, and as usual, he got busy in behalf of the people of his district. A telegram from him today says that the order to discontinue those offices has been revoked, and they will be continued as before. Falkland has been a post office for perhaps 75 years, and is among the oldest in the county.

THE TOBACCO CROP.

The Government Estimates of Tobacco August 1, 1911.

The total production of the principal crops of the United States for 1911, as indicated by their condition on August 1, reported by the United States Department of Agriculture, is as follows:

Under this head is given 600,588,000 pounds of tobacco for 1911; 984,439,000 pounds in 1910; a shortage of 383,851,000 pounds.

Condition and Indicated Yield.

Condition, 68.0 per cent. of a normal, compared with 72.4 per cent. on July 1. 78.5 per cent. in 1910 and 82.2 per cent. the ten year average. Indicated yield per acre, 672.4 pounds, compared with 797.8 pounds in 1910 and 826 pounds, the five year average.

Interesting figures from the Western Tobacco Journal's correspondent at Antwerp, Belgium, last week show that in the past ten years there has accumulated a shortage of 121,000,000 pounds—in other words, for the period named the increase in manufacturers and exports against the United States crop show this considerable deficit instead of excess as had been the experience up to about four years ago. This accumulated shortage added to the prospective shortage of 1911 crop makes a total shrinkage in supply of 504,851,000 pounds.

Things That Go Together.

Merchants with taste do not habitually display hams and ribbons in the same showcase; neither do they cantaloupes, dairy butter and horse-shoes. Still we are not prepared to charge a local dealer who exhibits in the same window a miscellaneous assortment of dice, revolvers and hand-cuffs, with doing violence to the eternal fitness of things. If they do not go together, how come it?—Charlotte Observer.

The Chinchilla.

The tiny chinchilla, not more than twelve inches long, with a plump little body on short, stout legs, thrives only in the tropics. The little beast have to be killed with the utmost precaution not to injure their fur, this grows on a skin nearly as tender and soft as a web of silk. A perfect skin not larger than a small pocket handkerchief is a revelation in fur growth. The texture of every hair is finer than floss silk, the length of it nearly an inch and the coloring about that of the soft, undyed marabou feathers.

CLOSING HOURS.

For Building & Loan Collections on Saturdays.

At the last meeting of the board of directors of the Home Building and Loan Association, the secretary was instructed to close his collections on Saturday at 7:30 o'clock, p. m., between April 15th and October 15th, and at 7 o'clock p. m. between October 15th and April 15th.

In compliance with this rule the secretary's office will begin closing at 7:30 o'clock, p. m., on next Saturday, August 12th. Stockholders should take notice and call to pay their weekly dues before the closing hour.

Gov. Drummond as Hung.

When Mr. F. A. Linney addressed the North Carolina editors at Boone a few weeks ago he referred to an ex-governor of North Carolina who was hanged. The publication of Mr. Linney's address aroused some inquiry on this point and inquiry has been made of the Landmark as to the name of the governor who suffered this ignominious fate. A friend of the Landmark who is studious and an enquiring turn of mind, has looked up the matter and finds that the governor was Drummond, the first governor of the state. The story is told in Mrs. Spencer's "First Steps in North Carolina History," and is as follows:

"In 1664 the Lords Proprietors appointed the first governor for Carolina, or rather for Albemarle country. He was William Drummond, a Scotchman by birth, who came from Virginia and was a friend of Governor Berkeley. As he was our first governor, it is pleasant to know that he was a man of good character and highly esteemed and of a good family. We know very little of the years in which he ruled the Albemarle country. He returned to Virginia afterward, and ten years later he became engaged in a serious rebellion of the Virginia people against their governor. Berkeley was getting old and very hard and tyrannical, and odious to the colonists after having been a popular and excellent governor for more than 30 years. They rose against him in 1776 in what is called 'Bacon's Rebellion,' and were beaten and forced to submit, and Berkeley took a base revenge by hanging all the leaders who came into his hands. Among them was ex-Governor Drummond, who had been his friend, but who felt it his duty to oppose his tyranny. The vindictive old man showed no mercy. He made a low bow to his prisoner and with cruel words of hatred told him he should be hung in half an hour. And so he was, as soon as a gallows could be built. Drummond died calmly and full of courage, believing that he died in a good cause. This was the sad end of the man who had been the first governor of our state. But for all that, he was a good and a brave man, and his name stands much higher than Berkeley's. It is of no consequence how a man dies if he has lived well. Berkeley died within that same year in England, where had had gone to explain away his barbarous conduct, but the king refused to see him or to forgive him for his cruelty. He is said to have died of a broken heart, but it is not likely that he had much heart to break. The lake in the Great Dismal Swamp between North Carolina and Virginia was named in honor of Governor Drummond."

So it will be seen that while the first governor of North Carolina met death by hanging, he was the victim of a tyrant and his offense was resistance to tyranny. By all accounts he was a good man and guilty of no crime.—Statesville Landmark.

The Horse Holds His Own.

At the present time there are 350,000 automobiles in the United States and the money invested in them amounts to a fabulous sum. It is stated, however, that we are on the eve of a still greater use of motor vehicles and the record shows that the number now in use will be increased by 100,000 automobiles in the next twelve months.

At one time it was believed that the noble horse would disappear before the chug wagon, but a census bulletin shows otherwise. There are now much larger numbers of horses and mules in the country than there ever was, and, strange to say, their value is greater than at any time in the history of the country. However, the growth of the automobile industry has progressed on marvellous lines in the last 14 years. About 18 years ago a few crude machines were made, but at the present time millions of dollars are invested in their manufacture and the industry gives employment in various ways to hundreds of thousands of men.—Wilmington, Star.
