

## SUNDAY NIGHT AT CHRISTIAN CHURCH

### FINE SERMON ON "GOLGOTHA." Building Filled at This Service—Two Beautiful Solos.

Last night the auditorium of the Christian church with chairs placed in the aisle was packed to hear Mr. Boblitt on the old, but ever interesting theme, "Golgotha."

There was a splendid song service under the personal leadership of Mr. Boblitt. Mrs. C. C. Ware sang with evident power and edification two most appropriate solos entitled "Calvary," and "Bearing His Cross," one just preceding, and the other following the sermon. Mr. C. M. Rock, minister of the Baptist church, read the fifty-third chapter of Isaiah and led the evening prayer.

The great audience listened intently while the evangelist using Rom. 5:8 as a text, depicted in a most eloquent touching way the arrest, suffering and death of Christ. This was done in graphic, lecture style. The agonies of Gethsemane just preceding the arrest, the miserable betrayal with a kiss by Judas, the mock trial before Annas, Caiaphas, Herod, and Pontius Pilot, when Roman and Hebrew jurisprudence were greatly violated in their most essential principles, Pilate delivering Him to the Jews for crucifixion against his conscience and better judgment, the cosmopolitan crowd that thronged His way to Golgotha, the ignoring and terrible sufferings of the cross, the jeerings of the multitudes, and His forgiving His enemies, and He the Divine Arbitrator of the souls of men saving the penitent thief and the terrible demonstrations of nature which made the centurion cry out "Surely this was the Son of God," the significant rending of the trial of the temple and the horrible outcry of Jesus expressing a sense of this abandonment by God, the Father, because of the awful load of human sins he was propitiating, and the final triumphant cry, "Tis finished," when Jesus dies, is the gist of this old story of Golgotha, told so effectively by the preacher. Mr. Boblitt then said that Christ is still despised and rejected by men, for Christ who is risen offers eternal life to all who will obey, and yet many stubbornly and carelessly refuse to avail themselves of this wonderful dispensation of grace, continuing in their sins, thus crucifying Him afresh forever. This awful sacrifice on the cross of the "only beloved Son of God" is for all mankind, as all of mankind is sinful. And if we would claim the blessings of this sacrifice, we must believe Him, repent of our sins, confess His glorious name, and be buried with Him in baptism, and arise to walk with Him in newness of life, for these are the conditions clearly given by Christ and the Holy Spirit, passages of Scripture proving this point being quoted by the evangelist. A very earnest exhortation was given to all who had not met these simple conditions of salvation through Christ to do so at once.

The crowded house of last night was confidently expected by the pastor and his people. The evangelist was encouraged and gratified by the attendance and splendid attention. The spirit of fellowship on the part of the various church of the town was quite manifest. The congregational singing showed improvement, and it was such singing as the mass of church goes delight in, being familiar songs under the splendid direction of a leader. The revival will continue a few days. The subject tonight is "Is Hell a Played-out Doctrine?"

### RESUMES FIGHT FOR FREEDOM.

#### The Case of Chas. W. Morse Came Up Again Today.

ATLANTA, Ga., Oct. 9.—The case of Charles W. Morse, the New York financier, serving a fifteen-year sentence in the Federal penitentiary here, came up again today before the United States circuit court of appeals in this city. In the present proceeding it is contended that Morse should have been sentenced on but one count of his indictment and that he should have been sent to a New York jail instead of to the penitentiary, where hard work is required. Federal Judge Newman ruled adversely on this contention some time ago, but an appeal was taken.

### MR. R. C. WHITE DEAD.

#### Passed Away Saturday Night In Kingston Hospital.

Mr. Richard Claudius White, aged 27 years, and youngest son of Capt. C. A. White, died about midnight Saturday night in the hospital in Kingston, where he was taken a few weeks ago for treatment. The remains were brought home on the Atlantic Coast Line train Sunday morning, and today were consigned to earth again.

The death of this young man is so sad. But recently he was the picture of health—strong, robust and with every promise of life and every surrounding to make life pleasant. But the latter part of July he was stricken with pneumonia, and complications following this, he lingered and fought through several weeks of intense suffering only to be overcome at last by the monster, death.

In the summer of 1910, he married Miss Clara Pugh, of New Bern, and to the young wife and infant daughter his death is saddest of all.

Early this year Mr. White purchased the drug business of Coward & Wooten and was carrying on the business with much success.

Dick White had a host of friends and they all are deeply grieved at his untimely death. Beside the wife and child and aged father, he is survived by two brothers, Messrs. S. T. and J. B. White, and one sister, Mrs. Lula Fleming. His mother died six weeks ago, after he was taken sick, and owing to his condition he was never told of her death.

The funeral service, conducted by Rev. J. H. Griffith, of Kingston, was held at 11 o'clock this morning at the residence of Mrs. Lula Fleming, sister of the deceased, the interment following in Cherry Hill cemetery. The pall bearers were Messrs. C. S. Carr, A. M. Moseley, F. J. Forbes, Charles Horne, F. M. Wooten, B. S. Warren, D. E. House, George Gornto, John Shelburn and R. C. Flanagan.

### RESUME LORIMER QUIZ.

#### The Committee Expects to get Down to Work Tomorrow Morning.

CHICAGO, Ill., Oct. 9.—The members of the senate committee appointed to inquire into the election of Senator Lorimer, of Illinois, have rounded up here preparatory to resuming their investigation, which was broken off at the adjournment of congress this summer. The committee expects to get down to work tomorrow morning. The courtroom of Judge Grosscup in the Federal building will be used as the place of hearing. The number of witnesses to be heard here is much larger than during the original sessions in Washington. Investigators have scoured Illinois, Wisconsin and Michigan and have summoned scores of persons who are supposed to have more or less personal knowledge of some of the circumstances attending the election of the Illinois senator.

### Wisconsin Congregationalists.

FOND DU LAC, Wis., Oct. 7.—With "The Church and the Age" as the general theme of discussion, the seventy-third annual meeting of the Wisconsin Congregational association began here today and will continue until Monday. The prominent speakers to be heard include Dr. C. W. Richards, of New York; Rev. J. N. Chandler, of Chicago; President Silas Evans, of Ripon College; Rev. Charles P. Connolly, of Milwaukee; Rev. H. F. Burns, of Superior; and Rev. P. S. Reeve, of Appleton.

### Grain Dealers in Session.

OMAHA, Neb., Oct. 9.—How the grain production of the United States can be made to keep pace with consumption is one of the big questions to be discussed by members of the Grain Dealers' National Association, who assembled in Omaha today for their fifteenth annual convention. The attendance includes nearly 1,000 elevator owners, grain brokers, commission men and receivers of grain in nearly every part of the country.

### Ambassador Bryce Lays Cornerstone.

HINGHAM, Mass., Oct. 9.—Ambassador Bryce today made the presentation of the old "Mounting Stone," which Old Hingham, in England, has sent as a gift to this town. The mounting stone, or horse block, stood in the village square of Old Hingham for at least 700 years. Today it was laid as the cornerstone of the bell tower which is to be built here as a memorial to the first settlers of Hingham.

## WOMEN SUFFRAGE IN CALIFORNIA

### ELECTION TO BE HELD TOMORROW

#### Closing of a Remarkable Campaign In That State.

SAN FRANCISCO, Cal., Oct. 9.—On the eve of tomorrow's general election, following the close of one of the most memorable campaigns in the history of this state, the women of California are confident of the victory of their cause at the polls tomorrow. For many months they have kept up the agitation in favor of women's suffrage, and with remarkable energy and ability they have conducted their state-wide campaign against big odds and deposits the powerful influence which the opposition brought to bear upon the campaign. Argumentative literature in favor of woman's suffrage was scattered broadcast over the whole state of California; suffrage orators traveled from one end of the state to the other, addressing meetings in the interest of the women's cause; the churches, women's societies and even the school children were enlisted in behalf of the momentous suffrage question and nothing was neglected that seemed to offer even the remotest promise of furthering the cause of suffrage.

Now, the exciting work of the campaign is ended and both sides to the great suffrage question are resting on their guns, eagerly awaiting the decisive battle at the polls tomorrow, which will settle, once and for all, whether the women of California shall be the political equals of the men or not. The advocates of women's suffrage, although admitting that they shall have to contend against a strong opposition, express themselves confident of victory. They believe that the strenuous work of their campaign was by no means wasted but that it caused the conversion of thousands of voters heretofore prejudiced against woman's suffrage.

The woman's suffrage amendment to the constitution, it is true, is by far the most important of the twenty or more constitutional amendments to be voted on at tomorrow's election, but there are several among them which claim considerable attention on the part of the voters. Although the other amendments have received less consideration during the past campaign, some of the are really more important than the woman suffrage amendment. Among them is an amendment which provides for the initiative and the referendum in state legislation. Other amendments provide for the recall of the elective officers of the state; for county charters and county home rule; for eliminating technical errors as a ground for reversal in criminal cases; for direct legislation; enlargement of the powers of the railroad commission; the abolition of justice courts; for the inclusion of the district courts of appeals among those state officers who may be impeached; providing for a divided session of the legislature; municipal ownership and for borough organization in chartered cities. The other amendments, about ten in number, are of minor importance and have been almost entirely overlooked, as they were overshadowed by the much greater importance of the other questions at issue.

### Parale Industrial Institute.

The Parale Industrial Institute, for the training and betterment of the colored youth, will begin Wednesday, October 11th. It will be remembered that this is a work that President W. C. Chance founded just a short while ago, and he is laboring earnestly to raise the members of his race to a higher plane. Prof. Chance has just returned from an extended trip through the North where he has had success in his effort to interest well disposed persons. He feels sure that he will be able to begin building very soon.

### To Celebrate Peace Mission.

ATLANTA, Ga., Oct. 7.—Four governors and a number of mayors, in addition to many of the most famous military organizations in the United States, will be in Atlanta the first three days of the coming week for the celebration in connection with the unveiling of the Old Guard monument at Piedmont Park. The monument is to commemorate the "mission of peace" on which the Gate City guards of this city made a tour of the north soon after the close of the Civil war.

## ANNIVERSARY OF GREAT CHICAGO FIRE

### OBSERVED ALL OVER THE UNION

#### People Taking Interest in Subject of Fire Prevention.

CHICAGO, Oct. 9.—The fortieth anniversary of the great Chicago fire was observed today not only in this city and state, but in many other states of the union, where the respective governors set aside the day under the appellation of "fire prevention day" to be observed in the interest of the inter-state movement of reducing the enormous losses by fire sustained annually throughout the country. In compliance with the agreement reached by the governors of various states at their conference a short time ago, Governor Deneen had issued a proclamation setting aside the anniversary day of the great fire as "fire prevention day," and had asked the citizens to co-operate in the interest of the movement for the reduction of losses by fire. Last year the property loss by fire in the United States was \$234,470,650, of which Illinois bore its share of about \$11,000,000. Between 1901 and 1910 the per capita loss to every man, woman and child in the United States was \$2.71 for this fire waste, while in Europe the loss was only 33 cents per head. In Germany the per capita loss was only 19 cents.

The special features of today's observance of the day were an exhibition arranged by the Chicago Historical Society, to illustrate the great Chicago fire of 1871 and the various phases of Chicago's civic development; and a general cleaning up of back yards, cellars, attics and other places where combustible material is usually accumulated.

FALL RIVER, Mass., Oct. 9.—After complete idleness for nine weeks and running part time for several months previous, the Fall River Iron Works Company, the Borden print cloth concern, resumed operations in all of its seven big mills today. The plant gives employment to 5,000 operatives.

Miss Campbell, who already held the British championship, came to this country last fall and annexed the championship of the United States. Her decision to return this year and defend her title has added greatly to the interest in the present tournament.

### NATIONAL GUARDSMEN MEET

#### Every Phase of War Practice Will be Discussed.

BUFFALO, N. Y., Oct. 9.—Every phase of war practice will be discussed by the military experts of the regular army and militia who have assembled here from all over the country for the annual meeting of the National Guard Association of the United States. The sessions will continue three days. A delegation will be appointed to urge upon congress the passage of the bill providing for federal pay for both officers and enlisted men of the National guard. The guests of honor at the convention include Major General Leonard Wood, chief of staff, U. S. A.; Major General Frederick D. Grant, commanding the eastern division, and Governor John A. Dix.

**WORK AGAINST THE LOCKERS.**

Though Carolina club has only between fifty and sixty members, (there should be more) the entire town is, or should be, interested in what it is and what it does. Because there has for some time been shown, even among the members themselves, a want of interest in the club, at a meeting not long since some one advanced the idea that to place individual lockers in the club would arouse more interest and cause a larger membership. There are advocates of this change in the club, and there are opponents, and to settle the question by a vote of the members a meeting will be held tomorrow night at which every member should be present either in person or by authorized proxy. Not one should fail to be represented in that meeting.

The Reflector is frank to say that it believes nothing would mean more certain death to the club than to put in the lockers. Really it would be a reflection on the town to have a locker club in it, and it is hoped a majority of the members will see the wisdom of voting down such a proposition. Persons both in and out of the club who are opposed to the lockers should use their influence against placing them in the club rooms.

Another lesson that Greenville needs to learn is to feel as much interest in home people and home business enterprises as is shown to outsiders. The home people are the ones who make the town and pay the taxes. They stay here and do business here, and are the ones who keep things going. With the transient it is not so. He comes along to scoop up the best of everything in reach and moves on to another pasture, leaving nothing behind but the memory of his having been here and a longing after what he took away. He does nothing for your town but sap it for his own benefit. If you have any business to give out, or any favors to show, the home folks who stand to your elbow are entitled to these. The municipality, the business men and the individual should all practice this.

With cotton low and tobacco high there may be such a change in crops next year as to spoil prices again. The wise farmer will plant moderately of both the so-called money crops, and go in heavy for grain, meat and hay crops. To raise all the needed supplies should be the first thought of the farmer who wants to come out well at the end of the year. Having to buy feed for man and beast at high prices out of the money received for cotton and tobacco is not a safe way to farm, even if this advice does come from one who never farmed.

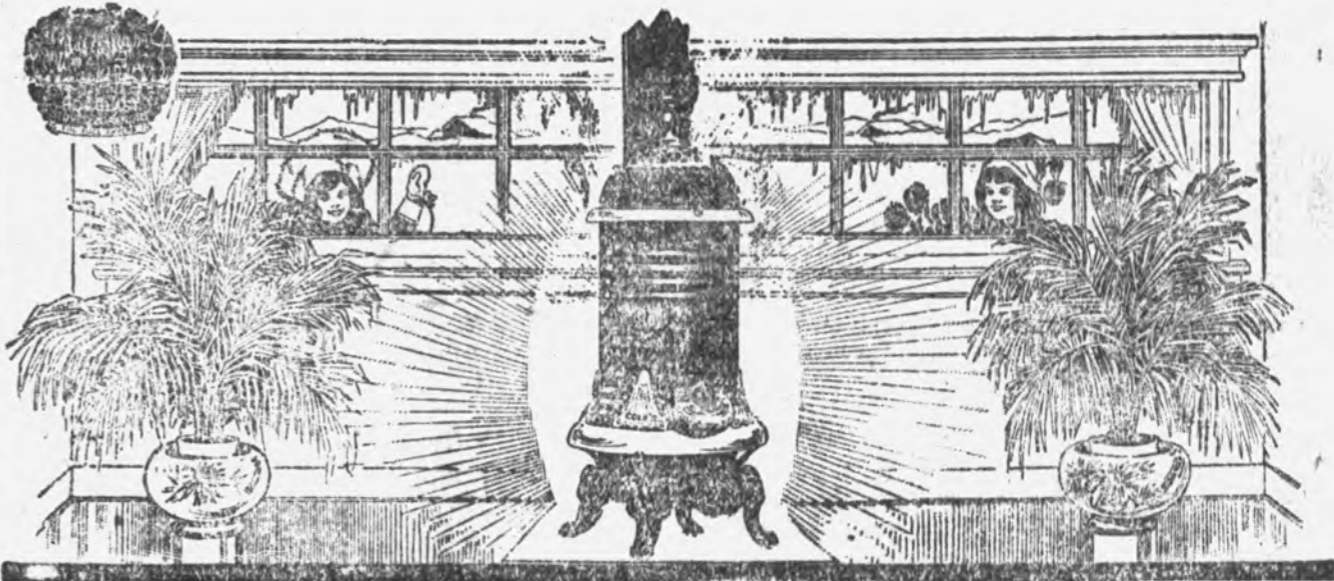
