The suggestion to reorganize Carolina Club and make it a commercial as well as a social body is meeting with much favorable comment and should be carried through with success. A meeting with this purpose in view is to be held next Monday night, 23rd.

Associate Justice John M. Harlan, of the United States Supreme Court, died in Washington City on Saturday. He was in his 79th year and his life has been prominent as a politician, a jurist and a churchman. This is the third member of the court to die in the last two years.

Raleigh's new municipal building and auditorium that has just been completed is a structure that the city, and even the entire state may feel proud of. It is ideal in construction, beautiful in appearance and perfect in its arrangement. Such an auditorium ought to restore to Raleigh her former prestige as the connection city of the State.

Under the plan of reorganization of the American Tobacco company, under the decree of the United States Supreme court, four companies have been established to take over and carry on the business. These are the American Tobacco company which will continue its corporate existence, the Liggett & Myers company, the P. Lorillard company and the R. J. Reynolds company. The business heretofore controlled by the combination will be carried on by the four companies. It effects a change in property to the value of \$115,000,000.

This fine statement by United States Judge Jeter C. Pritchard, of Asheville, is going the rounds: "That you cannot by law make an individual a good man, in one sense of the word, is true; but that you can by law remove such evil agencies as bar-rooms, and thereby minimize the temptations that beset young men is absolutely true. Experience teaches us that, were it not for the law it would be impossible to maintain our government and to protect the lives and property of our people. This has been so in all ages, and with all nations, and the time will never come when any government can exist without the enactment of suitable laws for the enforcement of its decrees and the maintenance of law and order."—Biblical Recorder.

WRESTLING BOUTS

One of the Oldest Forms of Sport Known to Man.

THE ART IN ANCIENT EGYPT.

Records Show That the Early Athletes Were Masters of Over Four Hundred Different Holds—Many of the Old Grips Are Used in the Modern Game.

The strenuous wrestling game is as old as the hills. In the days when men lived in caves, clothed themselves with fig leaves in summer and girded their loins and limbs with skins of fur in winter wrestling was part of their mode of fighting. That the change in the mode of life during the long circle of years to the present day has not injured the art, that it exists practically as it was in the dim, uncertain ages of the past, softened and meliorated perhaps in some of the rude essentials, is made manifest by the records which have stood all these years, mocking the attempts of Father Time to efface them.

In the temple tombs of Beni Hasan, located near the banks of the Nile, heven in stone, wrestlers are depicted in various positions, exemplifying all the holds and falls that the modern exponents of wrestling now use in their bouts. In tombs Nos. 16 and 17 the figures of the wrestlers represent nearly 450 positions. It would seem from this that the Egyptians were masters of the art of wrestling and that the present day athlete scarcely deviates from the methods employed by men in this sport when the earth was young and Egypt was the head legs and torso of civilization.

It was from the Egyptians that the Greeks obtained their knowledge of wrestling. The figures in the Beni Hasan tombs prove this. The Greeks were the greatest fighters of those days, and it was but natural that they adopted sports as a means to develop their physical condition; hence it was that at their games held at Olympia and elsewhere at stated intervals wrestling was part of the program. At these games the champions of the friendly nations met in rivalry. There was great glory attached to a victory. The successful competitor was treated like a hero. His return to his native land and his entry into his home city were made an occasion for a triumphant procession. He was the hero of the day, of the hour.

The Olympic games—their revival dates from 776 B. C.—were held every four years at Olympia, in Elis. They were started as a religious festival in honor of Jupiter, but the games, like the play, soon became the thing, and the people lost sight of the solemnity and sanctity of the meetings and assembled there just to see the sport.

It was in the eighteenth Olympiad, 107 B. C., that the first record of wrestling was established. Eurabatos, a Spartan, was the victor. He carried off the prize, a crown of wild olive made from a tree which stood within the inclosure at Olympia.

It will be seen from this that wrestling is one of the oldest sports, pastimes, means of attack or defense, call it what you will, known in the history of man. From the dawn of literature there are records of wrestling bouts. To Homer we owe that glittering, glowing description of the encounter between Ajax and Ulysses. He immortalized Ajax, who was the incarnation of strength, the physical power in man, and Ulysses, the crafty, the champion of every art and will. Homer before he was stricken blind witnessed many great wrestling bouts in the Greek cities. In his "Iliad" he graphically describes the wrestling bout between Ulysses and Ajax.

Nor is that all. In the convulsions of strife which followed among the fighting warriors, down through many chaotic changes out of which empires rose and fell along the path of time, in periods dull, creaking, rude and gross down to the present decade, wrestling was known, understood and played its part. That Shakespeare in his day realized its popularity and made use of it is evident in that scene between Orlando and the duke's wrestler in "As You Like It." Although the play was supposed to take place in France, the wrestling in this scene is a reproduction of that practiced in England at that time.

In the long time that wrestling has held sway there have been many styles—catch-as-catch-can, Greco-Roman, collar and elbow, recumbent and upright. Terminology of wrestling terms is mangled. The names in many instances were purely local—as, for instance, Cumberland and Westmoreland, which in this country is called back wrestling. Collar and elbow wrestling originated in the counties of Cornwall and Devon, England, and still is practiced there.

The catch-as-catch-can and Greco-Roman styles are now the only ones used in championship matches. The former is all that its name implies. A wrestler may catch his adversary on any part of the body, neck, head or limbs. In the latter style the hold is restricted to that part of the body above the waist line.

OUR NATURAL SAVAGERY

It Will at Times Break Through the Veneer of Civilization.

It's a mighty short step from modern civilization to the natural impulses of ancient savagery. If you don't believe it just watch some time, and you'll see a small boy—or a grown man—discover a rabbit.

The first thought that comes into his mind is to kill the rabbit. Quickly he searches his mind to see where a weapon can be found.

The second thought is to secure a rock to throw at it, just as some caveman might.

A man finds a snake coiled in the road. It may be a harmless snake, but it's a snake, and therefore his primitive instinct calls upon him to kill it.

A weapon! He seeks about for a club, just as his ancient, skin clothed ancestors would have done, and, having secured the club, he dispatches the snake, his soul singing with triumph.

Modern civilization probably would have urged the man to cut a forked stick and catch the snake by the neck with it, then to secure 10 cents' worth of chloroform and kill it swiftly and painlessly. But he goes after the club just as naturally as if he had never seen a steam heated flat or ridden on a trolley car or seen an automobile.

Children roam in the woods and eat every variety of berry they can find. It matters not if they be poisonous. They taste them all from the looks, and the amount eaten depends on the taste. This is probably what the cave children did, and the modern infants show the same intelligent caution regarding what they put in their mouths.

It's that way all through. We may have acquired a more or less thick veneer of modern civilization, but let emergencies arise and we're as primitive as the most primitive of our ancestors.—Galveston News.

## SOUTHERN POETS MASTERPIECES

ST. GEORGE TUCKER—1752-1828

St George Tucker was a noted man in his day. Born in the Bermudas he came in early life to Virginia, was educated at William and Mary college—where almost everybody else thereabouts was educated at that time—and after graduation began the practice of law. He wrote numerous dissertations on legal subjects, and his edition of Blackstone's commentaries was particularly well done. As professor of law at William and Mary he enjoyed unusual distinction. Yet he is remembered today as the author of a little poem, "Resignation," or "Days of My Youth." All of which goes to show how so fragile a thing as a beautiful sentiment may be very durable, indeed, for it never faileth, while prophecies do fail and tongues cease and even legal knowledge passes away.

He attended the local schools and then entered Amherst College, graduating with the class of 1875. He then entered the law school of Harvard University. He received his degree in 1877 and in the same year was admitted to the bar and began the practice of law in Springfield, Mass. Mr. Gillett was appointed assistant attorney general of Massachusetts in 1897 and served in that office until 1882. In 189-91 he was elected a member of the Massachusetts legislature and the following year was elected to congress on the Republican ticket. He has been re-elected every two years since.

The modern circus is the lineal descendant of the ancient Olympic games of Greece. The Romans adopted this form of popular amusement from the Greeks. The name "circus" is Latin, meaning a circle; and it was used to indicate the place in each city where chariot races, athletic contests, etc., were held. The circus flourished in Rome 2,500 years ago, and for ten centuries later. With the decadence of the mistress of the world came a decline of the circus in character, and it was frequently debased by revolting spectacles, such as the throwing of those obnoxious to the government, including Christians to wild beasts. Doubtless it was this that gave the church a prejudice against the circus, which is today still held by some extremely conservative church people.

The modern circus has about it nothing debasing. Mankind has always held physical achievement in high esteem; its heroes are those who have done something notable. Especially in courage and in the display of leadership on the battlefield held in the highest esteem. The military hero stands highest in the popular roll of fame. Physical powers delights the average man; and in the athletic exhibitions of the circus, the racing, the display of consummate horsemanship and so on, which are the leading features of a circus exhibition, nearly every one, young or old, takes pleasure—and a pleasure that is most certainly innocent.

Within the last half century or so, the circus in America has moved to a much higher plane than it ever before occupied. The exhibitions are unobjectionable on the score of morality; the comfort and convenience of spectators are carefully conserved; there is no more fear of meeting insult or disagreeable incidents than there is in attending a lecture or a theatrical performance. As a result the old-time prejudice against the circus as a proper amusement for all classes, ages and sexes is rapidly disappearing. The love of diversion and harmless amusement for all classes, ages and sexes is inborn in man. To forbid them is to turn counter to human nature. The Creator would not have implanted this desire for amusement in mankind were it detrimental.

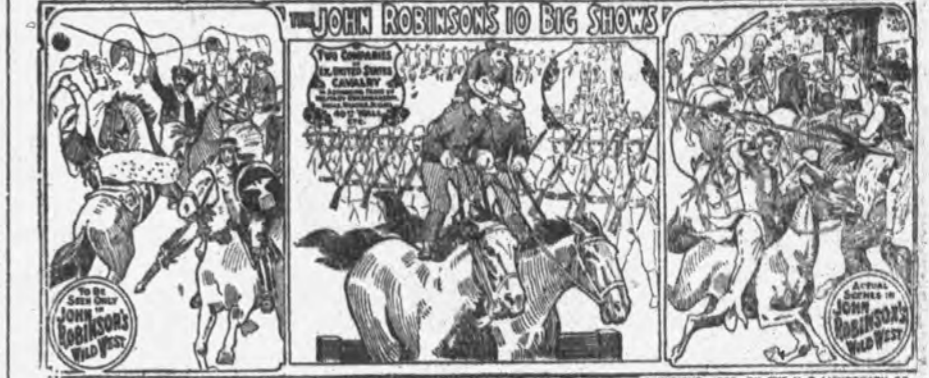
