LAY TEMPLE CORNER STONE.

High Degree Masons From All Parts of the U. S. Arriving.

WASHINGTON, D. C., Oct. 17.—WASHINGTON, Oct. 17.—High degree Masons from all parts of the United States are beginning to arrive in this city and everything is in readiness for the solemn laying of the corner-stone tomorrow of the new \$2,000,000 Scottish rite temple to be erected at 16th and S. streets, northwest. The program for the ceremony is very elaborate and the exercises will be highly impressive. Sovereign Grand Commander James D. Richardson, former member of congress from Tennessee, will deliver the opening address, after which John Russell Pope, of New York, the architect of the temple, will deliver the Masonic implements appropriate to the occasion to the grand master. The Masonic rite of laying the corner stone will be performed according to ancient usage by Grand Master J. C. Keiper, of the District of Columbia, assisted by other officers of the Grand Lodge. It is expected that nearly five thousand Scottish Rite Masons from all parts of the country will attend the ceremony.

Massachusetts W. C. T. U.

HOLYOKE, Mass., Oct. 17.—A large and enthusiastic attendance marked the opening here today of the annual convention of the Women's Christian Temperance Union of Massachusetts. Mrs. Katherine Lent Stevenson presided at the initial session this afternoon and delivered her annual address as president, which was followed by the reports of the other officers. At the succeeding sessions of the convention, which will continue until Friday, the prominent speakers will include Miss Flora R. Strout, recently from Japan and Mrs. Frances E. Beauchamp, president of the Kentucky W. C. T. U.

Monument to General Morgan.

LEXINGTON, Ky., Oct. 17.—The memory of General John H. Morgan, the noted Confederate cavalry leader, was fittingly honored here today by the unveiling of a statue erected in the court house square by the Kentucky chapters of Daughters of the Confederacy. The unveiling was attended by interesting exercises. The memorial consists of an heroic bronze equestrian statue of the famous soldier mounted upon a granite base. The statue was designed by the Italian sculptor, Homphl Coffini. The cost of the memorial was \$15,000.

Railway Bridge Builders Meet.

ST. LOUIS, Mo., Oct. 17.—The twenty-first annual meeting of the American Railway Bridge and Building Association opened here today with a large number of members, representing railroads in all parts of the United States and Canada, in attendance. Among the subjects to be considered and discussed during the three days of the session will be "Buildings and platforms for small towns," "Best Methods of fireproofing Frame and Trestle Bridges," and "Feasibility of using Brick Veneer for Station buildings."

Rear Admiral Marshall Retires.

WASHINGTON, D. C., Oct. 17.—Having reached the age limit for active service, Rear Admiral, William A. Marshall, one of the most popular and efficient officers of the navy, was placed on the retired list today by operation of law. Recently Rear Admiral Marshall has been in command of the Norfolk navy yard. The vacancy in the list of rear admirals resulting from his retirement has been filled by the promotion of Captain Frank P. Fletcher.

Indiana Red Men in Session.

INDIANAPOLIS, Ind., Oct. 17.—The Indiana Great Council of Red Men opened its annual session here today at Tomlinson hall, with a large attendance of delegates representing the lodges in nearly all sections of the state. One of the most important questions which will come up for consideration during the two days of the session will be the proposed erection of a state headquarters building of the order in this city.

CLUB WOMEN MEET.

Ohio Federation of Women's Clubs Meet in Cleveland.

CLEVELAND, O., Oct. 17.—The streets of Cleveland were crowded today with visiting club women from all parts of Ohio and the arrival of each train added to the number already in the city. The great gathering of the women, of whom nearly a thousand are expected as accredited delegates, is here for the sixteenth annual convention of the Ohio Federation of Women's Clubs. Following a reception at the Colonial Club tonight, the convention will have its formal opening tomorrow morning in the assembly room of the Hollenden Hotel. Three days will be spent in the transaction of business and in the discussion of a wide range of subjects of general interest, such as conversation, home economics, industrial and social conditions affecting women and children, library extension, art education and a loan scholarship fund. Interspersing the business sessions will be a number of features of entertainment. Mrs. Addison F. Broomhall of Troy, will preside over the sessions.

MICHIGAN BAPTISTS.

Noted Educators to Deliver Addresses During the 3 Day's Convention.

ADRIAN, Mich., Oct. 17.—The annual gathering of the Michigan Baptists which opened here today has attracted a large number of clergymen and laymen of the Baptist denomination, among them several noted educators who are scheduled to deliver addresses during the three days of convention. Among them are Dr. W. T. Stackhouse, the famous Canadian orator; Dr. George E. Horr, president of Newton Theological seminary; Dr. Milton G. Evans, president of Crozer Theological seminary, Pennsylvania; and a number of others.

INAUGURATE UNIVERSITY HEAD.

The First That Has Taken Place at the University in a Quarter of a Century

MINNEAPOLIS, Minn., Oct. 17.—At a meeting today of students, alumni and faculty of the University of Minnesota the final details of the programme were completed for the inauguration tomorrow of Dr. George E. Vincent, formerly of the University of Chicago, as president of the university. The inauguration will be the first that has taken place at the university in more than a quarter of a century and will be made the occasion of a very unusual gathering of distinguished scholars, educators and scientists from all over the United States and Canada.

Problems of City Rule Up.

DAVENPORT, Ia., Oct. 17.—Municipal problems of great variety are to be discussed by the League of Iowa Municipalities, which opened its fourteenth annual meeting here today with a large attendance of mayors and other officials of the leading cities of the state. Features of the opening session were an address of welcome by Mayor A. C. Mueller, of Davenport and the presidential address of Mayor J. R. Rector, of Waterloo. The meeting will continue until Thursday.

American Association of Title Men.

LITTLE ROCK, Ark., Oct. 17.—Delegates from the various state organizations represented in the American Association of Title Men, are gathered here in large numbers to attend the annual convention of the national organization which opened here today for a three days' session. The association was organized in Chicago in 1907, and consists of abstract of title men and employes of the title guarantee companies in all parts of the United States. After the adjournment of the business session the members of the association will visit the city of Hot Springs, as the guests of the Arkansas Land Title Association.

THE JONES CARNIVAL OPENED MONDAY

A Number of Tented Shows And Several Free Attractions.

The Johnny J. Jones Exposition shows opened their week carnival here Monday on the Williams lot, corner of Cotanch and Fifth streets. The first event to call attention to the readiness of the shows for the public was a concert in front of the post office by the splendid band with the shows. This was followed by a balloon ascension from the carnival grounds by Prof. Collins and the parachute jump. He made a successful ascension and cut loose his parachute over South Greenville, and descended on Evans street, near Ninth. He landed in a tree top, but came down to the ground without accident.

The carnival opened sure enough at night when the grounds were brilliant with hundreds of electric lights. It looked like nearly everybody in town was there, and the shows were well patronized.

There are several tented attractions. The wild animal shows have many fine specimens and the trainer does many daring things with them.

The Old Plantation affords much amusement. Dolletta, the smallest mother in the world, and her baby, (now larger than the mother) have been here before but are as much a curiosity as ever. The trained flees do many wonderful stunts and show to what extent training can go. The big snake is a real monster. The vadueville and Joy Land have many things to amuse. The merry-go-round and ferris wheel were on the go all the time.

Dare Devil Da Ralla, the one-armed high diver, jumps from the top of a 90-foot ladder into a net, a wonderful feat.

There are all kinds of booths to catch the change, from throwing balls at dolls to the candy wheel, and they all draw a crowd, and the time between is filled in with throwing confetti. Those looking for fun are finding it at the carnival grounds. Johnny Jones certainly has the best carnival that comes around.

ROSEBURG, Ore., Oct. 17.—Roseburg gave a cordial welcome today to the women gathered here from all over the state for the annual convention of the Oregon Federation of Women's clubs. A meeting of the executive board this morning was followed by a preliminary session this afternoon at which all the details of the convention program were completed. The gathering will continue over tomorrow and Thursday and will be devoted to addresses, papers, and discussions in which the brightest minds of the women of Oregon will participate.

SPRINGFIELD, Ill., Oct. 17.—Twelve hundred members of the Knights of Pythias, representing local lodges of the order throughout the state, gathered in the capital today for the forty-second annual convention of the Illinois grand lodge. The sessions will last three days and will be presided over by Grand Chancellor John B. Vaughan, of Carlinville.

CHRISTIAN TEACHING AT TRAINING SCHOOL

IMPRESSIVE Y. W. C. A. SERVICE

Pres. Wright Urges Students Work Together in Christian Harmony.

An impressive service for the recognition of new members of the Young Woman's Christian association was held in the assembly hall of the Training school on Sunday evening. Miss Minnie Best Dail, the president, had charge of the meeting.

President Wright made a talk that evinced his keen interest in the spiritual development of the students. He read a Scripture lesson, John 24:1-13, emphasizing verse 15: "And if it seems evil with you to serve the Lord, choose you this day whom ye will serve, whether the gods which your fathers served that were on the other side of the flood, or the gods of the aurorite, in whose land ye dwell: but for me and my house we will serve the Lord."

Today in this Christian land we are facing the same conditions that the Jews faced then; each individual must make his own choice. Every human being is religious in his nature and has a natural longing for good as well as for evil. This spiritual side of man must be fed as well as the physical or mental sides. In a state school conditions are such that denominational lines cannot be drawn, but there is rare opportunity for working together in Christian harmony. Christianity is stronger than any doctrine. Each Christian should be a member of some church but all should be able to work together in the full, true spirit of Christ.

He closed by saying he hoped every student would cast her lot among the Y. W. C. A. workers and would thus help develop a well rounded, noble Christian womanhood.

The music was especially fitting. There were three numbers besides the hymns: Misses Marguerite Davis and Arlene Joyner sang a duet; Miss Davis a solo, and, at the close of the service, the full school sang a chorus.

Atlantic Waterways Conference. RICHMOND, Va., Oct. 17.—Several hundred delegates, representing nearly every Atlantic Coast State, assembled in Richmond today for the opening of the fourth annual convention of the Atlantic Deeper Waterways Association. The aim of the gathering, which will continue its sessions three days, is to promote the construction, as a national enterprise, of a chain of canals connecting natural and protected waterways along the Atlantic Coast, thereby forming a continuous inner navigation route from Boston to Key West. President J. Hampson Moore of Philadelphia, is presiding over the sessions. Governor Woodrow Wilson of New Jersey is scheduled as the chief speaker.

"THIS IS MY 66th BIRTHDAY." James R. Day.

James R. Day, chancellor of Syracuse University, was born in Washington county, Maine, October 17, 1845, and received his education at Bowdoin College. He entered the Methodist ministry in 1872 and filled various pastorates in New England cities before he was called to the pulpit of Calvary Methodist Episcopal church in New York City. While he was pastor of this church, in 1893, he was elected chancellor of Syracuse University, which now has faculties numbering 250 and an enrollment of nearly 3,500 students. Dr. Day is recognized as one of the foremost educators in the country, and as a preacher he is said to have few equals in the Methodist communion. He was elected a bishop of the Methodist church in 1904, but resigned in order to continue his work at the University.
