

## THREE SEEK TO SUCCEED HOKE SMITH

### THE FIGHT LAUNCHED TODAY.

Prohibition is expected to figure prominently in the campaign.

ATLANTA, Ga., Oct. 26.—What promises to be one of the hottest fights for the governorship that Georgia has seen in years was formally launched here today when the state Democratic executive committee met to fix the date and make other arrangements for the state primaries to choose the successor of Governor Hoke Smith, who resigns next month to assume his duties as United States senator. It is generally expected that the committee will select the second week of December as the time for holding the primaries.

There are three leading candidates in the race for the governorship. They are former Governor Joseph M. Brown, former State Treasurer J. Pope Brown and Richard B. Russell, judge of the court of appeals. This is Joseph M. Brown's third race for governor. He defeated Hoke Smith for a second term in 1908, and in 1910 was defeated for a second term by Smith. His entry into the present contest has aroused the fighting blood of the Smith adherents who look on his candidacy as part of a plan of former Governor Terrell and the old machine to gain control of the Georgia Democracy and defeat Smith when he goes before the people for re-election as United States senator.

The prohibition issue is expected to figure prominently in the campaign. Judge Russell is to make the race on a local option platform, while J. Pope Brown is a supporter of the present state-wide prohibition law. Former Governor Brown straddles the prohibition question.

### TO NAME NEW BISHOPS.

The Number of Bishops is Likely to be Increased.

NEW YORK, Oct. 26.—The number of Episcopal bishops is likely to be materially increased as the result of action to be taken by the House of Episcopal Church Bishops, which met for a special session in this city today with Bishop Tuttle, of Missouri, presiding. The new bishops probably will be five or six in number. Several will be named to fill vacancies in existing missionary districts and the others will become the heads of missionary districts yet to be created. Vacancies in Japan and China are to be filled and bishops chosen for the new missionary district to embrace the Panama canal zone and for a new missionary district in South Dakota which it is proposed to create for the benefit of the Indians in that section.

### W. C. T. U. at Milwaukee.

MILWAUKEE, Wis., Oct. 26.—Hundreds of women wearing white ribbon emblems of the cause they advocate poured into Milwaukee today for the annual convention of the Woman's Christian Temperance Union, which opens here tomorrow. One of the largest gatherings at any national convention in years is expected to be on hand when the opening prayer is spoken tomorrow morning. The official board and various committees met today, disposing of some ante-convention business and completing the final details of the programme. Many of the most prominent temperance workers in the country will address the convention during its five days' session.

### Dairy Show Opens in Chicago.

CHICAGO, Ill., Oct. 26.—The sixth annual exhibition of the National Dairy Show association opened at the International Live Stock Amphitheater today, to continue until November 4. The management has worked hard to make the exhibition this year the greatest of its kind ever held and the success of their efforts is attested by the large and elaborate display of dairy animals, products and machinery.

## TALK ON HEALTH.

By President Wright to Students of Training School.

Another disease you, as teachers, should look out for is adenoids, an enlargement in the air passage of the nose. You should look out for enlarged tonsils, also. This completes the list of diseases I wish to talk to you about. It is my purpose to tell you some of the ways you may detect these physical derangements and some of the evil effects arising from them. I, of course, shall talk to you as a layman.

Every child has a right to the kind of education that will help him to develop into a useful citizen. The state owes this not only to the child, but to itself; for a state is no better than its citizenship. Each citizen is a unit in the mass of citizens that compose the population of a state. The wealth of a state is the combined wealth of its citizens. Every person who makes more than he consumes adds to the wealth of the state. Every person who consumes more than he makes, impoverishes the state to that extent. From this you see if the teacher can be instrumental in turning a non-productive agent into a productive agent, to that extent he adds to the material prosperity of the community. In other words, this work for health of children not only reduces suffering for the individual, but adds happiness to that home, and adds to the material prosperity of our people.

Each human being has born within him tendencies that if developed will make him a good and useful citizen. He also has tendencies that if not inhibited will make of him a bad and harmful citizen. It is for us to help kindle the former and quench the latter.

If the child is abused for things he can not help his disposition may be ruined. Let me sight for you a case. A little boy, I'll call him C, who could not see objects at a distance. He did not know it, for he never had seen them. He started to school. The teacher gave him tasks on the board. He could not do them. He was abused—"all manner of evil" was said against him falsely. He made no progress except toward the bad. Soon he bawn to think he was "a good-for-nothing." The young boy is high on to perdition when he begins to think of himself as "a good-for-nothing." His parents sent him off to another school. There he went from bad to worse until he began to think of himself as an outcast. He did so poorly that he was taken home almost ruined. The schools had done nothing for him but start him on the broad road that leads to destruction. One day his grandfather took the boy with him in the country. By chance, simply to have something to talk to the boy about, the old gentleman mentioned a sign near the road. The boy said "I do not see it. Where is it?" Then object after object was spoken about until the grandfather discovered that the boy had defective eyes. This little incident led to glasses and became the turning point in the boy's life, and today "C" is the leading physician in one of the towns of North Carolina.

### Mr. Joseph Shehdan Dead.

Mr. Joseph Shehdan, a Syrian merchant here, died about 9:00 o'clock this morning, at his home on College street, after an illness of several weeks. Mr. Shehdan was 33 years of age and a native of Lebanon, Syria. He came to America in 1904 and about two years ago located in Greenville where he and his two brothers, Messrs. B. and S. Shehdan, have conducted two stores. Besides these two brothers he is survived by a wife and one child who live here, and his mother in Syria.

The burial will take place at 3 o'clock Friday afternoon in Cherry Hill cemetery. A number of Syrian friends from neighboring towns are here to attend the funeral.

Noble, of this city, who was secretary of the interior under President Benjamin Harrison, reached his eightieth birthday anniversary today and was the recipient of congratulations from many friends. General Noble is a native of Ohio and a graduate of Yale. During the war he served with the third Iowa cavalry and was made brevet brigadier-general. With the exception of his service in the Harrison cabinet he has devoted nearly the whole of his time since the close of the war to his extensive law practice in this city.

Those who have not figured it out have little conception of the enormous loss sustained by the farmers individually, by the South generally, and the country, on account of the drop in the price of cotton as compared with last year. The Scottish Chief, of Maxton, in its issue of last week, presents a few figures that are eye-openers. On the same date last year the price of cotton was 14.50. The price on the day under consideration was 8.75, a difference of 5.7 cents the pound or \$28.75 per bale. The loss on the price of seed is estimated at \$5 a bale, making the total loss on a bale of cotton as compared with last year \$33.50. This, says the Chief, would mean a loss of \$670,000 on the 20,000 bales handled on the Maxton market; a loss of \$2,077,000 on the 62,000 bales raised in Robeson county, and a loss of \$23,150,000 on the 700,000 bales raised in the state. Think of the farmers of one county losing over two million in one season by depreciation in the price of cotton and a loss of \$23,000,000 in the state; then, think of the loss sustained on the cotton crop of the South! Then, remember, too, that last year the price was not unreasonably high, but was really a fair price. It's something serious and something to ponder.—Statesville Landmark.

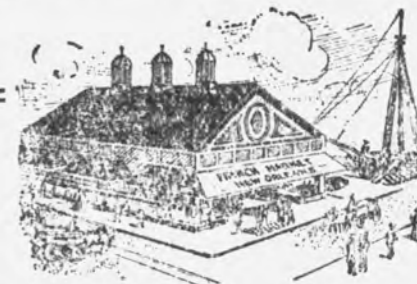
