FREIGHT WRECK AT THE JUNCTION

N. S. Train Cuts A. C. L. Train in Two

ENGINE AND TWO CARS WRECKED

While Atlantic Coast Line Train is Standing Across Junction a Heavy Norfolk Southern Freight Crashes Into It—None of Crew Injured.

About 7 o'clock Saturday night the long blowing of a steam whistle caused considerable uneasiness among the people of the town. At first some thought it was fire at one of tobacco sterneries or lumber plants but no outcry was heard. A large number went out in the direction of the blowing whistle and found that a bad wreck had occurred at the junction of the Norfolk Southern and Atlantic Coast Line railroads, just on the limits of the town, and that the noise was caused by escaping steam from a disabled engine.

Two freight trains were involved in the wreck, but the damage was mainly to one of them, the Norfolk Southern. The southbound freight of the Atlantic Coast Line had practically finished its work at the Greenville station and was doing some shunting preparatory to leaving. In this shifting it ran down the main track intending to back some cars into a siding. The train had come to a standstill with the engine and three box cars being beyond the junction, the fourth car being immediately over the cross tracks.

Just then the Norfolk Southern through freight from Raleigh, a heavy train of forty odd cars, rounded the curve west of the junction. It was so dark that this train was nearly to the junction before the engineer saw the other train standing across the track in front of him. He reversed his engine and applied brakes, but it was too late to stop short of the crossing. He and the fireman both jumped out to save themselves and escaped injury.

The Norfolk Southern train cut right through the Atlantic Coast Line train, picking up the empty box car that stood on the crossing and threw it down the embankment just beyond, smashing it almost into fragments. This was the only damage to the Atlantic Coast Line train, as the car which was struck became uncoupled and the others on both sides remained on the track.

Things went much worse with the Norfolk Southern train. The engine was badly smashed, it tore up the track and rolled over in a ditch not far from the junction. A box car loaded with cotton was thrown down the embankment and broken to pieces.

It took all night and until Sunday afternoon to get everything cleared away. Attention was first given to repairing the track in time for the early morning trains. A wrecking train with hoisting derrick came from New Bern and lifted the engine back on the track so it could be pulled to the shops at New Bern. The bales of cotton were pulled out and loaded on another car and the remnant of the two broken box cars were burned.

Throngs of people were going out all day Sunday to see the work of clearing up the wreck.

GOOD MOVEMENT.

Plan to Improve the Rural Public Schools in the State.

A movement that it is believed will result in great improvement of the rural public schools all over North Carolina is that just inaugurated by the State Department of Education, says an exchange, through S. L. Brodgen, the State supervisor of rural schools, for the organization of the county boards of education and the district school committees of each county for the study of school management and for co-operation and helpful exchange of ideas. Each county has three members of its county board of education and the number of district committees range from 200 to 3000 in the county. It is these forces that it is sought to bring into active co-operative relation. Some topics that are sought to be especially studied and impressed are: Qualifications and definite things that should be expected of the teacher in the district school; definite lines of co-operation that the school committees should extend to the school teacher; benefits of consolidation of districts and having school with two or more teachers instead of one teacher schools; lines of effort open to the school committees for the improvement of the educational advantages of the children of the district and the county. There are great opportunities to be opened up by such a movement and the highest good is expected from it.

Oates has been five times sentenced to death for the crime, but each time a new trial has been granted. Holly Van, a white man, charged with complicity in the robbery and murder of Arenoff, was hanged.

NEW ORLEANS, La. Oct. 30.—In answer to the call sent out by Governor O. B. Colquitt, of Texas, the governors of nearly all the cotton states of the South, accompanied by their commissioners of agriculture met here in conference today and discussed plans to check the downward tendency of cotton prices. Various plans were suggested, among them a plan by Theodore H. Price, the New York cotton operator, suggesting that the Southern States issue bonds for the valorization of cotton in the same manner as the Brazilian government has done with the coffee crops of that country.

MINE SAFETY DEMONSTRATION OPENS

TEACH A VALUABLE LESSON.

Tomorrow There Will be Another Demonstration.

PITTSBURG, Pa., Oct. 30.—Several thousand mine owners, superintendents and miners from all parts of the country, principally, however, from the local coal mining districts of the east and middle west, attended the opening here today of the great national mine safety demonstration, arranged under the joint auspices of the Bureau of Mines, the American Red Cross and the Pittsburgh Coal Operators' association. The demonstration, the first of its kind ever held in this country, will continue through tomorrow, and the presence of President Taft will lend additional interest to the otherwise less sensational program of the second day.

The two-days' demonstration which began today, was arranged by the newly established Bureau of Mines for the purpose to demonstrate to those actively engaged in the mining industry the dangers of certain common practices in mine work and the fallacy of the long established theories as to the cause of mine explosions. It is hoped that, by thus bringing the result of the studies and experiments of the experts of the bureau before the very eyes of the mine owners, superintendents and miners, they will be taught a valuable lesson which will have a tendency to prevent many mine disasters and loss of life.

Shortly after its establishment the Bureau of Mines acquired some coal land at Bruceston, twelve miles from Pittsburg, and there started an experimental mine for the purpose of testing various theories in regard to the cause of mine explosions. The most important of today's demonstration took place at the Bruceston mine, where in the presence of the assembled miners representing practically every mining state in the union, a mine explosion was enacted by the experts of the Bureau of Mines.

The Bureau of Mines has long been of the opinion that coal dust in a mine is a greater menace to the lives of the miners than gas and that by far the greatest majority of mine explosions is due to the ignition and explosion of coal dust by "blown-out" shots, that is blasts which do not reach the rock or coal, but blow out the packing and send a jet of flame into the mine, which causes the coal dust suspended in the air of the mine to explode. The experts of the bureau tested their theory by numerous experiments in the steel tube at the experiment station in this city and having become thoroughly convinced of the correctness of their theory, decided to convince the mine workers by an actual demonstration of the fallacy of their belief that coal dust would not explode.

The demonstration was made as realistic as it could be made under the circumstances. After the explosion foremen miners of the Bureau of Mines, equipped with various types of oxygen helmets and other "breathing apparatus" entered the mine to recover supposed victims and "First Aid" miners took charge of the pretended victims and resuscitated them. The rest of the day's program included demonstrations with safety lamps of various construction, experiments showing the danger of breaking incandescent lamps in an atmosphere saturated with coal gas or coal dust and the advantages of various new safety devices.

Home Building.

In the matter of home building and home boosting the man counts most who is interested so much in his home town that he is willing to patronize home institutions whenever he can and to lay aside his own selfish interests when they conflict in a small way with what appears for the greater public good. The knocker and the man who is void of public spirit never assist in the work of town building except as their peculiar interests or whims are served. On the other hand, there are a number of men who are ready to lend valuable service if the proper suggestion is given, as they are too modest to assume the lead where others more experienced are present. It is unjust to condemn this class before an honest attempt is made to enlist their co-operation in a boosting enterprise. The visionary and hot-air booster does better also when he has a pair of balances tied to him. It is impossible for a small town to become a New York or even an Atlanta in a single leap, and it is sometimes true that haste is better made slowly. There is a work for every citizen to do in this matter of building a home town, and it is never the right thing for a few men only to bear the brunt of the work in hand. But, by all means, lay aside petty jealousies, strive to promote the broadest harmony and create a home-pride and a home-boosting spirit in every one. It can be done where home institutions are supported and when all are pulling unitedly together.—Stanley Enterprise.

The Best of Advice.

No better advice, we believe, can be offered the people of Brunswick than to issue bonds and build good permanent highways. Other counties in and outside Virginia have taken this step. Why not Brunswick?—Brunswick Gazette.

The advice is the best possible, and is just as applicable to any and every other county in the State as it is to Brunswick. Good roads are as good an investment as any community can make; likewise, they are an asset which no community can ever hope to possess until and unless it is willing to put up the wherewithal to construct them. The latter is a fact which the Virginia counties fully realize, the better it will be for them. Improved highways cost money, and the easiest and best way to raise the money necessary for their building is to issue bonds. That is the way which several of the counties in the State are now pursuing; the others cannot be too quick to follow suit.—Virginian Pilot.

If there be such a thing as better advice than this, we are open-minded enough to want to receive it, but there is not.

And verily it is applicable alike to every county that hasn't already entered upon the task of road building; talk about "good" investment—it is next to the church and school, the best investment any county can make of its revenues. Moreover, with the exceptions aforesaid, a people can less afford to have bad roads than anything with which we are ordinarily afflicted; that isn't all, we go further to say that road building is one of the very few ways by which the rural tax payer can possibly receive an adequate return for the money he pays annually into the county treasury. With good churches, good schools and good roads, a community is quite well prepared to take good care of itself; upright living and a shot gun in the corner is a reasonably safe guaranty for most of its remaining necessities.

Coming to the point, The Times, which is not only devoted to the best interests of this county, but knows what these interests are, wants to see Northampton bonded for a sum sufficient to build a good road from Kiptopeake to the Accomac line, with cross-roads built from time to time that will facilitate easy hauling from all points to the various shipping stations along the N. Y. P. & N. and Cape Charles railroads. We advocate this for the benefit of the farmer, not for driving purposes merely, though for these there is plenty to be said. The farmer not only needs such roads, but simply can't afford, if he but knew it, to defer building them. That the carriage driver, or automobilist, if you please, will profit by them, is worse than no argument against good roads and the weapon of the narrow and inconsiderate adversary; there are, for every carriage driver, at least three carts and farm wagons, and to every automobile there are not less than forty vehicles for the local transportation of our farm products and in just that ratio, will the farmer who hasn't an automobile, or even a carriage, benefit in the excess of the automobile or carriage owner.

Our supervisors should realize and appreciate this; they owe it to their constituency to move in the matter—to omit it, is to neglect a very important element of their duty. It is nothing less than a reproach upon Northampton, that as much as our people—our representative citizenry—want and favor the building of good roads, that we are condemned, year after year, to travel the make-shifts for roads as we do. It is true, of course, that our roads are at no season, as bad as some of the roads of other parts of the State, but they are not what they should be, nor what they can be made by the application of appropriate energy.

The people should be allowed to vote on a bond issue and if they are, there'll be a bond issue and we'll have good roads. We can build them less expensive than by putting down stone roads and we should begin now, or some of us may never live to enjoy them.

Get on the job, Messrs. Supervisors, and show the world that you are alive to the wishes and necessities of your people.—Northampton (Va.) Times.

The Senatorship and Other Matters.

To the Editor: In your issue of October 7th Mr. Blue replies to Dr. Winston's letter advocating the claims for the senatorship of ex-Governor Aycock. Mr. Blue states that Mr. Kitchin is the greatest of the four aspirants for the senatorship. While we take no exception to Dr. Winston's advocacy of Governor Aycock, he would be our second choice. We are personally for Judge Clark.

But if it is true that Mr. Kitchin told the attorney general that the Federal government alone should regulate the trusts, why did he voluntarily leave the house of representatives where the trusts alone should be dealt with? Why did he seek the nomination for governor, and after having been nominated why did he traverse the state, from the Atlantic to Tennessee, pumping inflated atmosphere in abusing the trusts, telling what ought to be done with them, and what he would do if elected? We believed in Kitchin, and supported him very cordially, and hoped until after the legislature had been in session several days that he would try to do something for the relief of the people, but after his statement that the Bassett-Blow bill was as good as the Reid bill, we were convinced that we had been hoping against hope, for if every word of the Bassett-Blow bill had been written by the trusts, we are sure they could not have been better pleased.

Mr. Blue has much to say about his noble qualities, his morality, his clean life, etc., which is all very well so far as it goes, but, oh, that he had a little smattering of the material from which Woodrow Wilson was made! Then things would have been different!

It is all right for a man to be able to deliver a big speech, but he should not alone depend upon his personality, however, attractive and admirable it may be, but with it all a little business action is required.

Patrick Henry, when he made his celebrated speech, was not thinking about business at that time, but was for freedom, being fully assured that when that was obtained business would adjust itself.

As we have no recall in force in this state, what other remedy do we have except criticizing the acts of a public official without being accused of mud-throwing? We believe that the administration of Governor Kitchin is more noted for his failures to carry out pledges made to the people in regard to the tobacco trust, and pardoning criminals, than anything else. We believe that when a jury is acquainted with all the circumstances, and the judge passes sentence, that the verdict should very rarely be interfered with, except where the criminal, or new evidence has been discovered. Unfortunately lawyers when seeking a pardon, are not always as conscientious as they ought to be.

Mr. Blue seems to think that Governor Kitchin will certainly be elected. We think in that he is mistaken! We are sure there are a multitude of tobacco farmers who have been working themselves and children for the tobacco trusts for the last twenty years, who supported Mr. Kitchin for governor, who will not do so in this case, but will require something more than attractive personality. There are a great many persons who like candor and sincerity in their public officer who will not support Mr. Kitchin.

Now, farmers, I want to say a word to you. You are somewhat to blame for this state of affairs. If you would go to the conventions and assert your powers, and see that no one was nominated except such as take some interest in your welfare, things would not be as they are. The difficulty has been to a considerable extent men have been nominated for office from tobacco towns, where you sell your tobacco and spend your money, and where they are more interested in their own prosperity than they are in the farmer that is being robbed by the trusts. Even they must certainly know that if the trusts were dissolved business would take on new life, and every person would be benefited except Mr. Duke and a few others whose pocket books would not be quite so plathoric.

And while the Farmers Union is endeavoring to promote the interests of the farmer, it is to be hoped that its members will cease to vote for any man for any position who is not in favor of controlling the trusts.

Martin And Adjoining Counties to Form An Association.

To the Colored Teachers of Martin and Adjoining Counties:

The regular meeting of the Colored Teachers Association of Martin county will be held in the colored graded school building, Williamston, N. C., Saturday, November 18, 1911, from 1:30 to 4:30 p. m. An urgent appeal is made not only to every colored teacher in Martin, but adjoining counties, to attend this important session. At this meeting of the association an effort will be made to organize permanently an association of teachers representing Martin and adjoining counties. Meetings to be held annually, semi-annually or quarterly as the organization may decide.

The sole object of the organization is to form a more perfect union among the teachers in order to understand better the needs of the rural communities; to establish and maintain a higher intellectual and moral standard.

There can be no question that the future of the race, especially in the rural districts, depends upon those who go among them as teachers. They look upon the teacher as a leader of thought, and it is of the highest importance that his life be a worthy example, not only for the student body, but the entire community. He should not only be capable intellectually, but his moral fitness should be beyond reproach. His ambition should not be merely for what he can get out of the community, but the services he may be able to render his people. Not an effort to convince them of his greatness, or superiority, or shrewdness, but of his goodness and earnest desire to raise the masses to a higher plane of living.

In several communities may be found those who are groping in ignorance and superstition, who have become easy prey to degrading notions, their very souls perishing for the want of proper training and leadership. It is the duty of the teacher to put on the armor of right living and go among them and supply their long felt need. To teach them that, wherever they are, they may find salvation about them only by living honorable lives, and contributing their very best to whatever their hands find to do. And above all, by cultivating the art of peace and harmony with the next door neighbor.
