WHAT THE COUNTY FATHERS DID

Accounts Allowed, Reports and Collections of Officers, Jury List.

The board of county commissioners were in regular monthly session the 6th and 7th, all the members being present.

The following aggregate sums were paid in orders on the treasurer: For paupers, \$243.40; superintendent health, \$62.50; hookworm dispensaries, \$147.38; donation to Pitt county fair, \$50; county home, \$189.23; smallpox, \$4.25; court house, \$3-313.76; jail, \$158.45; constables, \$35.60; juries, \$29; board of health, \$8; printing and stationery supplies, \$145.25; Superior court, \$3.45; register of deeds, \$10.80; sheriff, \$19.40; commissioners, \$10.25; salaries: clerk, \$250; register of deeds, \$250; treasurer, \$200; sheriff, \$333.33; postage, \$5.77; general roads, \$112.60; Contentnea roads, \$16.26; Chicod roads, \$274.67; Falkland roads, \$5.68; Pactus roads, \$167.48; Swift creek roads, \$27.98.

The several officers presented their reports for the month. The collections were as follows: Sheriff, \$43.30; register of deeds, \$621.10; clerk, \$266.91.

DOCTOR FOR LORD MAYOR.

The New Lord Mayor Has Passed His Eightieth Year.

LONDON, Nov. 9.—The time-honored Lord Mayor's show took place today, and the new lord mayor of London, Sir Thomas Boor Crosby, was formally installed in office, succeeding Sir Thomas Vessey Strong. Immense crowds lined the streets of Cripplegate, Langhourn, and other sections of the metropolis through which the procession passed. The military display was the chief feature of the procession. The Territorial forces were better represented than ever before and were received with hearty demonstrations on the part of the crowds. The Boy Scouts took part in the pageant, together with the usual contingents of the city companies, with their banners and beades and old world paraphernalia.

The new lord mayor is a native of Lincolnshire and has passed his eightieth year. He is probably one of the oldest, if not actually the oldest, citizens who has ever filled the office of lord mayor of London. He is undoubtedly the first medical man who has been appointed, which may be considered remarkable, in view of the fact that his term will be the 73rd mayoralty of the city. For many years Sir Thomas has been recognized as one of London's foremost physicians. In politics he is a Conservative. As he is a widower, his daughter, Miss Crosby, is to be the lady mayoress.

LEWIS HEARING IN ST. LOUIS.

The Financial "Wizard" of The Country.

ST. LOUIS, Mo., Nov. 9.—The house committee on expenditures in the post office department, of which Congressman Ashbrook, of Ohio, is chairman, came to St. Louis today to resume the investigation begun in Washington last summer of the charge of E. G. Lewis that officials of the postal service were in a conspiracy to ruin him.

Lewis is the financial "wizard" whose alleged get-rich-quick schemes have bothered the authorities for several years and incidentally have caused several men prominent in public life to regret their acquaintance with him. Starting some ten years ago with capital about equal to the price of a box of cigars, Lewis organized the American Woman's League, which he subsequently employed as a medium to promote innumerable enterprises, including weekly and daily newspapers, co-operative colonies, banks, and realty and development companies. In the promotion of his schemes he is said to have drawn nearly \$10,000,000 from the purses of women throughout the country. When the government closed down on him and returned an indictment on charges of using the mails to defraud, Lewis retaliated by bringing charges of conspiracy against officials of the post office department. In the present investigation he is represented as attorney by Edwin C. Madden, former third assistant postmaster-general.

LINCOLN MEMORIAL DEDICATED.

Corner-stone Laid by President Roosevelt.

HODGENVILLE, Ky., Nov. 9.—The movement inaugurated five years ago by Robert J. Collier, of New York, for the erection of a suitable memorial to Abraham Lincoln at the place of his birth is now an accomplished fact. Today, in the presence of a gathering in which Mason and Dixon's line was obliterated, impressive exercises were held in dedication of the magnificent memorial structure surrounding and covering the old log cabin in which Abraham Lincoln was born, February 12, 1809.

The corner-stone for the memorial structure was laid by President Roosevelt on the centennial anniversary of Lincoln's birth two years ago last February. At the dedication today President Taft was the central figure. The exercises were held at the Thomas Lincoln farm, which was purchased by the Lincoln Farm association several years ago with a fund raised by popular subscription. After acquiring the property the association proceeded with the erection of the memorial building to protect for all time the lowly cabin in which the martyr president was born. The memorial stands on a slight elevation where stood the original Lincoln homestead. Some years ago the cabin was removed for exhibition purposes, but was restored to its original site when it came into possession of the Lincoln Farm association.

The memorial building is an imposing structure of white stone. It is of classic design, with giant pillars ornamenting the front and two sides. The entrance is approached by a broad flight of terraced steps.

Considering the fact that the Civil war, of which Lincoln himself was the central figure, was fought out only half a century ago, it is regarded as of especial significance that the dedication of a memorial in his honor should be an event of such distinct national interest and national proportions.

The dedication exercises were of a simple but very impressive character. In addition to President Taft the speakers and prominent participants included Henry Waterson, who delivered one of the principal orations; Governor Augustus E. Wilson, representing the state of Kentucky, and Robert J. Collier, who inaugurated the Lincoln Farm movement.

Dedicate Bay State Monuments.

BOSTON, Mass., Nov. 9.—Headed by Governor Foss, a large delegation of members of the Grand Army and of patriotic societies left Boston this afternoon for the South to attend the dedication next week of the monuments erected by the state of Massachusetts on the battlefield of Patersburg, and at Valley Forge, Virginia.

Leroy Percy.

United States Senator Percy, of Mississippi, who was defeated in the recent primary by ex-Governor Vandaman, was born in Washington county, Mississippi, November 9, 1861. He was graduated from the University of the South and also from the law department of the University of Virginia. His post-graduate course was at Princeton University. Mr. Percy then returned to Greenville and engaged in the practice of law in connection with themanagement of extensive land interests. Since early manhood he has taken active interest in the political affairs of his native state, although he never held public office until his election by the legislature last year as United States senator to fill the unexpired term of the late Senator A. J. McLaurin.

MISSOURI STATE TEACHERS

Assemble for Their Annual State Convention.

HANNIBAL, Mo., Nov. 9.—Hannibal capitulated today to an army of teachers who invaded the city from every direction for the annual convention of the Missouri State association. The visitors will remain in the city until the end of the week. The program provides for general sessions each morning and evening, with numerous department conferences in the afternoons. Dr. John W. Withers, of St. Louis is presiding and among the distinguished educators on the programme for address are President A. Ross Hill, of the University of Missouri; Prof. Frank McMurry, of Columbia University; Prof. Charles H. Judd, of the University of Chicago; Prof. L. H. Bailey, of Cornell University; Prof. W. C. Bagley, of the University of Illinois, and John S. Collins, assistant superintendent of instruction of St. Louis.

Leading Educators Present.

MILWAUKEE, Wis., Nov. 9.—The fifty-ninth annual convention of the Wisconsin Teachers association opened in the auditorium today for a 3 days' session. There are a large number of visiting teachers in the city and a profitable meeting is expected. Among the distinguished educators scheduled to address the association are President David Starr Jordan, of Leland Stanford University; Sarah Louise Arnold, of Boston; Dean L. H. Bailey, of Cornell University.

ELECTIONS IN SEVERAL STATES TUESDAY

HONORS ABOUT EQUALLY DIVIDED

Democrats Gain In Some States And Republicans In Others.

On Tuesday elections were held in several states, and a synopsis of the result is given below:

Massachusetts.

The Democrats won the state election and kept Massachusetts in the party column by continuing Gov. Eugene Foss in office for a second term. The complete returns gave Foss, Democrat, 210,622; Frothingham, Republican, 202,888. Foss' plurality was 7,734.

Maryland.

Thirty-nine precincts in Baltimore out of 321 gave: Goldsborough, Republican for governor, 4,473; Gorman, 3,081. Of the counties heard from the Republicans have carried Caroline and Carroll which four years ago gave Crothers, Democrat, for governor a majority. Compared with the vote of four years ago the Republicans have increased their majorities in the Republican counties and have made gains in the Democratic counties.

New Mexico.

Bursum, Republican, and McDonald, Democrat, for governor, both claim election on meagre early returns.

New York.

Tammany Hall's head on New York city was shaken in a battle of the ballots in which local offices were mainly at stake. The Democrats successfully defended their ancient strongholds of Manhattan and the Bronx, but by greatly reduced plurality. From a Democratic majority of 24 the state legislature turned overwhelmingly Republican.

New Jersey.

Returns indicate that the Republicans will control both branches of the legislature.

Virginia.

Democrats will have a majority of about 110 votes on the joint assembly which consists of 140 members.

Mississippi.

Democrats carried the state as usual, but the Social candidate for lieutenant governor polled a large vote.

Rhode Island.

The returns indicate a general Republican victory in the state.

Missouri.

Democrats gained a congressman in the second district by a majority of 1,200.

Pennsylvania.

There was little interest in this state except for municipal offices.

Illinois.

Democrats elect seven out of nine judges in Chicago.

Ohio.

Democrats made almost a clean sweep of the cities of Columbus, Cleveland and Cincinnati.

Kentucky.

This state came back to the Democratic column with a regular landslide.

Teachers Meet in Topeka.

TOPEKA, Kas., Nov. 9.—The school teachers of Kansas, nearly one thousand in number, rounded up in Topeka today for the annual convention of their state association. The sessions will continue two days and will have Brander Matthews, of New York, and other noted educators and scholars among the speakers.

The outlook is bright in Texas for a great free-for-all race for the seat of Joseph W. Bailey in the United States senate. Five candidates are already announced and several more entries are regarded as certain. Two representatives in congress, Morris Sheppard, of the first district and Choice B. Bandell, of the fourth district, are among the prominent aspirants for the toga.

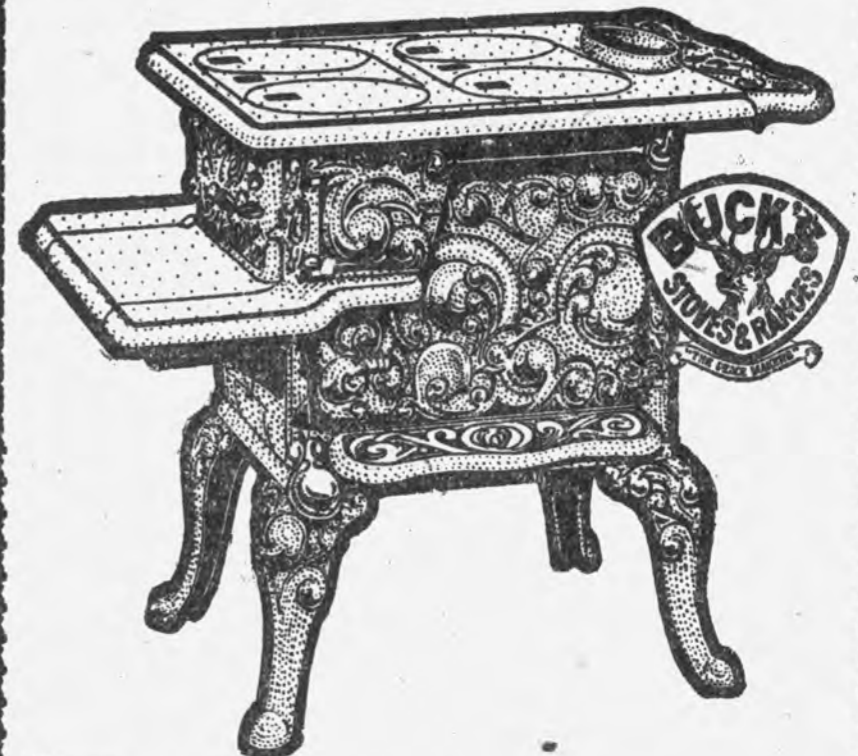

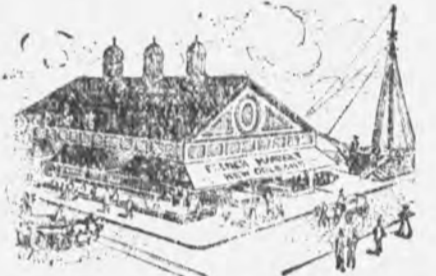

THE PRICE OF COTTON AND THE POLITICAL SITUATION.

Significant Relation Between Tariff Activity and Losses of Cotton Growers Arouses the South.

In the appointment of a delegation of cotton growers at the North Carolina state fair recently, with instructions to attend the meeting in New Orleans having for its purpose the holding by farmers and others of a considerable proportion of this year's cotton crop and the curtailment of next year's acreage, is to be found one of many indications of dissatisfaction existing over the present political relationship to the price of cotton.

It is said that President Taft's reciprocity campaign and the Underwood tariff bills not only adversely affected general business during the year 1911, but specifically caused the cotton manufacturers to lose, by shrinkage and decreased volume of trade, between \$50,000,000 and \$100,000,000.

Crippled and with a prospect of more tariff agitation in 1912, cotton manufacturers have naturally been unable to make purchases of cotton in the usual way, with the result that, with a full crop, political agitation has created a decline in the price of the staple thus far from 14 cents per pound to 9 cents per pound, with many predictions from well posted quarters that a much lower range will be experienced.

It is further claimed that without the extra session for the discussion of reciprocity the Underwood tariff measures would not have been introduced and in consequence there would have been but little probability that cotton would have declined under the force of a full crop lower than 11 cents per pound instead of registering in price the low water mark for years, as it does today.

The farmers in the south and the manufacturers of cotton generally are charging up a loss on this year's crop of not less than \$175,000,000, which loss they claim is directly traceable to political influence.

Another Panama Trip.

NEW YORK, Nov. 8.—Nearly a score of members of the committee on appropriations of the house of representatives, departed today on a three weeks' jaunt to Panama and Cuba. At the Isthmus the congressmen will inspect the progress of work on the canal and fortifications. On the way home they will stop at Havana with a view to determining the advisability of further appropriations to raise the wreck of the Maine.
