## ATTEMPT TO ROB BANK OF AYDEN

Proves Unsuccessful to Would-be Cracksman

### IMPRISON A CITIZEN IN A BOX CAR

Inexperience and a Good Safe Saves The Bank From a "Run"—Everything Going on as Usual Today in Our Neighboring Town.

AYDEN, N. C., Nov. 18.—(Special to The Daily Reflector).—A safe is a safe when it is in Ayden and is attacked by would-be-cracksmen, unskilled in the art of breaking up things. At 1 o'clock this morning one of Ayden's citizens was hurrying in search of medical aid for his sick child. As he was about to pass in front of the bank on the opposite side of the street, a white Raffles held him up to the point of a revolver and upon the arrival of a pal, also white, this citizen, Mr. W. M. Forrest, was securely bound and thrust beneath some sheltering place, and still guarded by the first highwayman he heard a little later three successive explosions that seemed to have its origin within the bank. "The door is off now," was his guardian's comment and then Mr. Forrest was sure that something was being done at the bank.

A little later the second robber appeared at the shelter and with the co-operation of the first one Mr. Forrest was unwillingly led to the railroad station and confined to a box car and had the door closed on him. The robbers evidently thought that the shelter was too near the bank and by taking their victim to a more distant place of seclusion they expected to give themselves more time for a "get away."

Mr. Forrest's protracted absence created some misgivings in his family and pretty soon a searching party in which about fifty Ayden citizens joined got busy. Their search led them to the railroad tracks and in passing some freighters they heard Mr. Forrest's voice from within the box car. His escape followed a tour of inspection of the bank. Here it seems that the safe-crackers had made use of nitro-glycerine to lay hold of the safe's contents, but beyond slight damage to the door, the safe or contents were as when the cashier left them yesterday afternoon.

That the robbers were "green" is evidenced first by their unsuccessful attempt to blow the safe open and secondly because the tools used were "borrowed" (without license of course) from the blacksmith shop of Mr. Tripp. Cracker-jack safe-crackers usually have their own kit of highly tempered tools and usually crack their safe.

Beyond a little nervous discomfort to Mr. Forrest and a slight damage to the bank's safe, Ayden is today much like yesterday.

#### Depositors Protected.

The safe and contents of the Bank of Ayden were protected by a "Burglary policy" in the Maryland Casualty Co. Had the attempted burglars been successful, the amount of loss would have been paid back into the bank in less than three days, as has always been the custom of the company in losses of this kind.

## MURDER TRIAL OF WIDE INTEREST

PATTERSON CASE IN COLORADO.

To be Tried for the Murder of Her Husband.

DENVER, Colo., Nov. 18.—Great interest is manifested here in the case of Mrs. Gertrude G. Patterson, the opening of whose trail upon the charge of having murdered her husband, Charles A. Patterson on September 25 last, is set for next Monday, in the Criminal court of this city. Both the State and defense are reported to be ready for trial and it is expected that the proceedings will be unusually interesting and sensational.

The tragical death of Charles A. Patterson, formerly a promising young man with a bright mind and a fine athletic record, but, at the time of his death a physical wreck suffering from tuberculosis, was the culmination of several years of misery owing to domestic infelicity. Patterson came from a good family. His mother is the principal of one of Chicago's public schools and his brother, Harry S. Patterson, is one of the counsel for the International Harvester Company.

Charles A. Patterson was a high-school student in 1907 and stood well in his studies besides being one of the crack athletes of the school. While roller-racing in the winter of that year, when he won the championship of Illinois, Charles became acquainted with Gertrude Gibson, a handsome and attractive girl of a few years older than he. It seemed to be a case of mutual love at the first sight, although later events had a strong tendency to make this match appear in a somewhat different light. It was the girl who proposed marriage and the boy was only too willing to accept the proposal. They were married in Chicago in 1908 and for a while seemed to live happily in a handsomely furnished flat on the south side.

The marital happiness, however, did not last long. Confessions which his young wife was said to have made to him concerning her former relations to Emil W. Strouss, head of the firm of Strouss, Eisendrath and Company, clothing manufacturers in Chicago, changed young Patterson's life from happiness to misery. He began to suspect that his wife, although she had tried to minimize her guilt in her confessions and had asserted that she had completely severed her relations with Strouss, was not true to him, but continued her intercourse with Strouss and received money from the latter.

Only a few months after her marriage to Patterson Gertrude Patterson left her home and went to Europe, where, it is said, she traveled several months with Mr. Strouss. During her absence Patterson had an attack of pneumonia, which left him an invalid, suffering from tuberculosis. He was not a strong character and though knowing his wife's past and realizing he had an ample cause for jealousy, he continued to love her and would have willingly pardoned all her past offences, had she reformed and remained true to him. Partly on account of his physical condition, partly because of the unrest and unhappiness which poisoned his life the young man, who was only twenty-six years of age, was unable to work and his mother and his brother supported him.

When Gertrude Patterson returned from Europe, her husband took her back and for a while peace seemed to be reigning in their house. Patterson's health, however, failed so rapidly that he went to Denver, accompanied by his wife. The change of climate only temporarily benefited Patterson's condition. After six or seven months he became so ill that he entered a sanitarium for consumptives. His wife, on September 10 filed a suit for divorce against him in Denver, charging cruelty and about a week later Patterson filed a suit against Strouss, asking \$25,000 damages for alienating his wife's affections.

On the afternoon of September 25 last Mrs. Patterson called at the sanitarium and asked for an interview with her husband, hoping to induce him to withdraw his suit against Strouss. They took a walk in the suburb of Montclair and during an altercation Mrs. Patterson it is charged, shot and killed her husband with a revolver, firing two bullets in his back. #### OPIUM CONFERENCE.

### International Opium Conference to be Held Next Month.

NEW YORK, Nov. 18.—Among the passengers sailing for Europe today on the steamship Lapland were several members of the United States delegation to the international opium congress which is to be held at The Hague next month. The party included Dr. Hamilton Wright of Maine and Henry J. Finger of California, who have been appointed delegates, together with the secretary, Frederic L. Huidekoper, and the assistant secretary, Wallace J. Young. Bishop Brent, the chairman of the delegation, is now en route to The Hague from the Philippines. The purpose of the conference, which will be attended by representatives of the leading nations, is to give effect to the resolutions of the international opium commission, which met in Shanghai two years ago and to endeavor to secure an agreement upon uniform national laws and regulations to control the production, manufacture and distribution of opium, its derivatives and preparations.

## NEWS FORECAST FOR THE COMING WEEK

PACKERS TO BE ARRAIGNED.

Steel Trust Investigating Committee To Resume Hearing Monday.

WASHINGTON, D. C., Nov. 18.—J. Ogden Armour and a dozen other of the great Chicago packers are to be arraigned in the United States District Court in Chicago Monday for trial on indictments alleging violations of the Sherman anti-trust act in the alleged maintenance of an "unreasonable" conspiracy to restrain the meat industry of the country. The Federal government has spent eight years in its investigation of the alleged "beef trust" and an endeavor to bring the principals to the bar.

The so-called Steel Trust Investigating Committee of the House of Representatives is to resume its hearing in Washington Monday. It is expected the first inquiry will be directed toward the rates charged for the transportation of ore by the steel trust roads in Minnesota. J. Piermont Morgan and Andrew Carnegie are scheduled to appear before the committee and their testimony is awaited with keen anticipation.

Interest in the work of the Interstate Commerce Commission is expected to center in the proposed investigation into the business of the express companies. The first hearing is to be held in New York Wednesday. The express companies have shown some disposition to oppose the investigation and it is not expected that any information will be gained in the matter except as the result of a strenuous fight.

The "Underwood for President" boom probably will be heard from during the week. In Birmingham a big banquet is to be given Thursday night in honor of the minority leader in the House. The affair has been arranged by the Democrats of Alabama and will be attended by prominent party leaders from all over the South.

The annual football game between the eleven of the West Point and Annapolis academies will be played in Philadelphia Saturday and will be made an occasion for the usual large and brilliant gathering of army and navy officials, public officials and society folk.

Currency reform will be the all-absorbing topic for discussion at the annual convention of the American Banker's Association, which will assemble in New Orleans Tuesday and continue in session through the greater part of the week.

Other conventions of the week will include the National Road Congress in Richmond, Va., and the annual meeting of the Mississippi-to-Atlantic Inland Waterway Association, in Montgomery, Ala.

A number of notable men and women are to observe their birthday anniversaries during the week. Sir Wilfred Laurier's seventieth birthday, on Monday, will be fittingly marked by the Liberal members of the Dominion parliament. Hetty Green, the "world's richest woman," will attain her seventy-sixth year Tuesday and four days later Andrew Carnegie, who has just given further evidence of his desire to die poor by donating an additional \$25,000,000 for educational purposes, will enter upon his seventy-fifth year.

Some of Charlotte's star gazers have become somewhat excited over the appearance of Venus in the day time.

We beg to disagree with those brethren who are of the opinion that the "Beautiful Isle of Somewhere" is no song at all. To our ear it sounds quite pretty.

Arch Joyner, of the Greensboro News staff, dropped in on The Reflector man while here Friday, and as one of the inducements held out for our attending the Printers' Cost Congress that meets in Greensboro Wednesday and Thursday, said that Bob Phillips was going to serve pie in the News office. That is tempting, for sure, and being as how the weather is cold we suppose Bob will have the pies kivered.

We have received from the publisher, Rev. Hight C. Moore, editor of the Biblical Recorder, a copy of the Baptist Year Book for 1912. The book contains a great fund of history and statistics that is of especial interest to the Baptist people of North Carolina. Among other things that the book tells about, is the organization of the Baptist State Convention in Greenville in 1830. It also has good photographs of some of the pioneer preachers of this state, as well as some of the most noted leaders of the denomination who are now living.

How Manure Is Wasted.

The waste of stable manure in this country is one of the most inexcusable of our many extravagances. During the past spring the writer observed a lot of stable manure hauled out from the stables and dumped in a pile on a hillside where all drainage from it passed into the road or into a nearby ditch. For weeks this manure laid there and fermented and leached. It was finally spread on the very field on the edge of which it was piled. This field had on it a growing crop of oats—an ideal place for the application of stable manure. After it had lost anywhere from one-fourth to one-half its plant foods value this manure was again put on wagons and spread over this field. What were the losses in this transaction?

1. The escape of nitrogen into the air from fermentation and the loss of a large part of the total plant foods is contained from leaching.

2. The unloading of the manure, reloading, and hauling it on the land, instead of spreading direct on the land with the manure spreader, when it was first handled from the stables. Any man knows better than to handle stable manure in that way.

We know that we waste half the value of our stable manure from lack of proper management. We also know that our lands need stable manure more than anything else, and yet we make little effort to save and properly use the stable manure made. It has been ignored so long that the habit has become fixed. If there is a by-product on the farm worth hard dollars and cents to us, it is the stable manure. It increases the yields of all our crops on all our soils, and why we do not prize it more highly, or at least prize it sufficient to save and utilize it to the best possible advantage, passes all human understanding.—The Progressive Farmer.

North Carolina Leads.

During the present year \$44,000,000 has been expended in the construction and improvement of public roads in the Southern States. North Carolina leads in this work as it leads in every other good work. Texas is placed first by the secretary of agriculture; but Texas is as big as all out of doors and \$7,600,000 for a state that is more than five times the size of North Carolina is not as much in proportion as \$4,505,000 for this grand old state. Even Virginia is doing better than Texas; for Texas is more than six times larger than Virginia which has invested in good roads construction and improvement during the last year \$4,004,000. At the North Carolina rate of improvement, Texas should have expended this year more than \$21,000,000 on its public roads, and the American army which manoeuvred on the Mexican frontier not long ago would testify to a man that something like that sum could be expended with advantage down in the San Antonio country.

Every dollar that is spent on good roads is a dollar invested for the benefit of the people. The mud tax costs this country annually at least a hundred million dollars, in wasted time, in broken vehicles, in inefficient service. Much has been accomplished; but the work has hardly begun, and it will not be finished until there is a network of good roads reaching from one end of the country to the other, and from the rising of the sun to the going down of the same. Good roads mean better living for the people, better school facilities, easier ways to markets and the saving of millions of dollars every year and year after year.

The Congress of the National Highways Association in Richmond next week, beginning on Monday and lasting three days, is the first concerted effort at national co-operation in this work. The next convention of this association should be held in Charlotte, the home of the good roads movement in the South, and it is hoped that the delegates from this city and the state will be instructed by the authorities to bring the convention here. Charlotte would be nearer even than Richmond to the centre of the country in which the good roads propaganda should be pressed, and Charlotte could take care of the convention in an altogether delightful way. Vote for Charlotte.—Charlotte Observer.

**"THIS IS MY 48th BIRTHDAY,"**  
 William A. Sunday.

Rev. William A. Sunday, the noted evangelist who is familiarly known as "Billy" Sunday, was born in Ames, Iowa, Nov. 19, 1863. After graduating from the high school in Nevada, Iowa, he attended Northwestern University. While a student at the university he developed a strong liking for athletics. His ability as a baseball player on the college team attracted attention and he was induced to become a professional player. For seven years he was a member of the Chicago, Pittsburg or Philadelphia clubs in the National League and was one of the best players in the entire country. When he quit baseball in 1890 it was to become secretary of Y. M. C. A. of Chicago. This position he held for several years and then embarked on his career as an evangelist. His vigorous appeals and his oftentimes sensational utterances attracted immense audiences and in recent years he is credited with having received 100,000 conversions. In 1903 Mr. Sunday was ordained a Presbyterian minister.

## NORTH CAROLINA DAY IN SCHOOLS

**PROGRAM ISSUED IN BOOK FORM**  
 Friday, Dec. 22nd, Will be Celebrated by Schools of State.

A very attractive booklet containing the program of exercises for North Carolina Day has been issued by the state department of education. It will be celebrated by the schools throughout the state on Friday, December 22.

The booklet is prepared by Mr. R. D. W. Connor, secretary of the North Carolina Historical Commission. It contains an address on "The Old North State," delivered by Charles B. Aycock at the first North Carolina Reunion at Greensboro, October 12, 1903, as well as some valuable history in names of counties of the state.

The booklet closes with a letter on "The Sir Walter Raleigh Statue" by Gen. Julian S. Carr, to the school children, school officers and teachers in North Carolina.

In the preface J. Y. Joyner, superintendent of public instruction, says: "As many of the schools are not in session as early as October 12, I have taken the liberty allowed under the law of fixing the date of North Carolina day this year and thereafter on the last Friday before Christmas. It is earnestly desired that all the public schools of the state shall engage in this celebration on the same day. This pamphlet has been prepared and sent out to aid busy teachers in the proper celebration of the day and to leave no excuse for failing to celebrate it."

Superintendent Joyner says further regarding the program: "Following the chronological order of the state's history, the subjects of the North Carolina day programs have been as follows: In 1901, the first Anglo-Saxon settlement in America; in 1902, the Albemarle section; in 1903, the lower Cape Fear settlement; in 1904, the Pamlico section; in 1905, the upper Cape Fear section; in 1907, the Scotch-Irish settlement in North Carolina; in 1908, the German settlement. In 1906 it was deemed proper to turn aside from this adopted plan of chronological study to devote the day to the study of the life, character, and splendid service of Dr. Charles D. McIver. In 1900 the mountainous section formed the subject of study. Thus the history to every section of the state has been studied, somewhat in the order of their settlement and development, and the entire period of the state's history this year to stimulate a study of local and county history and the biographies of the state's eminent men.

"These programs," continues Superintendent Joyner, "have been arranged with a view of giving the

children of the rising generation a knowledge of the history of the resources, manners, customs and ways of making a living of the different sections of the state. It is hoped in this way to awaken a proper pride in the history of the state, to inspire a proper confidence in its present and hope in its future, and to give the people of the different sections of the state a better acquaintance with each other."—Raleigh Ties.

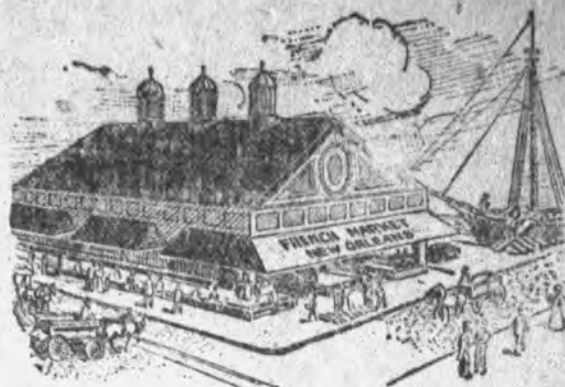
