MR. JOHNSON AT TRAINING SCHOOL

Editor of Charity and Children Delivers
Splendid Lecture

"THE CHILD OF TOMORROW"

An Important Individual That Deserves Careful Consideration—Comments the School Here in Its Work of Training Teachers for the Children.

The first of a series of lectures was delivered at the Training school Monday evening by Mr. Archibald Johnson, editor of Charity and Children. President Wright announced that the second in the series would be heard on Monday evening, the 4th of December, and would be given by Dr. Smith, president of Davidson college.

In a few well chosen and appropriate words, President Wright then introduced Mr. Johnson to the audience, announcing as his subject for the evening "The Child of Tomorrow."

Mr. Johnson belongs to that class of men who think before they speak, and therefore always have something to give which is worth hearing. This was clearly demonstrated Monday evening. He expressed himself as pleased at the opportunity of being here and seeing for himself what was going on, and was glad that he came. After other pleasing remarks Mr. Johnson said in part:

The child of tomorrow is an important individual and deserves our careful consideration. The world is coming to appreciate childhood. This has not always been true, even the architecture of the past by its high mantles, door knobs, etc., shows that only grown people were once considered. Let us therefore hope:

1. That the child of tomorrow will be a child. We do not need that children should be little men and little women. There are no little men and little women. It is a travesty on life that we should try to make them such. Every child ought to be free to be a child. Our appreciation of what childhood is, is now being shown by the fact that some of our ablest men are employed to make papers for children, and some of our best authors now are those who write books for children. Blessings upon mothers who know how to raise children and not have to do so with and by set rules. My purpose in speaking to you thus about children is to deepen your obligations as teachers.

2. Let the child of tomorrow have a chance. The poor child without a chance has not properly been emphasized. The child of the woods has been neglected. Our state is woefully neglecting them now with its present policy of education. One way to remedy this is give them more money. Let your influence be to get larger appropriations for the common school. I am glad to come here and have a true conception of what you are doing. I can frankly say, as far as it goes, you have the best plant in the state. You need some other things. You ought to have them. I find here a determination to keep this a training school, that this is to be its purpose. I am glad of this and I say, when you are doing this you have no rival in the state. You stand alone in a great field of harvest, and your future is bright. I would that you could turn out five hundred trained teachers each year. It takes teachers to get better advantages for the boys in the woods and we need the best talent there, but I do not blame you for not going there to teach at twenty dollars per month. We must have more money for these schools so that we can get this talent.

3. The child of tomorrow must have a mother. All great moral forces are dependent upon great mothers. All great men have had great mothers. Behind every great action you can see a great mother. Mothers we must have.

4. The child of tomorrow must have a teacher. I wonder how you all feel about this proposition. I wonder if you all feel that the teacher, the true teacher, is divinely called? I believe this, and that in importance and influence it is second only to the ministry. If you do not thus feel about it you will fall out of the work along the way.

A teacher must be (1): Consecrated. This makes the work grow on you for lectures.

PORTRAIT OF GOV. SMITH PRESENTED TO STATE

Y. M. C. A. WORK AT UNIVERSITY.

College Glee Club Getting in Readiness for the Season.

CHAPEL HILL, N. C., Nov. 21.—The North Carolina Society Sons of the Revolution presented to the state last week the portrait of Benjamin Smith, governor of the state in 1810 and 1811; Grand Master of the Masons; a progressive man who a hundred years ago was an earnest advocate of public schools and highways. The speech of presentation was made by Professor Collier Cobb, of the chair of geology in the University of North Carolina. Professor Cobb made a most scholarly address upon this occasion. He sketched the life of Governor Smith and showed how great service he had rendered the state.

The Historical society of the University met last Monday night in Chemistry hall and was entertained by Professor Noble with a lantern slide exhibition. Professor Noble showed the pictures of Indians and Indian life drawn by John White, and aside from their value as evidence of colonial art, these pictures are valuable because they are true delineations of the American Indian.

A large squad of candidates for the Glee club have been practicing during the last few weeks. The process of elimination has now been applied, however, and the real work of the season will be begun. Fivemen have been chosen for each of the four parts. Practice continues two nights every week so that the voices will be in trim for the first concert which is to be given during the fall dances. Those who passed the first degree were: First tenor—Smith, Norman, Stubbs, Pember, Hunter. Second tenor—Barbee, Bracket, Gattis, Shofner, Bradsher. First bass—Brown, Payne, Worth, Covington, Rights. Second bass—Stroud, Stroupe, Sawyer, Yelverton, Lassiter.

An important branch of the Y. M. C. A. work here is the neighborhood work. In the vicinity of Chapel Hill there are eight Sunday schools in which a number of the students, sent out by the Y. M. C. A. take an active part. Some students act as superintendents, and some as teachers. There are about twenty students engaged in this work and the attendance of the schools is over three hundred. Both the rural communities and the students are benefited by these schools. The people living in the county are brought into closer touch with the University, while the students are aided in their own development by the careful study and teaching of the Sunday school topics.

(2). The teacher must be earnest. She must make the moments count. You are the shapers of human destiny, the moulders of human character. Yet it is said that of those engaged in this great work only 33 1-3 per cent have had any training for it. This is a travesty upon teaching. Oh! for more trained, prepared teachers.

(3). The teacher must be strong in character, in womanhood. Money enters here again. We ought to have it to get teachers thus equipped, but teachers, for the present you must also be missionaries and go in the spirit of the great teacher, making sacrifices for the good of others. The children are crying for you. The country boy is worth looking after. Most of our great men have come from the hills.

In conclusion, there is one other thing you ought to feel called to do, that is to live, to work and to die in North Carolina. We need to be loyal. We have a great State. It needs you. It furnishes opportunities for you. Let's devote our best to redeem our own folks here in our own State.

This splendid address was much enjoyed and will live in the memory of those who heard it. Such plain, practical talks always bring results. The singing of the pupils was much enjoyed and is always a pleasing feature of these evenings set apart for lectures.

SUING AGAIN.

Laura Biggar Brings Suit Against the Estate of Henry Bennett.

JERSEY CITY, N. J., Nov. 20.—A suit brought by Laura Biggar, the former actress, for an accounting of the estate of Henry Bennett was called today before Vice-Chancellor Garrison. Bennett, who was a prominent theatrical manager in Pittsburgh, died several years ago leaving an estate estimated at \$1,000,000. His will left Miss Biggar, who claims to be his widow, a 60 per cent interest in the estate. The death of Bennett was followed by much litigation which was supposed to be ended when the former actress settled her claim against the estate for \$100,000. She now declares she was under duress when she made the settlement.

HOW ABOUT THIS!

We have been sent the following puzzle by a subscriber which we herewith give to our readers; and in sending it he requested an answer: "A man on this side of the river has a fox and a goose and a peck of corn. 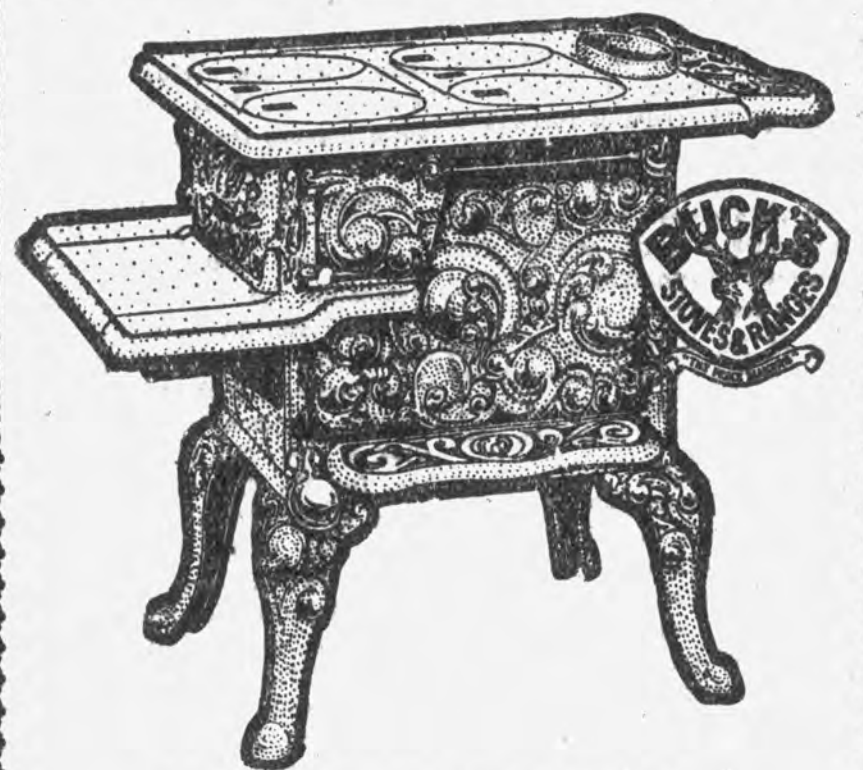

How is The Campaign Being Conducted?
By the establishment of free hookworm dispensaries at five points, one day per week for six consecutive weeks.

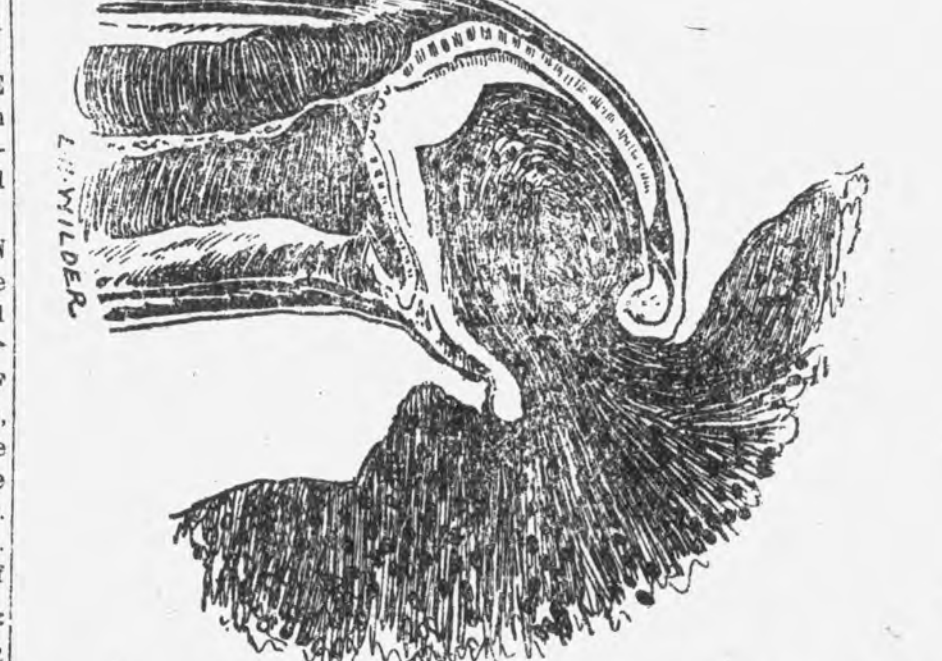
In our stomachs and the upper six feet of our small intestines.

How Many Hookworms May a Person Have?

From less than one hundred to five thousand.

How Do They Live?

By holding fast to the lining of the intestines and sucking our blood as you will see by studying the accompanying cut:



This cut shows how an adult Hookworm holds fast to the inner lining of our small intestines, sucks our blood, injects a poison into our system, thereby destroying our best friend (the blood), which is evidenced by paleness, tiring out easily, and retarded physical and mental development.

Name and Discuss Some of Their Harmful Results.

1. They suck our blood and cause us to become thin-blooded, pale and weak.
 2. They inject a poison into our system which destroys our blood, and often makes us nervous and restless, have headaches, become despondent, dull, listless, stupid; suffer with joint pains, indigestion; have heart trouble, tire out easily, become stunted in our growth and backward in our school work; have ravenous appetites, but no desire for fat meats.
 3. Hookworm disease weakens one and prepares his or her system for such disease as typhoid fever and consumption. One suffering with Hookworm disease recovers very slowly from an attack of any other disease, such as measles, grip, colds, etc.

Prevention of the Disease.

2. Wear shoes as long as there is any polluted soil, and don't eat uncooked foods which have been on, or near, contaminated soil.
3. See to it that every dwelling and schoolhouse is provided with sanitary closets, and that the stools of no one are deposited elsewhere.

Sanitary Closet.

A sanitary closet is one which has a fly-proof vault under the seat and a close-fitting lid on a hinge for the opening of the seat. Under the opening a pail or tub is placed by raising a hinged door in the rear of the vault. Dry dirt, lime or chemical disinfectants are put in the pails as needed to keep down the odor. The contents of the pail should be removed once a week and deeply buried as far from the well as possible, burned or treated with germicides, but not used as manure, because this scatters the infecting germs or worms, which are too small to be visible to the naked eye.

By visiting these dispensaries you will be attending a sanitary school. You can hear lectures on "How to Cure and Prevent Hookworm and Other Diseases." You can get literature on Hookworm disease, Typhoid fever, Flies, Rural Sanitation and Sanitary Instruction FREE.

Examination for and treatment of Hookworm disease and other intestinal parasites is made at these dispensaries FREE.

To be examined: Bring with you a small amount of your bowel action in a tin box, with your name and age on same. Give the box to the man using the microscope; ask him to show you the Hookworm eggs.

Treatment—All drugs, and directions for taking them, are given FREE by the Hookworm Specialist. But few people are cured by taking less than three treatments. Remember we only give one treatment at a time.

We invite you all to come, regardless of your belief or disbelief. Remember, that you need not be an applicant for examination in order that you may visit us.

Dr. C. F. Strohsider, Hookworm Specialist, will be in charge of the dispensaries, assisted by a trained microscopist.
