McNAMARA BROTHERS PLEAD "GUILTY" TO LOS ANGELES TIMES DYNAMITING

Harrison Gray Otis' Paper Blown Up
October, 1910 With a Loss of
Twenty-One Men

"A BOLT FROM A CLEAR SKY" IS PRESIDENT GOMPERS' COMMENT

GREATEST CASE INVOLVING LA-
BOR QUESTION COMES TO
SUDDEN STOP, AS ACCU-
SED BROTHERS PLEAD
GUILTY TO CHARG-
ES BROUGHT
UP IN LOS
ANGELES.

"I may shrink, but if I do it will not be for a principle. They could never have gotten me to the gallows on the evidence, but I was afraid that poor old 'Joe' may get it because of my fight for life. Poor Darrow and Scott and Davis are all in. They felt mighty bad about this. I told them to go and see the District Attorney and ask him to let me swing if it would let John off. The talk dragged a bit, but I turned the trick today. I pleaded guilty."—James B. MacNamara.

LOS ANGELES, Cal., Dec. 2.—The MacNamara Bros. on trial for the blowing up of the Los Angeles "Times" in October, '10, and the Llewellyn Iron works, also in Los Angeles, gave the labor world the lie today, when they confessed their guilt. James B. MacNamara will probably be sentenced to imprisonment for life, while his brother will face a term of twenty years of hard labor.

The Los Angeles "Times," blown up on the morning of October 1, 1910, with loss of life totalling 21. Harrison Gray Otis' warring on certain phases of organized labor in California, was the cause for the "blowing up." Union men were charged with the crime and the International Typographical Union issued a statement, offering funds and assistance in running down the authors of the crime and expressing its horror. Detective Wm. J. Burns, of San Francisco graft fame, was put on the case and the arrest of the MacNamara brothers followed after an exciting chase and no end of legal wrangling.

The trial, had it not been stopped by the MacNamara confession would have proved one of the costliest ever staged in any state, the county having already spent over \$200,000. John D. Frederick, for the state, had summoned over 450 witnesses, whilst Clarence D. Barrow, of Chicago, lawyer conducting the defense, had a list of witnesses numbering 200. The attempt to secure a jury started on October 11, and had gone on uninterrupted until yesterday, when the men plead guilty. Judge Walter Brodwell presided.

READY FOR CONGRESS TO OPEN MONDAY

The President's Message Will Be Read
Tuesday

SESSION PROMISES MUCH INTEREST

Forecast of Measures To Be Considered—Tariff Revision, Appropriations And Railroad Legislation—Members Will Have An Eye To Their Political Fences.

WASHINGTON, D. C., Dec. 2.—With the opening of the first regular session of the sixty-second congress but two days away senators and representatives who had remained at their homes over Thanksgiving day poured into the capital on every train today.

As all of the committees appointments and other details of organization already have been completed, there will be no work of organization called for on Monday. A little routine business may be transacted in both houses and then an adjournment will be taken as "a further mark of respect" to the members who have died during the recess of congress. Tuesday is likely to be devoted to reading of President Taft's annual message. After that the lawmakers should be able to get down to business immediately and for the next five or six months, barring the time of recess over the holidays, the country can watch them thrust and parry and intermittently legislate.

That the session is likely to be an unusually busy and important one is generally admitted. The approach of the national elections and the bitter rivalries of political parties will enhance the interest. The galleries will have to listen to floods of strident political oratory delivered purely for home consumption. No member with an eye to re-election will overlook an opportunity to "make good" with his constituents.

A flood of bills hitting at the trusts will be introduced. Senator Pomeroy, of Ohio, will push his resolution to put trust offenders in jail, and Representative Henry, of Texas, will introduce a similar measure in the house, providing some other member does not "beat him to it."

While the lawmakers in nearly all of the states concluded some time ago that anti-railroad legislation was no longer profitable or advisable with a view to the general interest, many of the members of congress appear still inclined to hold the roads responsible for many of the ills the country is supposed to suffer. In their opinion the time has not yet come to let up on the railroads.

Federal supervision of railroads to a greater extent than is now in force will be proposed in many ways. More power to the elbow of the Interstate Commerce court is a favorite slogan with the lawmakers. If the Commerce court shows a disposition to give the railroads a square deal, abolish it.

But the session will not be all buncombe. There is no dearth of important measures awaiting consideration—some of great national concern. The great appropriation bills will be fiercely fought over. In the house there will be a mighty contest over federal incorporation of interstate industrial corporations. The senate will wrestle with the arbitration treaties, and the lines will be sharply drawn between the jingolists and the peacemakers. Then there will be the subject of conservation, also the important question of the tolls to be exacted of vessels passing through the Panama canal.

Tariff revision, however, will be the big subject of the entire session. The tariff board's much-discussed report on the woolen industry is to be transmitted to congress soon after the opening, and the boards' report on cotton will follow probably within a few weeks. Besides the wool and cotton schedules, a host of other provisions of the tariff law, including proposals to reduce the duties on steel and iron, cotton machinery, chemicals, reciprocal free admission of bituminous coal across the Canadian border, etc., will figure in the tariff discussions.

CARD FROM MRS. DORA TRIPP.

In Which She Says Statements Made By Mr. Tripp Are False.
Greenville, N. C., Dec. 2, 1911.
To The Reflector:

In regard to the article published in yesterday's Daily Reflector, I, Dora Tripp, in justice to myself and family, hereby wish to correct all false statements published therein, in regard to the kidnapping of myself by my husband, Noah L. Tripp, on Saturday night, Nov. 25, 1911.

I do hereby certify, that all that was published therein in regard to my willingness to go with him of my own free will is an absolute falsehood.

And, furthermore, all statements which I hereby make can be substantiated by witnesses who were present at the time in which this cowardly deed was committed. I do hereby solemnly swear that I was taken by him solely against my will, in spite of every strenuous opposition on my part. I was pushed to the buggy which stood waiting for me, and by force on his part was lifted from the ground and placed therein, he holding me so as to make escape impossible. As for my people ever trying in any way to influence me to leave him, is an absolute falsehood substantiated only by he, himself, and I want to state to the public that I, Dora Tripp, on my own freewill on account of his cruel treatment and unwillingness to provide for me, as a true husband should his wife, and under these conditions is the soul reasons in which I am separated from him today. I will admit that I agreed to go by mother's for my baby, the sole reason of this being that it was the only hope I had of escape, knowing as I did if I could only once enter my mother's house I would be safe from the terrible situation in which I was placed, and in regard to my privilege of seeing and talking with him since the time of our separation, I, as a true woman, can truthfully say that it was no opposition on the part of my people in any way, feeling as I did under the circumstances I had no desire whatever to have any conversation with him. Do not understand me to say that any deadly weapon was brandished at the time I was forced into the buggy, but I do certify that on account of opposition on my part by refusing to ever live with him again, a pistol was drawn from his pocket by himself on the way between my home and Mr. Clark's and pointing it toward me, threatened to take my life. I also wish to state, the pistol was brought to observation once after I had entered the home of Mr. Clark in the presence of Mr. and Mrs. Clark, but I cannot state what his intentions were in Clark's home, as the pistol was taken from Mr. Tripp by Mr. Clark as soon as it was taken from his pocket.

I do hereby certify that the statements written herein are correct in every detail.

SOME VITAL NEWS FROM THE CAPITOL

Steel Trust Wants Investigation Against Them Stopped

ENORMOUS PROFITS OF EXPRESS

Champ Clark Says To Democrats, "Get Together And Stay Together"—Party Harmony Will Bring Success In 1912—Republicans Raising Corruption Fund.

(By Clyde H. Tavenner).
WASHINGTON, Dec. 2.—Having struck a trial leading to the front door of the house of John D. Rockefeller, and other trails ending at the doors of other millionaire trust magnates, the steel trust investigation committee of the house of representatives has been summarily commanded by Wall street to bring its probe to a halt.

The Stanley committee is in the possession of evidence sufficient to convict the steel trust of obtaining rebates, or preferential divisions of rates which amount to rebates, from the railroads amounting to millions of dollars. The evidence has not become public for the reason that the committee has not had time to reach, in public hearing, this feature of the trust's wrong doing.

"This investigation must be stopped," is the command that went out of Wall street several weeks ago. "Set up the plea that the investigation ought not proceed because Mr. Wickersham has already started a suit against the corporation." The steel trust attorneys carried the ultimatum to the committee in Washington.

But Chairman Stanley stands firm for a continuation of the investigation. "If," says Mr. Stanley, "the steel corporation has not violated the law, then it will welcome this opportunity to demonstrate its obedience to the law in advance of a litigation which will take years to determine, and if it has violated the law, it will use all its powers, and all its immense wealth to silence a committee which can neither be cajoled, deceived or corrupted."

Speaker Clark Urges Harmony.

"Get together and stay together." This is the advice Speaker Champ Clark said he would give to the Democrats of every community in the land if he had the opportunity. He added that it was the only instructions that it would be necessary for the rank and file of the Democracy to follow to insure a great national victory in 1912.

"Of course," said Mr. Clark, "I am taking it for granted that the tariff is to be the chief issue. No doubt the enemy would like to sidetrack that issue, but we must not permit it for an instant."

Mr. Clark had just arrived at the capital city preparatory to opening the first regular session of the sixty-second congress, and discussed the political situation optimistically at considerable length.

"Looking back at the recent election," said Mr. Clark, "they demonstrated two things—one, that the people endorse our tariff record, without doubt; two, that wherever we are united we can win."

"After the Democrats in congress have gotten together and made such a splendid record for solidarity it would be a shame and a calamity to lose in 1912 by reason of petty factional fights of a local nature. I believe firmly that we can win in 1912, but to do so there must be no factional fighting among Democrats. Consequently, I hope that Democrats will forget their local differences and present a united front. Now is the time for them to get together and stay together."

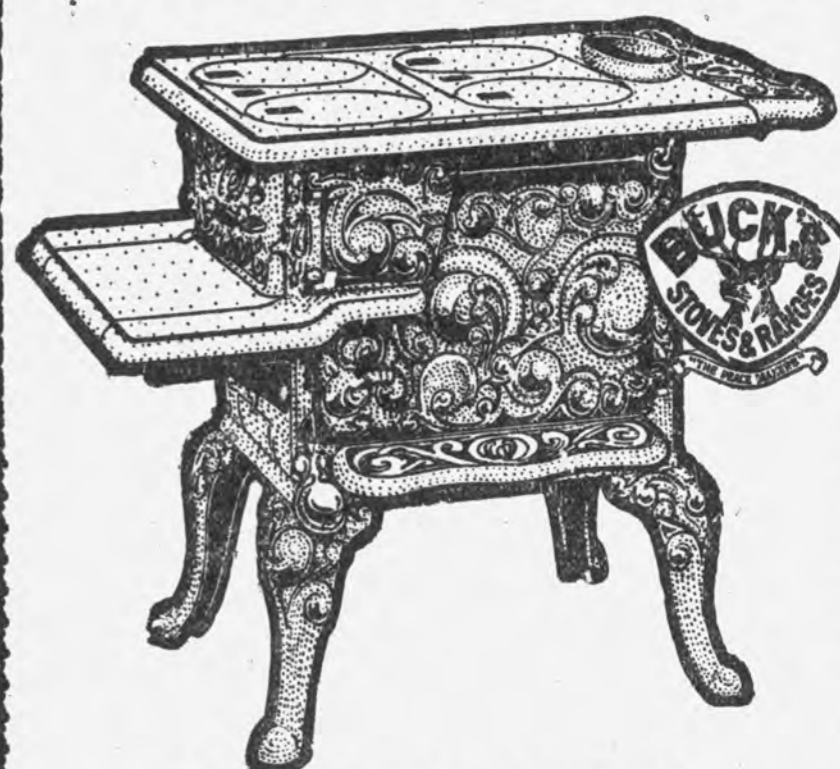

BOY LOSES LEG IN HUNTING ACCIDENT

LIMB AMPUTATED THIS MORNING

Robert Lee Accidentally Shoots Leland Weathington.

Friday afternoon some boys were out hunting together. In the Johnston field about a half mile below town they jumped a rabbit. Robert Lee sprung both barrels of his gun and shot the rabbit down with one barrel. He lowered his gun to let down the other barrel, and just at that moment Leland Weathington sprang forward to get the rabbit, when the other barrel of Robert's gun went off, the lead striking Leland in the left leg just below the knee.

The boys were only about 12 years of age, and while badly frightened at the accident they showed remarkable presence of mind. Leaving the other boys to care for Leland, Robert ran over to town to get some one to go bring in the wounded boy. Reaching the office of Mr. H. A. White he stopped to tell what had occurred. Mr. White telephoned Dr. Laughinghouse, and the latter hurried out, taking Mr. White and Robert in the buggy with him. When they reached the place where Leland had been left the other boys had taken him up in their arms in readiness to start home with him.

Dr. Laughinghouse took Leland in the buggy and carried him to the home of his father, Mr. E. G. Weathington, in South Greenville. An examination of the wound showed the bones of the leg were badly shattered and that amputation would be necessary. The boy was suffering so from the shock that Dr. Laughinghouse thought it not safe to amputate the leg until today. Assisted by Dr. J. E. Nobles and a nurse, he performed the operation this morning, taking off the leg about the middle third of the thigh. The boy is reported to be getting along as well as could be expected after the operation.

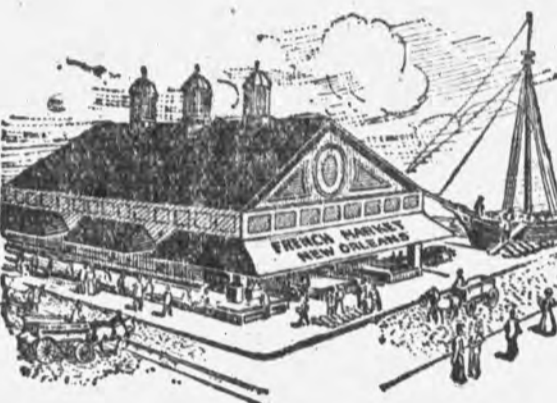

SOME VITAL NEWS

FROM THE CAPITOL

(Continued From 1st Page.)

To Prevent Wastefulness.
Democratic leaders in the house of representatives are planning to give a great deal of attention during this session of congress to the appropriation bills. It is by demonstrating their ability to spend Uncle Sam's money wisely that the Democrats hope to establish their claim for greater recognition next year, and if there is one thing upon which there is no division of opinion among the house majority leaders, it is the determination to make the coming session memorable for its business like administration of the vast government machinery.

That the Republican cabinet members realize that there will be no chance for unmerited expenditures is indicated by the fact that the greatest care is being given to the preparation of estimates. The interior department will ask for a million and a half less than was called for last year. The navy department, it is announced, will ask for two millions less, and similar savings will be effected in other departments. This saving is in the estimates alone, and by the time the appropriations committee gets through with its pruning work the probabilities are that the saving will be still further increased, while the efficiency of the government business will not be decreased in the slightest degree.

Congress To Be Educated.

The big financial interests which have their headquarters in Wall street have reached the conclusion that it will be worth one million dollars to "put the Aldrich banking plan through congress."

An organization, known as the "National Citizens' League for the Promotion of a Sound Banking System" has been formed, and the work of raising funds already is under way in all the big cities of the country.

Just how the money will be used to "put the bill through" has not been made clear. In Philadelphia the funds, as soon as they are collected, are being deposited in the Girard Trust company bank, and to the bankers who subscribed it was explained that "pressure would be brought to bear on the members of congress."

How Long!

How long must the people continue to pay express companies a profit of 40 per cent a year on money that is not invested in express business, and that exists in blue air only?

This is a question that the people desire answered, and one that they are beginning to become impatient about, judging from the ever-increasing number of communications on this subject that are being received by members of congress.

"Express companies ought to be permitted to make a good liberal rate of interest on money actually invested," writes an Iowa man to his congressman. "The thing that arouses our disgust is that the government permits the express companies to extort a profit of from 25 to 50 per cent on a capitalization that is two-thirds water. I would like to see a parcels post. If we cannot have a complete system, why can't we at least have a limited parcels post to start with, effective only between towns and cities and the surrounding country? Such a limited system would help rather than injure the business of the retailers. Think it over."

The Interstate Commerce commission's report shows that the net income from the express companies' operation is \$11,000,000, and on their own valuation of \$27,000,000 their profit is shown to be approximately 40 per cent. It is known that the actual value of the express companies equipment is less than one-half of what they allege, so that their profits on money actually invested run up to nearly 100 per cent.

revision, and revision downward, of some of the important schedules of the tariff act. Even the president will be expected to fall into line to make the work of congress effective by signing a bill.

President Taft's position is understood to be that he is in favor of "reduction of the tariff wherever it can be done and still give a living measure of protection of those industries that need it," "but that the tariff should not be changed and business disturbed except upon information which shall enable us to disturb business least." He has already declared that the failure of the wool bill at the extra session "should not be regarded as taking away the only chance for reduction by this congress."
