

THE BASEBALL MEN ARE IN SESSION

THE MEETINGS BEGAN TODAY

And Will Occupy The Greater Part Of This Week.

NEW YORK, Dec. 11.—Some interesting reading for the baseball fans is expected to be furnished by the series of meetings which began here today and will occupy the greater part of this week. In addition to the annual meetings of the National and American Leagues there will be meetings of the National commission, the National Board of Arbitration, the Eastern League and the Baseball Writers' association.

The American League assembled today to wind up the business of the past season and discuss preliminary plans for the coming year. The season of 1911 was a very successful one for the league and as nothing has occurred to disturb the harmony among the magnates the meeting was little more than a love feast.

Livelier proceedings are promised tomorrow when the National League meets in annual session. The recent death of President Russell, of the Boston club, has caused a revival of the talk of "syndicate baseball" and Barney Dreyfus, of Pittsburg, who has led the fight against the so-called syndicates, will probably bring the matter to the attention of the directors. Rumors are still current that an attempt will be made to oust Thos. J. Lynch from the presidency of the league, but those in a position to know declared today that while the meeting might develop some surprises the "passing of Lynch" certainly would not be among them.

The special meeting of the National commission, the supreme governing body in the baseball world, will transact considerable business left over from the recent Cincinnati meeting. It was considered doubtful, however, if the commission will devote much serious attention to the charges of collusion between scalpers and officials of the New York club in the sale of tickets for the world series last fall. The majority of the magnates are now inclined to let the matter drop, though all are in favor of adopting some plan that will prevent a repetition of the scandal in the future.

The Eastern League also seems to have its troubles, which are due to have an airing at the league's annual meeting. Owner Chapin, of the Rochester club, has come to town with the avowed intention of returning home with the scalp of President Ed Barrow dangling at his belt. Chapin has a number of grievances against Barrow, as the most of them are of little concern to the other club owners the probabilities are that Barrow will be returned to the presidency for another year at least.

YEGGMEN GET TEN YEARS.

Men Sentenced Who Attempted to Rob Ayden Bank.

In the circuit court of Halifax county, Virginia, two yeggmen were convicted of having in their possession burglars' tools and explosions with felonious intent. They were given terms of ten years in the penitentiary. These men were identified by Cashier Stancill Hodges, of the Bank of Ayden, as the ones who recently made an unsuccessful attempt to rob that bank. They were also believed to have robbed several banks in Virginia in recent years.

Jewish Women in Council.

PHILADELPHIA, Pa., Dec. 11.—Papers dealing with all phases of philanthropic, religious, educational and social work will be read before the National Council of Jewish Women, which holds its triennial sessions at the Hotel Walton this week. This council is one of the largest and strongest of the women organizations in the country and will have among those participating delegates from all parts of the country, many of them of national reputation.

Reformer Seeks Mayorality Again.

BOSTON, Mass., Dec. 11.—A number of Massachusetts citizens are to hold their municipal elections tomorrow. More than ordinary interest is manifested in the mayoralty contest in Salem, where Arthur Howard, the young editor whose reform methods caused a great stir in the "Witch City" during his former term as mayor, is seeking election again.

Still Trying Mabray Gang.

COUNCIL BLUFFS, Ia., Dec. 11.—The case of Benjamin Marks, alleged to have been a member of the notorious Mabray gang of swindlers, came up for trial in the district court here today. J. C. Mabray, the leader of the gang, who was recently released from the Elvenworth prison, is to be tried on other charges against him as soon as the trial of Marks is concluded.

To Honor Duke of Connaught.

MONTEREAL, Que., Dec. 11.—A special convocation of McGill University, for the purpose of conferring the honorary degree of Doctor of Laws on the Duke of Connaught, will be held in the Royal Victoria College tomorrow afternoon.

To Vote On Saloon Restrictions.

SPRINGFIELD, Ill., Dec. 11.—The first referendum election in Springfield since the adoption of the commission plan of government, will take place tomorrow. A vote will be taken on four measures, all of which propose further restrictions on saloons.

FOES OF SALOONS IN SESSION.

Delegates From All Over The Country Assembled in Capital.

WASHINGTON, D. C., Dec. 11.—Delegates from all over the country are assembled in the capital for the biennial convention of the Anti-Saloon League of America. The business sessions of the gathering will last four days and will be followed by a national conference to consider the question of interstate liquor traffic. Men and women prominent in temperance work, together with a number of members of congress, are expected to speak in support of the movement for federal legislation relative to the interstate liquor question.

The Anti-Saloon League of America was started at Oberlin, Ohio, about fifteen years ago by the late Rev. J. H. Knott, of the church extension board of the Methodist church, and Archbishop Ireland. The organization is a federation of churches, temperance societies and individuals opposed to the drinking saloon without regard to party lines or denominational differences. The league now has nearly 150 offices scattered over the country from which large quantities of anti-saloon literature are distributed each year.

G. O. P. Leaders Assemble.

WASHINGTON, D. C., Dec. 11.—Practically all of the members of the Republican national committee have arrived in the city for the meeting tomorrow at which the time and place for holding the national convention will be decided and other matters preliminary to the presidential campaign will be discussed.

To Speak For Arbitration.

NEW YORK, Dec. 11.—Joseph H. Choate has been selected to preside at the mass meeting here tomorrow night in support of the arbitration treaties now pending in the senate. Andrew Carnegie and Henry Watterston will be among the speakers.

Murder Trial at Waco.

WACO, Texas, Dec. 11.—The case of Jim Fix, charged with the murder of Policeman Frank Glasgow, at Hillsboro last June, came up for trial today. The case was brought here on change of venue from Hill county.

HOT CAMPAIGN ELECTION.

Will Be Held Throughout The Coal Fields Tomorrow.

PITTSBURG, Pa., Dec. 11.—Throughout the coal fields of Ohio, Pennsylvania, Indiana, West Virginia and other states, there were canvassing, rallying and parading of miners today to close one of the most strenuous campaigns for the election of district and national officers of the United Mine Workers of America in the history of that organization.

The election will be held tomorrow throughout the United States and Canada and the results will be announced at the national convention at Indianapolis next month.

The re-election of John P. White, as president, is opposed by a large faction made up of the followers of Tom L. Lewis, of Ohio, who succeeded John Mitchell as president and continued in office until defeated by White a year ago.

Edwin Perry, secretary, is the only national officer who has no opposition for re-election. Mr. Perry has held the office of secretary-treasurer for five years and during that time has handed over \$6,000,000 in funds belonging to the organization.

For vice-president Frank J. Hayes is being opposed by Samuel Pascoe, of Farmington, Ill. There are thirty-three candidates for the seven places as delegates to the next convention of the American Federation of Labor. Among these is John Mitchell, former president of the miners, and now vice president of the American Federation of Labor. Twelve candidates are in the field for the three places on the auditing and credentials committee, and twelve aspirants are out for the three places as tellers.

THEY TALK ABOUT GREENVILLE.

Religious And Educational Work Here Demand Attention.

Before beginning his sermon in the Baptist church, Sunday morning, Rev. C. M. Rock spoke a few words about the Baptist State convention which met last week in Winston Salem. He said it was a great convention, well attended, and showed splendid progress along all lines of the denominational work. Something most gratifying to him was the frequent questions asked about the Memorial church in Greenville and the work it is doing, showing that all sections of the state are interested in us and rejoice with us in the growth of Christ's kingdom here.

Another thing, said Mr. Rock, though not directly connected with our denominational work, that filled him with pride for Greenville, were the frequent remarks made to him about East Carolina Teachers' Training school. People all over the state have heard about this splendid institution and they wanted to know more of its equipment and what it is doing.

These things, he said, show that Greenville is in the eyes of the people of North Carolina, and they are watching with interest our religious and educational progress.

THE VILLAGE MUCKRAKER.

There once lived a man known to the world of horse-lovers as "Pa Hamlin."

This man ran a general store at East Aurora, and built up a large and flourishing trade, as country stores go.

And he was denounced by the merry villager in exact ratio to his success and the benefits he conferred upon the town.

It is the buyer's right to defame the seller; and this privilege is pretty thoroughly exercised the wide world over. When the setters set to and rip a man's reputation up the back, you may depend upon it that the person defamed is quite unlike the impeccable ones who do the defaming. The fact that a man has things that we want is justification enough for our damning him.

Any man who does much to benefit and help the city, town or village where he resides, is looked upon with suspicion.

Waterworks, sewerage, parks, paved streets are never the spontaneous evolution of the people of a town. They are pushed upon the many; and a deal of diplomacy, argument, handshaking, and kissing of babies is required to bring about the betterment.

Only one-man power counts. Everybody in town may say that Main street needs paving; but let any one man take hold actively to get it done and this man finds the way blocked, his hands tied, his feet manacled by the muckrakers whose chief business it is to muckrake time and a third. That is to say, he has to make terms with the genus setter; and when the thing is finally completed it is the common talk of the town that this man has benefited himself by the things provided for the good of all.

It is now the thorough belief of every business man who has any knowledge on the subject that Tweed in New York and Shepard in Washington benefited their respective cities immensely and that to a great degree they were victims of village hate.

Boss Tweed bought up great numbers of vacant lots, removed shanties, scattered the squatters and envolved Central Park—the great playground for the people.

At that time the city had not nearly caught up with the park and the enterprise and prophetic vision of Tweed were the very things that brought about this downfall.

We now know that the man did not profit at all by his transactions; and it is probably the same with Boss Shepard, who gave us the new Washington, which is the most beautiful city, from a typographical standpoint, in America.

This is no apology for the corruption of and waste of political bosses; but viewing matters in the light of results, the men just named were

benefactors of the public, and victims to the genus villager, who opposes the very things that he suggests, yet shares gleefully in the graft if it comes within grabbing distance.

Pa Hamlin was one of the first men in America to make glucose sugar. He bought the secret from a man who was unable to make use of it. Terrible tales were told about how he robbed this man.

When Pa Hamlin was raising horses, laying out beautiful farms, increasing the yield of crops, and showing farmers how to farm, he hired men who got even by damning him at the grocery every night. These parties, who nibbled at the crackers and sampled the cheese and occasionally swiped sardines, are classics; and their habit is never to forgive or to forget the people they have injured.

And the moral is this: When you hear successful people hotly denounced, just take off fifty, ten and five, and then withhold judgment until you know something for sure about the man.—The Fra.

John E. Carland, associate justice of the court of commerce, was born in Oswego county, New York, December 11, 1853. When he was about two years old, his parents removed to Michigan, and after an early life of toil he received a common school education and then studied law at Ann Arbor. He was admitted to the bar in 1875 and two years later removed to Bismark, N. D., where he practiced law until 1885, when he was appointed United States attorney for the territory of Dakota. He held that office until 1888, when he became associate justice of the territorial supreme court. On admission of North and South Dakota as states Judge Carland removed to Sioux Falls, where he engaged in the practice of law until 1896, when he was appointed United States judge for the district of South Dakota, which office he was holding at the time he was selected by President Taft for one of the associate justices of the new court of commerce.

It is true Walt Whitman chanted the song of democracy, but his chant is a magnificent prophecy of an ideal—it is an exhortation, not a poetic manifestation. The spirit that strove and is striving toward a realization of this democracy is best caught when exemplified in the lives and deeds of the men who lived and fought, who conquered and died fighting, moved by this spirit. This is the creative work of the poet we await.—Temple-Scott in Forum.

CITIES HARD TO KILL.

What Rome, Paris, Constantinople and London Have Suffered.

It is a difficult thing to kill a city, and there are some well known places that have so much vitality that they will survive any number of disasters.

Take Rome as a first example. No fewer than ten times has she been swept by pestilence. She has been burned twice and starved out on six occasions. Seven times she has been besieged or bombarded. But she still flourishes. Perhaps that is why she is called the Eternal City.

Paris has had eight sieges, ten famines, two plagues and one fire which devastated it. We make no reference to the number of revolutions, as they are too numerous to mention. But Paris still flourishes.

Constantinople has been burned out nine times and has suffered from four plagues and five sieges. There are some people who think that many of the sultans have been as bad for the city as any pestilence. And yet she goes on.

Lastly there is the English metropolis. London began as a kind of mound in a swamp. In her early history she was sacked, burned and all her inhabitants butchered. She has been decimated by plague five times, exclusive of typhus, cholera and such maladies. She has been more or less burned seven times. She is thriving in spite of all.

Yet He Loved the Sea.

It is said that Bryan Waller Procter, known as Barry Cornwall, who wrote the well known poem—

I'm on the sea! I'm on the sea! I am where I would ever be!

was the very worst of sailors. When we read that he was so seafick that he could scarcely bear the sound of a human voice it becomes apparent that his wife's conduct during his affliction could scarcely have been reassuring. As he lay on the deck of a channel boat, covered with shawls and a tarpaulin, she had the pleasing habit of humming a strain of his jovial sea song. The poet who loved the sea, but loved it best at a distance, had very little life just then, but what force he had was used in the entreaty: "Don't, my dear! Oh, don't!" Yet no doubt he loved the sea.

Origin of Panic.

No word has moved with the times more than "panic." Long ago in ancient Greece it was a mild fear inspired by mysterious sights and sounds among the mountains and valleys by night, which were attributed to the god Pan. Nowadays it has a by no means supernatural significance on the stock exchange. "Panic fear" was the original expression, and in shortening it to "panic" we have all really been as slipshod as the small boy who calls his "comic paper" a "comic." Shaftesbury 200 years ago would have used the word for any contagious feeling that seized upon masses of men. "There are many Panicks in Mankind besides merely that of Fear. And thus is Religion also Panick."—London Mail.

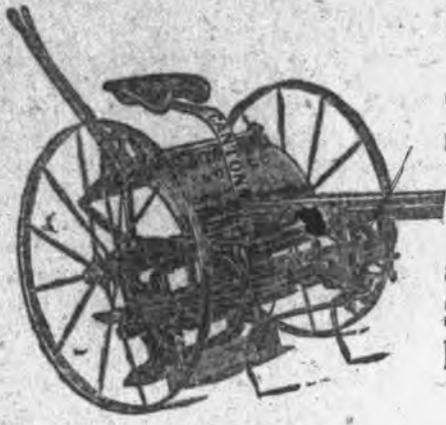

GRIDIRON STORIES

Football Games That Were Won by a Tongue Lashing.

A TALK THAT BEAT HARVARD.

Trainer Mike Murphy Made the Appeal to Penn, and the Red and Blue Rose to the Occasion and to Victory. A Dog Won a Game For Columbia.

Writing on football in the American Magazine, Edward Lyell Fox tells of football defeats that were turned into victories by tongue lashing. He says: "There are instances whereby coaches have won games all unbeknownst to the public. These are crises that have been faced in the dressing room between the halves, with the team stretched out dirty and bruised. Lashed by coaches' tongues or stirred by the appeal personal, an apparently disorganized and defeated rabble often becomes a steady but furious fighting unit.

"In 1905 Pennsylvania went to their dressing room after playing a 6 to 6 first half with Harvard. The tie score was misleading. Harvard had played the better football. They had ripped the red and blue line to tatters. And Harvard would have crushed Pennsylvania if Mike Murphy, the veteran trainer, had not jumped upon a table and talked three minutes to the team. Murphy, like Antony, was no orator.

"Do you want a lot of bean eaters up there in Boston to crow over the hash their team made of you? cried he. 'They'll turn that city inside out and on good Penn money at that! Your friends 'll be courtin' free lunch counters for weeks if you let those dubs get away with this! Myself—it almost made me cry to see those big stiff's walk all over you.' (He gulped noticeably.) 'Because I know how good you are. You weren't right that half. You'll kill 'em now. You've got to. Think of the crowd. And say, fellows, if there's no mother, father, sister or girl up there watchin', just think of me, fellows. Think of me, that takes care of you all. For I've got the "con." boys.'

"He coughed, brushed his eyes with the back of his hand and faltered on: "I won't be with you very much longer, and I want you to win this game."

"He finished speaking and stole away without a word. There was no cheering; the men were thinking too hard. The next half Harvard found a different Pennsylvania team, a team whose emotions were keyed up to such a pitch that their fierce football has never since been seen on Franklin field. Harvard was dazed, swept away and beaten—because a man spoke.

"Another remarkable turning of a game between the halves occurred at Ithaca in 1905. Cornell led Columbia by 6 to 0 when the teams returned to the dressing rooms. Columbia had not recovered from a wearing game with Princeton the week before. Many of the men were overtrained. There was a distinct feeling of the hopelessness of it all when the players lay down upon the floor and benches. Only Bill, a white bull terrier mascot, showed signs of liveliness. It was cold in the dressing room, and a trainer shook the ashes in the stove. He used a poker, the end of which became red hot. When finally he laid down the metal rod the red whitened, but the heat remained. Bill, deciding that the poker was to be played with like a stick, caught the heated end in his mouth. Instantly his lips seared and turned black. Bill only shook the poker harder. Two men grabbed him and tried to force him to open his mouth. But Bill fought back, and finally they had to choke him before he would loosen his grip. It was then that Coach Morley nudged Captain Fisher and pointed to the dog. Catching the idea, Fisher sprang to his feet and built up a speech around Bill. He compared Bill's nerve to the team's and asked the men if they were not ashamed of themselves. His closing sentence was, 'Just play for Bill, Bill, Bill!'

"When Columbia returned to the field, Bill, yelping furiously, led the way. All through the half the team heard him barking from the side lines. Said Von Saltza, the big tackle, after the game, 'We heard every yelp, and it simply drove us.'

"Also Bill's yelping was so good that Columbia won out, 12 to 6."

Very often, Mr. Fox declares, the ability of one man to kick has determined the outcome of the game. He writes:

Minnesota led 13 to 12. The first half ended, however, with Wisconsin swinging back into the lead. A touchdown came after a succession of end runs. The score was Wisconsin 17, Minnesota 13. In the second half the teams studied down and played 'close football.' No more scores were likely. But in the closing minutes Capron sent a kick twisting from the forty-five yard line. It cleared the bar, and the score was tied. Wisconsin had the better team; Minnesota had Capron."
