

STEEL TARIFF IS FIRST TO BE REVISED

Indications Are That Wool Will Be Delayed

DEMOCRATIC CAMPAIGN OUTLINED

Underwood Back From Christmas Holidays Clearly Outlines Plan For The Session—Metals Will Hold First Place With Sugar And Chemicals Coming Next.

There seems to be no further room for doubt as to the attitude of the Democratic party in congress toward the tariff board. Representative Underwood, the majority floor leader, let it be known yesterday, on his return from Richmond, where he spent Christmas with relatives, that the tariff program of the Democrats in the house has been mapped out, and that it takes little cognizance of the board.

According to Mr. Underwood, the first tariff bill to be taken up will be that providing for revision of the iron and steel schedule. After this the chemical schedule will be tackled, and then sugar. By that time he hopes the Democratic clerks of the ways and means committee will have completed the comparison they have been making between the tariff board's schedule and the Democratic schedule. The wool bill is based on the tariff board's schedule. It has been passed, and will be made a part of the tariff board's schedule. The tariff board's schedule is the basis of the resulting measure put through.

This comprehensive tariff program will not be completed, the majority leader believes, until some time in March, even under the most favorable auspices, and with the greatest possible expedition of business. He explains the rushing to the front of the steel, chemical and sugar schedules, which have not been reported upon by the tariff board, and the relegation to the rear of wool, which has been, by the reluctance of the majority to accept the tariff board's figures as final, and to their insistence upon thorough inspection and comparison of the board's statistics with those already at hand.

Inquiry at the headquarters of the tariff board in the treasury department yesterday brought to light the fact that the steel schedule will not be tackled for some time. No work at all has been done on it. The board is just completing its synopsis of the wool report and after this is out of the way, which will be in a few days, will rush work on the cotton report, so that it may be submitted to congress about the middle of January. Then inquiry into either the steel or leather schedule will be begun. There is no way of telling when the board will be able to get to work on the chemical or sugar schedule.

It was very plainly indicated by Mr. Underwood that the Democrats of the ways and means committee had no idea of delaying the sugar revision bill in order to get the report of the Hardwick special committee, which, ever since early in the special session, has been investigating the ramifications and activities of the sugar trust.

Radicals May Make Trouble.
"That committee," Mr. Underwood said, "investigated the sugar trust. The ways and means committee is empowered to deal with the tariff."

As a matter of fact, Mr. Hardwick and his colleagues devoted much of the time of their inquiry to an effort to demonstrate that sugar might be put on the free list without working injury to the sugar growers of the United States. Mr. Underwood, however, is said to be against free sugar, as he was against free wool, on the ground that the present finances of the country do not warrant such an enormous reduction in revenue as would be brought about through legislation to remove entirely the duty on these two products. There is, of course, a free sugar faction in the house, just as there is a free wool faction, and they may give Mr. Underwood and the other conservative leaders a struggle.

The Republican members of the ways and means committee have objected, and it is probable to fall in with the scheme.

CHINESE ARMY WITHOUT FUNDS MONEY REFUSED

Princes Refused To Grant Soldiers' Pays

PREMIER YUAN SHI KAI RESIGNS

Dowager Empress Weeps As Premier Tenders Resignation And Official Re-Considers His Decision—It Is Probable That He Will Continue Holding Office.

PEKING, Dec. 30.—The assembly in the palace today to discuss affairs connected with a settlement of the revolution was productive of at least one dramatic incident. The dowager empress, Premier Yuan Shi Kai and the Princess of the imperial clan were present, and the debate waxed so warm that finally Yuan Shi Kai arose and offered his resignation. This, however, was refused.

Premier Yuan Shi Kai explained to the princess that he could continue the government and retain the country north of the Yangtsee only by having funds placed at his disposition.

He asked the princess to empower him to obtain money. He explained that \$10,000,000 would meet the payments of the soldiers for five months, after which the province would be disunited and the emperor would return to the province.

Mrs. J. E. N. moved. They were very wealthy. None has given any substantial amount of aid to the government with the exception of Prince Ching, who handed over more than \$100,000 for that purpose.

The Dowager Empress wept, and Yuan Shi Kai showed signs of distress. Then he declared that he could not desert her and the child emperor, and agreed to continue.

Will Ask "Four Nations."
It is said tonight that Yuan Shi Kai intends to make another attempt to obtain a loan of \$10,000,000 from the "four nations" group of which three of the countries signified their willingness to furnish a loan three weeks ago. England declining to participate. The premier says that he will not use the money for a campaign of aggression, but will leave the republic.

MEAT PACKERS' ENORMOUS PROFITS

FOURTEEN THOUSAND DOL. CAPITAL

Subsidiary Companies Are Attacked By Government And Disclosures Of Importance Are Made Against The Beef Packers—Jury Excused Pending Admission Of Evidence.

CHICAGO, Dec. 30.—Objection by counsel for the defense to evidence which the government seeks to introduce regarding the operations of the Kenwood Company and the Aetna Trading Company halted the packers' trial today and caused Judge Carpenter to excuse the jury, pending the hearing of legal arguments.

The government contends that the ganized by the packers in 1900, and continued in business until 1905, was one of the alleged pools used to market the packers by-products. It is alleged that the Kenwood Company dealt in oleo and the Aetna Trading Company in the same period, dealt in casings.

\$4,000,000 In One Year.
The government expects to show that the Kenwood Company's profits were \$4,000,000 in one year, despite the fact that it was incorporated with a capital stock of only \$14,000. The profits of the Aetna Trading Company also are alleged to have been proportionately large, by counsel for the government.

By making an inadequate allowance for these by-products in figuring the test cost of the animals slaughtered, the packers were enabled to keep the profits of the parent concern within reasonable limits, according to government counsel.

CONDENSED NEWS ITEMS FROM EVERYWHERE

What the World is Doing—Told by Wire

New Year's Eve To Be Gay.
NEW YORK, Dec. 30.—Judging from the advance engagements of tables in all the prominent hotels and restaurants of the city and other extensive preparations the celebration of New Year's eve this year will be gayer and upon a larger scale than ever before. As New Year's eve falls upon a Sunday this year the character of the celebration will undoubtedly be somewhat less boisterous and the closing law will be enforced as much as possible against saloons, but the streets of Manhattan will be crowded as ever on New Year's eve and the noise just as deafening. The hotels and restaurants in central district are not affected by the closing rule and will be the scene of unusually gay and festive social gatherings.

Bishop Kelley's 38th Anniversary.
SAVANNAH, Ga., Dec. 30.—In commemoration of the 38th anniversary of his priesthood, Rt. Rev. Benjamin Kelley, bishop of Savannah, tomorrow will celebrate pontifical high mass, assisted by a number of distinguished clergymen of his diocese. Bishop Kelley, who was ordained priest on December 31, 1873, today was the recipient of numerous letters and telegrams of congratulation. Among the messages was one from Cardinal Gibbons who officiated at the consecration of Bishop Kelley at St. Peter's Cathedral, Richmond, Va., June 3, 1900.

Bishop Kelley was born at Petersburg, Va., October 13, 1847, and studied for the priesthood at the American College in Rome, Italy. After his ordination in December, 1873, he was in charge of various parishes in New Castle and Wilmington, Del., and later in Atlanta, Ga. In 1896 he was sent to Savannah and four years later was made bishop of the diocese.

"Samurun" Co. Sails For America.
LONDON, Dec. 30.—Max Rienhart's theatrical company, which is to produce the great Oriental pantomime "Samurun," one of the reigning successes of the continent for a year and a half, in a number of American cities under the management of the Shuberts, sailed today from Liverpool for New York. The company includes Miss Camilla Eigenschuetz, who will play the title role during the American engagement, and Miss Constantino, who will give her remarkable rendition of the dancing slave. At the premiere in New York the composer of the music of the pantomime, Victor Hollander, will conduct.

State To Take Telephones.
LONDON, Dec. 30.—Preparations are complete for the transfer tomorrow of the entire telephone system of the United Kingdom from private ownership to government control. In future the telephone business is to be operated as a part of the post office system. The transfer is regarded as one of the most gigantic industrial operations that England has ever known. It involves a business which has amounted to \$20,000,000 a year and in which more than 18,000 persons are employed.

TORONTO, Ont., Dec. 30.—With more than one-half of the municipalities of Ontario already "dry," the prohibition forces are hopeful of a considerable increase to the list as the result of the elections to be held next Monday. Of the 244 municipalities where local option campaigns were possible this year contests have been brought in about one-third. Port Arthur, Fort William and Catham are the most important places in which a vote will be taken on the license question.

LATEST NEWS FROM NATIONAL CAPITAL

Matters of Utmost Importance Discussed

WASHINGTON, Dec. 30.—New Year's day in the national capital will be made brilliant as usual with the president's reception at the White House, the customary breakfast given by the secretary of state for the foreign diplomats, and the exchange of visits by all persons prominent in official life.

Congress will re-assemble Wednesday. The big business of the immediate future promises to be tariff, as far as the house of representatives is concerned. Messages are expected from the president at an early date dealing with Alaska, the cotton schedule and the report of the tariff board on that subject, the postal commission's report and probably one on financial and monetary reforms.

The senate interstate commerce which is investigating trust problems, will resume its hearings Friday, but the Lorimer investigating committees, the Stanley committee that is investigating the steel trust and several other committees of similar nature will resume their activities until the following week.

During the week the state legislatures of Kentucky, Maryland, Rhode Island, Massachusetts, Mississippi and one or two other states will convene for their regular sessions. Special interest attaches to the meeting of the New York legislature, as the annual message of Governor Dix is expected to deal with matters of unusual importance.

Other events of the week of more or less public interest will include the local option elections in Ontario, the general elections in Prince Edward Island, the annual New Year's day rose tournament at Pasadena, Cal. the opening of the annual exhibition of the National Association of Automobile Manufacturers in New York City, and the resumption of the Federal grand jury investigation at Indianapolis into the alleged McNamara dynamiting conspiracy.

Many Diplomats To Be In Line.
WASHINGTON, D. C., Dec. 30.—The program for the customary observance of New Year's day by the president and the official circles of the capital in general indicated that traditions will be closely adhered to next Monday, when the new year will be officially ushered in. The president and Mrs. Taft will hold their reception in the forenoon, beginning with the reception of members of the cabinet. These will be followed by the members of the diplomatic corps.

As there have been numerous important changes in the diplomatic corps since the last New Year's day reception, the number of new faces at Monday's reception will be one of the notable features of the day.

After the diplomatic reception will follow receptions to the members of the justices of the Supreme court, the district judiciary, congress, army and navy and various district officials. Many members of the cabinet will keep open house.

U. S. Circuit Courts No More.
WASHINGTON, D. C., Dec. 30.—The United States circuit courts, which have constituted an important part of the Federal judiciary system for nearly a century past, cease their existence today. The passing of these courts, seventy-seven in number and covering the entire country, is one of the reforms provided for in a new judiciary code, enacted by congress on March 3, last, to become effective January 1, 1912. The existence of the circuit courts of appeal were created, has been regarded as superfluous and expensive. The circuit judges do not lose their positions by the change, as they will continue to sit in the circuit courts of appeal and help in the district courts.

CHILDREN FIND DYNAMITE UNDER ILLINOIS BRIDGE

While Playing, Find Fourteen Sticks of Explosive

R. R. HEAD MAKES ANNOUNCEMENT

Quantity Of Dynamite With Fuses Attached Is Found By Lads Under Big Bridge Structure Over The Mississippi River—Station Agent Notified.

CHICAGO, Dec. 30.—What may have been an attempt to destroy the Thebes bridge over the Mississippi river at Thebes, Ill., came to the attention of the Chicago and Eastern Illinois Railroad Company today with the news of several children finding a quantity of dynamite with fuse attached among the timbers of an over-earned bridge which spans the track approaches to the railroad bridge.

Agent Notifies Road.
"Our informant, C. W. Mogg, station agent at Thebes," said W. J. Jackson, vice-president of the Chicago and Eastern Illinois railroad, "sent a message to me saying that 14 sticks of dynamite with cap and fuse attached had been found by children beneath the wagon bridge. The explosive was in a position to threaten the tracks which are used by all our trains and to wreck the railroad bridge approaches."

The dynamite was discovered Sunday but the railroad officials at Thebes worked in secret for a time in the hope of apprehending whoever was responsible for the placing of the explosive.

No Evidence Against Bridges.
PITTSBURG, Pa., Dec. 28.—George Bridges, arrested early this week while carrying 72 sticks of dynamite and fuses in a suit case, will receive a preliminary hearing at Monessen, Pa., tomorrow. Although an investigation has been instituted by the federal authorities and local police with a view of ascertaining whether there is any connection with the nation-wide dynamite conspiracy, it is said tonight that little of value has been learned.

COTTON MEN ARE TO BE BLAMED

PLANTERS BALKED \$15,000,000 PLAN

Col. Thompson's Explanation Is That Southern Planters Turned Plan Down Because They Do Not Understand It.

Col. Robert M. Thompson, of New York, head of the syndicate which proposed to advance \$50,000,000 for the purpose of handling the Southern cotton crop, blames the Southern planters for the delay in putting the scheme into effect. He declared here yesterday that the syndicate still was ready to proceed with the plan, which he said meant everything to the Southern planters.

"We did not reject the plan," he declared. "It was the South which rejected it, and the Southern farmers are opposed to it only because they do not understand it. They will have to be educated into the knowledge that our scheme is not a speculative one, as they have been led by certain interested parties in the South to believe."

Still Willing To Try Plan.
"We would be willing today to put through the plan we proposed some time ago to the committee from the South, which met in New York and talked over the proposition. We are not trying to urge the South to accept something it does not want, but if it should appoint a committee and send it to us we would see to it that the plan we suggested was put through." "As it is, a number of individual farmers of the South have expressed their desire to have us handle their crop for them on the plan which we proposed for the entire South. This will be a test which will show the rest of the South just what we intend-

NEW HEAD FOR TELEPHONE COMPANY

Brother of Former President Succeeds Him

LATTER CHAIRMAN OF THE BOARD

F. H. Bedel, Chosen As President—Was Former Manager Of The Chesapeake And Potomac Company—Interests Of Concerns He Heads Amount \$175,000,000.

PHILADELPHIA, Dec. 30.—Frank H. Bethell, vice president of the Bell Telephone Company, of Pennsylvania, and associated companies, was today elected president of the Bell Telephone Company, of Pennsylvania, the Delaware and Atlantic Telegraph Company, the Diamond State Telephone Company, the Chesapeake and Potomac Telephone Company, and several other companies, succeeding Union N. Bethell, who becomes chairman of the boards of directors of those companies.

F. H. Bethell's identification with the telephone business in Philadelphia dates from 1906, when he came from Washington to assume the active management of the local Bell Company. In the early part of 1911 he removed to New York to assume, in addition to his other offices, that of vice president of the New York Telephone Company.

The election of Frank H. Bethell, of Washington, Philadelphia, and New York, to the presidency of four of the largest telephone companies in the east, succeeding his brother Union Noble Bethell, who becomes chairman of the board of directors, is another step upward in the remarkable career of these men.

Born in Newburg, Ind., of parents whose ancestry has been long established in America, and entering the same line of work within two years of each other, Union N., in 1888 and Frank H., in 1890, their rapid strides to the top of the telephone industry have followed close rapidly.

After his graduation from Hanover College in 1879, Union Noble Bethell was successively a graduate of the Columbia School of Law, a legal practitioner in the District of Columbia and before the Supreme court of the United States, a special agent of the government in the west, and, in 1888, secretary and treasurer of the New York and New Jersey Company in Brooklyn. He was later general manager of the New York Telephone company, president of the company operating in Washington, Baltimore, and surrounding territories, and president of those companies operating in Philadelphia and eastern Pennsylvania.

Combine Represents Millions.
The consolidation of these and other companies made him the head of an operating unit possessing more than a million and a quarter of telephone stations, with an investment of \$175,000,000, employing 31,000 persons. For his work in adapting the telephone to conditions in Japan, Mr. Bethell was decorated by the mikado with the Order of the Rising Sun.

IMPORTANT CAPTURE BY AYDEN POLICE

A BAD NEGRO NOW IN CUSTODY

About three months ago a negro, Ed Rouse, inflicted serious knife wounds upon two white citizens at Wassau, and in spite of the authorities efforts to make his arrest and bring him to trial, Rouse managed to escape himself from the law. The sheriff of Duplin county offered a reward of \$200 for his arrest and today the police of Ayden, with Rouse safely locked up, wired the Duplin county sheriff that they had his man.

The capture of the "bad negro" was a clever piece of work of Township Constable C. S. Smith and Ayden's police chief, C. P. Moore. About two months ago Rouse's wife took up her residence in Ayden and ever since her house has been constantly watched for the slightest indication of Rouse's presence. The police kept up their vigil and were rewarded last night when Rouse was seen to enter the house. Early this morning preparations were made for his arrest and upon the police order for Rouse's surrender, the negro exhibited a couple of razors and a gun. He managed to dodge the police around the house and would have made use of his gun had he not been assured that the police would use their weapons immediately if resistance was kept up any longer. Reluctantly he gave up and was locked up until the sheriff of Duplin county arrives.

All credit should be given Police-
man Smith and Chief Moore for their
clever work in effecting this capture.
