RAILROAD MAGNATES MEET DEATH IN PRIVATE CAR

J. T. Hanrahan And Other 3 R. R. Chief Victims Of Wreck

ENGINE CRASH INTO PRIVATE CAR

Flagman Testifies That He Did Signal In-Coming Express Train and Conductor Upholds Him—Engine Drivers Testimony Has Not Been Taken Yet.

CENTRALIA, Ill., Jan. 23.—Three investigations are under way to determine the cause of the rear-end collision at Kinmundy, 30 miles northeast of here, early this morning, in which James T. Hanrahan and three other men high in railroad circles lost their lives. The investigations are so far without definite result.

The four men were instantly killed when their private car attached to the rear of the New Orleans express was telescoped by the engine pulling the Panama Limited, running 50 miles an hour.

The coroner's inquest began here today. Witnesses were examined by Deputy Coroner Grant Weatherling, and the inquest was continued until Friday, to enable the crew of the engine of the limited to testify.

The deputy coroner expressed the opinion that the responsibility lies between Engineer Stuart, of the limited, and Flagman Henry J. Broecker, of the express, who lives in Chicago.

Broecker, testifying at the inquest, said he was riding on the next to the last car of the express, and that when it stopped at Kinmundy, 30 miles north of here, for water, he ran back with his lantern, and a block and a half to the rear gave the on-rushing limited a signal. He testified his signal was answered by the engineer by two blasts of the whistle.

BOYS SAVE THREE LIVES

Youths Lay On Ice And Drag Out Their Companions

OWN LIVES IN DANGER DURING RESCUE

Boys of Ten and Nine Arrive in Time to See Comrades Loosing Grip of Ice Cakes and Rescue Them—Carnegie Medals For Heroes.

WASHINGTON, Jan. 23.—Two boy heroes—Arthur Lusby, 10 years old, of 1141 Chicago-avenue southeast, and De Sales Quaid, 9 years old, of 1236 W. street southeast—rescued three playmates from drowning yesterday afternoon from the waters of the Eastern Branch, near Popular Point, where the five had been frolicking on broken cakes of ice. Lying prostrate on the ice the lads crawled to the edge of the opening where their playmates clung, and pulled them out with their coats, which had been tied together for ropes.

Carl Feddon, 10 years old, of 1216 W street southeast; Howard Cummings, 11 years old, of 1218 V street southeast, and Arthur Ludgke, 10 years old, of 2221 Shannon place southeast, owe their lives to their comrades, who risked their own to save them. Feddon and Cummings wore skates, and were being dragged down to certain death in the deep water when aid came.

The five boys, after leaving the Anasostia school yesterday afternoon went in search of adventure along the banks of the Eastern Branch and walked as far as the mouth of the sewer from the navy yard. The ice had been broken in the river by the navy yard tug, and the boys leaped on the cakes like the negro heroine in "Uncle Tom's Cabin."

DISTRICT BILLS ARE SIMPLE RAIDS ON THE TREASURY

Chairman Johnson, Of House Committee Expresses Himself

OBJECTS TO INTEREST CLAUSE

Representative Ben Johnson, of Ken- tucky Chairman of House Commit- tee Takes Entire Afternoon Explaining His Objection to Interest Clause —Half and Half Plan Assailed.

WASHINGTON, D. C., Jan. 23.—Representative Ben Johnson, of Kentucky, chairman of the house district committee, yesterday fulfilled his promise of several days ago, and put a stumbling block in the way of the provision of the district appropriations bill which would allow \$975,480 as next year's payment on the "interest and sinking fund on the funded debt" of the district. He made a point of order against the entire paragraph, saying it had no authority in existing law. This charge is in accord with statements which have been made by Mr. Johnson ever since his appointment as chairman of the district committee.

The house, sitting as a committee on local affairs, was plunged into a discussion by his objections, which took up practically the entire afternoon. Representative Garrett, of Tennessee, who was presiding, took the matter under advisement. His decision, involving not only the legality of the proposed appropriation, but also appropriations that have been made annually for many years, probably will be given to the house today.

Mr. Johnson spoke nearly two hours and received no assistance from any of his colleagues. Representatives Saunders, of Virginia; Taylor, of Ohio and Burleson, of Texas, each made an effort to demonstrate that the law had not been misinterpreted.

CONNAUGHT TO VISIT TAFT

Uncle of British Ruler to Pay Respects to President

CANADIAN GOVERNOR IN NEW YORK

Members of Royal Family Are Being Entertained by Ambassador Reid— Duke of Connaught Will go to Washington Tomorrow.

NEW YORK, Jan. 23.—The one surprise of the first day's visit of the Duke of Connaught was the unexpected revision of his original plan not to go to Washington and the announcement that he had decided to do so to pay his respects to President Taft.

According to the altered plan, the governor general of Canada will leave New York early Thursday morning for the capital city, accompanied only by Col. Lowther, his military secretary. Unless there is a further change of the plans, the dutchess and her daughter, the Princess Patricia, will not go to Washington, but will remain in this city Thursday, and in the evening join the duke here for departure for Ottawa.

The viceregal party spent the day rather quietly at the Reid home, although the duke received a large number of callers, including the British and Russian consuls and former Mayor Seth Low.

Ambassador and Mrs. Reid gave a dinner of about 50 covers tonight in honor of the viceregal party. No official list of guests was given out, but it included Cardinal Farley, Gov. and Mrs. Dix, Bishop and Mrs. David H. Greer, Mr. and Mrs. Joseph H. Choate, Mr. and Mrs. Robert T. Lincoln, and Maj. Gen. and Mrs. Frederick D. Grant. A musicale followed the dinner.

North Carolina News : : : In Brief

Anti-Saloon League Convention Fri- day.

CHARLOTTE, Jan. 23.—The convention season of the year 1912 in North Carolina will begin with the convention of the North Carolina Anti-Saloon League, which will be held in Raleigh Friday, Saturday and Sunday next. A number of speakers of state-wide and national reputation have been secured to take part in the program of this convention, and the leaders of the Anti-Saloon League movement express the hope that the attendance upon this occasion will be the largest and the most representative of any convention in the interest of prohibition and temperance yet held in this state. The invitation to this convention is open to the entire state, no credentials are required and effort is being made to get churches, temperance societies and other organizations that favor the objects of the Anti-Saloon League to send representations to the convention.

Stock Law in West Cumberland Car- ried.

FAYETTEVILLE, Jan. 23.—All of Cumberland county west of Cape Fear river, voted on the stock law question today. No exact figures could be secured tonight, but it is conceded that the stock law has been carried by a good majority. The vote was small. Fayetteville and other parts of prescribed territory are already in stock law bounds, but all voted on the question.

Pinehurst Trap Shooting.

PINEHURST, N. C., Jan. 24.—Noted marksmen from many parts of the country faced the traps today at the opening of the fifth annual mid-winter handicap trap shooting tournament. The event is one of the biggest shooting tournaments of the year. A total of nearly \$2,000 added money is offered. The winner of the Pinehurst Handicap, which will be shot next Saturday, will take down \$500 in cash and a silver trophy valued at \$150.

To Discuss Child Labor.

LOUISVILLE, Ky., Jan. 24.—Many visitors arrived in Louisville today to attend the eighth annual conference of the National Child Labor Committee, which will meet tomorrow for a four days' session. The conference will bring together leading experts on child labor reform and new methods in education from all over the country.

Fruit Men Discuss Problems.

ROCHESTER, N. Y., Jan. 24.—Many prominent fruit growers met in this city today and opened the fifty-seventh annual meeting of the Western New York Horticultural Society, which will last three days. The program provides for addresses by a number of noted horticultural experts from Illinois, New Jersey, Michigan and several other states.

School Trustees of Alberta

CALGARY, Alta., Jan. 24.—The sixth annual convention of the association of school trustees of the Province of Alberta met in this city today for a two days' session. The improvement of rural schools and school sanitation and medical inspection are the

leading subjects slated for consideration. The scheduled speakers include C. W. Mitchell, the Provincial minister of education, and Dr. W. C. Murray, president of the University of Saskatchewan.

Civil Engineers at Montreal.

MONTREAL, Que., Jan. 24.—Leaders of the civil engineering profession from many parts of the Dominion came to Montreal today for the annual meeting of the Canadian Society of Civil Engineers. The proceedings will cover three days. The unusually large attendance combines with an attractive program of papers and discussions to give promise of one of the most successful meetings in the history of the society.

Joseph H. Choate is 80.

NEW YORK, Jan. 24.—Joseph H. Choate, the eminent New York lawyer and former American ambassador to England, was eighty years old today and the occasion was marked by the receipt of a number of congratulatory messages from friends on both sides of the Atlantic. Mr. Choate is a native of Salem, Mass., but has been a resident of New York since shortly after his graduation from Harvard in

Slight Damage Done At The Home Of Mr. E. H. Thomas

LOOK OUT FOR THE THIRD ONE

The nerves of the people of Greenville, especially those on South Evans street and that vicinity, had hardly settled back to normalcy from the fire Tuesday morning, when twelve hours later there was another alarm. It was about 4 o'clock in the afternoon when fire was discovered in the kitchen at the home of Mr. E. H. Thomas, and the clanging of the fire rim sent people hurrying in that direction. It was in the same section, only half a block from the scene of the morning fire. The fire was between the ceiling and weather boarding on the side of the kitchen and had burned through both, but was

COST OF STEEL TO BE KEPT IN DARK BY COMBINES

Head of Steel Combine Asks Stanley Stanley Board to Hide Figures

INJURIOUS TO PRODUCERS, HE SAYS

According to James J. Ferrell, And- rew Carnegie Did Not Know What He Was Saying When He Testified Before Committee—Declares Non- Existence of Agreement As to Prices.

WASHINGTON, D. C., Jan. 23.—James J. Ferrell, president of the United States Steel Corporation, protested before the Stanley steel investigating committee yesterday against unnecessary publicity of manufacturers' cost of steel products in this country as ruinous to foreign trade of domestic manufacturers. The steel corporation head also discussed with the committee the "Gary dinners" and ideas of trust regulation which differed somewhat from suggestions previously made by Elbert H. Gary, executive head of the steel corporation, Andrew Carnegie, and others.

President Farrell asserted that the "Gary dinners," at which steel manufacturers assembled to discuss the trade, had no influence in fixing or maintaining prices, though he thought they had influence in maintaining the stability of the market.

"I do not believe," he said, "that the prices of any two steel manufacturers in the United States today are alike."

"Why has Judge Gary said that the day of competition has passed?" asked Representative Beall.

"I think he referred to destructive competition," said Mr. Farrell. "As a matter of fact, steel prices today are very low. There is no doubt that reports will show that they are not getting the cost of manufacture out of present prices."

WOULD RECALL SUPREME JUDGES

La Follette Declares They Have Justi- fied Doctrine

WISCONSIN SENATOR SPEAKS IN N. Y.

Before Two Large Audiences Robert La Follette Attacks Supreme Court and the Trusts—Introduced by Gil- ford Pinchot, Roosevelt's Man.

NEW YORK, Jan. 23.—The political atmosphere in the East was further charged tonight by the first appearance in this section of Senator Robert M. La Follette, of Wisconsin, since he announced his candidacy as a "progressive Republican" for the presidential nomination.

In connection with the senator's coming there was political gossip to the effect that Col. Roosevelt might also appear at the Carnegie Hall mass meeting which Mr. La Follette addressed, and possibly lend assistance to his "boom," but the colonel was not present. Instead, he attended a dinner of several prominent leaders in charity work at the National Arts Club.

Gifford Pinchot, a close friend of former President Roosevelt, who has been regarded as a staunch Roosevelt lieutenant, appeared with Senator La Follette, however, and presided at the meeting. He presented the senator "as the candidate I support for the Republican presidential nomination."

While the meeting was under way the crowd which sought admittance, grew to such proportions that the police would not allow a further tax upon the capacity of the large hall, and an overflow meeting was held in the street, which the Wisconsin senator addressed, while those inside were listening to Mr. Pinchot.

PRESIDENT TAFT READY TO TAKE ACTIVE PART

Activity In White House Is Of Great Meaning

TAFT AFTER REPUBLICAN BARNES

Taft's Friends Will Do Their Utmost to Instruct New York Delegates to Chicago Convention—Iowa and West Virginia Will be Thoroughly Canvassed For Taft.

WASHINGTON, Jan. 23.—Evidence that the advisers of President Taft are awakening to the fact that they must get their campaign under way at once if they are to offset the work that is being done against them was shown by the activity at the white house yesterday.

For the first time in months there was evidence that all the campaigning is not confined to the various Democratic camps and to Oyster Bay, but that the president himself is in the fight.

The word went forth that the friends of the president were preparing to "get the scalp of Bill Barnes," the New York State Republican leader, who has announced himself in favor of an uninstructed delegation from that state, and that a fight is to be waged against him if he continues to oppose the election of delegates pledged to Mr. Taft's re-nomination.

It was stated also that an effort would be made to elect Taft delegates in Iowa, although Senator Kenyon, now the chief administrator supporter, is expected to support his colleague, Senator Cummins. It is argued, however, that the favoritism movement in Iowa is not likely to be injurious to the cause of the president, and that Senator Kenyon at any moment will be ready to work for Mr. Taft in the convention should any move be made to swing the delegation to any one else.

Frank S. Katzenbach, former mayor of Trenton and for many years a prominent figure in New Jersey politics, is mentioned for the Democratic nomination for vice-president.

VIRGINIA WOMEN REFUSED BALLOT

After Lengthy Discussion Franchise is Refused

LIQUOR LICENSES REVISED UPWARD

License to Cost \$750 and a Hundred Per Cent Increase For Wholesale- ers—Whiskey Privileges Will be Increased \$700,000.

RICHMOND, Jan. 23.—The women of Virginia will not be accorded the privilege of voting by the present legislature, as the house committee on privileges and elections this evening, after a lengthy executive session decided to report adversely the bill providing for an election on amending the constitution to give women the right of ballot. It is not expected that the bill will come to a vote in either branch over the committee's report.

Both houses of the legislature concurred today in the election of former Representative Robert G. Southall, of Amelia county, to succeed Walter A. Watson as judge of the Fourth judicial circuit, Judge Watson, who presided at the trial of H. C. Beatty, Jr., having resigned in order to make the race for congress, and in electing Richard S. Kerr judge of the corporation court of Staunton to succeed Judge Holt, who has been made a circuit judge.

The senate spent most of the session in discussing the Gravatt bill, to have foodstuffs sold by weight instead of measure.

In the house the Stephenson bill, making it unlawful to bet, wager, or play for money, was recommitted by a vote of 43 to 33.

THE HOTEL QUESTION.

So very little have we heard lately about the hotel proposition made by Proctor Bros., of Grimesland, to the moneyed people of our community that we are afraid that not unlike other questions this one has been answered by a silence that does not mean consent.

It would seem that not a fairer proposition could have been put to the business men of this community. For a very long time we have told each other that if there was something Greenville needed and needed mighty bad, it was a modern hotel. It has been shown that a hotel would redound to the benefit of practically every business and property man in Greenville and yet when it came to talking dollars and cents quietness prevailed. It does not mean that we no longer need the hotel in question. Far from it. Only a week ago the hotel facilities were put to a test and they were found to be painfully wanting. The only hotel we possess, worthy of that name, had to turn down people who had come to see what they could see and it was to be deplored that we could not house them better.

We do need the hotel. Greenville is progressive and can surely afford to be so and it is hard to understand how such an important an issue is not given more and prompter attention. It would be ridiculously to expect outsiders to do all for us. We never dream of having our neighbors foot our grocery bills. Out of the question, we say. And thus far we are right. But, why not use the same line of reasoning with the hotel question?

The property owners (that is Proctor Bros.) have made a fair proposition, as we see it, and whilst we do not expect a rush to cover it, sufficient time has elapsed for the moneyed men of our community to think it over and take steps towards accepting it. It is not that \$30,000 can't be rounded up in Greenville. We dare say that many men could put that in individually, yet the fact remains that days after the matter was brought before them by the secretary of the Carolina Club, it would appear that they have decided to decide nothing.

NORTH CAROLINA PREACHERS.

The second North Carolinian to be called to London has finally accepted and after repeated invitations is to sail for Britain's capital to fill the post formerly occupied by Dr. F. B. Myers in Christ Church. Dr. L. G. Broughton is the second Baptist preacher to honor his state in this manner, Rev. A. C. Dixon having gone to London some time ago to become pastor of Spurgeon's church.

Dr. L. G. Broughton was born in Raleigh and although his career began as a physician, he soon deserted it for his favorite calling. He had set his heart on Christian work. He soon entered the ministry and he had

successful pastorates in Winston-Salem, N. C., and Roanoke, Va. From this latter place he went to Atlanta where he built a great congregation together with a church, hospital and all the appurtenances of an institutional church that is monumental. Long ago he received the call from London, but being engaged in building his "monument" he would not desert it and now that he has completed it he is ready to preach the Gospel in the largest city in the world.

Such sons do great honor to the Old North State and we shall follow him in spirit to his new church and congregation.

Something that is considerably agitating the people of that section of the county southeast of Greenville is the stock law territory. The last legislature passed a bill changing the boundaries of the stock law territory, straightening out the line so that a shorter fence would embrace a larger scope, this bill to go into effect the first of this year. There was opposition to the change among those who would be brought under the stock law, and they have been pushing their opposition to the law going into effect and the building of the new fence. This week the matter has been heard before the county commissioners and also before the Superior court, and it has brought in quite a number of interested people. The matter is not yet settled.

The bill before the Virginia legislature to amend the constitution of that state so that women might be permitted to vote, got a knock-out blow on the first round before the committee.

THIS IS MY 40TH BIRTHDAY Charles P. Flint.

Charles P. Flint, eminent as a merchant and capitalist and an author on trade relations between the United States and South American countries, was born in Thomaston, Me., January 24, 1850. In 1868 he graduated from the Polytechnic Institute of Brooklyn and the next year entered the employ of a prominent firm of ship chandlers. Two years later he organized a similar firm of his own and in 1885 he became the head of the shipbuilding and shop-owning firm of Flint and Company,

WITH OTHER EDITORS

Toddy Now Toddless There is a small railroad station in Pitt county, on the East Carolina railroad, named Toddy. Shakespeare is authority for the misleading statement "there's nothing in a name," as the case of the town of Toddy showed. In Pitt county court last week, in the trial of a noted blind tiger from Toddy, it was brought out in evidence that in the months of November and December 229 barrels of whiskey were shipped to Toddy. Most of it was marked to the names of persons dead or unknown, but it was delivered to a notorious blind tiger operator, who was convicted and sentenced to twelve months on the roads.

The conviction of a violator of the law of that character is an event that speaks well for the courts. There remains a matter for the authorities to pursue and end. It seems that most of this liquor was shipped to parties who were unknown or dead, but delivered to a well known law-breaker. The railroad and express companies are to blame here and steps should be taken to compel these corporations to stop becoming the virtual co-agents of the blind tiger operators by delivering whiskey to one man when it is ordered in the name of dead men and men unknown. If the railroads are doing this at Toddy, who knows how general is the practice? A railroad and express company under present laws must haul liquor shipped from another state, but it makes

itself also an aider of the blind tiger operator if it hauls by wholesale and delivers liquor shipped to dead men or unknown men to a party or parties as was done at Toddy. The public service corporations owe a duty, to obey the law, and such conduct makes them in effect the aiders and abettors of law violators. Why should not the authorities demand and receive a statement of all liquor hauled by their companies and the persons to whom shipped?—News and Observer.

The Norfolk Southern railroad is continuing its enterprises of bringing possible settlers into this territory in the eastern part of the state. Last week it carried a special train of people from Ohio, New Jersey and Pennsylvania to Greenville, where the visitors were given good entertainment at the East Carolina Teachers Training school. These excursions are conducted by Mr. B. E. Rice, the land and industrial agent of the Norfolk Southern. The Greenville Reflector says: "He is the man who looks after getting up and conducting the Northern and Western Excursion parties into this section, and accompanies them. Even on the train he can't keep still, but is constantly on his feet, pointing out things in passing and explaining the advantages of eastern North Carolina." The Norfolk Southern is the sort of a railroad Charlotte wants to secure.—Charlotte Chronicle.

As a result of his successful efforts in organizing the United States Rubber Company and other large industrial combinations, Mr. Flint has frequently been called the "Father of Trusts."
