North Carolina News : : : In Brief

Three Charters Granted.
RALEIGH, Jan. 26.—The Bank of Coats, Harnett county, was chartered today with \$50,000 capital authorized and \$5,000 subscribed by J. T. Coats and others of that section for general banking business. Another charter of special interest is the United Fruit Growers of Western North Carolina (Inc) of North Wilkesboro, capital \$100,000 authorized and \$2,000 subscribed by H. W. Horton, M. L. Townsend and others of the North Wilkesboro section for handling fruits, vegetables, produce, meats and all produce and necessities of western North Carolina and for maintaining canning factories, cider and vinegar generators. There is also a charter for the Reidsville Hardware Company of Reidsville capital, \$25,000, by G. A. Miller and others.

Wayne County Man Gets Ten Years For Killing Another.
GOLDSBORO, Jan. 26.—The case of State vs. Harrison Johnson, charged with killing J. H. Bowen, both white was given a hearing this afternoon. Johnson plead guilty of manslaughter and was given ten years in the penitentiary. Johnson carved Bowen to death with a knife on the public road just before Christmas.

Tobacco is Bringing Good Prices on Kinston Market.
KINSTON, Jan. 26.—One of the best pleased men on the tobacco mar-

ket yesterday was George H. Parker, of Grifton, of the firm of Tucker and Parker, tobacco planters, who, after having figured his possible income from the day's sale, received a check for \$160 instead of the \$110 which he expected. Mr. Parker received an average of 16 cents a pound, and his offering was not fancy tobacco.

Wentworth Flouring Mill Totally Destroyed by Fire.

WENTWORTH, Jan. 26.—The flouring mill at this place, the property of T. Ruffin McCollum, was destroyed by fire yesterday. The origin of the fire is unknown. There was insurance of \$1,000 which will not cover the loss, as it was a very nice country mill property. Mr. McCollum intends to rebuild, if possible.

Found Dead in Bed.
MOUNT AIRY, Jan. 26.—Two children found dead in bed was the record of last week, and while this is an unusual occurrence, strange to say, both deaths occurred in a few miles of each other and only two days apart. On Thursday morning Mr. and Mrs. Cleve Golding, on R. F. D. route No. 6 found their one month old infant dead and no cause could be assigned for its death. On Saturday morning Mr. and Mrs. Dixie Fletcher of this city, were bereft of their two-months-old infant in precisely the same manner.

COL. ROOSEVELT MAINTAINS SILENCE INSPIRE OF FRIENDS

Lodge and Longworth pay Visit to Former President

T. R. FAILS TO DEFINE HIS POSITION

Friends Admit That They Talked Politics to Ex-President But Declare They Are Unable to Throw Light on the Situation Owing to Roosevelt's Failure to Explain Himself. Plan For Aggressive Campaign.

WASHINGTON, D. C., Jan. 26.—Senator Lodge and Representative Longworth returned yesterday from a visit to Col. Roosevelt. Neither of them brought back to Washington any statement from him concerning his attitude with respect to the Republican nomination. If they went to see Col. Roosevelt for such a purpose their mission was a failure, although Senator Lodge is quoted as having told some of his colleagues yesterday afternoon that he urged the former President not to be a candidate.

Whether these two Republicans went to New York on behalf of the President or on their own responsibility is not known. In discussing his visit with his colleagues Senator Lodge declined to go much into the detail about what Mr. Roosevelt may have said, but he did admit that he brought back no pledge.

Representative Longworth, also, could throw no light on the situation. That they talked politics he did not deny, but this interview does not seem to have changed the Cincinnati member's position.

SECRETARY KNOX ADMITS THAT HE HAS BEEN LENIENT

Secrecy of state Department as to Funds Called "Loose"

MONEY SPENT FOR FLOWERS

Member of Cabinet Exhibits Letter From President Taft Before House Committee. Chief Executive Was in Favor of Having Statements of Canadian Celebration Expenditure Made Public. Correction of Improper Custom Ordered.

WASHINGTON, D. C., Jan. 26.—That the custom of the State Department of keeping secret numerous appropriations made by Congress for specific purposes on the ground that they were of a diplomatic nature was "loose," and that this practice, as applied to the \$20,000 appropriation for the Lake Champlain celebration in 1909 was "improper," was admitted yesterday by Secretary Knox to the House committee on expenditures in the State Department.

Secretary Knox took to the committee room the vouchers for the Lake Champlain expenditures, in response to a subpoena and read a letter he had written to President Taft who under the law has discretion concerning the publication of diplomatic expenditures and the President's reply to the effect that the Lake Champlain accounts ought to be placed before the committee.

"In congratulate you, Mr. Secretary, on getting around to our view of this matter," said Representative Courtney W. Hamlin of Missouri, chairman of the committee. "It didn't take me long to get there when I got started," smilingly replied the Secretary.

What the World is Doing—Told by Wire

The German Emperor's Birthday.
BERLIN, Jan. 27.—Emperor William celebrated his fifty-third birthday anniversary today. The usual court festivities were attended by royal and princely persons from all parts of the empire. Berlin observed the day as a general holiday, the festivities being in the nature of a continuation of the Frederick the great bicentenary celebration which has occupied the greater part of the week.

Kansas to Celebrate.

WASHINGTON, D. C., Jan. 27.—Kansas in the national capital area to celebrate Monday the anniversary of the admission of their state into the Union. Plans for the observance of the day by the Kansas Association of Washington include a banquet and appropriate exercises with addresses by members of the Kansas delegation in Congress.

Virginia Railway May Extend.

NORFOLK, Va., Jan. 27.—Stockholders of the Virginia Railway at their annual meeting here today voted to increase the capital stock from \$36,000 to \$65,000. The added capital, it is understood, to be employed in extensive improvements, with a possible extension to the Great Lakes through new lines or purchase of existing lines. The road was built by the late H. H. Rogers and is still controlled by his estate.

Wilson to Visit Rhode Island.
PROVIDENCE, R. I., Jan. 27.—Politicians here are looking forward with considerable interest to the visit of Governor Woodrow Wilson, who is coming to Providence tomorrow for the purpose of conferring with the Democratic leaders of the state upon the coming presidential campaign and the general situation in Rhode Island. During his stay here the New Jersey executive will be the guest of former Governor James H. Higgins.

Indiana Socialists Active.

INDIANAPOLIS, Ind., Jan. 27.—Representatives of the Socialist party in Indiana gathered in the capital today for a two day's convention to complete plans for an active campaign this year. Nominations for a state ticket will be made by the convention and submitted to a referendum vote.

Boston to Welcome New Cardinal.

BOSTON, Mass., Jan. 27.—Boston Catholics, with the co-operation of members of the denomination throughout New England, today completed the elaborate preparations for the welcome of Cardinal O'Connell upon his return home from Rome. The new Cardinal and his suite are passengers on the White Star liner Canopic, which is due to arrive here Monday. The ceremonies of welcome will be continued an entire week.

FIGHT FOR TARIFF IS ON TO DAY

Underwood Reports New Iron And Steel Schedule

REPUBLICANS SHOW THEIR STAND

Party Vote Loses Consideration of Revision Measure for Tariff Board Statement—Plea for Reform Meets with Open Debate.

WASHINGTON, Jan. 26.—The tariff revision debate of the sixty-second congress will begin today in the house when Representative Palmer, of Pennsylvania, will open the argument in favor of the steel and iron schedule reported yesterday by Chairman Underwood, of the ways and means committee.

The attitude of the Republicans toward the Democratic revision program was indicated at yesterday's meeting of the committee, when Representative Payne moved that consideration of the iron and steel schedule be deferred until a report had been received from the tariff board. This was lost by a strict party vote. The Republican members indicated that there would be no Republican substitute for the Democratic bill, but a long string of amendments would be offered.

DISTRICT BILL PASSED BY HOUSE MEMBERS

They Agree to \$10,307,000 Appropriation

REDUCTION MADE IN MILITIA PAY

Extra Compensation of \$1.25 Per Day Lost by 1,500 National Guardsmen. Total of Appropriation Increased by \$5,150. No Provisions Made For Establishment of Garbage Reduction.

WASHINGTON, D. C., Jan. 26.—The District appropriation bill, the provisions of which provoked constant wrangling throughout ten legislative days, was passed late yesterday by the House. The measure, so far as the total which it would appropriate is concerned, will be sent to the Senate Monday, practically unchanged, as it was reported by the committee on appropriations. The committee asked for \$10,302,208 and the House gave \$10,307,358 the increase being \$5,150.

Just before the bill was passed, Minority Leader Mann made a motion to recommit it to the appropriations committee with instructions to report it back to the House immediately with amendments providing for additions to the Chevy Chase, the Bifney and the Takoma Park school buildings. The motion was defeated 121 to 74.

Representative Johnson of Kentucky chairman of the District committee, kept up his campaign against the provisions of the bill to the end. He succeeded in eliminating the paragraph allowing \$24,000 to the troops of the District National Guard by the use of his deadly point of order. The amount was reinstated through an amendment by Chairman Burleson, but in such a way that the money cannot be expended to enlisted men in the same way as heretofore.

POLITICAL FORECAST FOR COMING WEEK

Important and Political News From National Capital—Schedule of Next Week's Business

REFLECTOR'S WEEKLY LETTER FROM CAPITAL

WASHINGTON, Jan. 27.—Here is some more evidence of how "protection" does not "protect" the workman. The following is an extract from an appeal for arbitration sent by the 15,000 striking textile workers at Lawrence, Mass., to William M. Wood, president of the woolen trust:

"We are of the opinion that you have had ample time to consider the demands of the men, women and children who have made the American Woolen Company what it is today. In view of the fact that machinery has been improved, the workers turn off more and more work, but they are not paid accordingly, even though the prices of food, clothing and shelter has in many cases increased 50 and even 100 per cent within the last few years.

"We, the committee, are willing to meet the officials of the company at any time and submit the grievances of the strikers. So if you believe in a square deal you will not refuse to meet with us, but will come forward at once and try to bring the trouble to a final conclusion. You must bear in mind the fact that these men, women and children have not gone on strike for light or transient causes, but because they could no longer bear up under the burdens laid upon their shoulders. It seems to us that the American Woolen Company has within the last few years built several mills, which are paid for, according to your own figures and the company has even in the worst of times managed to pay dividends.

"The workers are of the opinion that the only competition left is the struggle among themselves for a miserable job at \$6, \$7 or \$8 a week." And this is how Schedule "K" "protects" the workman, for whos benefit the Payne-Aldrich bill

(according to Payne and Aldrich) was passed.

Since the protectionists admit that Schedule "K" which places a heavy tax on every article of woolen clothing sold in the United States, was designed solely to benefit the working men in the woolen industry, and since the \$6, \$7 and \$8 wages paid by the woolen trust demonstrates beyond successful contradiction that that Schedule "K" does not protect the workers, why should the American people longer tolerate Schedule "K"?

Data Disappears.

Several months were spent by Hon. Jonathan Bourne, Progressive Republican senator from Oregon, in gathering data on the subject of the use of federal patronage to control national conventions. One night recently his office was entered and his files were looted of all this material.

The Fallacy of Protection.

Whenever an American trust wants the tariff rate raised, it bases its plea on the argument that "American manufacturers cannot compete with the cheap labor of Europe."

In eleven months of last year the exports of iron and steel products, together with agricultural improvements and freight and passenger cars, amounted to nearly \$270,000,000—an increase of about \$54,000,000 over the corresponding period of 1910.

These materials are exported from this country to all parts of the world. In the face of the competition of England, Belgium, Germany and France. The steel trust's foreign competitors had the advantage of that "cheap labor" which the trusts and their Republican friends fear so greatly whenever a proposal is made to lower the tariff, yet the trust's trade in foreign markets is constantly on the increase. ROYAL WELCOME ACCORDED TO DUKE OF CONNAUGHT

Big Crowds Cheer Duke As He Proceeds Along Streets of Capital

WHITE HOUSE WELCOMES GUEST

Duke of Connaught Remains Only Eight Hours in National Capital, But Has Strenuous Time. Informal Reception Given in His Honor by National Press Club. Uncle of British Ruler Received at Union Station by High Officials.

WASHINGTON, D. C., Jan. 26.—His royal highness the Duke of Connaught was received in the Capital of the United States yesterday with all the pomp and ceremony due to a member of the reigning family of Great Britain and the official head of the Dominion of Canada. President Taft and Ambassador James Bryce of Great Britain, united in making the event one of the most memorable ever arranged in Washington, except when the late King Edward, then Prince of Wales, visited President Buchanan in 1860 and when Prince Henry of Prussia called upon President Roosevelt.

The duke was in Washington a few minutes less than eight hours, but during that time he went the "American" pace, calling on President Taft at the White House, receiving a return call from the President at the British Embassy, being the guest of honor at a dinner at the embassy, given by Ambassador Bryce and later at a reception at the embassy; then paying a call and making an address at the National Press Club, and finally boarding his special car for New York shortly after midnight.

SENATOR BROWN OPENS TAFT FIRE

Initial Shot in Favor of Taft Fired by Nebraska Senator

WARMLY PRAISES TAFT'S RECORD

Senator Brown Declares That There Would Not Be Enough Votes in Democratic Electoral College If Press Were to Tell The Truth About Taft.

INDIANAPOLIS, Ind., Jan. 26.—Achievements of President Taft's administration were defended here tonight by Senator Norris Brown of Nebraska at the annual banquet of the Republican editors of Indiana. The speech was regarded as a keynote of the administration efforts in launching a country-wide campaign. Besides the editors, Republican party leaders from all over the state attended the banquet.

Senator Brown reviewed at considerable length what had been accomplished by President Taft and the Republican party and laid the greatest stress on the Payne-Aldrich tariff law, railroad regulation, direct election of United States senators, income tax amendment, enforcement of the anti-trust law and other measures and the peace treaties. He praised the Payne-Aldrich bill and added:

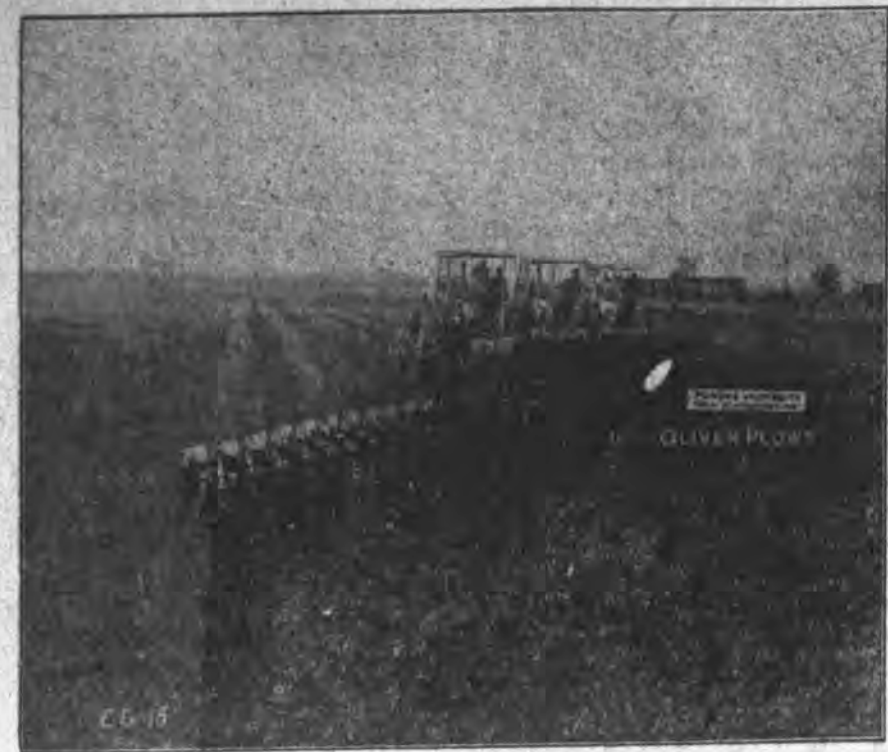

S. A. REPUBLICS IN SESSION

(Continued From 1st Page). The Argentine minister of foreign affairs, Ernesto Bosch, has received a telegram from the Minister at Asuncion, announcing that he had not received a reply from the Paraguayan government to Argentina's demands for satisfaction he had withdrawn from the legation this afternoon and with his whole staff had gone aboard the Argentine gunboat Parana. He added that he would arrive at Buenos Aires tomorrow.

On January 24 the Argentine government ordered the dispatch of four warships to Paraguay in anticipation of the breaking off of diplomatic relations.

The Argentine foreign minister recently instructed the Argentine Minister at Asuncion to present a formal claim for compensation for the attacks on Argentine shipping and property. The Paraguayan government refused to discuss the matter and the Minister was then instructed to demand satisfaction within 24 hours. The trouble arose through Paraguayan revolutionists firing on Argentine vessels lying in Asuncion harbor.

POLITICAL FORECAST FOR NEXT WEEK

(Continued from 1st Page). We will see the people allow themselves to be fooled by trust "logic."

Taft and the People. President Taft, in his recent speech at New York used these words: "The people are not always able to decide what is best for them. A great many men who believe this to be true lack the courage to say it."

In explaining that "the people do not always know what they want," the president made no mention of the fact that the people do not always have a chance, under the present cumbersome election methods, to give expression to their opinions. The people, for instance, probably would not be in favor of allowing hundreds of office holding Republicans in the south to nominate the candidate for president, but how can they help themselves? Moreover, when the people decide almost unanimously that they want a certain thing, such as the recall in Arizona, the president steps in and says they shall not have it. Apparently it makes small difference to Mr. Taft whether the people know what they want or not.

Railroad Wrecks. The tragic deaths of former president J. T. Harahan, of the Illinois Central, and three other high railroad officials, at Kinmundy, Ill., again illustrates the small regard American railroads have for human lives, compared to other nations. The number of passengers killed in this country in 1908 was 301; in 1909 the number was 253, and in 1910 the number rose to 421. These figures are for passengers alone, and do not include trainmen and other employes among whom the fatalities annually reach into the thousands.

Against this slaughter of American railroad passengers the British railroads, in 1910, killed only 23 passengers, a number greatly in excess of the average. 1911 not a single passenger was killed in a wreck in England.

That these wholesale deaths are not necessary in this country is proven by the fact that one of the big eastern roads, for the last two years, has used nothing but solid steel coaches, during which time not a single passenger has been killed in that road.

To Resume Through Car Service. CHICAGO, Ill., Jan. 27.—The Chicago, Rock Island and Pacific and the Chicago, Burlington and Quincy railroads have arranged to resume through sleeping car service tomorrow to Los Angeles and San Francisco in connection with the Denver and Rio Grande and Southern Pacific and Western Pacific lines. This service was discontinued last September, owing to a controversy between the lines east and west of Ogden.

Boston Motor Boat Show Opens. BOSTON, Mass., Jan. 27.—Boston's annual motor boat show the place where the boat builders, the engine makers and the manufacturers of nautical fittings for power craft disclose to the public their latest product for the coming season, opens in Mechanics' Building tonight and will continue for one week. Every available foot of space in the big exhibition hall is filled with exhibits, some three hundred manufacturers having been assigned places.
