WOMAN ASSUMES GUILT IN ORDER TO SAVE HER BROTHER

Although No Confession is Made, She
Points to Self

INSULT FILLED HER WITH RAGE

Mrs. Martin Does not Make Confession
but Leads Lawyers to Moment
When she Faced Muldoon, Knife in
Hand—Filled With Rage at Insult
From Man for Whom She Had
Deserted Home.

NEW YORK, Jan. 31.—That she had done the killing of which he was accused was practically confessed yesterday by James McDermott's younger sister at his trial for manslaughter in general sessions. Her startling story was not shawen on cross-examination, but Assistant-District Attorney Manley will question her sharply again today.

McDermott fatally stabbed Charles Muldoon in the barroom at the southwest corner of Lenox avenue and One Hundred and Thirteenth street, on March 17 last, the charge runs. McDermott, who is about twenty-four years old, was a clerk in the Hotel Belmont on West Forty-fifth street, and lived with his brother at No. 431 West Thirty-eighth street. His sister, twenty-two years old, Mrs. Theresa Martin, lived at One Hundred and Twelfth street and Lenox avenue. She had separated from her husband and was seen much with Charles Muldoon, who was a customs inspector. McDermott bitterly opposed the intimacy. On the night of March 17 he found his sister with Muldoon in the barroom. The men quarreled. She left the place. Then McDermott stabbed Muldoon to death, it is said.

SOCIALIST SEE DISSENTION IN ARMY AND NAVY

Secretary Of Navy League So Declares
In Washington

SEEK TO DISRUPT BOTH THE BODIES

That the Socialists are Trying to
Cause Dissatisfaction Among En-
listed Men, is the Accusation Made
by Secretary of Navy League—Will
Try to Prosecute Them as Soon as
Possible.

WASHINGTON, Jan. 30.—A campaign is being conducted by us to offset the socialistic attacks on the army and navy in their efforts to discourage enlistments in both arms of the military service and advising the men to desert and to mutiny, said Henry W. Ward secretary of the Navy League of the United States and formerly a captain in the navy, today.

"When it is possible to do so the league causes criminal prosecution of those responsible for the propaganda, furnishing prosecuting officers with evidence with which to convict the offenders. The post office department is assisting in this work and investigations are constantly in progress to locate persons responsible for sending through the mails matter that may be regarded as treasonable.

Much Cotton Being Stored.

Statesville.—More than 1,000 bales of cotton have been stored in Iredell county waiting for higher prices and the number is increasing each day. In order to accommodate the demands another warehouse has been built by the side of the one filled with cotton, for the purpose of storing.

COL. WATTERSON ASKS NO "WHICH ONE HAS LIED?"

Asserts That Gov. Wilson Is Afraid To Face Controversy
Issue

WAS FORCED TO JOIN NEW JERSEY GOV. FORCES

Editor Declares He Was Dragooned to Aid Presidential Campaign of New
Jersey Governor—Further Says That Wilson is Now Afraid to Face
Facts—Ready to Produce Conclusive Evidence—Knew About Ryan's
Proposed Contribution.

"The sole issue is whether I have lied, as Gov. Wilson says I have, or he has lied, which I have engaged conclusively to show: He dared not face the facts."

When Col. Henry Watterson wrote that, which is but one of many concise specimens of the king's English, in the use of which he is a past master, and gave it to the public last night, his final word in the Watterson-Wilson-Tillman muddle, he bequeathed to posterity a remarkable political document. No candidate before the American people asking their support for the nomination for the highest office within the gift of the electorate ever has been the victim of a pen more sarcastic than that with which Col. Watterson indicted his arraignment of Governor Wilson.

Awaits Word From Governor.

The country now will wait in impatient mood to see in what vein will come the retort courteous from the scholarly and learned Dr. Wilson, who, having left behind him the cap and gown, is now scurrying about the country beating the bushes for votes for Woodrow Wilson, the politician.

Col. Watterson characterizes the whole affair as a "most distasteful episode," which, so far as he is concerned, has been brought to a close because of Mr. Wilson's refusal to accept his proposition regarding the proofs he holds. Col. Watterson justifies his withholding publication of these proofs on the ground of party prudence and desire to avoid an invasion of private rights. Apparently there is in this statement an admission that it would not be wise for the party that the country should know whence came the funds. Specifically, however, he denies that any came from Ryan.

Reviews the Whole Circumstances.

The veteran editor begins his communications with a review of the circumstances to which he owes "the misfortune of having made Gov. Wilson's acquaintance." During one of his several conferences, he says, reference was made to the senatorial primary in New Jersey that had gone by default, "in which a person named Martine, represented as wholly unfit, had obtained a rather meager vote."

The succeeding months, he says, brought him into confidential relations with Gov. Wilson. This recital brought out a certain conference at the Manhattan Club in New York about which Col. Watterson, for some purpose not expressed, but implied, says as little as needful "to justice between man and man." This conference seems to have been the result of "a most urgent appeal for money from a gentleman of distinction, closely associated with, if not actually directing the Wilson organization." Col. Watterson admits this conference was called to consider ways and means—"else why, and for what," he asks, "was Gov. Wilson there?"

WOMAN KILLED; POLICEMAN STABBED IN LAWRENCE RIOTS

Governor Foss Sends More Troops to
Massachusetts Town

FOSS URGES OPERATIVES TO GO BACK

Striking Workers Attack Cars in
Which Strike Breakers Attempt to
Reach Mills—Day of Rioting in
Lawrence, Kills Woman, Wounds
Many—Meetings and Parades Are
Forbidden—Militia Guards Mills.

LAWRENCE, Mass., Jan. 30.—A day of rioting culminated tonight in a battle, in which one woman was killed and a policeman was stabbed by rioting strikers or sympathizers. A thousand men and women attacked the Everett mills tonight. Police and militia, using clubs and rifle butts freely, succeeded in breaking up the mob.

The victim of tonight's riot was Anna Lopez, a striking millhand. A man nearby was firing a revolver into the ground when the woman dropped. It is believed she was struck by a glancing bullet.

When the crowd first gathered, police went to the scene, but had little effect in quelling the disturbance. Officer Benit became separated from his companions, and while surrounded by nearly 100 angry, threatening men was stabbed in the back.

Additional officers arrived, but although they used their clubs freely, they made little impression on the crowd until two companies of militia came up.

PRESIDENT TAFT MAKES ISSUE OF TARIFF IN OHIO

Cleveland Speech is Hailed as Cam-
paign Keynote

WILLING TO STAND ON HIS RECORD

Republicans Should Ask Verdict of
Country as to Whether Wool and
Cotton Revision Should Have Been
Accepted in Form in Which They
Were Drawn—Faces Future With
Great Confidence.

CLEVELAND, O., Jan. 30.—The big event of the first day of President Taft's three-day visit to his own state came this evening at the McKinley day banquet given by the Tippecanoe Club at the chamber of commerce.

Addressing 650 northern Ohio Republicans grouped about the banquet table, the president made a stirring appeal to the Republican party to stand by its guns and rest confident that it has carried out the pledges it made to the people of the United States.

He declared that he faced the future with equanimity and in the belief that the judgment of the country would prove him right in his opinion.

To his hearers it appeared that a "key note speech," on which the coming campaign might be fought to a finish, was being delivered.

"Looking over the record of what has been done," said the president, "it seems to me that we are armed with the facts and with things accomplished sufficient to meet our enemy in the open field and to overcome him, in the judgment of an impartial umpire."

CONDENSED NEWS ITEMS FROM EVERYWHERE

What the World is Doing—Told by Wire

Welcome for Chief Scout.
NEW YORK, Jan. 30.—When Sir Robert Baden-Powell, the hero of Mafeking and the founder and chief scout of the British Boy Scouts, arrives here on the steamer Arcadian which is due in this port tomorrow, he will meet with an enthusiastic welcome. Extensive arrangements have been made for welcoming him upon his arrival and for entertaining him during his visit to this city. The principal object of Gen. Baden-Powell's tour is to further the boy scout movement of which he is the father. His tour will last six weeks and will take him to a number of the largest cities of the United States and Canada.

During his stay in New York Sir Robert will be royally entertained. He will attend the second annual meeting of the National Council of the Boy Scouts of America which will be held here February 9, and on the following day he will witness a demonstration of scout activities by more than 5,000 boy scouts. On the evening of that day the General will give an illustrated lecture on "Scouting in Peace and War." He will also visit the George Junior Republic at Freeville, N. Y., in which he is greatly interested. There are about 300,000 boy scouts and more than 6,000 scout masters in the United States alone and an equally large number in Canada, which in a measure amounts for the great interest with which the arrival of Sir Robert is awaited.

From here General Baden-Powell will go to Boston and then to Washington, where he will meet President Taft, the honorary president of the Boy Scouts of America. At the conclusion of his tour Sir Robert will sail from San Francisco for Australia.

To Meet in Iowa City.

IOWA CITY, Ia., Jan. 31.—Preparations have been completed for the meeting here next week of the fifth annual conference of the church workers of the state universities of the United States. The sessions will begin Tuesday and continue two days.

Pallium for Mgr. Pendergrast.
PHILADELPHIA, Pa., Jan. 31.—Before a distinguished portion of the Roman Catholic hierarchy of the United States, including the three American cardinals and numerous archbishops and bishops, the Most Rev. F. Pendergrast, archbishop of Philadelphia, was today invested with the sacred pallium. This insignia is the official recognition by the church of the archbishop's power to succeed to the functions of the late Archbishop Ryan, who died February 11, last.

The ceremony took place in the Cathedral of St. Peter and Paul. The structure was decked in the papal colors, yellow and white, interspersed with the American colors and the archbishop's purple. The rarity and significance of the occasion and the presence of so many dignitaries of the church attracted a large crowd. The vicinity of the cathedral was roped off entirely an hour before the ceremonies began.

Perkins Tells How to Succeed.

NEW YORK, Jan. 31.—George W. Perkins, who started his business as an office boy in Chicago and later became a partner of J. P. Morgan and Company in the banking business, was fifty years old today. The eminent financier did not permit the anniversary to interfere with his ordinary routine of work. Just at present Mr. Perkins is an exceedingly busy man, for, if rumor is correct, he is looking after the financial end of the Roosevelt presidential boom, in addition to giving his time and attention to the many great business enterprises in which he is interested. When asked to give his advice to the young men who are eager to succeed in life he replied: "Keep pegging away. Time and conditions may change, but the old rule remains the same, that there is no success without keeping everlastingly at it."

CANDIDATES AGREE ON PRIMARIES

Agreement is Arrived at Conference
Held Saturday

CANDIDATES SIGNED STATEMENT

The Four Senatorial Candidates Met
in Raleigh, in Supreme Court Room
and Agreed as to Primaries—All
Sign Document to This Effect.

The four senatorial candidates, ex-Governor Charles B. Aycock, Chief Justice Walter Clark, Governor W. W. Kitchin and Senator F. M. Simmons met by agreement in the supreme court room in Raleigh Saturday and made the following unanimous agreement as to the primary and the expenditures in the campaign.

We, the undersigned candidates for the United States senate,

1. Respectfully ask the Democratic state executive committee at its coming meeting to recommend to the Democratic state convention to order a senatorial primary to be held on the day of the general election in November, and we further respectfully ask said committee that it prepare rules for the holding of said primary and submit them to the state convention.

2. We agree that we will offer to the newspaper reporters in the city of Raleigh and request prompt publication thereof, not less than ten days before the nomination, and also again within ten days after the nomination, all amounts expended by us in the senatorial contest, which are required by the federal state to be filled by senatorial candidates with the secretary of the United States senate—the purpose of this agreement being to forthwith give the public the information required by act of congress to be

LAWYER DARROW IS BEING HELD

Accused of Attempting to Bribe Some
of Jurors

PLACED UNDER \$20,000 BAIL

Counsel For Dynamiters is Placed
Under Bail Which He Furnishes
And Takes Lawyers to Defend Him.
District Attorney Threatenes That
Others Will Follow Darrow.

LOS ANGELES, Cal., Jan. 30.—Clarence S. Darrow, union labor attorney, today was indicted for bribery and corruption of jurors by the county grand jury, which for four weeks has been investigating allegations of corruption in connection with the trial jury in the McNamara dynamite case.

Two indictments were returned containing four counts. Two of the counts charge Darrow with the bribery and attempted corruption of Robert Bain, the first juror sworn to try James B. McNamara, the confessed dynamiter and murderer, now serving a life term in San Quentin prison. The remaining counts allege the bribery and corruption of George N. Lockwood, a venieman, summoned in the McNamara case.

Rock Hill Plan.

Raleigh.—Releigh is to have the first of a series of meetings to take action on the "Rock Hill Plan." This is to be on the first of February. The "Rock Hill Plan" for aiding the cotton farmers at this meeting is to be presented to the people of the state. The plan in brief is for a reduction of acreage by 25 per cent and for the planting of a larger acreage than theretofore of various food crops. Col. E. J. Watson, the president of the Southern Cotton Congress, is to visit the capital of each Southern State to present the plan, this at the request of the State Farmers' Union of South Carolina. He is to confer with officers and is to set the machinery of the plan in motion. He will be accompanied by Mr. J. G. Anderson, of Rock Hill, the proposer of the plan.

Farmers' Institute.

New Bern.—On next Wednesday, January 31, a Farmers Institute will be held at the court house. The morning session will open at 10 o'clock and the afternoon session will begin at 1:30 p. m. The institute will be conducted by Mr. Frank Sherman, entomologist, of the state department of agriculture, with a competent assistant, who will discuss agricultural topics of interest to the farmers. At the same time and place a Woman's Institute will be held and conducted by Mrs. W. R. Hollowell and Mrs. Orr. Every farmer in the county with his wife, daughter and son, are requested to be present.

Appeals for Red Cross Funds.

Raleigh.—As ex-officio chairman of the North Carolina section of the Red Cross Society Governor Kitchin issues an appeal to the people of North Carolina for contributions to be used in relieving the suffering of the Chinese in the famine zone of the empire. Joseph G. Brown, of Raleigh, is treasurer for this state. The appeal by the governor is following that of President Taft for the whole country, issued yesterday.

The M. B. Entertain.

Morehead City.—Last Friday night the M. B. entertained at Hotel Charles from nine to twelve in classy manner. The guests were received by a committee and conducted to the cloak and coat rooms, then to the drawing rooms, where various amusements were indulged in; music and conversation being the most prominent forms. At ten o'clock an elegant six course supper was served in the dining hall. Then a return to the parlors and sundry pastimes until twelve when all repaired to their homes, having had a very delightful evening.

Fire in Simpson.

SIMPSON, Jan. 31.—Early this morning fire totally destroyed the home of Mr. W. E. Tucker here. At six this morning a fire was made in the kitchen to prepare breakfast and in some way it wasn't confined to the stove as pretty soon the kitchen was wrapped up in flames and before any material assistance could be rendered the house was a total wreck. The cause of the fire as far as could be ascertained was a defective flue. Damage was to the extent of \$3,500, with insurance of \$1,700 carried by H. A. White agency in Greenville.

Bullet in Brain.

Weldon.—J. A. Rittenbarger, a prominent citizen of the town, committed suicide yesterday by sending a bullet into his brain. He lived three hours after the rash act. His home life was happy, and he leaves a wife and four children. He suffered a sunstroke the past summer and since that time he has feared he was losing his mind. He appeared in his usual health at dinner hour, ate the mid-day meal with his family and went off to his room and fired the fatal shot.

BOOSTING A TOWN.

Two cities in the Union with hundreds of miles between them have made such rapid steps towards progress, growth and wealth, as to claim the attention of many cities that are trying hard to "get there."

Detroit, Michigan, and Birmingham, Alabama, are the two cities. One almost in the extreme north, the other almost in the extreme south of the Union, and in spite of their variance of latitude the same methods have been adopted by the interested citizens of those towns to work their way to where they stand today. Birmingham had a population of 38,415 little over ten years ago. Birmingham has today a population that exceeds 140,000. This is a gain of over 245 per cent in a decade. Its production has increased in the same proportion and its buildings alone are valued at over 3 1-2 billion dollars. This is indeed a fine showing for Birmingham and we congratulate the fair city of the South.

Detroit claims for itself as fine a showing as made by Birmingham. We will only mention one item that shows clearly how one single desirable industry brought its own increase of population. One company began to operate with 350 employees. It has now on its payroll over 2,000, or an increase of nearly 250 per cent in a few years.

How have these cities attained success? By a simple process of systematic co-operation. Such associations as a Board of Commerce, a Board of Trade, a Real State Board, an employers' association, etc., etc., working closely together have done for those two cities what they have today.

These institutions have worked, and for that matter are still working along lines of co-operation and Detroit and Birmingham are growing examples of their efforts.

We don't know if the people of Detroit and Birmingham had any hatchet to bury when their towns were small. It is a "dead cert" that there is something else which they did certainly bury, and that was the hammer. This instrument is by far the most dangerous one that can be used to destroy the pavement of a road to success. People who are perfectly in earnest and willing about certain changes or additions in a community will listen doubtfully to the hatchet-wielder. This party with the chopper, may have a grievance against certain progressive citizens back of the movement for better things. That is why his words do not go such a long way to impress the listener. On the other hand, the man with the hammer may be a fairly good citizen, with absolutely no apparent interest in the matter in question. Nine times out of ten, he really has no interest in it. For this reason he is liable to be paid attention to. His words will go a long way towards dissuading his audience. And, therefore, the danger of the hammer.

It has always been an injustice to the fair sex in crediting them with

exclusive privileges to "knock." We, the men, are just as given to use the mallet as the ladies are.

So if we are to use anything at all, let us take out the hatchet and bury the hammer in its place. We are not liable to do so much damage with it, and in the end the whole community will be better off for the exchange of weapons.

FRONT YARDS.

We are very sorry that the majority of cases compels us to head this "Front Yards," as we would like to say "Front Gardens," but if we are to stick to the "Truth, the whole truth and nothing but the truth" we will have to call them front yards, and not front gardens.

It is a great pity that we should have to put it this way, we repeat. Nothing looks better, more inviting and gives a better idea of the people who occupy the set-back-in-the-lot-house than a clean lawn on a carefully trimmed hedge or a pretty garden in front of such a house.

To be sure the weather has been against such prettiness of late, but the time is coming when hoseholders can show in their front yards a little pride. We mentioned this before, but it seems that the time is most appropriate to again remind our citizens of it. They really owe to themselves, as much as they owe it to the community at large. It certainly would cost but very little to make this improvement and would give a better idea to visitors to our town. This is a matter for each individual householder and we really cannot understand why it should not be done.

Shock to Youthful Modesty.

One of the most eminently sensible mothers in Greensboro thinks so well of an article in the February number of World's Work that she says the people of this city and of North Carolina ought to read it. We quote it here and commend it to all thoughtful mothers and sensible school girls:

Modest people in many cities are shocked at the tendency of overdress by young girls; for we seem to be suffering from an epidemic of youthful immodesty in dress. One does not need to read the report of the New York Child Welfare League to learn that the school girl of today has abandoned the simple and charming garb which made her so enchanting, and has taken to hobble skirts, Louis XV. heels, gossamer hose, corsets, coiffeur, and cosmetics—yes, an astonishing number of girls even to powder and paint.

It's a pity. Of course, the feminine young person thus makes herself a bad caricature to an elder eye; but the trouble is with the mothers of such children. For the correction of such an impropriety must come by the strong hand of authority. And fashion seems to have got the better of material taste or power.

The subject may seem, in some moods, a mere passing fad; but it is really a very serious misfortune. In the first place, no nice girl should be permitted to make a guy of herself; in the next place, over-dressing costs money and time, endangers health, and distracts the mind from the more important interests of that most important and delightful period of existence—school days. Not to speak of snobbishness, over-dressing causes envy, and a great many other unpleasant things.

There is no other country in which misses are permitted to attire themselves in the fashion of their mammas and married sisters. No English peeres, no German graffin would dream of allowing her daughter to do up her hair, don a corset, and take to high heels, while she was in school. Common sense shoes and braided hair are the happy lot of school girls

everywhere—except in our own cities.—Greensboro News.

Dying Hard or Resurrected?

On January 18 was published the Watterson interview, together with comment from sundry worthies to be effect that Wilson was politically dead.

January 18 Senator Newlands, who has been indorsed by the Nevada legislature for the presidency, declared that the Democrats of Nevada and the west should recognize Wilson as the true progressive leader and rally to his support.

The same day Senator Gore of Oklahoma took up the cudgels for Wilson, saying that the entire incident was a "bubble, not a billow."

Also a petition was sent to the secretary of state at Lincoln, Neb., placing Woodrow Wilson's name on the Nebraska preferential ballot for the presidency. A number of Bryan's personal friends signed the petition, and the president of the Nebraska Wilson league says it was done in answer to the Harvey charges.

January 20 Congressman Small of North Carolina declares: "There is one thing you can say for North Carolina: We are going for Woodrow Wilson."

This evening in response to a call issued by a number of Democrats, prominent in the state, a meeting will be held in Minneapolis to organize a Minnesota Wilson Club.

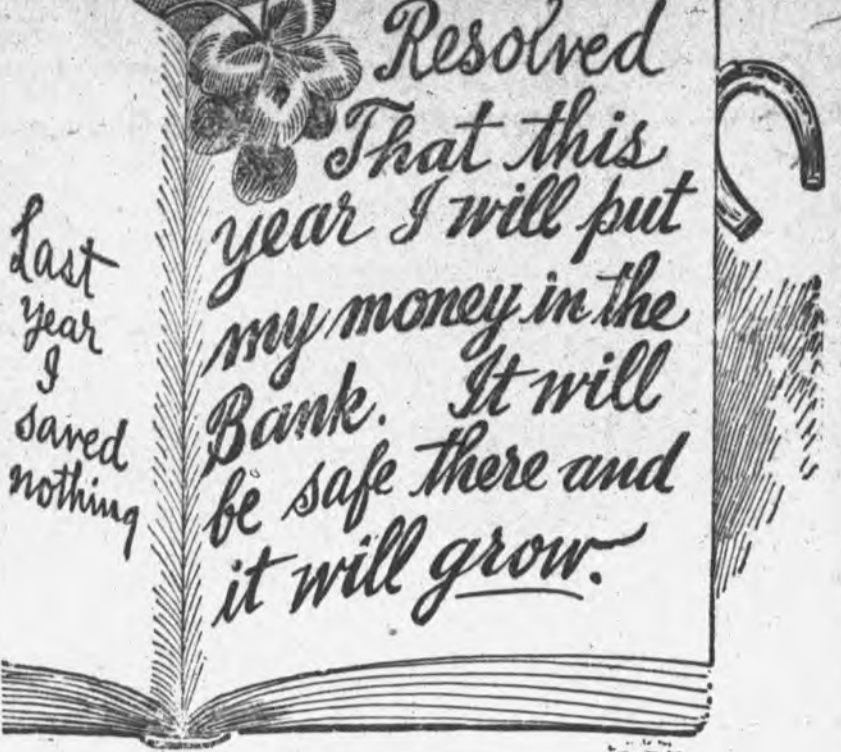

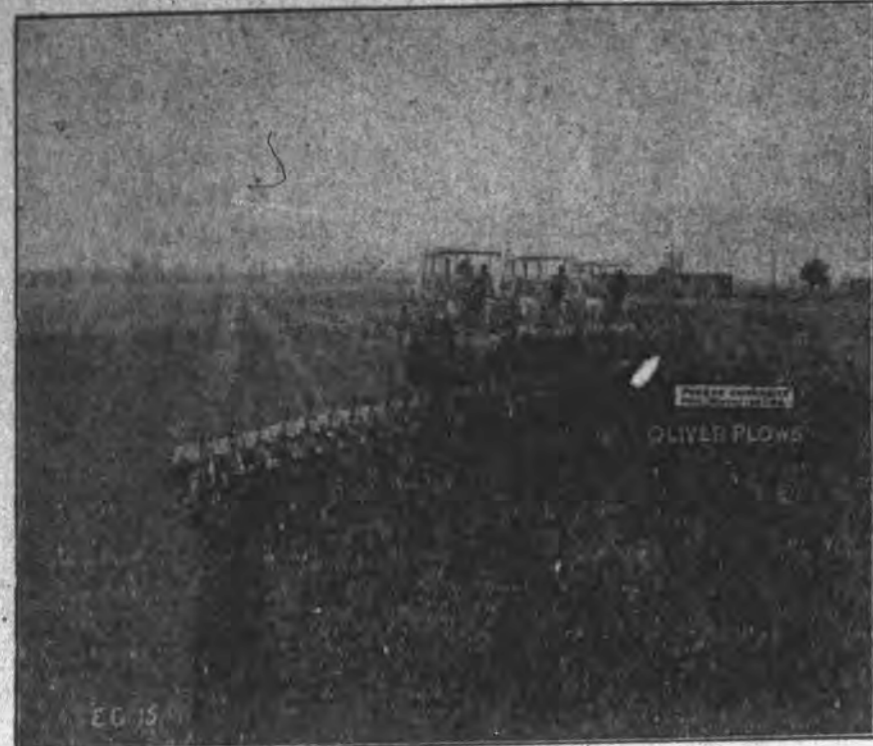

THE COTTON CROP OF 1912.

Should the Farmer Profit or Lose by Its Production?

To the Producers of Cotton in North Carolina:
The present crop exceeds the requirements of the commerce of the world, consequently the price means a loss to the farmer. To increase the price to remunerative figures there must be a reduction in amount produced.

There have been for the past six months many meetings and much resolving on this subject. The time for action is at hand. To affect the price of cotton now on hand some reliable opinion must be given the men interested as to the probable amount of the crop that will be produced this year. To this end, as related to North Carolina, the commissioner of agriculture representing the farmers' department of the state government, the president of the North Carolina branch of the Farmers' Educational and Co-operative Union of America and the president of the North Carolina Farmers' State Alliance issue this address, inviting the farmers interested in the cotton crop to assemble at the court house in their respective counties at 12 o'clock m., on Saturday, February 17, 1912, and take action by enrolling the names of those who will agree to a reduction on their premises. The plan of the Farmers' Union is thought most feasible, viz: "That I promise to plant at least one acre in some food crop for each acre that I plant in cotton this year." Blanks will be furnished by the Farmers' Union and in counties where the union is not organized, upon application to the secretary, Mr. E. C. Faires, Aberdeen, N. C.

Those present can arrange for a canvass of the county by appointing persons or committees to cover the territory. Every business and professional man is interested in the price of cotton and contributions to defray the expenses should be solicited.

The carriers on the free delivery routes can be used to great advantage in this work and would do it very economically. The paper when signed should be forwarded to the secretary of the union or the commissioner of agriculture.

The purchase of unnecessary commercial fertilizing material, in amount or kind, which could or

should be produced on the premises is a great drain on the farm and is as much a loss as the purchase of food or other supplies which can be made at home. This subject should be given careful attention; it is poor policy to spend money for unnecessary goods what has been saved upon a self supporting farm so far as relates to rations. Let the farmer produce at least his nitrogen by leguminous crops and the elements in barnyard manure, and many thousands of dollars that now go out will remain with him.

The North Carolina farmer has surpassed his brother in almost every line of farming in which the situation is such that he can compete. But there is no place to rest, each year makes its peculiar demands. Let us meet those of 1912 as they arise and with thanks to a beneficent Providence for the blessings of the past and a prayer for strength to meet the obligations of the future with stout hearts and steady hands.
