## "NOT GUILTY" SAYS JURY IN BRYAN CASE

### New Bern Man Walks Out of Court a Free Man

## IS RE-ARRESTED IN LIQUOR CASE

### After 90 Hours' Deliberation the Jury in the Case of Bryan Returns a Verdict of "Not Guilty"—Solicitor Abernethy Charges Two Witnesses With Improper Conduct.

NEW BERN, Feb. 17.—At 3:55 o'clock yesterday afternoon the jury in the Baker Bryan murder case after being out for more than seventy hours brought in a verdict of not guilty.

Immediately Solicitor Abernethy arose and stated that he wished to file affidavits charging Messrs. Wm. Styron and J. F. Rhodes, two of the jurors, with improper conduct. The judge allowed this and he proceeded. He stated that Mr. Styron had been seen leaning out of the window and conversing with Fred Carter, one of the crew of the revenue cutter "Pamlico" and that Mr. Rhodes' relations with Baker Bryan were such that he could not give the state a fair and impartial trial. Judge Foushee asked Mr. Styron if he had a conversation with Fred Carter and he stated that he only spoke to him as he was passing on the street. The judge then ordered Mr. Rhodes to stand up. He asked him if he had ever stated that he believed Baker Bryan killed Will Avery accidentally. Mr. Rhodes stated that he had not. He then asked Mr. Rhodes if he was on Bryan's bond in a liquor case. To this question Mr. Rhodes replied that he guessed he was and explained how the affair came about. He stated that he was walking down Middle street one day several months ago and that some one told him that Bryan wanted to see him. He saw Bryan and that he asked him to stand his bond for \$100 and he would give him a mortgage on a piano as security. This he did. Judge Foushee failed to sustain the allegations of the affidavits and discharged the prisoner. Immediately he was placed under a bond of \$250 for operating a bawdy house. This bond was furnished and Bryan walked out of the house a free man as far as the murder was concerned.

Solicitor Abernethy then stated to the court that the verdict rendered by the jury was one of the grossest miscarriages of justice ever perpetrated in the state of North Carolina. At this assertion practically every one of the large number of spectators in the court room openly applauded. This trial has cost the county at least \$3,000. Two hundred and sixty special venire men were summoned at the opening of the term. A large number of witnesses are to be paid and there are a long list of expenses attached to the trial.

Both men were locked up in the local jail. This morning Mayor Wooten asked for a \$200.00 bail for their appearance for a preliminary trial tomorrow morning at 10:00 o'clock. Bond was given by Frank Hopkins, but Fleming is still in the cell, as he could not procure the necessary \$200.

## FITNESS FOR OFFICE AND STRENGTH FOR RACE

WASHINGTON, Feb. 19.—The Democrats of Texas spoke last night upon the availability of Governor Woodrow Wilson as the Democratic candidate for president. The expression was made through her two senators, Culberson and Bailey, but the views were widely divergent. Senator Culberson declared unequivocally in favor of Governor Wilson while Senator Bailey declared that if nominated the Jersey governor would certainly be defeated. Senator Bailey did not express his choice, but it is well known that he prefers Governor Harmon, of Ohio, over all other candidates that have been suggested. Senator Bailey, who is soon to retire from the senate, stated that he could do so without neglecting his duty he would leave Washington and go home within 30 days to assist in organizing a campaign against Governor Wilson, because he does not, in his judgment, "fitly represent Democratic principles."

Senator Culberson is one of the recognized leaders of his party in the senate, and until recently, when he voluntarily resigned on account of ill health, he was the minority leader, having been unanimously elected by his Democratic colleagues. He has been frequently mentioned for the nomination himself.

## SIMMONS GETS BACK AT GOVERNOR KITCHIN

### North Carolina Contingent Reads Attack on Simmons

## SIMMONS AGREED WITH TAR HEELS

### Senior Senator Declares That all that Stood With Him in the Lumber Vote Should be Read Out According to Kitchin—He agreed With all North Carolinians.

WASHINGTON, D. C., Feb. 19.—Every member of the North Carolina colony in Washington, whether congressman or federal officeholder, was anxious to get a copy of The News and Observer today to read of Governor Kitchin's opening attack on Senator Simmons last night. The governor's speech was the chief topic of conversation among the Tarheels this afternoon.

Senator Simmons tonight gave out the following statement: "I had heard that Governor Kitchin in his speech in Raleigh last night would charge that I had voted with the Republican majority on the Payne-Aldrich bill; that I voted for subsidies and that I was undemocratic and reactionary. Supposing that this would be the line of his attack, as I see from The News and Observer it was, there was mailed to the North Carolina papers last night an answer to these several anticipated criticisms, and I hope these papers will give me the same space in its publication as I see The News and Observer gives Mr. Kitchin. Mr. Kitchin's labored effort to show an inconsistency in my position on lumber and wheat as stated in my Snow Hill speech in 1902 and in my speeches on those subjects in 1908 were fully answered by me in these latter speeches.

"In 1902 we manufactured practically only high grade lumber such as Canada does not produce at all, and there was practically no competition between the two countries in the sale of this article."

# NEWS FROM THE POLITICAL WORLD

WASHINGTON, D. C., Feb. 17.—  
Several decisions of unusual import-  
ance may be handed down by the Su-  
preme court of the United States when  
it reconvenes Monday after a three  
weeks' recess. Two of the cases in  
which decisions are looked for at an  
early date deal with important phases  
of construction of the Sherman anti-  
trust act, the cotton pool case and  
the anthracite pool case. A third case  
of importance is the suit brought to  
test the constitutionality of the Ore-  
gon initiative and referendum law.

The recent withdrawal of Joseph  
W. Folk as a candidate for the Demo-  
cratic presidential nomination is be-  
lieved to assure the unanimous in-  
dorsement of Speaker Clark by the  
Democratic state convention of Mis-  
souri, which is to be held in Joplin  
Tuesday. The action of Missouri is  
likely to be followed by the Democra-  
tic state convention of Oklahoma, where  
the Clark candidacy already  
has been received with much favor.  
The Oklahoma convention will be held  
in Oklahoma City two days after the  
Missouri gathering.

The annual celebration of Washing-  
ton's birthday Tuesday will be the oc-  
casion as designated to read Wash-  
ington's farewell address before the  
senate on that day. In the evening  
Senator Fletcher, of Florida, Senator  
Bailey, of Texas, Senator Williams, of  
Mississippi, and Senator Taylor, of  
Tennessee, will speak at the annual  
dinner of the Southern Society of  
Washington.  
President Taft, Secretary of the  
Navy Meyer and W. Morgan Shuster,

deposed treasurer general of Per-  
sia, will head a distinguished list of  
speakers at the annual convention of  
the navy league of the United States  
to be held in Washington Thursday  
and Friday.  
The general managers of all of the  
prominent eastern railroads are to  
confer in New York Friday regarding  
the demand made by the locomotive  
engineers for higher wages. The en-  
gineers are uniting in a movement for  
an advance of fifteen per cent and  
every railroad east of Chicago, north  
of the Chesapeake and Ohio and south  
of the Canadian border, is affected  
by the demand, and also the Grand  
Trunk of Canada.

Governors of twelve eastern states  
have accepted invitations for repre-  
sentation at a conference to be held  
in Harrisburg, Pa., Tuesday and Wed-  
nesday to devise means to check the  
spread of the chestnut tree blight,  
which is killing millions of dollars  
worth of trees in New England, New  
York, Pennsylvania and the South,  
and is threatening the Ohio river  
valley.

Mr. Jussurand, the French embas-  
sador, will deliver the Washington's

The National Congress of Mothers  
and Parent-Teacher Organizations,  
Sixteenth Annual Conference on Child  
Welfare, convenes at St. Louis, Mo.,  
March 20th to 26th. Reports will be  
given of an enormous work done in

in both the National and State bodies.  
These are: child labor, child hygiene,

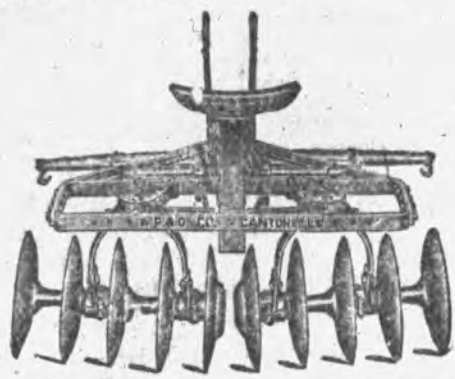

## GREAT WORK IS A LIBRARY ON CIVICS, HISTORY AND INDUSTRIAL PROGRESS OF THE UNITED STATES.

Messages and Papers of the Presidents Compiled in a Series of Eleven Volumes.

An Encyclopedic Index Sets Forth Important Questions of Government From the Foundation of the Republic.

declared May 12, 1846. This war is fully treated in the encyclopedic index volume, and the history of it is told in Polk's various addresses and messages. The treaty of Guadalupe Hidalgo brought the war to a close in 1848, by the terms of which treaty Mexico sold for \$18,000,000 that territory which now comprises California, Nevada, most of Arizona, New Mexico and Utah and a part of Colorado and fixed the boundary of Texas at the Rio Grande.

The Wilmot proviso was an attempt to exclude slavery from any territories to be acquired from Mexico. While this proviso failed of passage, it gave a forecast of the bitter war that was soon to settle the slavery question in the United States.

The election in 1848 resulted in victory for the Mexican war hero, General Zachary Taylor. Taylor was a Whig, but his popular success was due largely to his military record.

Taylor recommended a protective tariff for the protection of home industries and for the insurance of good wages for labor. Taylor's term was cut short by death.

Fillmore's recital of the history of his time is of extraordinary importance because the country was on the eve of its greatest crisis. Fillmore rather leaned toward the slavery doctrine and signed the fugitive slave act and other compromise measures, which lost him the favor of the Whig party in the north. The Fillmore fugitive slave proclamation is partially reproduced in facsimile. This proclamation is as interesting as fiction when looked back upon across the bloody chasm of the war which reversed its fiat.

President Fillmore adduced philosophical arguments in favor of a tariff for revenue which might properly amount to a protective tariff.

Fillmore advocated internal improvements and recommended that some means be found of opening a line of communication between the valley of the Mississippi and the Pacific on account of the "unprecedented growth of our territories on the Pacific in wealth and population and the consequent increase of their social and commercial relations with the Atlantic states."

The Clayton-Bulwer treaty with England was agreed to, the terms of which have been somewhat in dispute recently because it dealt with the then proposed Nicaraguan canal, but, broadly interpreted, would be effective as to the Panama canal, which was discussed in the newspapers recently as to whether the United States has the right to police and control the Panama canal without an infraction of the Clayton-Bulwer treaty.

Among the illustrations in the Fillmore period of history which lighten up the work and give it a tinge of romance is the cartoon entitled "Ridicule of Jenny Lind's Popularity in 1850."

Louis Kossuth, the great Hungarian leader in the European struggle for liberty, was in 1851 aided to escape from Turkey by the United States government and visited America, being heralded as a great emancipator. Reference to this historical event, throwing a side light on foreign history, is given in the encyclopedic index volume.

The Gadsden purchase was arranged by treaty with Mexico during Pierce's administration and added considerable territory to the United States.

Pierce declared unreservedly his conviction that slavery was constitutional and upheld the fugitive slave act. He denounced bitterly the slavery agitation.

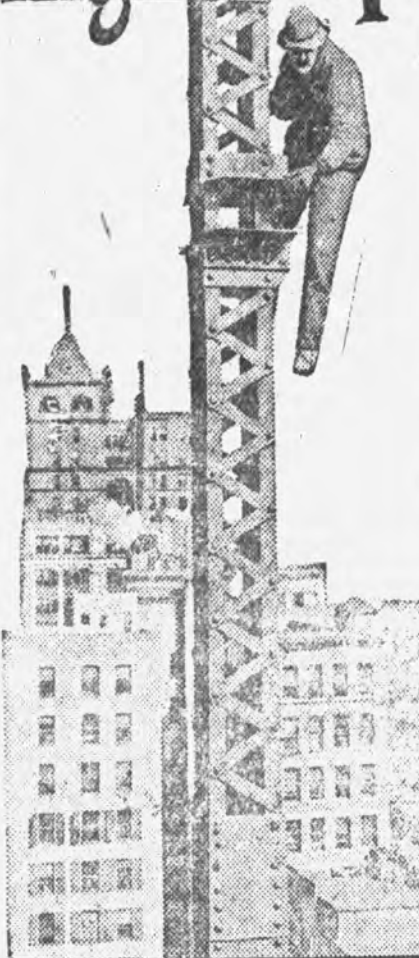
