RE-ORGANIZED COOPERAGE CO. BEGINS ACTIVITIES

Pushing their Railroad Tracks To Woods

ERECTING OTHER BUILDINGS

That the Greenville Cooperage and Lumber Company, a concern organized here February 29th to succeed the old Cooperage Co., with a capital of \$100,000 means business is well attested to by the activities in evidence in the plant.

Already workmen are pushing fast the tracks of the Company's railroad to the woods in the neighboring country and other evidences are conclusive that we are soon to have this plant running full blast.

It is calculated that when running full the plant will provide work for about one hundred or one hundred and twenty workmen, which means the maintenance of at least 500 people.

An inspection to the plant as it now stands gives a good idea of the amount and quality of work which can be turned out and the benefit Greenville will derive from having such a company in operation.

Officer McGowan Dies of Pneumonia

A Good Man and Useful Citizen Passes Away—Leaves a Wife and Seven Children—Been on Force Twelve Years.

Mr. William Henry McGowan died of pneumonia about 10 o'clock Sunday morning at his home in South Greenville. He was 44 years of age and was a good man and useful citizen.

About twelve years ago Mr. McGowan was elected on the police force of the town and the fact of his re-election by each succeeding administration speaks its own compliment to his faithfulness. Through most of these years he was night policeman and was always found at his post of duty, going about his task cheerfully regardless of weather. It can be truly said that he gave his life in the service of the town, for it is no doubt true the exposure in the severe weather of this winter contracted the disease that resulted in his death. His passing away brings much sadness in the community for he had a host of friends.

He is survived by a wife and seven children and much sympathy is expressed for these in their great bereavement.

The funeral took place at 2 o'clock this afternoon from his residence, the interment being in Cherry Hill cemetery, services being conducted by Rev. E. M. Hoyle. The pall bearers, all official representatives of the town, were Messrs. F. M. Wooten, J. C. Tyson, J. T. Smith, G. A. Clark, H. C. Edwards, W. A. Bowen, B. F. Tyson and Z. P. VanDyke.

Raleigh.—The J. D. Ford-Price Realty Company of Charlotte was chartered today with \$50,000 capital by J. D. Ford, R. F. Price and C. W. Barreno for real estate development. Another charter is to the R. F. Henry Jewelry Company of Statesville, capital \$10,000 by R. F. Henry, O. W. Stone and others. There is an amendment to the charter of the Wade Stockard Company of Greensboro that changes the name to the Hill-Stockard Company. Roland Hill is president.

FIFTH EXCURSION OF N. S. SYSTEM

IN ALL THERE WERE ABOUT 25 PEOPLE IN THE PARTY—GIVEN BANQUET AT ELKS HOME

NEW BERN, March 11.—The fifth in the series of homeseekers' excursions inaugurated by the Norfolk Southern Railroad arrived here this afternoon. There were about twenty-five excursionists in the party. They were met at the depot by the chamber of commerce's reception committee and escorted to the Gem Hotel, where they will make their headquarters while in this city.

During the afternoon the visitors were taken for short trips into the country. Tonight the chamber of commerce tendered the visitors an informal banquet at the Elks Temple. There were a number of talks made by representative citizens and by members of the visiting party. The excursionists will leave tomorrow for the Norfolk Southern special for Morehead City.

The excursions are proving to be very popular with the homeseekers of Ohio, Indiana and other Northern and Western states. A number of very desirable immigrants have already been secured through the agency of these excursions and Secretary Williams has received many inquiries from prospective purchasers of homes in this section, who have made trips here and have become very favorably impressed with the section of the country.

News Forecast for the Present Week

The Reflectors Special Weekly Letter of Intelligence on Coming Affairs, From the National Capital. Political News and Comments From the Labor World Discussed by Tavenier

FIFTY FOUR LABOR LEADERS AND OFFICIALS WILL BE ARRAIGNED TO-MORROW

WASHINGTON, March 11.—Republican State conventions to elect delegates to the national convention will be held during the week in Virginia and Oklahoma. The Taft supporters are confident of victory in Virginia, but in the Oklahoma State and district conventions the Roosevelt followers plan to make a vigorous fight for control.

The Democratic leaders will turn their attention towards Kansas, where the State convention to elect delegates to the Baltimore convention will meet in Hutchinson Thursday. Clark, Wilson and Harmon each claims a following in the Sunflower State and the outcome of the convention is problematical.

In Alabama and the State of Washington the Progressive Republicans are to hold state conferences to consider plans for pushing the Roosevelt candidacy.

Tennessee Republicans will meet in Nashville Tuesday to nominate a State ticket to be voted for in the approaching election. The renomination of Governor Hooper appears to be assured. A second convention will be held in May to select delegates to the Republican National Convention.

New Mexico's first State legislature will convene in Sante Fe Monday. Within ten days after convening the lawmakers will begin balloting for two United States senators.

A State election will be held in New Hampshire Tuesday to elect delegates to the convention which will meet in

Concord next June to frame a new State constitution.

Labor troubles and the prevalent unrest in the industrial world will continue to occupy a large measure of public attention. The progress of the coal miners strike in Great Britain will be followed with interest, while efforts to prevent a similar struggle between the mine owners and miners in the Anthracite fields of the United States will attract even more attention on this side. It is expected that the operator's answer to the demands of the miners will be made public at a joint conference called for Wednesday.

The fifty-four labor union officials and business agents under indictment in the dynamite conspiracy cases are to be arraigned in the federal court at Indianapolis Tuesday. At this time the men charged with crime must answer they are guilty or not guilty.

The contempt proceedings involving President Samuel Gompers, vice President John Mitchell and Secretary Frank Morrison of the American Federation of Labor are docketed for hearing Monday before the full bench of the supreme court of the District of Columbia.

A joint conference of locomotive engineers and managers of practically all the Eastern railroads will meet in New York City Thursday to consider the wage demands recently made by the engineers. The demand is for an increase in pay ranging from 15 to 50 per cent and the standardization of wages.

During the first week or ten days of the session the interest of the lawmakers will be centered almost wholly upon the election of two United States senators. The Republicans have a majority of nine on joint ballot. Insuring the selection of two Republicans as the first representatives of New Mexico in the upper house of the national congress.

CHICAGO, Ill., March 11.—Players of the Minneapolis club of the American Association gathered in Chicago today preparatory to their departure for Hickman, Ky., where they are to lumber up for several weeks in readiness for the season's opening. The training quarters will be established on the farm of Joe Cantillon, the manager of the Minneapolis club.

THEY MUST STAY IN JAIL

MOTION DENIED BY JUDGE

PRISONERS IMPLICATED IN HAWKINS MYSTERY DENIED MOTION FOR RELEASE

ASHEVILLE, N. C., March 11.—A motion for the release, under a writ of habeas corpus, of Abner McCall and his wife, Beatrice, who were yesterday indicted by the grand jury at Hendersonville for the murder of Myrtle Hawkins last September, was denied this morning by Judge Foushee, sitting at the criminal term of Henderson county court.

The McCalls, together with George and Boney Bradley, brothers, also indicted in the case yesterday, were arraigned and held for trial at the May term of the superior court, without bail.

The Bradley brothers were brought to Asheville tonight and lodged in the Buncombe county jail. This action was deemed necessary, it is said, owing to the overcrowded conditions existing at Henderson county's jail.

COTTON CROP OF PITT COUNTY.

41,503 Bales Ginned, With 1,115 to be Ginned.

Mr. J. C. Lanier, special agent of the government on cotton gin reports for the eastern half of Pitt county, sent in his closing report for the past season on Saturday. He advises us that for the season ending March 1st there had been ginned in this county 41,503 bales, with 1,115 bales to be ginned. This puts the crop of the county for 1911 at 42,618 bales. It would have been larger than this but for some loss through inability of farmers to get their cotton picked out. It is estimated that fully a thousand bales were not picked.

ANOTHER J. P. WRITES.

Editor of Reflector: I notice that some justice of the peace seems to be in a hurry to get the farmers living in what is known as the new stock law to shut up their stock. I naturally suppose that he lives in town.

I have consulted legal authority and wish to call attention to Sec. 1683 of the Revisal of 1905, which says "The stock law authorized by this chapter shall not be enforced until a fence shall have been erected around any territory proposed to be enclosed with gates on all the public roads passing into and going out of said territory." I am also informed that the supreme court has decided that the new stock law is subject to the provisions of chapter 386, Laws of 1901. Sec. 7, of this act says, "That no person shall be guilty of any violation of the laws concerning the running of stock at large in said territory until the fence around the same shall be constructed."

"Murder Will Out"

It may be, and doubtless is true that many murders have escaped the just punishment of their crimes, but in the great majority of cases the law has exacted the full toll. It is a matter of record, too, that murders, "made cowards by conscience," have confessed their guilt under the mental lash. But whether overtaken by the law's machinery or voluntarily acknowledged, "murder will out." It is one of the seven deadly sins crying to heaven for vengeance, and its bloody trail must sooner or later lead to the assassin's door. The cry of "murder!" has always been one to numb the brain and strike terror to the human mind and heart. It was such a cry that Shakespeare invested with all the horrors of human imagination; around the crime of murder he painted scenes of frightful vividness.

"Murder most foul, as in the best it is," will not down. Those who are guilty of it may kill themselves into a felling of comparative security in the passage of time, but eye re and haunt them. The murderer knows no real rest, for "wherever you go, the thing you are will follow after you". The fear of discovery is always upon the wretch whose hands are stained with which human blood; his ears are never closed to the death cries of his victim.

In the pursuit of the manslayer the law is unrelenting. A mass of legal technicalities may delay the day of reckoning, or circumstances temporarily insurmountable may favor the culprit, but the hangman's noose is always at the end of the road.—Asheville Citizen.

Moreheads Address:

State Chairman, John M. Marehead has issued an address to the Republicans of North Carolina, in which he concentrates his fire on the national committeeman. "It is the belief and conviction of your committee," he says, "that your national committeeman should be elected on recommendation by your state convention and that he should be an ex-officio member of the State executive committee and amenable to and bound by the majority action of the committee. As is thoroughly well known and understood, there has been fiction between both the former and the present State organization on the one hand, and the present national committeeman on the other. The former State chairman has repeatedly affirmed that his recommendations were not worth the

paper upon which they were written, and your present State chairman has likewise been seriously hampered in his effort to build up a strong and cohesive party in the State, which conditions is now known to have been brought about by reasons of the peculiar friendship and relationship between the national committeeman and the Postmaster General." Continuing, Chairman Morehead says that if it is considered advisable to accord, by the action of the convention, "to the position of national committeeman dignity and authority, which would seem entirely proper and logical, then let us make the position part and parcel of our State organization and make the individual filling it responsible to and found by the majority action of our State committee, rather than permit the national committeeman to roam the entire political pasture, unbridled and unguided except by personal preference that may be exercised regardless of local and even State-wide sentiment." The picture of the national committeeman roaming "the political pasture; unbridled and unguided" is good. Verily, the Republican political pasture is a cause of much and consuming jealousy... Charlotte Chronicle.

Harold Hoffding

Harold Hoffding, the celebrated Danish philosopher and writer, was born in Copenhagen, March 11, 1843. He was educated in the metropolitan school and university of Copenhagen, receiving his degree as a doctor of theology in 1865 and as a doctor of philosophy in 1870. He became a lecturer at the University of Copenhagen in 1880 and since 1883 he has been professor of philosophy at that noted institution of learning. Dr. Hoffding has received honorary degrees from the university of Copenhagen, St. Andrews, Oxford, Cambridge and Geneva. His "History of Modern philosophy" and several of his other works on philosophical problems have been translated into numerous languages.

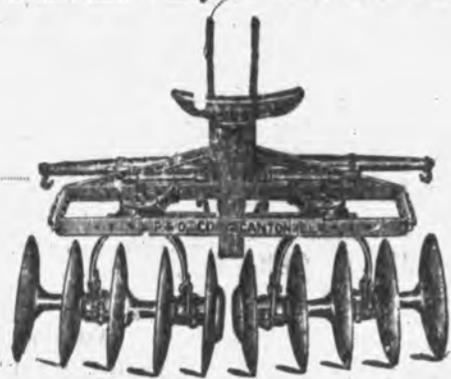
MERCHANTS, TAKE NOTICE.

WASHINGTON POLITICAL NEWS

WASHINGTON, March 11.—Instead of taxing sugar nearly two cents a pound, place a tax on wealth!

The Democratic House of Representatives has announced this as a part of its program to bring about a reduction in the cost of living.

Now get ready for the old cry: "You can't do it; it's unconstitutional!" Whenever it is proposed to tax wealth instead of poverty, wealth raises the question of unconstitutionality, accompanied with the charge of "radicalism". The income tax is not radical. Every first class nation of the earth—except this one—raises a part of its revenue to meet the expenses of the government by taxing incomes, among such nations being Great Britain, Japan, France, Denmark, Germany, Holland, Austria, Switzerland, Australia, New Zealand and many more.

Under our present fiscal policy, the expense of maintaining the army and navy, building public buildings and running the government, is met by taxing the things the people must have in order to live. Practically all revenue is derived through the customs houses and internal revenue offices, with the exception of a comparatively small amount derived from the corporation tax, which was substituted for a tax which was recently passed as a cheating substitute for an income tax. While the hats, coats and shirts of the masses are taxed almost 71 per cent under this fiscal system, Rockefeller, Morgan and the other millionaires are not asked by the federal government to pay any tax whatever on their swollen fortunes. Thus a poor man with a family actually pays more toward running the government than does a millionaire bachelor.

The Democratic plan is to place sugar in the free list. This will reduce an annual burden of \$107,000,000 in taxation from the breakfast table now borne by the American people. Then the present corporation tax will be extended to include individuals and copartnerships having an annual income of \$5,000 a year or more. The excess of income over \$5,000 will be taxed one per cent, bringing into the treasury between \$50,000,000 and \$60,000,000 a year, which will more than cover the \$53,000,000 now derived annually from the sugar tariff. The price of sugar to the consumer is estimated, will then be reduced about 1-2 cents a pound.

Those who scout the idea that an income tax bill can be drawn as to stand the test of the supreme court, may be referred to the opinion of one of the country's leading lawyers, William Howard Taft, as follows: "In my judgment, an amendment to the constitution for an income tax is not necessary. I believe that the income tax, when the protective system of customs and the internal revenue tax shall not furnish income enough for government needs, can be devised, which, under the decisions of the supreme court, will conform to the constitution."

"Protecting" the Children.

Nothing in the history of American tariff-making has so thoroughly demonstrated the fallacy of the high protection principle as the testimony of the Lawrence, Mass., strikers.

In the same room where Carnegie and Schwab told how they juggled millions, the Rules committee of the House heard fathers, mothers and children tell how whole families were forced to live on \$5 and \$6 a week paid by the highly protected woolen trust. The witnesses told how they were forced to work 10 hours a day; how they had to use "a sort of molasses as a substitute for butter; how children had to go in the mills at an early age in order to keep the family from actual starvation and how the constant demand of the mill owners was for more and more speed for the little children.

In the committee room sat some of the mill children. They were fresh from the mills and a mere glance at them told more than spoken volumes could tell. All had pinched faces. All were poorly dressed, some of them having only a cheap sweater in lieu of coat and overcoat. Most of them had dull expressionless faces, in which there was no trace of color or animation. All of them, moreover, were slightly deaf, because of their work amid the fearful clatter of the mill machinery, so that at times the committee members almost had to shout to make themselves heard. All the children looked worn and old, as though they had been speeded up beyond the limit of endurance.
